NOTE: The information on Duff is being made available to locate Duff. Duff reportedly was an acquaintance of Oswald. Duff formerly employed as chauffeur and handyman for General Edwin Walker, Dallas, Texas. Dallas is attempting to locate Duff in order to question him concerning his alleged acquaintance with Oswald. Duff allegedly a conman and Dallas thought he might be subject of a pending Bureau investigation which would facilitate our locating him. Our files contain no information indicating we have pending criminal investigation on Duff.

By letter dated 1-17-64, the President's Commission was advised of contact by attorneys for General Edwin A. Walker. Attorneys desired information on alleged shooting at Walker residence perpetrated by Oswald. At this time Commission advised Duff only suspect developed and absolved by Dallas Police Department. Commission advised that we are making efforts to locate Duff for interview and results of same would be furnished. Duff last reported seen boarding Oklahoma City bound bus during October, 1963. Our Dallas, Los Angeles and Oklahoma City Offices are endeavoring to locate Duff. This is being closely followed.

CONCERNING CONNECTION OF WILLIAM MC EWAN DUFF WITH LEE HARVEY OSWALD.

ON PAGES TWO NINE NINE OF REPORT OF SA ROBERT P. GEMBERLING, DEC. TWENTY THREE LAST THERE IS REFLECTED INTERVIEW WITH JOE LORIA, A RESTAURANT OPERATOR, DALLAS, WHO STIED THAT APPROXIMATELY SEVEN OR EIGHT MONTS AGO SAW INDIVIDUAL KNOWN TO HIM ONLY AS SCOTTIE, WHO WAS SUB SEQUENTLY IDENTIFIED AS DUFF, WITH INDIVIDUAL BELIEVED TO BE OSWALD. HE BASED HIS IDENTITY ON PHOTOGRAPH OF OSWALD HE HAD SEEN IN DALLAS NEWSPAPERS AND RECALLED ONLY ONE TIME THAT HE THOUGHT HE SAW OSWALD AND SCOTTIE TOGETHER.

ADDITIONAL INVESTIGATION RE HIS ALLEGATION REFLECTED ON PAGES THREE ZERO ZERO THROUGH THREE ZERO EIGHT IN REPORT OF SA GEMBERLING, DEC TWENTY THREE LAST.

INVESTIGATION BY OKLA CITY AND LOS ANGELES DIVISIONS TO DATE HAS FAILED TO LOCATE DUFF WHO IS ALLEN FROM SCOTLAND. HIS INS FILE IS LOCATED AT DALLAS AND STOP HAS BEEN PLICED THERE. EFFORTS TO LOCATE DUFF CONTINUING UACB.
