DETAILS: AT ST. LOUIS, MISSOURI

A review on January 21, 1964, of the military service records on file at the Military Personnel Records Center, for WILLIAM MC EWAN DUFF, Serial Number AF 19 607 309, indicated he enlisted in the U. S. Air Force on December 6, 1957, and entered on active duty on the same date at Los Angeles, California. He received an undesirable discharge under other than honorable conditions on December 18, 1959, as an Airman Basic at McGuire Air Force Base, New Jersey, by reason of unfitness.

His record reflected he was tried and convicted by a Summary Court-Martial, September 24, 1959, for [REDACTED] of the U. S. Air Force. He was sentenced to be confined at hard labor for thirty days and to forfeit \$50.

His record also indicated he received two article 15's (company punishments). One was on April 9, 1959, for operating a private motor vehicle without a valid U. S. Air Force's (USA) driving permit and for failure to report a vehicle accident within twenty-four hours to the Air Police; he was reduced to the grade of Airman Basic and reprimanded. The other was on December 15, 1958, for drinking and having on his possession approximately twelve ounces of whiskey while on duty; he was reduced to Airman Basic and reprimanded.

This document contains neither recommendations nor conclusions of any kind. It is the property of the FBI, and its contents are not to be distributed outside your agency.

His record contained a clinical record with consultation sheet dated September 28, 1959, which reflected a diagnosis [REDACTED]

[REDACTED] It was also indicated he has been characterized by his aunt as being an habitual liar. He has applied for American citizenship and has little worry over the fact that his possible discharge from the service would make him ineligible for citizenship.

The record reflected only one additional address, that of 719 South Maple Avenue, Monterey Park, California, 1959. His Social Security Number was shown as 572-54-0914.

His record failed to reflect any pertinent information in addition to that previously reported.

His date and place of birth were shown as November 8, 1931, Grangemouth, Stirlingshire, Scotland.

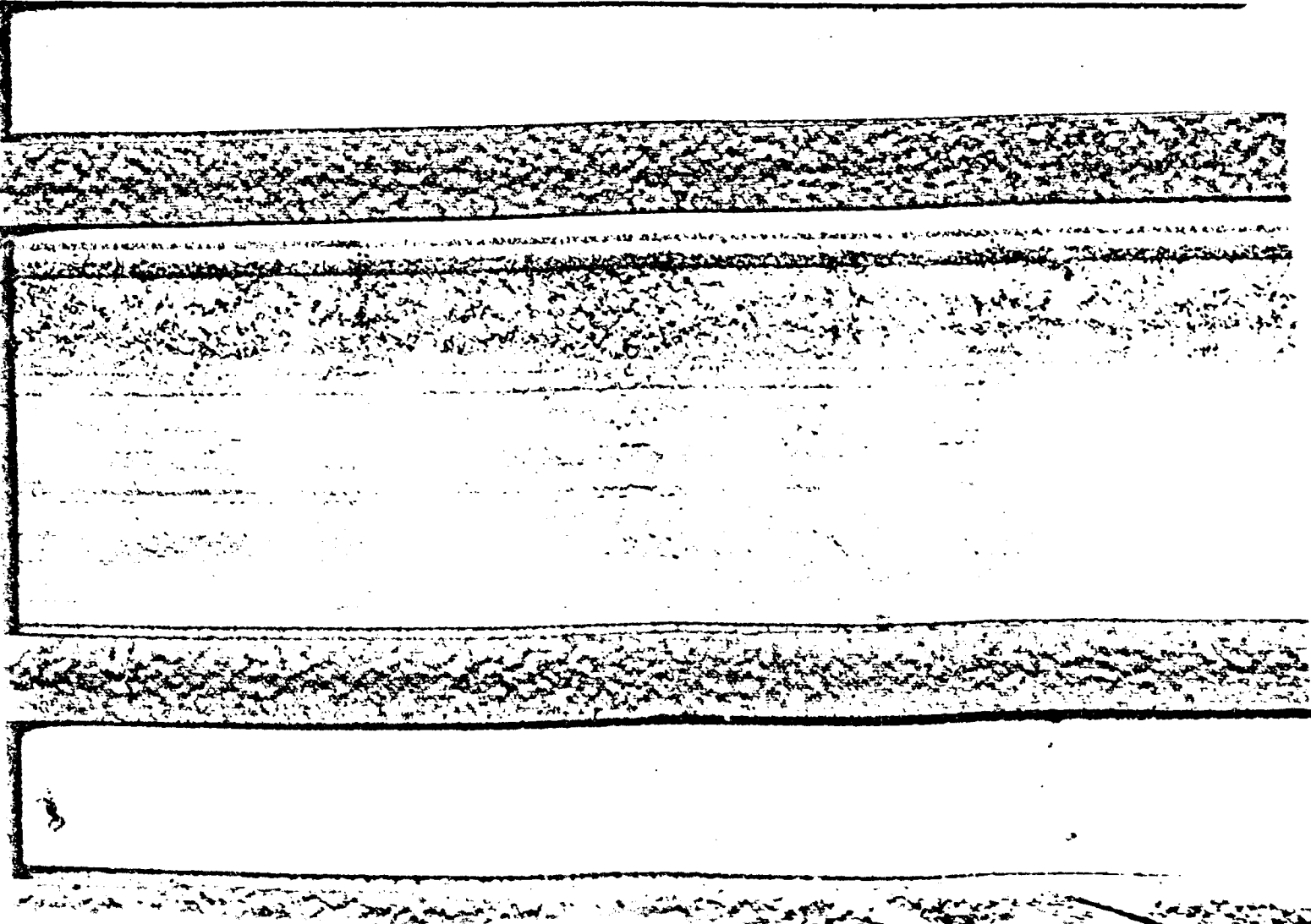

The Detroit, Oklahoma City and Phoenix offices are being furnished referenced Cleveland airtel to provide background concerning this phase of the LEE HARVEY OSWALD investigation. In addition, these offices are being furnished photos of NANCY JANE RITZ, nee MC CLAIN, and WILLIAM A. MARLOWE, JR.

Referenced Bureau airtel reads:

"It is requested that you promptly locate and interview Nancy Jane McClain, aka Nancy Marlowe, to determine if she does, in fact, have any information pertaining to the captioned subject or Jack Ruby. Even though it appears unlikely that she has such information, this allegation must be run out. Determine if she was ever in DL and, if so, complete details of her visits to that city, her associates, acquaintances, et cetera."

The Dallas office has advised that the whereabouts of OSWALD has been sufficiently established for the period October 15, 1962 to November 24, 1963, to have precluded his having lived with a prostitute in Cleveland, during early 1963.

AT CLEVELAND, OHIO

The following investigation was conducted by SA EDWARD P. GAZUR on the dates indicated:

Officer JOHN BERRY, Third District Vice Squad, Cleveland Police Department, on January 8, 1964, informed that he arrested NANCY JANE RITZ, nee MC CLAIN, on September 25, 1963, together with WILLIAM A. MARLOWE, JR., and FRANKLIN REYNOLDS. He stated that NANCY JANE RITZ is a prostitute who was conducting her profession from the Greyhound Bus Depot, 1465 Chester Avenue, Cleveland, during September, 1963, for which she was eventually arrested. He stated that his investigation revealed that FRANKLIN REYNOLDS was her procurer and that WILLIAM A. MARLOWE was an individual who was living in a common-law relationship with NANCY JANE RITZ. He pointed out that at the time of arrest it was assumed that NANCY JANE RITZ was actually married to WILLIAM A. MARLOWE, although it was determined that she was married to an individual named RITZ.

Officer BERRY noted that he has not seen NANCY JANE RITZ and WILLIAM A. MARLOWE since their arrest and, inasmuch as they are no longer in the neighborhood of the Greyhound Bus Depot, assumes that they have left Cleveland. In this respect, he noted that NANCY JANE RITZ was carrying on her immoral dates at the Ohio, Dakota and Grand Hotels which are in the immediate neighborhood of the Greyhound Bus Depot.

He stated that FRANKLIN REYNOLDS is a small-time hoodlum and gambler who hangs out evenings at the Greyhound Bus Depot waiting to meet destitute girls whom he feels he can place in this illicit profession. He stated that he last saw FRANKLIN REYNOLDS during November, 1963, and has

not seen him since. He stated that this is odd, inasmuch as REYNOLDS can be located any night of the week at the Greyhound Bus Depot. He stated that REYNOLDS is a resident of the Town Apartments, 2344 Prospect Avenue, Cleveland. Officer BERRY related that he, as well as all members of the Vice Squad, knows NANCY JANE RITZ, and should she be still in the area of the Third District Vice Squad her presence would come to their attention.

Officer BERRY was recontacted on January 13, 1964, and again on January 20, 1964. On both occasions, he related that all members of the Vice Squad are on the lookout for NANCY JANE RITZ and WILLIAM A. MARLOWE, however, no information has come to their attention that they are still in the Cleveland area. He stated that each of the members of the Vice Squad have contacted their sources and, as a consequence, all avenues have been alerted.

Officer W. C. DOTY, Scientific Investigations Unit, Cleveland Police Department, on January 9, 1963, related that their records reflect that WILLIAM ALBERT MARLOWE, JR., FBI #849 560D, a white male, was arrested on September 26, 1963, and charged with hustling. He was released on a suspicious person's waiver on September 27, 1963.

Cleveland Police Department records reflect that WILLIAM ALBERT MARLOWE, JR., was born December 2, 1942, at Cleveland, Ohio, and he lists a residence of 1320½ West Filmore Street, Phoenix, Arizona. His parents are WILLIAM and MARY MARLOWE, JR., and he was previously arrested on May 18, 1963, on stolen auto charges; released same date on a suspicious person's waiver.

A photograph of WILLIAM ALBERT MARLOWE, JR., was obtained from this source.

These records further reflect that FRANKLIN ROOSEVELT REYNOLDS, a white male, with FBI # 628 454 D, was arrested on September 26, 1963, for hustling and was released on September 27, 1963, on a suspicious person's waiver. His mother is listed as KATHERINE and his residence is listed as 2344 Prospect Avenue, Cleveland.

These records further reflect that NANCY JANE RITZ, nee MC CLAIN, aka., NANCY MARLOWE, "SUGAR", was arrested September 26, 1963, and charged with prostitution. She was referred to the Cleveland Municipal Court on this charge for which she received a sixty-day jail sentence and costs which were suspended, and she was placed on probation. She has a prior arrest on May 18, 1963, on a charge of "stolen auto", and she was released on the same date on a suspicious person's waiver.

NANCY JANE RITZ is a white female, 5' 5" tall, 115 lbs., black hair, blue eyes, pock-marked face, and she has a scar above her wrist. She was born December 25, 1941, at Shelby, Michigan, and her spouse is listed as EDWARD MICHAEL RITZ. Her Cleveland Police Department number is 114 323 and her addresses are listed as 879 West River Street, Elyria, Ohio and 245 Fifth Street, Elyria.

A photograph of NANCY JANE RITZ was obtained from this source.

Miss L. C. ABBOTT, Probation Officer, City of Cleveland Probation Office, Cleveland, Ohio, on January 9, 1964, related that she handled the probation for NANCY JANE RITZ who was sentenced by the Cleveland Municipal Court on September 27, 1963, at which time she was sentenced to sixty days in jail and costs which were suspended.

Miss ABBOTT stated that her records reflect that NANCY JANE RITZ was placed on "inactive probation", on September 27, 1963, and that her only contact with her was on this date. She stated that inactive probation means that the individual is not required to report to the probation office and can leave the state at any time. However, should the individual be arrested within a period of one year from the date of sentencing, the individual's probation can then be revoked.

She stated that her records reflect that NANCY JANE RITZ comes from a broken home, and that she never knew her mother. Her father, ERNEST MC CLAIN, 1051 Fountain Street,

Grand Rapids, Michigan, is presently married to LOIS MC CLAIN, and NANCY JANE has never been able to adjust herself to this marriage. These records reflect that NANCY JANE RITZ was married to EDWARD MICHAEL RITZ, on June 17, 1962, at Lorain, Ohio, and they were separated during April, 1963, because EDWARD RITZ was unable to hold a steady employment. NANCY JANE RITZ came to Cleveland, Ohio from Phoenix, Arizona, with WILLIAM A. MARLOWE and Probation Office records reflect that it was her idea to prostitute herself to financially help MARLOWE, and that it was the first time that she had ever prostituted herself. These records also indicate WILLIAM A. MARLOWE, JR., had been a friend of EDWARD MICHAEL RITZ, and it was through this relationship that MARLOWE and NANCY JANE met.

Mr. RAYMOND STITT, Chief Investigator, Cuyahoga County Welfare Department, Cleveland, Ohio, on January 9, 1964, produced a Welfare application for EDWARD MICHAEL RITZ.

This record reflects that EDWARD MICHAEL RITZ, on April 2, 1963, applied for relief and was rejected on the same date as "ineligible because childless couple".

Mr. STITT noted that this was a telephonic application and that EDWARD MICHAEL RITZ and his wife did not appear at the office.

Background contained in this record reflects that EDWARD MICHAEL RITZ, born February 17, 1942, and NANCY JANE RITZ, born December 25, 1941, had been in Cleveland, for one day and they were "homeless". They recorded their last address as 224 Park Street, Willard, Ohio, and noted that they had come to Cleveland the previous day from Willard, Ohio. EDWARD MICHAEL RITZ noted in his application that he enlisted in the United States Air Force, on May 21, 1958, at Willard, Ohio, and was honorably discharged August 3, 1961. His Air Force Serial Number is listed as AF 15624314.

In respect to the above, it should be noted that this was a telephonic application, and the possibility exists

that WILLIAM A. MARLOWE at this point was assuming the identity of EDWARD MICHAEL RITZ in order to obtain the relief.

Miss T. ROGERS, Room Clerk, Ohio Hotel, 1527 Prospect Avenue, Cleveland, on January 9, 1964, produced a registration record which reflects that a Mr. and Mrs. WILLIAM MARLOWE, no address, checked in the hotel on September 25, 1963, and stayed overnight.

Miss ROGERS viewed pictures of both NANCY JANE RITZ and WILLIAM A. MARLOWE, however, she stated that these individuals are not known to her.

Miss ROGERS caused a review to be made of all hotel registration records from January 1, 1963 through the present, however, no further record could be located for NANCY JANE RITZ, WILLIAM A. MARLOWE or LEE HARVEY OSWALD.

She stated that no one resembling LEE HARVEY OSWALD has ever resided at the Ohio Hotel.

Mrs. MARY ALICE BENNETT, Owner, Dakota Hotel, 2045 East 18th Street, Cleveland, on January 9, 1964, checked her registration records from January 1, 1963 until the present, and could find no record pertaining to WILLIAM A. MARLOWE, NANCY JANE RITZ, or LEE HARVEY OSWALD.

She viewed photographs of NANCY JANE RITZ and WILLIAM A. MARLOWE and advised that she has seen both of these individuals in the immediate area during the Fall of 1963, but has not seen them since. She stated that no one resembling LEE HARVEY OSWALD has ever resided at the Dakota Hotel.

Mrs. ELLEN CHITHAM, Floorlady, Dakota Hotel, on January 9, 1964, identified photographs of WILLIAM A. MARLOWE and NANCY JANE RITZ as individuals who have stayed at the Dakota Hotel on at least two occasions during a period from the Summer of 1963 to the Fall of 1963.

She stated that she recalls that on occasions that these two people were at the hotel they would be guests

for overnight only and recalls that the individual identified as WILLIAM MARLOWE would leave the hotel in the morning and leave the girl in the hotel room. On one occasion, he remarked that he was going to the Greyhound Bus Dept to meet a man on business.

In respect to the above, she stated that she has not seen RITZ or MARLOWE since the Fall of 1963, and felt that if they were still in the neighborhood she would be cognizant of their presence.

In view of the above, all hotel registration cards for the period June, 1963 through November, 1963, were reviewed, however, none could be identified with MARLOWE and RITZ.

Mr. GEORGE POULAS, Owner, Grand Hotel, 2107 East 18th Street, Cleveland, on January 9, 1964, reviewed all his hotel registration records from the period January 1, 1963 through the present, and could find no reference to NANCY JANE RITZ, WILLIAM A. MARLOWE or LEE HARVEY OSWALD.

He further advised that he did not recognize WILLIAM MARLOWE or NANCY JANE RITZ as individuals he has seen in the neighborhood or at the hotel.

Mrs. ANGIE POULAS, wife of the owner, Grand Hotel, on January 9, 1964, related that the photograph of NANCY JANE RITZ looks familiar to her, although she does not know this individual. She recalls seeing a white female with a pock-marked face, whose hair was extremely long and stringy. It was for this reason that she remembered this individual, however, does not recall when she last saw this individual, although she believes it was some time ago. She noted that she also operates the Grand Restaurant which is in the Grand Hotel building and that this individual may have been a customer at the restaurant.

MYRTLE HALL, Waitress, Grand Restaurant, on January 9, 1964, advised that the photograph of NANCY JANE RITZ looks familiar, although she is not positive and further noted

that it is actually no one she knows, but rather someone she may have seen in the restaurant. In this respect, she stated that she does not recall when she last saw this individual but believes it must have been some time ago. She stated that the photograph of WILLIAM A. MARLOWE does not look like anyone she knows.

Mrs. HELEN PUMA, Desk Supervisor, YWCA, 1716 Prospect Avenue, Cleveland, on January 9, 1964, related that the YWCA has no present registration for NANCY JANE RITZ, aka., and further noted that registrations since the first of January, 1963, contain no reference to this individual. She added that she usually knows all the girls staying at the YWCA by sight, however, noted that the photograph of NANCY JANE RITZ does not look like anyone who has ever stayed at the YWCA.

EDNA BRANNING, Telephone Operator, YWCA, on January 9, 1964 viewed the photographs of WILLIAM A. MARLOWE and NANCY JANE RITZ. She stated that she has never seen WILLIAM A. MARLOWE, although there is something familiar about the photograph of NANCY JANE RITZ. She was positive that NANCY JANE RITZ had never resided at the YWCA inasmuch as she is in a position to observe all the girls entering and leaving the premises, however, felt it may have been someone she may have seen in the neighborhood. In this connection, she stated that she has not seen this individual whom she believes may be identical to NANCY JANE RITZ, since probably the Summer of 1963.

LIL PEARSON, Manager, Open Kitchen Restaurant, 1612 Prospect Avenue, Cleveland, on January 9, 1964, stated that she has never seen WILLIAM A. MARLOWE on the premises. However, she did state that the photograph of NANCY JANE RITZ looks like a customer who used to stop in at the restaurant occasionally during late 1963. However, she has not seen this person for about the past five months. She stated that she never spoke to this individual concerning her personal background and would have no idea where she is presently located.

RUTH BARTLEY, Waitress, and LARRY WINNTERS, Handyman, Open Kitchen Restaurant, on January 9, 1964, viewed

photographs of NANCY JANE RITZ and WILLIAM A. MARLOWE and advised that they had never seen these individuals.

Mr. HOWARD BORHAM, Manager, Town House Apartments, 2344 Prospect Avenue, Cleveland, on January 10, 1964, related that FRANKLIN REYNOLDS and his brother, DONALD REYNOLDS, were tenants of his apartment from February 26, 1963 until December 10, 1963. He stated that DONALD REYNOLDS lived alone at the apartment from approximately the first of December, 1963, until he vacated the apartment and advised that his brother, FRANKLIN REYNOLDS, had gone to Kentucky. Mr. BORHAM stated that he had no forwarding address for FRANKLIN REYNOLDS, although his brother, DONALD, advised that FRANKLIN would be back in Cleveland around March, 1964, and that he would probably rent another apartment at the Town House Apartments.

Officer ROBERT RIEDTHALER, Cleveland House of Correction, Cleveland, Ohio, on January 10, 1964, related that FRANKLIN R. REYNOLDS was committed to the House of Correction on November 30, 1963, and is presently incarcerated.

He stated that FRANKLIN REYNOLDS was sentenced to eight months on a charge of assault and battery and petty larceny by the Court of Common Pleas, and he was fined \$300 and court costs of \$39.75. FRANKLIN REYNOLDS will be released on July 13, 1964, if he pays the fine and court costs, otherwise he will be released on December 19, 1964.

FRANKLIN R. REYNOLDS was interviewed in the House of Correction, Cleveland, Ohio, on January 10, 1964. He stated that he was born April 26, 1933, in Cleveland, Ohio, and that he last resided at 2344 Prospect Avenue, Cleveland, Ohio.

He stated that he first met NANCY JANE RITZ and WILLIAM A. MARLOWE during April, 1963, at the Greyhound Bus Depot, Cleveland. He stated that they appeared to be destitute and in dire need of some help, and he, therefore, bought them some food. He stated that since this initial contact with them he saw them on numerous occasions during

the period April, 1963 until he was arrested with MARLOWE and NANCY JANE RITZ, on September 26, 1963.

He stated that it was always his impression that WILLIAM MARLOWE and NANCY JANE RITZ were married to one another, and he always knew her as NANCY MARLOWE. He stated that during the period that they resided in Cleveland, they had no permanent place of residence, but rather they used the Greyhound Bus Depot as a place where they would sleep. He explained that NANCY and WILLIAM kept their clothing in a bus station locker and would use the washroom facilities of the depot for sanitary purposes. In addition, they would purchase what food they needed locally or else if they had enough money would eat in the nearby restaurants.

He stated that WILLIAM MARLOWE and NANCY JANE would solicit "dates" from men they would meet at the Greyhound Bus Depot and if they were lucky enough to solicit a customer would have the customer rent a hotel room at either the Ohio or Dakota Hotels where NANCY JANE would later meet the customer.

FRANKLIN REYNOLDS noted that NANCY JANE and WILLIAM did not have very much luck in soliciting male customers inasmuch as NANCY JANE is considered unattractive and had an unkempt and unclean appearance.

FRANKLIN REYNOLDS stated that he has not seen WILLIAM MARLOWE and NANCY JANE RITZ since the time of their arrests. He also stated that had either WILLIAM MARLOWE or NANCY JANE been in the neighborhood of the Greyhound Bus Depot he would have known of this, and this surely would have come to his attention prior to his own incarceration on November 30, 1963.

He stated that he has no idea of the present whereabouts of NANCY JANE and WILLIAM MARLOWE, although he does recall that some time prior to their arrests they both left Cleveland and went to Phoenix, Arizona, for a visit, where WILLIAM MARLOWE's parents are alleged to reside. They later returned just prior to their arrest, on September 26, 1963.

AT ELYRIA, OHIO

The following investigation was conducted by SA ROBERT H. WILSON, on January 14, 1964:

WILLIAM GWIN, President, Northwestern Adjustment Company, 304 Robinson Building, Elyria, Ohio, advised he recalled that NANCY RITZ was employed by the former owner of that company, HOWARD HEAD, in 1962. She rented HEAD's house at 809 West River Street, Elyria, during this employment which only lasted about one month. He recalled that when she obtained the job she was practically destitute. He stated he knew nothing of her background and inasmuch as Mr. HEAD is no longer with the company and is located out of town, he knew of no one who could furnish any information concerning NANCY RITZ. Mr. GWIN stated he has an account in the amount of approximately \$20.00 he had tried to collect from NANCY RITZ but had never been able to locate her after she left her employment. He stated her husband's name was EDWARD, and he identified the Cleveland Police Department photograph of NANCY RITZ as being identical with the one who had worked in Elyria.

Mrs. SALLY HILDEBRANDT, Elyria Credit Bureau, advised a file was opened in October, 1962, for EDWARD and NANCY RITZ whose address was 245 Fifth Street, Elyria. No previous address was listed, and the only information in the files was that a hardware company wrote off a loss of \$94.00 for an uncollectable account in 1963.

Mrs. MARY SHURLEY, Record Room, Elyria Police Department, advised the files of that department contain no record of EDWARD or NANCY RITZ.

T. P. DUKEMAN, 243 Fifth Street, Elyria, Ohio, advised the former owners of the residence at 245 Fifth Street have moved out of town. He did recall that about two years ago a NANCY and EDWARD RITZ rented a small apartment at 245 Fifth Street, but they only were at that address for a period of a month or less, and they moved out and no one knew of their forwarding address. He stated they did not associate with the people in that neighborhood, and no one knew anything concerning them.

AT WILLARD, OHIO

The following investigation was conducted by SA RICHARD W. SHIMER, on January 15, 1964: *1/15/64*

Mrs. ORRA TANNER, 224 Park Street, advised that she has owned the house at this address for the past three years and has lived in the house continuously and at no time during the past three years did either EDWARD MICHAEL RITZ or NANCY RITZ ever live in it. She said she did not know either of them.

Mrs. KENNETH COX, 304 Park Street, next door neighbor to 224 Park Street, advised that EDWARD MICHAEL RITZ lived at 224 Park Street many years ago with his grandfather, HARRY RITZ, who died five years ago. EDWARD was only a young boy at the time, and the grandfather finally put him in a home.

She said that about one year ago EDWARD MICHAEL RITZ and his wife, NANCY RITZ, came to her front door on a Sunday and told her they were broke. They attempted to borrow some money from her, but she did not loan them any. They stayed only a few minutes and then left, and she has not seen them since. She identified the photograph of NANCY JANE RITZ, nee MC CLAIN, as the NANCY who was with RITZ at the time they visited her. She said she is sure neither of them are presently in Willard as Willard is a small town, and she would see them or hear about them if they were here. She said EDWARD RITZ came to Willard because he thought his grandfather, HARRY RITZ, might have left the house to him or mentioned him in some way in his will, and as he was broke, he was in dire need of money. She said EDWARD RITZ has no relatives in Willard, since his grandfather died years ago. She said MICHAEL RITZ's mother, IDEALL RITZ, went to Lorain, Ohio, about eight years ago, but she does not know if IDELL RITZ has remarried or anything about her.

Mrs. NEVA CHRIST, Clerk, Jackson's Drug Store, Myrtle Avenue, advised that she knew EDWARD MICHAEL RITZ to see him, but has not seen him around Willard for years.
