George Hall (now ASAC, Baltimore) was responsible for reviewing all vouchers submitted by SIS Agents from mid-1942 until 1946. In addition, he lectured to each class of new SIS Agents during this period. He states he instructed the Agents to secure receipts for every expenditure, including those to informants, to the fullest extent possible and in any event to fully account for each and every expenditure. That this was done is attested by the research conducted by the Administrative Division in locating the vouchers submitted by Wade. Mr. Jackson of that division personally examined all of the vouchers and receipts submitted by fifty other SIS Agents, and noted that the expenditures of funds by these Agents were properly accounted for in each instance.

Heber Clegg (now ASAC, Salt Lake City) was Number One Man to C. H. Carson (now deceased) in the SIS Division and also recalled that payments to informants were handled in accordance with regulations in force in the domestic field. Clegg not only supervised operations at headquarters but also made actual inspection trips throughout Latin America and states that he and the other Inspectors made a point of looking into the expenditures made in connection with the informant program. He recalls that the Inspectors talked with each Agent whether undercover or on open assignment and discussed their informants and the payments they received making sure that the Bureau was receiving full value for the money that was being spent.

Assistant Director Tavel recalls that Agents were required to submit regular expense accounts, that these were subjected to rigid examination and inspection and that it was necessary to account for every single expenditure that was made.

SAs Nathan L. Ferris, Sam Papich, Sheldon Parks, and Wade Knapp, all of whom saw extensive SIS duty, fully support the foregoing statements.

Wade's own file contains a memorandum from C. H. Carson to Mr. Ladd, July 30, 1942, which states that Wade was given definite instructions in regard to the preparation of his expense vouchers. While Wade was still in training, an audit and inspection of SIS accounting methods was performed and they were found to be in order and correct, and a system of 90-day audits was established.

For information of St. Louis, the late city edition  
of 11/30/63 of "The New York Times" contained an article on

activities of OSWALD up to and including 11/26/63. This  
article contained no by-line. The third paragraph states  
that on 9/26/63 OSWALD appeared at a store in Laredo, Texas  
where employees reported he purchased \$32 worth of clothing.  
Further, that FBI agents were in Laredo Monday through  
Wednesday (presumably 11/25 through 11/27/63) tracing his  
activities there because of a receipt from the store dated  
9/26 that was found among his belongings in Dallas after  
the assassination.

Re Dallas airtel indicates that Dallas and San Antonio are unable to resolve the allegation in article outlined above and requests the NYO through "The New York Times" to determine source of the allegation and to interview this source.

On 2/12/64, GRADWIN HILL, manager of the "Times" Los Angeles office presently sitting on the national desk at the "Times" in NYC, advised that he and four other "Times" writers were in Dallas on 11/29-30/63. He stated that he himself does not know who wrote the article but that it appears to be a composite of old news already known which appeared in prior editions. He stated that the following writers were with him in Dallas at the time:

- 1) JACK LANGGUTH, presently in Dallas, Texas.
- 2) DON JANSON, presently in Tucson, Arizona on vacation but returning to his permanent post of the "Times" St. Louis, Mo. office on Monday, 2/17/64.
- 3) JOE LOFTUS, presently in Chicago, Illinois.
- 4) FRED POWLEDGE, presently in NYC.

HILL advised that after telephoning the various persons listed above, none of them can specifically recall who wrote the article. He stated that JANSON believes he could have written it, but will not be able to recall for certain until he checks his notes at his office in St. Louis. On 2/13/64, HILL stated that JANSON could be reached in Tucson at AX 8-2358, but he was told that the FBI would contact him (JANSON) in St. Louis on 2/17/64 where he can refer to his notes.



JOHN HOWARD BOWEN, was interviewed at Florence, Alabama, February 8, 1964. He claims to be itinerant missionary Baptist preacher, who has traveled extensively as such in the United States for about fifty years, and has also traveled in Mexico during the past twenty years. BOWEN claims he has never been a school teacher or traveled in any other foreign country, other than Bermuda.

He recalls making a bus trip from Nuevo, Laredo, to Mexico City, Mexico, September 26-27, 1963, and sat next to a young man described as 29 years of age, 5'8", 150 pounds, thin blond hair, dark complexion, who appeared to be Mexican or Puerto Rican. This person went to sleep soon after boarding the bus; and after lunch stop at Sabinas Hidalgo, Mexico, above person moved to back of bus where he reclined on seat and went to sleep. BOWEN claims did not talk to above person, and not able to identify him as LEE HARVEY OSWALD through press photographs.

BOWEN states he is acquainted with ALBERT OSBORNE, who is also a Baptist preacher or missionary from Canada and while in Oaxaca, Mexico, in 1958, BOWEN misplaced identification papers, and during a census there borrowed OSBORNE's identification papers. BOWEN claims he never before or since used name of OSBORNE. BOWEN observed photographs furnished by referenced airtel from Little Rock, and identified man in front of castle-like building as ALBERT OSBORNE, and man in zippered jacket and helmet as photograph of himself, taken about twenty years ago.

BOWEN last saw OSBORNE at Railway Express Office in Mexico City during Spring of 1961 or 1962. He has heard that OSBORNE was in Mexico during December, 1963, and January, 1964, and OSBORNE reportedly returning to Canada, where he may take up residence near Vancouver. BOWEN described OSBORNE as being about his same size and age, but OSBORNE has noticeable English or Scottish accent.

BOWEN considers his residence at St. Anthony Hotel, Laredo, Texas, and expects to be there about February 15 through 17, 1964. BOWEN may have in Laredo bus ticket receipt reflecting date above bus trip, and may have correspondence from OSBORNE.

Photograph and fingerprints of BOWEN were taken on above occasion.

Setting out of leads other than those below being left to discretion of the Dallas Division. Report follows.

LEADS:

SAN ANTONIO DIVISION

At Laredo, Texas:

Arrange to contact JOHN HOWARD BOWEN at St. Anthony Hotel about February 15-17, 1964, and exhibit to him photographs of subject LEE HARVEY OSWALD to determine if he is identical to person riding with him on above bus trip.

Obtain from BOWEN any available bus ticket receipt which would establish date and time of above bus trip.

Obtain from BOWEN any available correspondence he may have from ALBERT OSBORNE, and attempt to determine present whereabouts of OSBORNE.

Check bus company records at Laredo, and Nuevo Laredo, Mexico, of all bus companies furnishing transportation to Mexico City for roster of passengers on trip to Mexico City on or about September 26, 1963, noting that BOWEN claims he signed such a roster at Nuevo Laredo.

NOTE: Osborne-Bowen claims to be itinerant clergyman. Appears he is religious quack who has been soliciting funds for nonexistent mission in Mexico. He traveled with Oswald on 9-26 to Mexico City by bus sitting next to him. He made comment en route that Oswald seemed to have been to Mexico before. We interviewed him 1-7-64 in Mexico as Osborne at which time he furnished false info re whereabouts of Bowen in US. On 2-8-64 BH interviewed him as Bowen and he denied using dual identity and denied knowledge of Oswald during Mexican trip. This man is obviously lying and now two other witnesses on bus have identified Osborne's picture as the elderly man who sat next to Oswald who was manifested as Bowen.



Enclosed are Italian language newspaper clippings from the February 7 and 11, 1964, issues of "L'Unita", organ of the Communist Party of Italy; from the February 4, 11 and 12, 1964, issues of "Avanti", organ of the Italian Socialist Party; and from the February 12, 1964, issue of the English-language Rome daily newspaper, "Rome Daily American".

The February 4, 1964, article of "Avanti" shows no mention of the possible employment of the subject by CIA or the FBI, whereas the February 5, 1964, issue of "Avanti" (furnished to Bureau by relet) does so, indicating rather clearly that the February 5, 1964, article was based directly upon the February 4, 1964, article by LUCIO MANISCO in "Il Messaggero" (furnished Bureau by relet).

The enclosed articles dated February 7 and 11, 1964, and the Italian language article dated February 12, 1964, indicate that "Avanti" and "L'Unita" are not at this time following up on their efforts to convey the idea that the subject was employed by the FBI or the CIA.

The enclosed English-language article dated February 12, 1964, indicates that the leftist press in the United States has also picked up the rumor of CIA and FBI employment of subject.

As in the past, Rome office personnel are constantly alert to any pertinent information of interest to the Bureau. Any additional material developed of interest to the Bureau in instant matter will be promptly forwarded.



## Leftist Accepts Oswald

NEW YORK (NANA) — Dwight MacDonald, one of the more honest of the leftwing journalists, has chastised fellow-intellectuals for attempting to pin the assassination of President Kennedy on the lunatic right.

"Oswald is our baby, not theirs," says MacDonald. As a result, MacDonald will undoubtedly suffer the slings and arrows of certain know-it-alls who cannot bring themselves to believe that someone of the "progressive" faith might have brutally murdered Mr. Kennedy.

Naturally, in their way of thinking, the foul deed had to have been perpetrated by an evil rightist.

The leftwing is not of one mind about Lee Harvey Oswald, however. The pro-Castro weekly National Guardian, for example, is arguing that the accused assassin was a botched victim of a rightist-engineered frame-up. Of course, this argument presupposes that the FBI and the Secret Service are involved in a monstrous plot to cover up for the real assassins.

On the other hand the Communist Party "Worker" acknowledges that Oswald may have been the killer, but the Khrushchev organ vehemently denies Oswald's connections with the left. In fact, the Worker has suggested that Oswald was, in reality, a rightwing agent in the employ of the FBI and CIA.

Meanwhile, the Warren Commission has decided to probe the activities of a so-called rightwing group recently accused of having threatened the lives of 20 congressmen who had voted against appropriations for the House Committee on un-American Activities.

Counsel J. Lee Rankin said the commission would explore any relationship between the Minutemen, a para-military group, and the events of last Nov. 22.

But the FBI report on Oswald, now in the hands of the Warren Commission, in effect fully exonerates the so-called rightwing from any involvement in the President's assassination. In fact, the FBI report fully explores Oswald's direct links with leftist-liberal groups such as the Fair Play for Cuba Committee and the American Civil Liberties Union. The FBI report also makes it clear that, in all probability, the assassination was not the product of a conspiracy, but rather the end-product of a tortured psychopathic mind. Oswald's psychiatric history, ranging from the streets of the Bronx through service in the Marine Corps and defection to the Soviet Union, is thoroughly explored.

Dwight MacDonald's remark came as a result of a column by "TRB" (actually Richard L. Strout of the Christian Science Monitor) in the New Republic. Strout, alias "TRB" concluded an item on the broadcasting network of the so-called right as follows: "They are the kinds of programs . . . that the brooding Oswalds of the left or right wing listen to and sometimes act on."

MacDonald, one of our liveliest intellectual journalists, took umbrage. In a letter to the New Republic, MacDonald observed that "the awkward thing for liberals about Oswald was that he was a crackpot leftist — it now appears he did take an unsuccessful shot at General Walker."

Questa è l'indiscrezione che è circolata stasera dopo che il giudice Brown ha respinto la richiesta del difensore di Ruby, avvocato Melvin Belli di San Francisco, perché il processo contro l'assassino del presunto assassino di Kennedy fosse tenuto in un'altra città del Texas per avere garanzia di un giudizio imparziale.

L'udienza odierna ha ristato il primo scontro diretto fra la pubblica accusa, rappresentata dal procuratore distrettuale Henry Wade e la difesa di Ruby. Belli ha chiesto innanzi tutto che le prove contro Ruby raccolte dall'accusa siano trasmesse alla difesa, ma il giudice Brown ha respinto la richiesta. Il procuratore Wade si è astenuto allora per opporsi a tale manovra.

# Utile la testimonianza della madre di Oswald

WASHINGTON, 11. — La deposizione di Marguerite Oswald, madre del presunto assassino del presidente Kennedy, non modifica in nulla l'idea generale del delitto così come lo me lo raffiguro attualmente», ha detto ieri sera alla stampa il giudice Earl Warren, alla fine della prima deposizione.

Il presidente della Commissione d'inchiesta presidenziale ha rivelato che la madre di Lee Harvey Oswald non aveva avuto «alcun contatto con suo figlio» nel corso dell'anno che ha preceduto il dramma. Secondo il parere degli esperti, questa constatazione diminuirebbe sensibilmente la importanza attribuita alle antecedenti dichiarazioni della

signora Oswald che, in numerose occasioni, si era dichiarata convinta dell'innocenza del figlio. Il giudice Earl Warren ha d'altra parte precisato che la signora Oswald non ha dichiarato ieri che suo figlio non aveva ucciso il presidente Kennedy. Egli ha aggiunto che la deposizione della madre di Lee Harvey, durata sei ore, «contiene fattivi elementi utili». Marguerite Oswald afferma infatti di avere molte più prove da fornire sull'innocenza del figlio. La signora Oswald, che, secondo Warren, appare «stanca», ha ribentito, nell'arco dell'ultima di ieri, la vita del figlio dall'epoca della partenza per l'URSS, nell'ottobre del 1959, fino al giorno dell'assas-

sino del presidente Kennedy. La testé è stata anche chiamata ad identificare un certo numero di lettere che Lee Harvey le aveva scritte dal URSS.

Alla fine della sua deposizione la signora Oswald ha espresso il desiderio di fare una dichiarazione alla stampa, ma il suo avvocato, John F. Dyer di Washington, si è opposto categoricamente limitando a consigliarle di parlare quando avrà finito la deposizione davanti alla commissione. A questo proposito, lo dichiarare del giudice Warren: «Non copre che, se vorranno, la commissione concluderà l'esclusione della testé verso la metà della settimana.






During the above period, I am aware that no effort was made to develop LEE HARVEY OSWALD as an informant. In view of my responsibility and knowledge of all informant matters, I am aware that no money was paid to LEE HARVEY OSWALD for allegedly serving as an informant. Funds for payments to informants are personally handled by me and it would be impossible for LEE HARVEY OSWALD to have been paid any funds without my knowing of same.



This first interview occurred at Fort Worth, Texas, on or about June 26, 1962, and I was assisted in this interview by Special Agent B. Tom Carter.

Upon a second occasion I interviewed Lee Harvey Oswald on or about August 16, 1962, at Fort Worth, Texas, and upon this occasion was assisted by Special Agent Arnold J. Brown.



At no time during or in connection with the above interviews did I or either of the above named agents make any payment of any kind to Oswald for any information he furnished us or which he might furnish in the future. No effort was at any time made to recruit Lee Harvey Oswald's services in any capacity on behalf of the Federal Bureau of Investigation or any other Government agency. Furthermore, no suggestion, either express or implied, was ever made that Oswald might act as an informant or employee in any capacity for the Federal Bureau of Investigation or for any Government agency.

During these interviews, Lee Harvey Oswald exhibited an arrogant and hostile attitude, and in view of his uncooperative attitude I never felt that he could be trusted to furnish any reliable information.

The Director's affidavit relative to the fact that Lee Harvey Oswald was never an informant of the FBI and the administrative procedures for the handling and payment of confidential informants was delivered to Mr. J. Lee Rankin of the President's Commission today.

Mr. Rankin read the cover letter and the affidavit very carefully, after which he commented that he wanted to make it clear that Henry Wade did not actually testify before the President's Commission. Rather than testifying, Mr. Wade appeared at the offices of the Commission and was interviewed relative to his knowledge concerning the allegation that Oswald had been an informant of the FBI and was then questioned concerning his recollection of procedures for handling informants while Wade was a Bureau employee. Rankin stated that he wanted to make it extremely clear to the Director that Mr. Wade was furnishing information to the best of his recollection concerning Bureau procedures and was not vouching for the correctness of his statements. Mr. Rankin also advised that Wade was not in any way critical of the Bureau or any of its procedures.

Mr. Rankin commented that Chief Justice Warren and he, Mr. Rankin, were extremely appreciative of the Director's attitude concerning this matter, that he had seen fit to furnish an affidavit covering this situation, and that he had expressed a willingness to testify before the Commission if such should be necessary. He also commented that the Commission was most certainly not questioning the work of the Bureau and that they certainly accepted the Director's statement as being true, but they were considering this problem from two angles: (1) The necessity for satisfying the Commission of the truthfulness of the situation, which had already been done; and (2) having the records sufficiently complete so that at such time as the public would have an opportunity to see the work of the Commission there would be sufficient facts to show that the matter was fully explored and that the record would completely reflect the true situation.

With regard to Mr. Hudkins, the reporter from a Houston, Texas newspaper, Mr. Rankin stated that the matter of calling Hudkins before the Commission had been considered and that prior to calling Hudkins the Chief

Justice desired to see the Director's affidavit. He advised that now that the affidavit has been received consideration will be given to calling Hudkins before the Commission. He advised that there was no objection to the Bureau going right ahead with an interview with Hudkins or anyone else that the Bureau desired to interview to nail this situation down. He stated that if Hudkins were interviewed he would appreciate it if a signed statement could be obtained from him. He also stated that in the event Hudkins attempted to rely on some source of his for this story and would not disclose the source he had in mind calling his employer and Hudkins before the Commission in order to obtain the true facts.

Concerning Henry Wade and the material which was shown to Mr. Rankin portraying the actual handling of expense money and payments to informants and receipts and full accounting of Wade's expenditures in South America, Mr. Rankin stated he would like very much to have a copy of this material and he was told it would be prepared and made available to him as soon as possible. He also advised that there was no objection to talking to Mr. Wade concerning his expenditures while he was in South America in order that Wade would be fully apprised of what his activities were at that time and how he accounted for his expenditures.

RUMORS THAT OSWALD WAS FBI INFORMANT

Mr. Rankin was advised that the allegation that Oswald was an FBI informant is spreading rapidly; that the Bureau had had a number of press inquiries and that we were answering such inquiries with "No comment." He was told that if this story breaks and the allegation is made in the press, the Director would necessarily have to make a statement that it is an absolute lie. Rankin was told that Senator James O'Eastland (D.-Mississippi) of the Senate Internal Security Subcommittee had advised this rumor had come to his attention and that it had also been brought to the attention of Senators Roman L. Hruska (R.-Nebraska) and Everett McKinley Dirksen (R.-Illinois). He was told that consideration was being given to calling a meeting of the committee to air this matter fully and the committee was considering calling the Director to furnish testimony on the matter. Rankin was told that the Director was instructing that Senator Eastland be contacted to let him see in confidence the affidavit that the Director had prepared concerning this matter. He was also advised that if Senator Eastland desired, the affidavit would also be shown to Senators Hruska and Dirksen. Rankin was advised that any hearing by the Internal Security Subcommittee would be a duplication of the work of the President's Commission and that the purpose of contacting Senator Eastland and the other Senators was to keep the matter in the hands of the President's Commission to avoid publicity. He was advised that the Bureau was being placed in a bad position and that the best way to handle this situation was to show the affidavit to Senator Eastland in confidence.

MRI RANKIN DESIRES THE BUREAU TO PROTECT ITSELF

Mr. Rankin commented that this situation was extremely bad and that the Bureau's reputation was involved; that the President's Commission did not desire to interfere in any way with the Bureau's handling of this situation. He stated the Bureau should proceed in this matter in the same manner that it would handle any situation arising and disregard the existence of the President's Commission. He also commented that, in addition to this being a problem for the FBI, the Commission considered it a problem involving all of the intelligence agencies. He stated that rumors were beginning to circulate involving other intelligence agencies and that for this reason the Commission intended to go into this matter thoroughly and would explore it to whatever extent necessary to clarify the record. He stated that when the Bureau completed its inquiries into this matter he would appreciate being furnished the results and he was assured that this would be done at the earliest possible time.

Mr. Rankin again repeated his statement that he wanted the Director to know that the Commission was not questioning the Bureau's statement concerning the fact that Oswald was not an informant but they were desirous of clarifying the record.

Mr. Rankin also asked if we could furnish him with the affidavits which we have taken from our agents who interviewed Oswald and our SACs in the field where these interviews were conducted. He was told that these would be made available to him promptly.

ACTION (AHB/csh):

1. Mr. DeLoach was advised that the Bureau's affidavit should be shown to Senator Eastland at once, and if Eastland agreed it should be shown to Senators Hruska and Dirksen; further, Mr. DeLoach should press Sourwine for his source in the State Department and CIA who allegedly confirmed the story that Oswald was an informant of the FBI.

2. Following Mr. DeLoach's discussion with Sourwine, our Liaison will contact State Department and CIA, refer to these allegations, and pin them down.

3. We have notarized affidavits from our field agents and SACs, with the exception of New Orleans which does not have a notary public. New Orleans has been instructed to get these affidavits notarized through the nearest field office and send them immediately to the Bureau. They will be given to Rankin this coming Monday or Tuesday, 2/10 or 11/64.
