The following information is set forth in connection with an article appearing in the "Saga" magazine, March issue, entitled, "Ex-FBI Agent Charges: 'The FBI Gould Have Saved President KENNEDY's Life,'" by WILLIAM W. TURNER:

This article, at the beginning, states that TURNER was in Dallas, Texas, on November 22, 1963, "just a few hours after President JOHN F. KENNEDY was shot to death by LEE HARVEY OSWALD."

Captain GLEN D. KING (NA), 519 Goldwood, Dallas, telephone CA 4-4162, advised he is Administrative Assistant to Chief of Police JESSE E. CURRY, Dallas Police Department, and was so employed during the period including November 22, 1963, and continues in that capacity.

Captain KING said he had, on January 24, 1964, observed the March 1964 issue of Saga magazine, which had been exhibited to him by a Dallas newspaper reporter. This magazine included an article purportedly written by a former FBI Agent who, as KING recalled, had been "fired." He said his attention had been specifically called to the quotation in the article attributed to him to the effect that he had stated the Dallas Police Department had no record of LEE HARVEY OSWALD prior to the assassination and that there was no reason why the police should have had a previous record inasmuch as there had been no indication OSWALD engaged in any criminal activities, which would have been normally brought to the attention of the police.

Captain KING stated that he, on November 22, 1963, and subsequent days, was contacted by innumerable representatives of various news media. He stated he is quoted substantially correctly inasmuch as he had given this same answer to numerous reporters who had inquired as to whether the Dallas Police had a previous record of OSWALD.

A copy of the March 1964 issue of Saga was exhibited to KING, along with a photograph of WILLIAM W. TURNER, purportedly the writer of the article in question. KING stated he is reasonably sure he recalls TURNER as one of the many persons who contacted him although he might not have been able to select his photograph if it had been exhibited among other photographs. He said the name WILLIAM W. TURNER was not recalled specifically. He said, however, he recalls that an individual was in his office on an unrecalled date representing he was a magazine writer.

TROY F, MOORE, 1802 Mecca, Dallas, telephone TA 7-6007, advised telephonically on the night of January 24, 1964, he is an aide to Captain GLEN D. KING, Administrative Assistant to Chief of Police JESSE E. CURRY. MOORE stated he worked on Friday, November 22, 1963, from 8:00 AM until 1:30 or 2:00 AM, November 23, 1963.

He said that immediately following reports that shots had been fired at the Presidential Motorcade, hundreds of local and long-distance calls began to come in to the Dallas Police Department, these calls being from "crackpots and drunks," well-meaning citizens, public officials, news media representatives from all over the country, and others. He said he was assigned to assist in receiving such calls, working part of the time in Captain KING's office and a part of the time just out of KING's office at the clerk's desk.

He said he was extremely busy in that when he had finished a particular call three or four others were awaiting his attention. Accordingly, he is unable to recall definitely the time of any particular call and, in many cases, the details.

MOORE related that on January 24, 1964, GEORGE CARTER, police reporter, Dallas Times Herald newspaper, exhibited to him the March 1964 issue of Saga, a magazine which MOORE termed "crackpot." He said he scanned the article hurriedly but did not read it in detail. He did read a quotation attributed to him by the writer of the article, whose name he did not know at the time of interview, this quotation having been called to his attention by reporter GEORGE CARTER. He said as he recalled it, the writer of the article had represented he was sitting by the desk of Officer MOORE and that following a particular telephone call MOORE had turned to the unidentified writer and stated in substance, "This guy says that we have the wrong person in connection with the assassination of the President. He says he will call us later and tell us who the right one is."

MOORE stated that the name WILLIAM W. TURNER is not familiar to him, TURNER being identified to MOORE as the purported writer of the article in question. MOORE said he had viewed a photograph of the writer which accompanied the article and that he had no recollection of having seen this person. He recalled the individual was allegedly an ex-FBI Agent who had been fired and that he, in his own mind, wondered as to the purpose and truth of the article. He specified that he could not say positively he had not seen TURNER on November 22, 1963, since there were literally scores of newspapers, radio and television; reporters, FBI and Secret Service Agents and others, many not personally known to him, in and out of the area where he was working.

He said he did not work on Saturday or Sunday, November 23 or 24, 1963, and that, accordingly, if TURNER did hear his telephone call, as referred to above, it would have been on November 22, 1963. MOORE said he believes he recalls the telephone call to which the writer of the article was apparently referring but does not recall at what time of day or night the call came in. He said he believed the call came from a male individual, apparently drunk, from Tennessee or Kentucky. MOORE speculated he may well have, on completion of the call, made the remark that the caller had said that the police had the wrong man and that he would call the man back later to tell the police who the man was. He said if he did make a statement it was not "sarcastically, as alleged by the magazine writer, but perhaps in a tone of disbelief."

WELCOME EUGENE BARNETT, Traffic Officer, Dallas Police Department, residence 6018 Menger, Dallas, telephone EV 1-0726, advised he is regularly assigned to direct traffic at the intersection of Akard and Commerce Streets, Dallas. During the month of November 1963, he worked a 3:00 PM to 11:00 PM shift and on December 1, 1963, was switched to a 7:00 AM to 3:00 PM schedule.

BARNETT stated on November 22, 1963, he was instructed, as a part of the Security Detail in connection with the travel of the Presidential Motorcade, to a station at Houston and Elm Streets, Dallas. He took his position at 10:00 AM. His specific instructions were to chserve crowds of people for any demonstrators or other persons who might appear bent on causing trouble and, as the Motorcade approached his position, he was to stop all traffic moving west on Elm Street, a one-way street, until the Motorcade had passed. He said Officers J. M. SMITH and another SMITH (FNU) were assigned at the same location.

BARNETT said as the Presidential Motorcade turned from Main Street to Houston Street and came within his view, he stepped from his position near the southeast corner of the Texas School Book Depository Building, toward the middle of Elm Street and held the Elm Street traffic back. After the Motorcade had passed and made a left-hand turn on the approach to Stemmons Freeway, he heard a shot. He said he was bewildered as to the point from where the shot came, due to the "echos", but as further shots continued he conceived in his own mind the shots must have pome from the top of the Texas School Book Depository Building.

He said he could not, from his position close to the building, see any persons in the windows. Accordingly, without instruction from anyone, he raced to the rear of the building to determine if there was a fire escape or rear exit, having previously noted a fire escape on the east side of the building. Noting no fire escape to the rear, he returned to the front of the building and was shortly assigned to prevent entrance of any persons into the front part of the building. He remained at this post until 3,00 pm.

BARNETT stated several reporters—newspaper, radio and television—appeared at the entrance he was guarding, some no doubt local reporters. He said it is no doubt probable at that time, in answer to questions, he told of having gone to the rear of the building at the outset.

BARNETT stated he had not at that time or at any subsequent time told any person that he was certain the sniper was a stranger since the Police Department had not been informed that any employee in the Texas School Book Depository was potentially dangerous. He said accordingly that any statement attributed to him in this latter regard by any writer, was false. He said, as he recalled, his name appeared in an issue of the Dallas Morning News immediately following the assassination as one of the officers who was on duty on November 22, 1963, near the Texas School Book Depository Building.

BARNETT stated he remained at the post described until 3:00 PM, November 22, 1963, when he returned to his regular traffic post at Akard and Commerce. He remained there until 11:00 PM. He was on duty again at that station November 23 but did not work on Sunday and Monday, November 24 and 25, 1963. He returned to duty on November 26, 1963.

BARNETT stated he does not recall the names of any reporters of any type who have interviewed him concerning his activities on November 22, 1963. He said he recalls specifically that two Life magazine reporters, a Spaniard representing a foreign newspaper and a person representing himself to be with, as BARNETT recalls, the "Washington Post," interviewed him at Akard and Commerce Streets during his tours of duty there following the assassination, dates and times of day not recalled.

With regard to the reporter believed to have represented a "Washington Post" connection, BARNETT described this individual as being about 35 years of age, 6 feet, 160 pcunds, bareheaded, sandy hair, nice-looking, neatly dressed in what he recalls as probably a flannel suit, 3-button, probably wearing a vest. He conceived this individual was staying at the Baker Hotel, at the intersection of Akard and Commerce Streets, near BARNETT's traffic post.

This person talked to him on two or three different occasions and, in BARNETT's language, gave him trouble in "trying to put words in my mouth." He said the gist of what the reporter was trying to do was have BARNETT say the shots came from two or three different points in the vicinity of Houston and Elm Streets, with the logical inference more than one person was involved in the shooting.

BARNETT stated he had been off duty due to recent surgery and had not been informed that he was quoted in an article by WILLIAM W. TURNER in the March 1964 issue of Saga magazine. He said the name of TURNER was not familiar to him. He said he does not recall that any person representing himself to be an FBI Agent, except Special Agents of the Dallas FBI Office known to him personally, or on one occasion a Special Agent not known to him but who exhibited proper credentials, has interviewed him. He said he does not recall any person representing himself as a former FBI Agent as contacting him.

On January 26, 1964, a copy of the March 1964 issue of Saga magazine was exhibited to BARNETT. On observing the photograph of WILLIAM W. TURNER, purportedly the author of an article in the publication, BARNETT stated this individual is not recognized by him as being any person with whom he had been in contact. On observing the portion of the article in which he was quoted, BARNETT reiterated that while he did in fact go to the rear of the Texas School Book Depository Building following the shots at the Presidential Motorcade, he went there for the reasons previously stated. He again denied that he had made the statements attributed to him to the effect that the sniper was obviously a stranger, etc.

Previous investigation has been reported identifying an individual as JAMES R. OSWALD, Carswell Air Force Base, Texas, who called the Indiana-Lawrence Bank and Trust Company, North Manchester, Indiana, on the late afternoon of what was believed to be November 18, 1963.

On January 22, 1964, Mr. CHARLES ECK, OSI Agent, Carswell Air Force Base, advised SA EARLE HALEY that Lieutenant JAMES R OSWALD is assigned to the Ninth Bomb Squadron of the Seventh Bomb Wing at Carswell Air Force Base but is on temporary duty at the Castle Air Force Base, Merced, California and will not return to Carswell Air Force Base until March 15, 1964. Efforts are being made to locate Lieutenant JAMES R. OSWALD to determine if he is related or acquainted with LEE HARVEY OSWALD or any member of his family.

Under date of January 31, 1964, the Los Angeles Office advised that the following investigation was conducted by SA CLARENCE E. NEWTON, JR.:

AT CASTLE AIR FORCE BASE, CALIFORNIA

On January 28, 1964, HAROLD KORSLUND, Office of Special Investigations, advised that Lt. JAMES R. OSWALD, Air Force Serial No. 70450A, was temporarily assigned to the 329th Bomb Squadron as a student until March 5, 1964. From a review of records regarding OSWALD at this base, there is no indication of any connection between him and deceased subject.

On January 28, 1964, Lt. JAMES R. OSWALD advised that he was assigned to Carswell Air Force Base at the time of the assassination of former President KENNEDY, and in fact, was attempting to obtain a transfer from this base because of having the same name as OSWALD. He said he is no relation whatsoever to the subject, has never been remotely acquainted with him, and had no connection whatsoever with LEE HARVEY OSWALD.

On February 4, 1964, Assistant Chief of Police LEON POWERS, Irving Police Department, Irving, Texas, telephonically advised SA ROBERT P. GEMBERLING that he had just learned that a young couple between the ages of 30 and 35 by the name of DELOY W. and HELEN CHRISTING OSWALD had just moved into a residence at 2208 Concord, Irving, Texas, having come to Irving from Seattle, Washington.

Assistant Chief POWERS stated he did not know the type of work DELOY W. OSWALD did and had no information indicating they were related to LEE HARVEY OSWALD, but was furnishing the above information for any use it might have.

On February 6, 1964, Mrs. DELOY W. OSWALD (HELEN CHRISTINE), 2208 Concord Drive, Irving, Texas, advised SA PAUL L. SCOTT that she and her husband moved here from 11343 Alton Avenue NE, Seattle, Washington, January 1, 1964. Her husband is employed by Visador Company, 2429 Converse Street, Dallas, Texas, and was formerly employed by the same company, Seattle, Washington.

DELOY W. OSWALD, white male, was born September 5, 1927, at Osgood, Idaho. He is no relation to LEE HARVEY OSWALD and she and Mr. OSWALD have never heard of LEE HARVEY OSWALD prior to the assassination of President KENNEDY.

On January 24, 1964, Chief of Police JESSE E. CURRY advised S& J. GORDON SHANKLIN that he had received information from a Mr. MORROW, 2334 McAdams, Dallas, Texas, telephone FE 1-1346, to the effect that LEE HARVEY OSWALD had applied for a job at the All Right Parking Station, 1208 Commerce Street, five or six days prior to the assassination of President KENNEDY.

Chief CURRY stated that according to MORROW, OSWALD had a paper in his hand and when he applied for the job he asked someone how high the building was.

Chief of Police CURRY stated that Mr. MORROW had indicated that OSWALD may have talked with CLAUDE HALLMARK, EMMETT MONTGOMERY and CHARLIE DOBBS, or DOBBOS or DOBBIS, at All Right Parking Station at 1208 Commerce Street.

HUBERT ANDERSON NORROW, JR. advised he resides at 2334 McAdams in Dallas, telephone FEderal 1-1346. He advised he had been employed at the Southland Hotel Garage (Allright Parking System), 1208 Commerce Street, Dallas, Texas, for about five months as the day manager. He said he works there from 7:00 AM to 6:00 PM daily.

MORROW advised that shortly after LEE HARVEY OSWALD was allegedly killed by JACK RUBY, he observed a photograph of OSWALD in the paper and on television and recalled that a person who strongly resembled OSWALD, and whom he believed to be identical, came to the Southland Hotel Garage early one morning about two weeks before the assassination of President KENNEDY on November 22, 1963, in answer to an ad for help to work at the garage. He said he wrote the name of this man down on a pad of paper and put it down, "LEE HARVEY OSBURN", and the individual said, "No, my name is OSWALD". He said he did not keep the paper and it had been thrown away with the trash. He said that he recalled this man asked him how tall the building was and if it had a good view of Dallas and he recalled that this man had a "Dallas Morning News" newspaper under his arm, was dressed in a footballtype sreatshirt and blue jeans. He said this man left the name which he recalled to be OSWALD, but no address, and waited around about 45 mintes or one hour and departed, about 7:30 or 7:50 AM, but was not interviewed. He said that there were two other people working with him at the time this man came into that garage, CHARLES DOBBS, a Negro driver, no longer employed by the Allright System, and EMMETT MONTGOMERY. He said that these drivers were busy parking cars and would not have heard any conversation between him and OSWALD and possibly did not have an opportunity to see him; however, he believed MONTGOMERY saw him. He said that he told Detective CARROLL of the Dallas Police Department about it on Thursday, January 23, 1964. He said the Detective told him that he had learned from some other source that he, MORROW, had information about OSWALD applying for a job.

MORROW was asked who he had discussed this with and at first he said no one, but Detective CARROLL then upon reflection, said, "Well, I guess I was excited and told a lot of people about it." He said he could not recall the identities or names of any of these persons. He said he had never known OSWALD before.

MORROW advised that he has known JACK RUBY as a customer at the Nichols Brothers Parking Garage, which is near the Southland Hotel Garage, but he has never been with him socially and has never known of any association between OSWALD and RUBY and he had never been into the Carousel or the Yegas Clubs when they were being operated by JACK RUBY. He said that he could furnish no other description concerning OSWALD and he did not ask him if he had a driver's license or if he was able to operate an automobile.

GARRETT CLAUD HALLMARK advised he lives at 831 Quanah Street in Dallas, Texas, and is employed by the Allright Parking System, Inc., at 701 Wilson Building, telephone Riverside 8-5943. He said he placed an ad for help for the Southland Hotel Parking Garage in the Dallas Morning News", first run on October 28, 1964, for four days, Monday through Thursday, and the second ad was run from November 3 to 6, 1963, and he confirmed this fact through Mrs. McKNIGHT of the Dallas Morning News", Ad Section.

He said he had no record of LEE HARVEY OSWALD ever applying for a job but Mr. H. A. MORROW, JR., the day manager of the Southland Hotel Garage, a branch of the Allright Parking System, did claim that a person he believed to be LEE HARVEY OSWALD, had been interviewed for a job by HALLMARK. MORROW told him this applicant came in after the second ad was run, namely after November 3, 1963, possibly a week before the assassination.

HALLMARK said he immediately searched his records and was unable to find where anyone named LEE HARVEY OSWALD had ever applied for a position and he was certain that he had not interviewed anyone by that name. He said that MORROW first made mention of the fact that OSWALD was an applicant about Tuesday or Wednesday following the assassination of the President at Dallas, Texas, on November 22, 1963.

HALLMARK said as far as he was concerned, he believed the entire story concerning LEE HARVEY OSWALD, as told by MORROW, was a fabrication on the part of MORROW. He said that when MORROW first talked to him, he recalled that MORROW said he had run LEE HARVEY OSWALD off because he, MORROW, did not think HALLMARK would hire OSWALD.

HALLMARK said on the contrary, he would have possibly been interested in getting a young man as clean cut as the pictures of OSWALD reflected him to be, at least to interview him, had he made application. He also noted that Mr. MORROW comes to work at 7:00 AM and finishes his day at 6:00 PM daily and the early hours, 7:00 to 9:00 require that all of the men at the garage be on the go parking customers automobiles in the downtown area.

EMMETT FULTON MONTGOMERY, 1803 Fuller Drive, advised he has telephone number DAvis 7-1086, and is employed at the Southland Hotel Parking Garage, which is a branch of the Allright Parking System, located at 1208 Commerce Street, Dallas, Texas. He had been working there since August, 1963.

MONTGOMERY said he recalled that the day manager, Mr. MORROW, told him a person applied for a job about a week before the President was assassinated and MORROW asked him if he recalled seeing this man applying for the job and he said he believed he did.

MONTGOMERY said he did not talk with this man but Mr. MORROW told him the man asked him how many floors of parking the garage had and MORROW replied 7. He said MORROW told him that the man asked what the working hours were and was told that the hours were from 7:00 AM to 6:00 PM.

He said he believed this man came to the garage to seek employment about 8:00 AM, but he did not know when he left because he, MONTGOMERY, was busy taking cars up the ramps and did not have time to pay attention to people coming and going in the rush hour. He said he did not know what this man looked like but when he saw a photograph of LEE HARVEY OSWALD, and MORROW discussed it with him, he seemed to recall someone resembling OSWALD might have been at the garage, but he could not have been at all sure. He said he did not know anyone else at the garage who might have seen this person.

MONTGOMERY said he knew JACK RUBY as a customer, but never did speak to him or know him in any other way and did not know LEE HARVEY OSWALD or of any association between RUBY and OSWALD. MONTGOMERY said he had never been in the Vegas or Carousel Clubs when they were operated by JACK RUBY.

BOB K CARROLL, Detective, Dallas Police Department, advised on January 27, 1964, that he received information on December 1, 1963, from JOHNNY SIMPSON, who is employed at the Simon Parking Garage at Field and Jackson Streets, Dallas, that LEE HARVEY OSWALD had applied for a job at the Southland Hotel Garage, a branch of the Allright Parking System at 1208 Commerce Street, Dallas, about two or three weeks prior to the assassination of President KENNEDY.

CARROLL made available a copy of a report dated January 23, 1964, which is hereinafter stated:

"Thru: Lieutenant Jack Revill Criminal Intelligence Section Special Service Bureau Dallas Police Department

"Mr. Morrow stated that approximately six or seven days prior to the assassination of the President of the United States John Fitzgerald Kennedy SUBJECT came to the parking lot asking for a job. Mr. Morrow stated that while talking to him about the job, SUBJECT asked him how high the parking lot building was and if it afforded a good view of Dallas. Mr. Morrow stated that at the time SUBJECT was applying for employment he was dressed in a dirty white T shirt and blue jeans, and was carrying a newspaper, and that it was during the early morning hours. Mr. Morrow stated that the last time he saw SUBJECT he was waiting to talk with Mr. Claude Hallmark another one of the managers. Mr. Morrow states that the reason he remembers SUBJECT so well is that he wrote SUBJECT'S name down, and that he thought the name was Osburn, but that when he called SUBJECT Mr. Osburn, SUBJECT corrected him and told him that the name was Oswald. Mr. Morrow related that two of the employees also observed SUBJECT while he was at the parking lot. These employees are: Emmett Montgomery, N/M and Charlie Dabbs, C/M. Emmett Montgomery is still employed at the parking lot, but Charlie Dabbs is no longer there. Mr. Morrow did not know the residence addresses of these two employees and the personel files were not available at the time of this interview.

"On January 23, 1964, the undersigned officer attempted to contact Mr. Claude Hallmark for interview, but Mr. Hallmark was not available. An interview was obtained with Mrs. Viola Sapp, cashier at the parking lot, whose residence address is 2728 Mateur, FE-7-8264. Mrs. Sapp stated that she knows for a fact that SUBJECT did not ever talk with Mr. Hilmark and that SUBJECT never made a written application for employment.

JOHN JUNIOR/SIMPSON advised he lives at 312½ Akard Street, Dallas, Texas, and has no telephone. SIMPSON is employed at Simons Parking Garage, Field and Jackson Streets, telephone Riverside 8-2641. He recalled about a month ago, the night attendant at the Southland Hotel Parking Garage on Commerce Street, told him that LEE HARVEY OSWALD had made application for work there with the day manager, Mr. MORROW. He said that according to MORROW, this man, believed to be OSWALD, made application for work about a week or two prior to the assassination of President KENNEDY on November 22, 1963. SIMPSON said he immediately called Detective B. K. CARROLL, Dallas Police Department, as soon as he heard the story and that is all he knew about the matter.

SIMPSON said he had seen JACK RUBY and knew him when he saw him. He advised he did not know LEE HARVEY OSWALD and knew of no association between RUBY and OSWALD. SIMPSON advised he has never attended the Vegas or Carousel Clubs in Dallas, formerly operated by RUBY.

B. ALLEGED ASSOCIATION OF OSWALD AND JOSE SORIA PEREZ

BASILISA ESTHER ALVAREZ RAMIREZ, Mexican citizen and United States resident who entered the United States at Brownsville, Texas, October 1, 1957, and was born May 25, 1931, Torreon Coahuila, Mexico, having United States Alien No. 10 821 635, residing at 3101 Fairmont Street, Dallas, Texas, with her sister and brother-in-law, Mr. and Mrs. EFRAIN LOPEZ, was interviewed at the Dallas Office of the FBI. She stated she is employed at Curtis Mathes Company, Dallas, and has been so employed since 1959.

She advised she attends the Guadalupe Catholic Church on Harwood Street in Dallas, Texas. At this church during the latter part of May, 1963, she met a woman by the name of ESTHER SEGURA, who is about 43 years of age, and lives with her two minor children near the corner of Collette and Tremont Streets in Dallas. Mrs. SEGURA's husband, a Cuban, resides in Cuba. Mrs. SEGURA is a Cuban refugee in the United States. She is employed at Neiman-Marcus as a hand-finisher on dresses and other clothing items.

She also met at this church a person by the name of JOSE SORIA PEREZ, age 25, of Mexican descent, a United States citizen who was born in Harlingen, Texas. He is employed in an electronics factory in Richardson, Texas.

ALVAREZ stated that she, SEGURA and PEREZ are all members of a choral group of the Guadalupe Church. She stated this choral group had on a number of occasions practiced at her house. She said Mrs. SEGURA had on many occasions urged ALVAREZ to marry PEREZ but she did not want to do so. She said that because she had refused to marry PEREZ, PEREZ had been following her around in a car and she believed other people were also following her around in cars. She stated she has continued to resist the advances of PEREZ and she believes that both PEREZ and SEGURA are mad at her. She thinks that PEREZ and SEGURA believe she is in some way connected with the police because she once knew a deputy sheriff from Fort Worth, Texas. She stated she is afraid that SEGURA and PEREZ mean to do her harm.

ALVAREZ advised her purpose in coming to the FBI Office was to reveal information she had received from both SEGURA and

PEREZ in connection with the assassination of President KENNEDY,

She said she recalls on one occasion about a month before President KENNEDY visited Dallas, Mrs. SEGURA told her that President KENNEDY was coming to Dallas and would not leave alive. She could not recall where Mrs. SEGURA told her this, but definitely recalls her making the statement.

She further advised that PEREZ had on one occasion taken her to his car which was parked outside of her house and showed her a pistol which was in the car and also told her that he had been selected for a very dangerous mission. Later PEREZ told her that another person had been selected to carry out this mission and that this person was an Anglo-Saxon. She said PEREZ showed her the gun and told her about his dangerous mission about two weeks before President KENNEDY came to Dallas.

She said that about a week after the President's assassination, PEREZ had told her that he knew OSWALD and that he had dinner with OSWALD and some important people on the night before the assassination.

ALVAREZ advised she had related these matters to her attorney, ROBERT BENAVIDES, with offices in the United Fidelity Building in Dallas and he had advised her to go to the FBI with the story but she had not done this until now because of fear of PEREZ and SEGURA.

She was advised that due to the serious nature of these charges, immediate investigation would be made and that both SEGURA and PEREZ would be interviewed in this connection. She was advised that it would be entirely possible that these persons would know that she had come to the FBI with this information. ALVAREZ advised she understood. She insisted that she was telling the truth.

ROBERT BENAVIDES, Attorney, offices at 1002 United. Fidelity Building, Dallas, telephone RIverside 2-7604, home telephone Andrew 2-1404, was interviewed on January 31, 1964. He advised that he knows BASILISA ESTHER ALVAREZ RAMIREZ, as he and his law partner, PHILEMON VALDEZ, handled a personal injury case for her. He said a good settlement had been obtained on behalf of ALVAREZ. He stated the settlement arose from a serious automobile accident in which ALVAREZ had been involved. He advised that a few days before Christmas, 1963, ALVAREZ had come to his office and had talked to him at length about some personal problem she had.

BENAVIDES advised this problem involved a Cuban woman who works at Neiman-Marcus in Dallas and teaches English to Latin-Americans in Dallas, and a Mexican youth by the name of PEREZ. According to him, ALVAREZ told him the Cuban woman was trying to get her to marry PEREZ but she refused to do so. The Cuban woman and PEREZ had become angry with ALVAREZ for this refusal and as a result PEREZ was following her around in a car. Also, he said ALVAREZ told him that other people were also following her around. She stated she was very afraid of the Cuban woman and PEREZ and, in fact, feared for her life.

He said ALVAREZ had told him that about two weeks before President KENNEDY came to Dallas PEREZ took her to his car and showed her his pistol. He said he had a dangerous mission to perform. He had later told ALVAREZ that somebody else had been selected to do the job instead of him. ALVAREZ further told him that about a month before President KENNEDY came to Dallas, the Cuban woman had told her of the impending visit of President KENNEDY and that President KENNEDY would not leave Dallas alive.

He further advised ALVAREZ told him that PEREZ had said approximately a week after the assassination of President KENNEDY that he (PEREZ) knew OSWALD and had dinner with OSWALD and other important people the night before the assassination.

When he heard these matters, BENAVIDES told ALVAREZ to go to the FBI, but she said she was afraid to go because she feared for her life. She stated the Cuban woman and PEREZ would try to kill her. She told BENAVIDES the Cuban woman and PEREZ

BENAVIDES then consulted with his law partner, PHILEMON VALDEZ, about this matter and he told him to forget about it because it was his opinion ALVAREZ was "nuts".

PHILEMON/VALDEZ, Attorney, in partnership with ROBERT BENAVIDES, with offices at 1002 United Fidelity Building, Dallas, telephone Riverside 2-7604, home telephone TR 5-3944, Ennis, Texas, said he remembered BASILISA ESTHER ALVAREZ RAMIREZ very well. He said he and his partner had handled a personal injury suit for her and had been successful in effecting a good settlement in her behalf.

He said that when the suit was settled, he had been perhaps a little abrupt in dismissing her because he needed to attend to other work. He said that whereas their relationship up to that time had been very pleasant, she became somewhat resentful because he did not spend more time with her after the suit was settled.

He said based upon his relationship with her, he believes she is a very lonely person who needs attention and seeks to gain that attention by conversing with and presenting problems to persons of importance, such as his law partner and now possibly with Agents of the FBI.

He stated in hisopinion ALVAREZ is a "screw-ball". He said he discounts her entire story about the statements made by the Cuban woman and JOSE SORIA PEREZ to her as related by Mr. BENAVIDES.

He stated his judgment of ALVAREZ is his own personal opinion based upon his contact with her and not upon any medical evidence.

Father/LUIS, Our Lady of Guadalupe Church, Dallas, advised he has been acquainted with Miss ESTHER ALVAREZ and Mrs. ESTHER SEGURA for a period of several months, during which time they have been associated with his church and have been members of the choir in this church. Father LUIS said to his knowledge, Miss ALVAREZ has never shown any emotional instability nor has she given any indication of mental sickness. Without knowing the reason for the question being asked, Father LUIS volunteered information he had heard through other members of the church that Miss ALVAREZ on one occasion several weeks ago and quite an argument with Mrs. SEGURA, which argument resulted in considerable rafsing of voices. Father LUIS continued, it is his understanding the disagreement arose as follows:

Mrs. SEGURA had selected a boy friend for Miss ALVAREZ which did not meet with the approval of Miss ALVAREZ. It seems Miss ALVAREZ already had a boy friend and Mrs. SEGURA was attempting to push her selection on Miss ALVAREZ. Miss ALVAREZ resented Mrs. SEGURA's intrusion and took exceptional offense at Mrs. SEGURA's actions in this regard.

Father LUIS concluded by advising he had never known of any other disagreements between the two women.

Dr. SERGIO L. MURRILLO, Office 3116 Fairmont Street, residence 5020 Rexton Street, Dallas, Texas, furnished the following information:

Dr. MURRILLO is well acquainted with ESTHER She has been a patient of his since May, 1959. She last visited his office on October 28, 1963. Dr. MURRILLO was questioned as to whether or not in his treatment of Miss ALVAREZ and during a period of acquaintance with her, if she had shown any sign of emotional instability or whether she had ever given any indication of being mentally upset. He stated at no time during his treatment of ALVAREZ has he observed in her any overt psychosis but at times she has shown signs of emotional instability. He stated ALVAREZ was thrown from a car as a result of a collision in November, 1962, at which time she suffered severe injury to her neck, back and abdomen and was unconscious for a period. He believes her recovery from this accident is complete. He stated that although she has had no overt psychosis during the short time he has treated her, that such could occur without previous indication. He described Miss ALVAREZ as extremely conscientious and as being employed in a job where it requires intense effort on her part at all times to meet production quotas, which in his opinion has lead to her emotional instability in the past.

Mrs. ESTHER SEGURA, 5003 Tremont, Dallas, Texas, after being advised that she did not have to make any statement, that any statement made could be used against her in a court of law and that she was entitled to an attorney, furnished the following information:

Mrs. SEGURA, a Cuban refugee, came from Cuba with her two children in August, 1962. She was formerly a teacher of English in a Cuban school and resigned her position and came to the United States claiming ill health. She had tried to leave Cuba for two years prior to this time. She stated the reason she left Cuba was because she wanted to get her children away from Communism. Her sponsor in Dallas, Texas, was ELENA ESTEVANEZ, Lemmon Avecue. Her husband and other members of her family still remain in Cuba.

Mrs. SEGURA is a devout Catholic and has been attending Our Lady of Guadalupe Church on Harwood Street, in Dallas, since coming to Dallas. While in Dallas and since becoming an active member in this church, she joined the church choir where she became acquainted with ESTHER ALVAREZ and JOSE PEREZ. She became acquainted with them approximately five months ago.

ALVAREZ was unable to speak English and since becoming acquainted with her, SEGURA has tried to help ALVAREZ learn English. In this connection, she has visited the ALVAREZ home on several occasions and ALVAREZ has visited in her home. Shortly after she became acquainted with ALVAREZ and began teaching her English, mutual friends told SEGURA she was wasting her time in "fooling" with ALVAREZ, since ALVAREZ is "sick"; SEGURA indicated ALVAREZ was sick mentally. SEGURA stated that in her opinion, ALVAREZ was a frustrated woman.

About one month ago, for some unknown reason, ALVAREZ became angry with SEGURA and has not spoken to her since that time. ALVAREZ also became angry with two other girls who had been residing with ALVAREZ and has refused to speak to them. ALVAREZ also became angry with JOSE PEREZ, a mutual friend. Mrs. SEGURA stated ALVAREZ's

change of attitude had bothered Mrs. SEGURA and on one occasion she approached ALVAREZ and told her if she (Mrs. SEGURA) had done anything to hurt Miss ALVAREZ, she was sorry, however, ALVAREZ did not change her attitude according to SEGURA or indicate to her why she no longer was speaking to her.

SEGURA said she and most of her acquaintances were greatly saddened by the assassination of President KENNEDY and had occasionally discussed the assassination She recalled that on one Sunday, after the assassination, there was a general discussion of the assassination by a group including Miss ALVAREZ. She said she had read in the paper where 1963 would possibly be a fatal year for President KENNEDY since President ABRAHAM LINCOLN had met a similar fate almost 100 years ago. She stated on that afternoon, she made some comment regarding this statement which she had seen in the newspaper. As far as she could recall, this was the only time she had discussed the assassination of President KENNEDY when Miss ALVAREZ was present. Mrs. SEGURA was questioned regarding a statement which she allegedly made one month before President KENNEDY's visit to Dallas, which was that the President was coming to Dallas but he would not leave Dallas alive. Mrs. SEGURA was shakened by this accusation and stated at no time has she ever made such a statement or insinuated such a thing. It was noted while questioning Mrs. SEGURA, she expressed interest at two or three points in the reason for the questions being asked her. When she was asked if she knew Miss ALVAREZ, she immediately replied by stating "now I see the reason". She continued "I have attempted to help her learn to speak English, I have been kind to her, and now she is stabbing me in the back".

Mrs. SEGURA appeared extremely upset that such accusations had been made against her and she stated she was going to speak about this with her Priest.

Mrs. SEGURA said she had no knowledge of the assassination of the President except what she had heard on radio, television and seen in the newspapers. She stated she did not know JACK RUBY and had never heard of or seen him. She did not know LEE HARVEY OSWALD and had never seen or heard of him.

JOSE SORIA PEREZ, 5204 Junius, Apartment 8, Dallas, Texas, after being advised that he did not have to make a statement, that any statement made could be used against him in a court of law, and that he had the right to consult an attorney, furnished the following information:

PEREZ is employed as an electronic assembler,
Power Engineering Company, Richardson, Texas, and has been so employed since April 28, 1963. He came to Dallas in April, 1963, from Rio Hondo, Texas. He formerly served in the U.S. Air Force from April, 1955, to October, 1962, under perial number 18479958, receiving an hozorable discharge.

PEREZ is acquainted with ESTHER ALVAREZ and ber sister BEATRIZ ALVAREZ, having met them at Our Lady of Guadalups Church, Harwood Street, Dallas. PEREZ said ducing the past few weeks, Miss ALVAREZ has been unfriendly toward him and in fact has not even spoken to him for some reason which is unknown to PEREZ. PEREZ stated as far as he knew, he had not done anything to incur the somity toward him and was at a loss to understand her present attitude toward him. He stated in the past he has been present on social occasions when Miss ALVAREZ and Mrs. SEGURA were members of the group. He stated there was some discussion of the assassination of President KENNEDY which took place among the members of the group after the assassination occurred, however, all discussions were based on news received from the radio, television and the newspapers concerning this event. PEREZ advised he has no knowledge of the assassination of President KENNEDY except what he has heard through the news media. He is not a member of any group in Dallas other than Our Lady of Guadalupe Church. He does not own a pistol or any other type of gun and has never possessed a gun since residing in Dallas, Texas. He stated he was not acquainted with and had never seen LEE HARVEY OSWALD and did not attend any dinner or meeting at which OSWALD was present. PEREZ denied making any statement to anyone that he had been given a dangerous assignment and that his assignment had later been given to another person.

Mr. LONNIE Ex MULLIGAN, owner, Mulligan's Firestone Store and Texaco Service Station, 510 Carteret Street, advised that about ten or twelve days before Fresident JOHN F. KENNEDY was shot in Dallas, Texas, an unknown man had come into his place of business at about 8:00 a.m. one morning. He further advised that he was of the opinion the unknown individual resembled photographs he had seen of LEE HARVEY OSWALD, the person who allegedly assassinated Fresident KENNEDY. Mr. MULLIGAN stated that WILLIAM BROWN, JR., who is employed at his Firestone Store and Texaco Service Station, also observed the unknown individual and also was of the opinion that the unknown individual who came into the Firestone Store resembled LEE HARVEY OSWALD.

Mr. MULLIGAN stated that upon entering the sore, the unknown individual went directly to a point near the cash register. The unknown man then asked Mr. MULLIGAN for a map of Texas and in reply, Mr. MULLIGAN told the unknown man that no map of Texas was kept in stock in the Pirestone Store because of the very limited demand for such maps of Texas in this part of the country. He said he gave the unknown man a map of Georgia and offered him information on how to find the way to Savannah, Georgia, where he could get on U. S. Highway 80 which if it were followed westward, would eventually take the unknown man to Texas.

Mr. MULLIGAN apprised that the unknown man then left the Firestone Store and walked toward the main street of Beaufort, South Carolina, instead of in the direction which Mr. MULLIGAN had indicated the unknown man should take to travel to Savannah, Georgia, and U.S. Highway 80.

Mr. MULLIGAN stated that he had never observed the unknown man since that original contact and had not talked with anyone else who had seen the unknown man.

WILLIAM/BROWN, JR., 807 North Street, Beaufort, South Carolina, was located at Mulligan's Firestone Store and Texaco Service Station, 510 Carteret Street, BROWN advised that he was on duty one morning at instant store and service station where he is employed. He said that he recalled that he and Mr. MULLIGAN, owner of Mulligan's Firestone Store and Texaco Service Station, had just opened for business that morning at about 8:00 a.m.

BROWN stated that it was about ten or twelve days before President JOHN F. KENNEDY was shot in Dallas, Texas. On this particular morning, an unknwon man entered the Firestone Store, walked directly to a point near the cash register, which is in from the door about fifteen feet. He said the unknown man, after looking around the store, addressed himself to Mr. MULLIGAN, owner of the store who was standing nearby. BROWN stated the unknown man asked for a map of Texas and was advised by Mr. MULLIGAN that he had no maps of Texas since there was a very limited demand for such maps in this part of the country.

BROWN stated that Mr. MULLIGAN then offered the information that if the unknown man wanted to travel to Texas the best way was to go to Savannah, Georgia, get on U.S. Highway 80 and follow it westward to Texas. He said that the unknown man was given a map of Georgia by MULLICAN and then left the store.

BROWN advised that because of the strange actions of the unknown man in going to a point near the cash register, he stopped what he was doing and moved over closer to the man and observed him closely during the remainder of the time he was in the store. BROWN stated he was of the opinion that the unknown man closely resembled photographs of LEE HARVEY OSWALD which he had seen in the newspapers since the assassination of President KENNEDY and the subsequent shooting and killing of OSWALD.

Firestone Store and Texaco Service Station, 510 Carteret Street, was displayed a photograph, Number 112 723, taken August 9, 1963, by the Police Department, New Orleans, Louisiana, of LEE HARVEY OSWALD. Instant photograph was displayed to Mr. MULLIGAN in view of the fact that he had reported that he and WILLIAM BRCWN, JR., an employee of Mulligan's Firestone Store and Texaco Service Station were of the opinion that LEE HARVEY OSWALD had been observed in Beaufort, South Carolina, about ten or twelve days before the assassination of President JOHN F. KENNEDY.

Mr. MULLIGAN was advised that LEE HARVEY OSWALD'S time had been accounted for during the period in which Mr. MULLIGAN allegedly observed an unknown man who resembled OSWALD and that it would be almost impossible for OSWALD to have been in Beaufort, South Carolina, about ten or twelve days prior to November 22, 1963.

Mrs. MULLIGAN then stated that the resemblance of the unknown man to LEE HARVEY OSWALD was remarkable.

He was displayed a photograph, Number 112 723 taken August 9, 1963, by the Police Department, New Orleans, Louisiana, of LEE HARVEY OSWALD.

Instant photograph was displayed to WILLIAM BROWN, JR., in view of the fact that he had reported that he was of the opinion that an unknown man who resembled LEE HARVEY CSWALD had been observed at Mulligan's Firestone Store and Texaco Service Station, 510 Carteret Street, Beaufort, South Carolina, approximately ten or twelve days before the assassination of President JOHN F. KENNEDY.

BROWN was advised that LEE HARVEY OSWALD'S time had been accounted for during the period in which BROWN allegedly observed an unknown man who resembled OSWALD and that it would be almost impossible for OSWALD to have been in Beaufort, South Carolina, about ten or twelve days prior to November 22, 1963.

BROWN advised that upon scanning the photograph of LEE HARVEY OSWALD which showed him in a full length pose and two close up side and front views, that he did not believe the unknown man observed ten or twelve days prior to the assassination of President JOHN F. KENNEDY was identical to LEE HARVEY OSWALD.

Captain JAMES W. MARLIN, Webb Air Force Base, residing at 104A Gunter Circle, voluntarily furnished the following information:

MARLIN advised while on a sightseeing trip to Washington, D. C., he took a picture of a group of pickets in front of the White House, on September 22, 1962. He stated he recently viewed the slide picture on his projector and believes one of the individuals in the picket line as shown by the picture to be LEE HARVEY OSWALD. He advised the slide shows a man carrying a sign, "Don't Make Cuba Our 51st State," whom he feels, after some study, is OSWALD.

MARLIN further advised the man whom he believes to be OSWALD is partially hidden behind a man in the exact center of the slide wearing a grey suit carrying a sign against his chest. Captain MARLIN further advised he desired the slide picture be returned to him at the above address via registered mail.

MARLIN advised that OSWALD was unknown to him and that the picture was a complete happenstance. He stated he was aware of the identity only after comparing the slide with pictures of OSWALD appearing in the local newspaper. He stated he is unaware of any connection between LEE HARVEY OSWALD and JACK RUBY, and that both men are not known to him.

Under date of January 30, 1964, the FBI Laboratory furnished an enlargement of the slide depicting an individual carrying a sign "Cuba is not the 51st State", which item was furnished by Captain JAMES W. MARLIN, Webb Air Force Base, Big Springs, Texas.

The FBI Laboratory advised that on the basis of the enlargement it was not possible to state that the individual involved was or was not identical with LEE HARVEY OSWALD.

Previous investigation conducted reflects that on December 4, 1963, Mr. E. L. CARTER, JR., Credit Manager, Montgomery Wards, Fort, Worth, Texas, advised SA B. TOM CARTER that his records reflected LEE HARVEY OSWALD purchased a television set from his company on September 22, 1962. At the time of this purchase, he listed his address as 2703 Mercedes, Fort Worth, Texas. He bought the television set on credit and as he had no previous credit record with Montgomery Wards, and was unable to furnish any credit references, his brother, ROBERT L. OSWALD signed the note guarantying payment.

The following investigation was conducted by SA ALBERT J. F. MURPHY, Jr.:

AT BROADUS, HONTANA

On January 16, 1964, Mrs. LEONA LULL, Post Office Box #253, Broadus, Montana, advised that JUDIE LOZALES DUFF is her daughter and currently resides at 234 North Lincoln, Monterey Park, California.

Mrs. LULL stated that WILLIAM McEWAN CUFF is her daughter's ex-husband, her daughter separating from DUFF approximately two years ago and her divorce becoming final, in California, about six months ago. Mrs. LULL advised she has no idea as to the present whereabouts of DUFF and in fact, she is aware that her daughter is also seeking him as he is well in arrears on his support payments.

Mrs. LULL advised that her ex-son-in-law is not an American citizen, having come to this country from Scotland about five years ago. He married her daughter after he had been in the United States for about a year. She stated that DUFF is shiftless, "lazy, foolish and a liar"; however, to her knowledge his relatives in California are "good-living respectable people". Concerning DUFF's relatives, Mrs. LULL advised that she believes LUFF's mother, name unrecalled, currently resides with her son ROBERT DUFF, who is either an accountant or a tax consultant in Long Beach, California. She is aware ROBERT DUFF is employed as an accountant or tax consultant as she has heard it mentioned he makes his living siding people in preparation of their State and Federal taxes.

Mrs. LULL continued that I TT also has a mister ALICE, last name unknown, residing in California, and a mister MARGARET, who is recently remarried. She stated ALICE was living in the San Gabriel, California, area but does not know if she still resides there. She advised that she believes her daughter has maintained contact with some of the members of the DUTF family and can probably advise of the exact location of at least some of them.
