The following investigation was conducted by SA
ALBERT J. F. MURPHY, Jr.:

AT BROADUS, MONTANA

On January 16, 1964, Mrs. LEONA LULL, Post Office Box #253, Broadus, Montana, advised that JUDIE LORRAINE DUFF is her daughter and currently resides at 234 North Lincoln, Monterey Park, California.

Mrs. LULL stated that WILLIAM McEWAN DUFF is her daughter's ex-husband, her daughter separating from DUFF approximately two years ago and her divorce becoming final, in California, about six months ago. Mrs. LULL advised she has no idea as to the present whereabouts of DUFF and in fact, she is aware that her daughter is also seeking him as he is well in arrears on his support payments.

Mrs. LULL advised that her ex-son-in-law is not an American citizen, having come to this country from Scotland about five years ago. He married her daughter after he had been in the United States for about a year. She stated that DUFF is shiftless, "lazy, foolish and a liar"; however, to her knowledge his relatives in California are "good-living respectable people". Concerning DUFF's relatives, Mrs. LULL advised that she believes DUFF's mother, name unrecalled, currently resides with her son ROBERT DUFF, who is either an accountant or a tax consultant in Long Beach, California. She is aware ROBERT DUFF is employed as an accountant or tax consultant as she has heard it mentioned he makes his living aiding people in preparation of their State and Federal taxes.

Mrs. LULL continued that DUFF also has a sister ALICE, last name unknown, residing in California, and a sister MARGARET, who is recently remarried. She stated ALICE was living in the San Gabriel, California, area but does not know if she still resides there. She advised that she believes her daughter has maintained contact with some of the members of the DUFF family and can probably advise of the exact location of at least some of them.

Mrs. LULL informed that during the day time her daughter is employed by a bank, she believes named THE FIRST SECURITY BANK, located about one mile from Monterey Park, California.

Concerning DUFF, Mrs. LULL advised that in the few conversations she has had with him he has never mentioned having any friends in Texas, nor does she recall him ever mentioning anyone named OSWALD, nor did he ever discuss politics of any kind with her.

Mrs. LULL stated that she could think of no other information which would aid in the location of her ex-son-in-law.

On January 18, 1964, Mrs. BILLY I. ~~GITTINGS~~, Johnson's Trailer Court No. 26, Buena Vista, Colorado, advised SA WALLACE G. HAGUE she taught school at Lancaster, California in 1956-57 as MARGARET ~~PAIRCHILD~~. She said she was a maid of honor in June, 1957 at the wedding of CONNIE BLICKHAM and ED PENCAL at Lancaster. She was introduced to a SCOTTY ~~McDUFF~~ at the wedding reception. McDUFF was a guest of ROBERT PENCAL, brother of the groom, who advised he had met McDUFF and felt sorry for him as he was in the United States by himself.

Following the reception, the group went to a night club north of Lancaster where they danced and drank. While there, McDUFF expressed interest in FAIRCHILD and asked to see her again. She advised him she was leaving Lancaster the following day to return to college and wrote her name and address as Monte Vista, Colorado on a card which she gave to McDUFF.

She advised she left Lancaster the following day and has had no subsequent contact with McDUFF. She states she knows nothing concerning his background, acquaintances or possible whereabouts.

She advised she has lost contact with ED and CONNIE PENCAL; however, several years ago she heard PENCAL was employed in a rodent control program for the State of California.
