Mrs. ~~SIDNEY~~ RICHEY, owner, Commercial Employment Agency, Fort Worth National Bank Building, was interviewed based on receiving information that LEE HARVEY OSWALD had placed an application with her agency one or two years ago for a sheet metal job in Fort Worth.

Mrs. RICHEY stated that her records reflected an application card for LEE H. OSWALD, 7313 Davenport Street, Fort Worth, telephone PE 2-3245, and dated June 26, 1962.

Mrs. RICHEY stated that she recalled OSWALD coming in to the employment agency and that she herself had interviewed him. She stated that he appeared to be a quiet young man and was reluctant at first to give any information concerning where he had been employed previously doing sheet metal work. She stated that on further questioning of OSWALD he stated that he had done sheet metal work abroad, and when she finally pinned him down he stated that he had been in Russia and had returned to the United States in 1962. She said that he told her he had worked in a sheet metal factory in Moscow.

Mrs. RICHEY furnished the application, which she stated was signed by OSWALD and which she witnessed on June 26, 1962. She stated that this is the only record that she has concerning OSWALD being in her employment agency. She added that she did not get OSWALD a job and did not have any further contact with him after the initial meeting.

These records were examined and revealed LEE OSWALD registered as a transient on October 15, 1962, in Room 415 and checked out on October 19, 1962, at which time he was still listed on the records as a transient guest.

Mr. GARY E. ~~TAYLOR~~, 4115 Falls Drive, Dallas, Texas, furnished the following information:

He lived at 3519 Fairmount, Apartment 12, from March through December 1962. LEE OSWALD never resided with TAYLOR at this address or any other address. He first met the OSWALDS in September 1962. He subsequently brought MARINA OSWALD to live with him. He believes LEE OSWALD lived at the Y.M.C.A. at Dallas, Texas, from the early part of September to the early or possibly the middle part of October 1962. He states he called LEE OSWALD two or three times during this period and never had any trouble getting him to the telephone at the Y.M.C.A. He indicated he would call OSWALD at the Y.M.C.A. in order to make arrangements to pick OSWALD up and bring him to his apartment to visit with MARINA.

He recalled MARINA OSWALD moved back to Fort Worth when a woman--he now believes to be a Mrs. HALL--had a serious automobile accident. He recalls he once met this woman's ex-husband and his name was JOHN HALL. He indicated the HALL woman lived at the south edge of Fort Worth off the South Loop of the Expressway. He advised around the early part or possibly the middle of October 1962, possibly on a Sunday, LEE OSWALD called him and asked him to pick him up at the Y.M.C.A., Dallas, Texas, take him to Fort Worth and move him and MARINA to an apartment in Dallas.

He picked up LEE OSWALD later that day at the curb of the Y.M.C.A., Dallas, and drove him to Fort Worth to the HALL residence, where MARINA OSWALD was living. OSWALD had a suitcase with him, and he believed OSWALD had been living at the Y.M.C.A.; however, he reiterated he picked up OSWALD at the curb of the Y.M.C.A., did not see him come out of the Y.M.C.A. building and can only assume that OSWALD had been living there.

He then drove LEE OSWALD to Fort Worth, where he rented a trailer from a service station on University Drive east of the

Expressway. He believes it was a Nationwide trailer. He and LEE OSWALD then picked up MARINA and their personal belongings and he moved them to an apartment house which he believed to be one block west of the intersection of Davis and Zangs, being in the southwest corner of that block. He described the building as a 2-story, red brick apartment building on the corner of Elsbeth Street. He then looked at a street map of the City of Dallas and pointed out the northeast corner of the intersection of Elsbeth and Davis as the exact location.

He further advised around March or April 1963 he went to the apartment on Elsbeth and observed that OSWALD's name was no longer on the mail box. He spoke to a man who was sitting in the front yard in front of this building. He believes the man was the manager of the apartments, and this man told him the OSWALDS had moved to another apartment about one block over on Neely Street. He went to this apartment on Neely, which he described as being in the upper part of a 2-story white frame house which he thinks was almost directly behind one block of the apartment on Elsbeth. The OSWALDS were not in at this time.

He further advised he went back to this apartment during the latter part of May or early June 1963, at which time he visited with MARINA.

The following investigation was conducted by SA B. TOM CARTER and JOSEPH M. MYERS at Fort Worth, Texas, on January 28, 1964:

It should be noted that University Drive in Fort Worth, Texas, does not run East and West but does run North and South.

A check of the Fort Worth ^{Trs} telephone and city directories failed to reflect a Nationwide or other trailer rental company on University Drive.

FRANK ~~X~~ HEFLIN, Owner, AAA Trailer Rental, 500 Henderson Street, advised that he formerly operated a Nationwide Trailer Rental in Fort Worth, Texas; however, after searching his records for 1962, he failed to find a trailer contract for a trailer rented by GARY E. TAYLOR of Dallas. Mr. HEFLIN stated that he knew of no Nationwide Trailer Rental Company on University Drive, however, suggested the Westside Trailer Rental which is located just off of the East West Freeway in Fort Worth.

On January 29, 1964, EMMITT ~~X~~ L. WILSON, Westside Trailer Rental Company, 5430 Camp Bowie Boulevard, advised that he is the Nationwide Trailer Agency for Fort Worth. WILSON stated he knew of no trailer rental on University Drive in Fort Worth. WILSON failed to locate a record of a trailer rental by GARY E. TAYLOR in 1962.

A physical check of University Drive, Fort Worth, on January 28, 1964, failed to reflect a trailer rental company North or South of the East West Freeway.

Mr. W. F. ~~TOBIAS~~, SR., Manager of the apartment house located at 602-604 Elsbeth, Dallas, Texas, made available rent receipts which when examined revealed the following information:

LEE HARVEY OSWALD paid \$68.00 rent for Apartment # 2, 604 Elsbeth, on November 3, 1962. Mr. TOBIAS verified this date as being the date on which the rent was paid but stated he did not actually observe OSWALD to move into this apartment on that day. He indicated he did not see MARINA for at least one week after OSWALD rented the apartment.

He stated the OSWALDS occupied this apartment until March 3, 1963, at which time they moved to 214 Neely, Dallas. The rent receipts for Apartment # 2 reflect that this apartment was vacant from September 29, 1962, until November 3, 1962, the date OSWALD paid TOBIAS one month's rent.

Mr. TOBIAS further advised apartment regulations forbade anyone from moving in before their rent had been paid.

TOBIAS exhibited the above-described apartment, which is a furnished apartment, at which time it was noted that the front door to this apartment was not locked. TOBIAS was asked if this was the policy to leave the front door unlocked, and he stated that since he lives directly across the court from this apartment, he could easily see whether or not anyone had been occupying the apartment. He did state, however, that the back entrance to this apartment was kept locked at all times when vacant.

In addition to the above, TOBIAS recalled that OSWALD came to look at this apartment around the first part of October 1962, at which time he indicated to TOBIAS he would probably rent the apartment; however, he wanted to talk it over with his wife.

LEE HARVEY OSWALD filled out a Withholding Exemption Certificate on October 12, 1962, at which time he listed his residence as 3519 Fairmount, Dallas, Texas. Mr. STOVALL advised that this was the date OSWALD first started working for Jaggars-Chiles-Stovall Company. The time records of LEE HARVEY OSWALD while working for above company, reflected that he had worked every day during the period October 19 to November 2, 1962, except for Saturdays and Sundays. He did, however, work on Saturday, November 3, 1962.

The records of Jaggars-Chiles-Stovall Company also revealed that LEE HARVEY OSWALD listed a new address of 602 Elsbeth, Dallas, on January 11, 1963. On April 1, 1963, OSWALD listed a new address of Post Office Box 2915, Dallas.

GEORGE A. BOUHE, 4740 Homer Street, Apartment O, was reinterviewed and furnished the following information in addition to information furnished by him during prior interviews, November 23 and 28 and December 27, 1963:

Concerning the residence of LEE HARVEY OSWALD after he moved from the Y.M.C.A. in Dallas on or about October 19, 1962, he next recalled that OSWALD was living at 602 Elsbeth in the Oak Cliff Section of Dallas. While still residing at the Y.M.C.A., OSWALD obtained a job at Jaggars-Chiles-Stovall and OSWALD called him on a couple of occasions after getting the above job to tell him he was doing all right.

BOUHE, in thinking back, recalled that at some time or other, possibly after OSWALD left the Y.M.C.A., OSWALD may have mentioned that he had obtained a room possibly on Madison Street from someone named CARLTON.

BOUHE checked the current Dallas Telephone Directory and noted that the Madison-Carlton Hotel was listed at 1159 North Madison, Dallas.

BOUHE advised further that he had not given OSWALD any money to pay his rent at the YMCA and had no information as to the exact date OSWALD left the YMCA or his mode of transportation.

He pointed out that prior to that time, when OSWALD was residing in Fort Worth and when he and his wife MARINA were practically destitute, he and some friends had purchased a baby bed for their baby, as well as a \$5.00 pair of shoes for MARINA, and he gave OSWALD \$5.00 cash.

BOUHE could furnish no further information concerning the period of OSWALD's residence from October 19, 1962, to November 2, 1962.

ROBERT OSWALD was interviewed at his residence, 1009 Sierra, and furnished the following information:

He stated that he believes he has all of the remaining clothes of LEE HARVEY OSWALD and that he does not believe that his mother has any of the clothes. He made available all of the clothes of LEE HARVEY OSWALD that he has. They were stored in a closet in the carport. From these clothes the following items were obtained:

1. Long-sleeved grey shirt
2. Overcoat liner- (USMC)
3. Beige long-sleeved shirt
4. 1 pair blue jeans
5. 2 pairs Marine Corps trousers - green wool
6. 1 Beige short-sleeved sport shirt
7. 1 pair blue outdoor shorts
8. 1 blue and white print short-sleeved shirt
9. 1 brown and white flannel-type short-sleeved shirt
10. 1 fatigue jacket - (USMC)
11. 2 pairs khaki-colored trousers
12. 5 khaki-colored long-sleeved shirts
13. 1 pair high-top shoes
14. 1 pair black Russian boots

ROBERT OSWALD stated that about 1957 or 1958, LEE HARVEY OSWALD left a small camera with him and picked it up when he got out of the Marine Corps about 1959. He described this camera as a cheap American-made camera worth probably less than \$10.00, about 6 inches high, 3½ inches wide with a view-finder on top which opens to permit looking at the scene to be snapped. He recalled it was an off-brown color. He never used it himself and cannot recall the brand name or the size of film but knows it used roll-type film.

He advised that he does not know anything about any Russian camera that LEE HARVEY OSWALD owned.

On January 24, 1964, Mr. ~~WARREN~~ ^VEDDIE BARKER, Director, KRLD Television and Radio, advised that ~~WARREN~~ FULKS had interviewed Mr. ILYA MAMANTOV, 6911 East Mockingbird Lane, on December 5, 1963, at the KRLD Television Studio. BARKER advised that MAMANTOV is employed as a Geologist for Sun Oil Company and teaches at Southern Methodist University.

BARKER stated that prior to filming the interview FULKS and MAMANTOV discussed the interview and arranged several of the questions in order to make the interview interesting. BARKER advised that part of the interview was shown on their news programs on December 6 and December 7, 1963, and that they were re-runs of the previous showing. BARKER stated that they taped the entire interview, however, only one part of the interview was actually used in the news program.

BARKER made available the sound film of the entire interview with MAMANTOV for review by the FBI.

Date February 5, 1964

On February 5, 1964, SA ALLAN D. BRAY reviewed the sound film obtained from EDDIE BARKER, KRLD Radio and Television, of an interview between ILYA MAMANTOV and KRLD announcer WARREN FULKS, on December 5, 1963, in the KRLD Television Studio.

MAMANTOV stated that the Communists tried to show the world that Dallas was a "hot spot" politically and tried to create "confusion" by the assassination of President KENNEDY. When asked what he meant by this, he replied that if OSWALD had not been caught, the South would have been blamed for former President KENNEDY's assassination, and this would enable the Communists to show that the United States was politically unsound. He felt the Communists would take advantage of this situation in several years, possibly even as long as ten years from now.

When asked if the pattern followed by OSWALD was similar to other Revolutionaries, MAMANTOV replied that the pattern was similar to that followed by Revolutionaries in Paris, Berlin and other countries in Europe.

MAMANTOV stated that JACK RUBY was part of the "underground conspiracy", because when OSWALD gave a press conference at the Dallas City Hall, he grabbed the microphone and yelled, "I would like to see JACK ABT", and this was his (JACK RUBY) code call. He stated that RUBY had received his "assignment" from the "higher-ups" in the "underground conspiracy" to assassinate OSWALD, and the purpose was to keep OSWALD from talking and to eliminate him.

MAMANTOV stated that when he was younger, he had met young, uneducated individuals similar to OSWALD, who went to Russia from Latvia and came back to Latvia as freelance photographers. MAMANTOV stated that these persons later became top officials in the Communist party in 1940 and 1941.

Concerning OSWALD's easy access to Russia, MAMANTOV stated this was part of the "underground conspiracy".

He stated that no one with OSWALD's financial standing could go to and leave Russia after having married a Russian woman as easily as OSWALD had done. MAMANTOV stated he believed OSWALD had been sent to different schools while in Russia, including an "underground conspiracy school", in order that he could leave Russia as easily as he did. He described OSWALD as an agent waiting for an assignment in America after he had left Russia.

When queried concerning the benefit the Communists would derive from the assassination of former General WALKER, MAMANTOV stated that the assassination of WALKER, if they had succeeded, would have eliminated one more speaker against Communism. MAMANTOV stated that WALKER had spoken all over the United States, and was considered as an "unwilling element" by the Communists.

When asked about the developments arising from the assassination, MAMANTOV replied that the United States should henceforth be more careful in its political accusations, and careful as to the people they trust. It was his opinion that the assassination would bring the American people more closely together.

ILYA A. MAMANTOV, 6911 Mockingbird Lane, Dallas, Texas, was interviewed at his place of employment, Sun Oil Company, Research Laboratory, Richardson, Texas. He said that he had no first-hand information to indicate that LEE HARVEY OSWALD had ever attended any "underground conspiracy schools" while in Russia and said he never knew OSWALD personally. He said he also had no first-hand information to indicate that JACK RUBY had received any "assignment" to assassinate OSWALD or that he was part of any conspiracy.

He said his statements over Television Station KRLD when interviewed by announcer EDDIE BARKER concerning the above were personal conclusions drawn by him, MAMANTOV, from his knowledge of Communism and Russia. In substantiation of his conclusions, he related the following:

When he, MAMANTOV, was in grade school in Lithuania he was acquainted with two boys who were exactly the same type as OSWALD. He said they were all raised near the Russian border and no difficulty was encountered in crossing back and forth across the border. These two boys disappeared from the town one day without explanation, but their parents did not seem concerned. They were not seen again in the town until eight to ten months later, when they were allegedly expelled from Russia for being "undesirable persons".

After returning home they both held all types of jobs, never holding any one job very long, and moved frequently from place to place. They were in constant trouble with the police for disturbing the peace, malicious mischief, and various other minor troubles. This went on from approximately 1924 to 1940, at which time their country was taken over by the Soviet Union. They immediately thereafter were given good jobs and became substantial citizens in the community. MAMANTOV found out from mutual friends that when these boys disappeared, they had gone to Russia and had attended Communist schools, where they were taught, among other things, disruptionist tactics and ways and means of creating disturbances, which they thereafter did when returning home from the school, until Russia took over their country.

MAMANTOV said that OSWALD acted the same as the two boys above, i.e., he had traveled around from place to place and from job to job, causing trouble whenever he could, and generally creating trouble wherever he went. Because of the similar pattern of OSWALD and the two boys, he felt this was an indication that OSWALD had attended the same type schools in Russia as had the two boys.

He related other instances where men had gone to Russia and had attended Communist training schools. He said he knew another man who was a free-lance photographer who had reportedly attended an underground school in Russia and had thereafter worked as a photographer until the Russians took over his country, at which time he was made District Attorney of the district in which he lived. MAMANTOV pointed out that OSWALD had also worked as a free-lance photographer.

He also said it is common knowledge that when a Communist assassin gets caught or gets in trouble with the police, he is often "liquidated" by the Communists to keep him from talking or revealing his Communist connections. He said he felt that this was the pattern in the killing of OSWALD, and that therefore RUBY must have been a part of a Communist conspiracy.

MAMANTOV also said he had observed that it is a pattern of Communist agents to try to mix with the police whenever possible and become friendly with them, as had been the case with RUBY.

MAMANTOV stated that he had absolutely no first-hand knowledge of OSWALD, RUBY or the assassination of President KENNEDY in addition to that already furnished the Federal Bureau of Investigation.

On November 23, 1963, Mrs. JOHN O. THOMPSON, Manager, Austin Motel, 1220 South Congress Street, Austin, Texas, advised SA H. T. BURK that BILL RANDLE, 2439 West Fifth Street, Irving, Texas, had arrived at that motel at approximately 7:00 PM, November 22, 1963, with one BERRY J. CASTER, 214 West Shady Grove, Irving, in a 1963 Chevrolet pick up, bearing 1963 Texas license 3F8823. They both claimed to be employees of the Irving Counter Top Company, no street address given. *T. R. S.*

RANDLE claimed that he lived two or three doors from LEE HARVEY OSWALD and that RANDLE's wife worked in the same building as OSWALD. RANDLE also mentioned that it had been rumored in Dallas that if the President came to Dallas, he would be killed on account of the Veterans Administration offices being moved out of Dallas, Texas. RANDLE indicated a personal acquaintanceship with LEE H. OSWALD but did not indicate the degree of association.

RANDLE attempted unsuccessfully to contact one MARVIN RANDLE, telephone number BL 3-9040, at Irving, Texas, about 7:30 PM, November 22, 1963.

Mrs. THOMPSON advised that subsequently, on the same date, RANDLE returned to the motel and placed a long-distance call to the same number, and reported that he had learned that his wife had been called in for questioning concerning the assassination of President KENNEDY. RANDLE checked out of the motel and reportedly returned to Dallas by plane, at 11:05 PM, on November 22, 1963. Mrs. THOMPSON reported that BERRY J. CASTER checked out of the motel at 7:00 AM, November 23, 1963, with stated destination of Irving, Texas.

LINNIE MAE RANDLE, 2439 West Fifth Street, Irving, Texas, was interviewed on December 1, 1963, by SAS BARDWELL D. ODUM and GIBBON E. MC NEELY. She advised that she was the sister of BUELL WESLEY FRAZIER, who was employed by the Texas School Book Depository and who has also been interviewed. She also furnished other information of value which has been reported.

RANDLE related that he personally has no knowledge of LEE HARVEY OSWALD except what he has seen on television and in the news media. He explained that he never saw OSWALD prior to when his picture appeared in the local newspapers. He also related that his brother, MARVIN, who lives at 2819 West 11th Street in Irving, has never seen OSWALD and has no pertinent information regarding him. RANDLE stated that he also contacted MARVIN RANDLE by telephone from Austin on November 22, 1963. He explained that MARVIN is the owner of Irving Counter Top, and that he had wanted to talk to him about business matters.

He related that he does not recall ever making the statement to the effect that the President (KENNEDY) would be killed if he came to Dallas, because Veterans Administration offices were being moved out of Dallas, Texas. In short, he had no pertinent information concerning either LEE HARVEY OSWALD or JACK RUBY.
