Re Bureau airtel to Dallas 3/9/64, and Dallas airtel to Director 3/18/64.

Your airtel of 3/18/64 enclosing results of an interview with Jean Lollis Hill revealed on page two the comment that Mrs. Hill following the shots observed a white man wearing a brown raincoat and hat running west away from the Texas School Book Depository Building in the direction of the railroad tracks. From the description furnished this individual is not identified in Bureau files. Dallas is instructed to conduct immediate inquiry in an attempt to locate and identify this individual noting this appears to be new information. However, if this individual has been previously identified and interviewed, advise the Bureau of the identity and the report in which this interview is contained. This matter has to be resolved and Dallas is instructed to handle promptly.

NOTE:

A meeting was had on 2/18/64 at the town hall in New York City sponsored by the National Guard where Mark Lane, voluntary defense attorney for Lee Harvey Oswald criticized investigation conducted by the FBI and Secret Service. He played a tape recording of a telephone conversation made 2/18/64 with Mrs. Hill. Dallas was instructed by airtel 3/9/64 to identify and interview Mrs. Hill. Dallas did locate and identify Mrs. Hill and submitted results of interview. However, in her interview she commented she observed a white man wearing a brown raincoat and hat running away from the Texas School Book Depository Building in the direction of the railroad tracks. She described him as a man of average height and heavy build, and she did not get a good look at him, does not know who he was and never saw him again. Bureau files do not reveal the identity of this individual or whether he has been previously identified and interviewed. To fully resolve this, Dallas has been instructed to conduct appropriate inquiries.

The source of the data set forth in the enclosed LHM is inf [redacted] San Francisco, California, who is a confidential informant of the San Francisco Police Department and who has requested his identity be concealed. [redacted] furnished the information set forth in LHM to SA FRANK S. PERRONE on March 20, 1964.

The Bureau may desire to forward a copy of instant LHM to Legat, Mexico, in an effort to attempt to locate ARNOLD (LNU) who was reported to be a resident of the Casa de los Amigos in Mexico City.

San Francisco has no further identifying data regarding ARNOLD in its possession and no information reflecting whether this individual has previously been interviewed in connection with captioned matter.

On March 20, 1964, an individual, who has requested his identity not be divulged but who has furnished reliable information in the past, advised that he was in Mexico City until approximately two weeks ago. While in Mexico City he had occasion to visit the Casa de los Amigos operated by the American Friends Service Committee in Mexico City. While visiting the Casa de los Amigos, he met one ARNOLD (LAST NAME UNKNOWN) who was residing at the Casa de los Amigos.

ARNOLD had in his possession a press card which identified him as an employee of the "Mexico City Times", but he was not employed by that publication at the time he met the source mentioned above. In addition, source was unable to furnish any information as to where ARNOLD was working at the time.

ARNOLD related he had been in Mexico City for approximately four months and commented to source that he had had dinner with LEE HARVEY OSWALD on the occasion of the latter's visit to Mexico City prior to the assassination of President Kennedy. ARNOLD did not say where this dinner engagement took place, nor did he relate any of the details of the conversation he had with OSWALD on the occasion of this dinner. Source advised he did not learn whether ARNOLD met with OSWALD on any other occasion either in Mexico or elsewhere.

Source described ARNOLD as a white, male, American, 20 - 24 years of age, 5'10", 160 pounds, blond hair, ruddy complexion, and full mustache. Source noted that ARNOLD claimed to be from Berkeley, California. *Report 1940-1944*

Source concluded by stating he has no additional information regarding the above matter, no further description of ARNOLD, and no idea where ARNOLD is living and working at the present time.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

MANIFEST IS AUTHENTIC. ARE OTHER BUS MANIFESTS AVAILABLE FOR PERIOD IN EARLY OCTOBER ONE NINE SIX THREE? OBTAIN CLEAR-CUT STATEMENT FROM APPROPRIATE TRANSPORTES FRONTERA PEOPLE AS TO WHETHER OR NOT THE MANIFEST IN QUESTION IS AUTHENTIC. ENDEAVOR TO DETERMINE WHO UTILIZED SEATS ONE AND THREE DURING TRIP IN QUESTION WHICH WERE MANIFESTED UNDER TICKETS NUMBERS THREE NINE SIX THREE THREE AND THREE NINE SIX THREE FOUR ISSUED IN NAME OF THE DRIVER SAUCEDO. on Transportes Frontera Company records. Incoming states that the manifest was found by bus company officials in the "trash" when Mexican Government instituted investigation. The names of "Oswald" and Angel Perez appear on manifest, however, no tickets were indicated for them and the bus officials now state that they believe these two individuals were not on the bus and their names appear on the manifest only as reservations, which were not picked up, must have been made in their names. The bus officials also state that the top of the manifest which identifies the bus and the date of the trip was not filled in when they located it among the "trash." This certainly suggests that the manifest may be a manufactured document of no value. It is, therefore, necessary to dig further into this.

**LEE HARVEY OSWALD**

It has been determined that Lee Harvey Oswald, who has been the subject of investigation in connection with the assassination of President John F. Kennedy, departed from Mexico at Nuevo Laredo, Mexico, some time between midnight and 8 a.m. on October 3, 1963. His mode of travel at the time of his departure is not known, however, there is some indication he may have traveled from Mexico City to Nuevo Laredo by bus or by automobile. On the late afternoon or evening of October 3, 1963, Lee Harvey Oswald appeared at Dallas, Texas. His mode of transportation from Nuevo Laredo to Dallas has not been established.

It has been determined that on October 3, 1963, between the hours of 8 a.m. and 5 p.m. one Eugene Everald Hunter departed from Nuevo Laredo, Mexico, destined to Portland, Jamaica, British West Indies. Mr. Hunter possessed Jamaican Passport Number 25517 and claimed to reside at Long Road, P. A., Portland, Jamaica, British West Indies. He was described as a male citizen of the British Commonwealth, as 41 years of age and as a contractor. Mr. Hunter's mode of travel on departure from Mexico is not known.

It has been further determined that on October 3, 1963, time unknown, two female residents of Caracas, *Barbados 1910* Venezuela, departed Nuevo Laredo by air en route to Caracas. These individuals were Matilde Muracciole Davila, aged 54, single, bearer of Venezuelan Passport Number DF-148820; and Maria Cristina Saracciole Davila De Piedra, a widow bearing Venezuelan Passport Number M-05635. *Venezuela*

It is requested that Mr. Hunter and the female residents of Caracas, Venezuela, be interviewed to determine if they can shed any light on the departure from Nuevo Laredo of Lee Harvey Oswald on October 3, 1963. We are particularly interested in learning the mode of transportation utilized by Oswald between Mexico City and Nuevo Laredo, and thence on to Dallas, Texas. We are also interested in learning if
