Dear Mr. Rankin:

Reference is made to your letter dated March 24, 1964, and my letter dated April 8, 1964, concerning the laundry mark "30 030" which appears in the gray jacket identified by certain witnesses as the jacket of Lee Harvey Oswald.

Enclosed are two copies of a memorandum dated April 21, 1964, at Dallas, Texas, captioned, "Lee Harvey Oswald." This memorandum reveals the laundry mark and/or dry cleaning tag was not identified as originating from any cleaning or laundry establishment in the Greater Dallas, Texas, area. Our investigation has been extended into the New Orleans, Louisiana, area endeavoring to identify these marks. However, there are over four hundred similar establishments in this area, which necessitates extensive investigation.

When the results of this phase of the investigation are received the information will be promptly furnished to you.

**NOTE:**

By letter 3/24/64 the Commission requested the laundry mark "30 030" appearing in the gray jacket owned by Oswald be checked with Dallas laundries for purposes of obtaining a more exact identification. 453 establishments were checked, also Marina Oswald, Buell Wesley Frazier and others were reinterviewed in an attempt to locate the laundry. However, identification was not established. To fully resolve this matter, even though the Commission requested only Dallas laundries be checked, investigation has been extended into the New Orleans area which is still pending. There are numerous establishments to be checked in New Orleans and Commission was advised by letter 4/8/64 the investigation is extensive.



NOTE:

We are trying to locate and interview a Hilda Quezada, who was on bus in question and who also traveled on same bus from Monterrey to Nuevo Laredo on which Oswald traveled on 10/2-3/63. According to the Translation Section, Hilda, a German name, is not in common usage among people of Spanish ancestry and its usage suggests a possible family or working relationship of Spanish person with person of German origin. There is no record of Hilda Quezada in Mexican immigration, however, we found trace of child Hilda Quezada-Alfaro, of Mexican nationality who entered U. S. in 1962. This child is now in Prichard, Alabama, and incoming sets forth lead to interview her. This is believed inadvisable because of her age.

 Detective Edward Thompson, Laundry Mark File, Technical Research Bureau, furnished the following information concerning the laundry and/or cleaning marks located on K-42, a gray jacket:

The Laundry Mark File maintained by that department pertains to laundry and cleaning establishments in the northeastern section of the United States, with occasional submissions from other sections of the country. The imprinted number, 30-030, and the tag containing the number B-9738, were not identified in this file, however, each geographic section of the country has its own system of marking and filing.

In general, however, in regard to the 30-030 mark, the first group of numbers (including any letter prefix which might be indicated by the blur preceding the first 3) pertains to the retail cleaner or launderer and the second group to the individual customer. The imprinting of the number into the cloth is indicative of a steam laundry or a dry cleaning plant which sends its work out. The B-9738 stapled ticket is indicative of a "one hour cleaner" or an establishment which performs work on the premises. For an effective check, however, the area where the garment was cleaned or laundered would have to be known, according to Thompson.
