His age was shown as 6. birth shown as July 9, 1939. (It is noted that this is a different birthdate for LEE HARVEY OSWALD.) C., before the Subversive Activities Control Board on the latter date, advised that he had been contacted by EARL-LIVELY, who had visited in New York City sometime during the first days of March, 1964. LIVELY told LOWERY that he had visited HERB PHILBRICK in New York City and had obtained information from someone connected with the Garrity Publishing Company there to the effect that NATHANIEL WEYL and his wife had said that they thought Mrs. MARGUERITE OSWALD, mother of LEE HARVEY. OSWALD, had been a communist at one time. Lowery stated that WEYL, according to LIVELY, was supposedly an ex-communist who testified in the case involving ALGER HISS. NATHANIEL WEYL is the author of a book entitled, "Red Ster Over Cuba," which was published by Devin-Adair Publishing Company and is supposed to live somewhere in Florida. LOWERY described EARL LIVELY i: t as an "ultra'rightist" and stated that he had never heard of NATHANIEL WEYL during the time he was a member of the Communist Party in Dallas, Texas.

LOWERY said that he considers LIVELY an "ultra rightist" because he is a person who believes that no one in the United States Government can be trusted; that the communists may be taking over our country, and because he devotes considerable time to fighting communism to prevent what he thinks might be a communist takeover of this country.

On December 8, 1963, he obtained property of LEE HARVEY and MARINA OSWALD which was in the home of RUTH PAINE, Irving, Texas. Included in this property was a box which contained a two volume history, some Russian books, and a small American-made camera. He stated he had never made this camera available to authorities before February 24, 1964, because he had never been asked for it previously, and because he could see no evidentiary value to anyone interested in the assassination of President JOHN F. KENNEDY, of this cheap camera which belonged to LEE HARVEY OSWALD. He stated it had never occurred to him that anyone would be interested in the camera.

He advised he has no letters in his possession that LEE HARVEY OSWALD had written, and that the only letters he did have have been turned over by him to the President's Commission.

ROBERT OSWALD made available the box which contained this camera, and the items it still contains, all of which were the property of either LEE HARVEY OSWALD or MARINA OSWALD. The first thirteen items are books:

"I, Vada Oswald, make the following statement to Bardwell D. Odum and R. Neil Quigley who have identified themselves to me as Special Agents of the Federal Bureau of Investigation.

"I have never heard anything from Marina Oswald or Jim Martin, her former business manager, or from anyone else, except my husband, concerning a threat by Lee Harvey Oswald to shoot Richard Nixon, former Vice-President of the United States.

"The only thing I have heard was from my husband, Robert L. Oswald, who told me that both Jim Martin and Marina Oswald had told him that when Richard Nixon was in Dallas (and I don't know when this was) Lee Harvey Oswald had told Marina that he intended to shoot Nixon, and that Marina had locked him in the bathroom and kept him there all day. Jim Martin got this from Marina, and later Marina told my husband, Robert, but Marina did not discuss this with me. Robert told me about this incident sometime the latter part of January, 1964.

A personal statement by Mr. FORD in this file dated February 1960 reflects he had previously resided in Ventura, California; that he owned unnamed stocks and bonds and had life insurance in the amount of \$10,000. This statement reflected he had military service from 1942 to 1945 in the U. S. Navy. He owned a 1959 automobile, free and clear.

As of February 1960 Mr. FORD had only one listed account at a clothing store and this was satisfactory. A check revealed he had a sizable checking account at a local bank in Dallas. Since his file was opened, there have been approximately twenty-one inquiries, mostly from retail merchants in Dallas. There were also four inquiries from banks and one inquiry from the Metropolitan Savings and Loan Association concerning a mortgage. This inquiry was on March 8, 1963. This file reflects his wife as KATHRYN or KATHYN. Wrs. BELCHER was not sure of they spelling of this name.

Mrs. BELCHER advised further this association has a record concerning one STANLEY LX SKOTNICKI and his wife KATHERINE This record was opened on November 15, 1947. He was last known to be employed as of June 1958 with Sears-Roebuck and Company on Ross Avenue in Dallas as a salesman. His last known address was 1.6.

This file reflects SKOTNICKI was from Stephenville, Texas, and he was born in Thurber, Texas, on October 15, 1919.

He and his wife were parents of two children. The file reflects that in October 1958 SKOTNICKI sued his wife KATHERINE for divorce. On October 23, 1961, KATHERINE FORD sued STANLEY SKOTNICKI for a debt.

On March 9, 1964, Mr. J. G. VICKERY, Identification Division, Dallas Police Department, and Mr. JAMES KITCHING, Identification Officer, Dallas Sheriff's Office, advised SA HEITMAN they had no record concerning DECLAN P. FORD or KATHERINE, FORD in their respective files.

On March 9, 1964, Miss Helen ST. JOHN, Secretary, U. S. Immigration and Naturalization Service, advised SA HEITMAN there is no record at this office for Mrs. DECLAN P. FORD or Mrs. STANLEY L. SKOTNICKI.

From the period of Pebruary 25, 1964, through March 11, 1964, Special Agents ANATOLE A. BOGUSLAV and WALLACE R. HEITMAN have had opportunity to converse with Mr. and Mrs. DECLAN P. FORD in connection with interviews which were being conducted with MARINA OSWALD. On these occasions both Mr. and Mrs. FORD / /// furnished information concerning themselves. Mr. FORD advised he is a geologist by profession and formerly lived in California, where he has several brothers who are attorneys. He stated he, at the present time, is in business for himself and works out of his home. He said he does not have an office at any other place, nor is he connected with any other firm.

KATHERINE FORD advised Special Agents BOGUSLAV and HEITMAN she was an interior decorator by profession. She stated she had been married previous to her present marriage and her previous married name had been SKOTNICKI. She said her two older children, a daughter approximately sixteen years of age, and a son approximately twelve years of age, were the children of her previous husband, Mr. SKOTNICKI. Another small child was observed at the house. This child, a boy, is named GREGORY, and is the son of Mr. and Mrs. FORD. He is about two years old.

It was observed that the home in which the PORDS lived is in the \$40,000 to \$45,000 class, and is located in the extreme northern part of the City of Dallas, Texas.

Mr. MAX CLARK, attorney at law, with office in the Ridglea State Bank Building, Fort Worth, Texas, advised that he is an acquaintance of DECLAN P. FORD and his wife KATHERINE. He advised DECLAN P. FORD had been employed as a geologist with the firm of DeGolyer and MacNaughton in Dallas for a number of years. He spent a number of years with this firm in Spain. He stated about a year ago FORD was let go by this firm because of reduction in force. He was paid two years salary. Mr. CLARK advised FORD was a loyal American citizen of excellent reputation. He stated that he was evidently very skilled in his profession of geology.

He said he believes DECLAN P. PORD was single at the time he met the then KATHERINE SKOTNICKI, whose nickname is KATYA OF KATCHA. He said KATHERINE SKOTNICKI was divorced in Dallas and later she and DECLAN P. FORD were married. He said the FORDs, at the present time, live in their own home at 14057 Brookcrest in Dallas. He stated that this home was in the \$40,000 to \$45,000 class.

CLARK stated Mrs. DECLAN FORD had evidently wanted to step up in society a bit and that may have been one of the reasons why she divorced STANLEY SKOTNICKI. CLARK advised SKOTNICKI had met KATHERINE in Germany. He said KATHERINE PORD was evidently not too well educated but was very intelligent. He said she dressed well and was very glad to be living in the United States. He said he believes she is a loyal American citizen.

Baker, Dallas, Texas, and his residence telephone number is ME 1-3569. He said he is classified as a Radiology Resident at Parkland Memorial Hospital in Dallas, where his telephone number is ME 1-5050, Extension 201.

Doctor DOCKERY said he was present during the time surgery was performed on LEE HARVEY OSWALD on the second floor at Parkland Memorial Hospital, on November 24, 1963, for about one hour prior to the death of the patient. He said he took about nine rolls of 35 mm black and white and color film showing the surgical procedures. This film was turned over to Mr. C. J. PRICE, Administrator of Parkland Memorial Hospital, and it has not been developed.

Destor DOCKERY said the film was the property of the hespital and would have to be produced by subposed duces tecum addressed to Mr. PRICE and/or Mr. ED MAHER, Chairman of the Board of Managers of the Dallas County Hospital District. He said the film was not identified prior to being turned over to Mr. PRICE and he would not be aware of the exact number of black and white film or color film or what number of exposures he made of the surgical procedures.

Doctor DOCKERY said he was unable to recall observing any scars on the inner wrists of LEE HARVEY OSWALD, but it was possible some of the photographs might show the inner wrist area of the patient.

MARINA OSWALD was interviewed at 14057 Brookcrest, the home of Mr. and Mrs. DECLAN P. FORD.

MARINA was questioned concerning two thick books which she believes to be history books on the subject of the United States which she recalled were read and studied by LEE HARVEY OSWALD. She said she can recall that OSWALD had two such books which she believed were concerning the history of the United States. These books were written in English and had dark blue covers and the pages had red edges. It was a two volume work she believes. She can recall last seeing these books at the Magazine Street address in New Orleans. She cannot recall seeing them since they left New Orleans. It is her belief the books were owned by OSWALD prior to his trip to Russie and they were among other effects OSWALD left with his brother ROBERI. She can recall the books were in good condition. She cannot recall that OSWALD made notes in the books.

Mr. JAMES HERBERT MARTIN, and Mr. JOHN M. THORNE had traveled en route from Washington, D. C., to Dallas, Texas, following her testimony before the President's Commission. She said she cannot now remember what name she traveled under or the names which MARTIN and THORNE used. She was asked if she could recall the name "HOBBS" as being the name which was used by her. She said the name sounds familiar but she cannot exactly recall if that is the name used by her.

MARINA was asked if to her knowledge OSWALD had any American acquaintances in Russis other than persons he had met in the U. S. Embassy or connected therewith. She replied the only such acquaintance she can now recall is the American woman news correspondent who interviewed LEE HARVEY OSWALD in Moscow prior to the time he went to Minsk. MARINA said the name MARY LOW PATTERSON is not familiar to her. She said she cannot recall OSWALD ever mentioning this name. She does not believe OSWALD knew other Americans in Moscow or Minsk.

At approximately 11:30 p.m., MARINA OSWALD was telephonically contacted at the home of Mr. and Mrs. DECLAN P. FORD, 14057 Brookcrest in Dallas, following a telephonic request from MARINA to the FBI Office in Dallas that Agent BOGUSLAV call her.

MARINA stated that during the testimony she had given the President's Commission in Washington she had been shown a book written in Russian entitled "The Eyes Which Inquire." This book was written by a Bulgarian author. She was asked by the Commission to explain why some letters had been cut out of this book and at the time she could not explain this. She said she could now remember that LEE HARVEY OSWALD had cut certain letters from a book to form her name, MARINA NIKOLAEVNA OSWALD. He told her he intended to. place the assembled name over the bell at the Elsbeth Street address. She asked him why he would do this because her name was spelled out in Russian letters. She said this was one of LEE HARVEY OSWALD's pranks. Thereafter, OSWALD assembled her name in English letters; photographed it at his place of employment, and put it over the bell at the Elsbeth Street address.

The Russian book entitled "The Eyes Which Inquire" (English translation) is Item No. 324 in the list of personal effects of MARINA and LEE HARVEY OSWALD.
