The President's Commission also made available with its letter of July 23, 1964, a copy of a letter dated June 25, 1964, from JOHN J. KAYLOCK to Governor JOHN CONNOLLY, Austin, Texas, postmarked at St. Petersburg, Florida, June 25, 1964, which letter is quoted as follows:

"Dear Governor Connolly:

"Thank God that He has spared you from that terrible ordeal of the assassination of Pres. John F. Kennedy!

"Since the Warren Commission has ended its investigation---so it claims, therefore, I am no longer legally and morally bound to Albert E. Jenner, 135 LaSalle St., Chicago, Illinois, who was appointed as one of the Chief Investigators by the Warren Comm., in its investigation of the assassination of President John F. Kennedy,

"On January 21, 1964, a letter was written to Albert E. Jenner, voluntarily offering him "information" pertaining to the case, secured from Lee Oswali on public contact at Punta Gorda, Florida, on October 2, 1963.

"On January 24, 1964 Attorney Albert E. Jenner graciously acknowledged my letter in which he offered "confidentiality" upon my request. He also stated that he would take advantage of my proffer to help when due time presented itself. To this very date no public contact for "confidentiality" for exchange of information, nor any mail from him.

"If the State of Texas is conducting its own investigation, therefore, I voluntarily will offer "information" and co-operation to bring the investigation to a successful conclusion.

It should be noted that previous investigation has established that LEE HARVEY OSWALD was en route from Mexico City to Dallas, Texas, on October 2, 1963, which fact has been confirmed through Mexican Immigration records.

TESSE LEE DAVIS, JR., a self-employed plastering contractor, was interviewed at his request, in respect to a telephone call received from him, at the residence of CHARLES C. HAMPTON, 4348 Mockingbird Lane, telephone number LAkesida 8-8321, where he was employed doing some plaster repair. DAVIS said he resides he was employed doing some plaster repair. DAVIS said he resides at 2715 Peabody, Dallas, Texas, and has telephone number HA. 1-7991. DAVIS advised he was born July 2, 1918, at Mount Pleasant, Taxas.

DAVIS advised that on the morning of November 22, 1963. the day President KENNEDY was assassinated, a car turned around in the driveway at his residence. DAVIS said he cannot set the exact time this occurred, but believes it was probably late in the morning. He said that, as near as he can recall, this car, make and model unknown, had either Alabama or Georgia license plates. DAVIS said he approached the car and its lone occupant. whereupon the occupant asked if he would like a tree removed from his yard. DAVIS advised he noticed there was nothing in the car which could be used in removing a tree and pointed this out to this individual. During this entire time, DAVIS stated the man in the car "just kept grinning." After seeing LEE HARVEY OSWALD on television following the assessination of President KENNEDY, DAVIS stated he is certain in his own mind that the individual who turned around in his driveway on the morning of the assassination was LEE HARVEY OSWALD.

DAVIS advised he discussed this incident with a friend named SALON MYERS, who lives somewhere on Denley Street, Dallas, Texas. DAVIS stated MYERS informed him he also observed LEE HARVEY OSWALD on November 22, 1963. He stated MYERS informed him that he saw OSWALD on East 10th Street in the Oak Cliff area of Dallas, and related that OSWALD had either driven to that location in a car or had been driven there because, when he (MYERS) saw him, he apparently had just left the car. His reason for leaving the car, MYERS informed, was because a police cruiser had stopped to question him. DAVIS said MYERS told him that, at this point, OSWALD draw a gum, ran toward the police car and shot the police officer while he was still seated in the car. After doing

DAVIS said he does not know the name of the service station, but stated there is only one located on this corner.

He said he had not planned to give the above information to the Federal Bursau of Investigation but, on May 17, 1964, he found a "San Antonio Express" newspaper in his car. DAVIS stated this newspaper was in "issue" condition and was not dirty or wrinkled. He stated he had no idea who left the paper in the car, but stated his car was unlocked and someone may have spent the night there. After finding this newspaper and after "praying," DAVIS said he decided to furnish this information to the Federal Bureau of Envestigation.

In support of the veracity of the above information, DAVIS said he would like it known that he has been "different" from his contemporaries. He advised that, as a young boy, he developed what he later learned to be a "sixth stree." This caused him much difficulty in his adolescent years, because he was so much further advanced than his friends and they, at times, did not understand him.

DAVIS advised that although he has not concentrated on this power he has, which he stated he knows must come from God, nor has he tried to develop it, he stated it still remains with him. One evening, while in his late teems, DAVIS advised he was lying on the bed at his home. He stated he had closed his eyes and, upon opening them, observed a square of light on the ceiling

and determined the source of this light to be coming out of his chest over his heart. Naturally, DAVIS stated, this frightened him and he completely covered himself. He said he tucked the covers in the bed all around him and made a little tent so he could again observe this light. He said the light continued to come from his chest and projected a picture on the blanket. He said he was horrified when he observed himself in this picture lying in a casket with his weeping mother and sister by his side. He stated he knew, if he remained living with his mother and sister any longer, he would die, and it was at this time he left home.

many similar ones, such as being able to look into a person's eyes and being able to determine if they are good or bad, or guilty or not guilty of a crime. On one occasion, DAVIS stated, he received a call from the mother of one of his friends and she asked if he knew how her son had died. DAVIS said he knew nothing of the incident, but prayed and was able to tell the woman that her son had been the victim of a stabbing on a city street.

DAVIS advised that, at times, it is very troublesome to him to be able to see things which others cannot selve. He stried he wished solve problems which others cannot solve. He stried he wished he did not have this power, but apparently this is God's will, which he accepts.

DAVIS stated he is not acquainted with and, to his knowledge, has never had any contact with LEE HARVEY CSWALD or JACK RUBY. Further, he stated that, other than the above, he had no information which might assist in the investigation of the assessination of President KENNEDY.

WILLIAMS related EUSTACE is 83 years of age, has rather poor eyesight, and has been known to let his imagination overcome his judgment on occasions. WILLIAMS recalled that on one occasion within recent months EUSTACE informed him that prior to the assassination of President KENNEDY, EUSTACE had been in a bus station at Houston, Texas, and happened to notice a man who had been in the tus station at that time. EUSTACE told WILLIAMS after he saw photographs of LEE HARVEY OSWALD in the newspapers he recalled that OSWALD looked very much like the man he had seen in the Houston bus station. WILLIAMS stated when EUSTACE told him this he did not report it to anyone because he placed no credence whatever in EUSTACE's remark and while he had no doubt that EUSTACE was an honest man, he felt with respect to this information, that EUSTACE had probably "dreamed this all up."

WALTER J. EUSTACE was interviewed at 2406 Avenue V, Galveston, Texas, and he furnished the following:

Sometime around the first of November, 1953, he was seated in the waiting room at the bus station, Houston, Texas, when a man, tall, thin, age 30's, sat down in a seal about six or eight feet from him. As well as he could recall, this man was there for about one hour. He did not converse with him. While waiting at the bus station, a bus from Dallas, Texas, arrived and a man departed from the bus with a bag on his shoulder. The above mentioned tall, thin man then followed the man with the bag on his shoulder from the bus station. A short time later, he observed the man with the bag on his shoulder, and this man remarked he was going to New Orleans, Louisiana, to visit his sister.

EUSTACE stated that after President KENNEDY was shot, he observed on television and later in the newspapers photographs of OSWALD and RUBY.

A photostat of the October 14, 1963, issue of "The Militant" was exhibited to Mrs. OSWALD and she was asked if she possessed any information indicating that LEE HARVEY OSWALD had received this issue of "The Militant." It was pointed out to her that on pages 4, 5, and 6 of this issue of "The Militant" is an article entitled "What Is Our Line? The Line Of Consistent Anti-Imperialism," a major policy speech by FIDEL CASTRO. Mrs. OSWALD stated she did not know if her husband, LEE HARVEY OSWALD, had received this issue, October 14, 1963, of "The Militant" or if he had reed the article appearing on pages 4, 5, and 6 of this issue. Mrs. OSWALD further stated that her husband, LEE HARVEY OSWALD, had not discussed this article with her or made any remarks concerning this particular speech by CASTRO which would indicate he had read "The Militant" for October 14, 1963.

Mrs. OSWALD advised that in early December, 1963, while she was living at the residence of her then business manager, JAMES H.

MARTIN, in Dallas, Texas, she recalls that four newspapers were forwarded to her from New Orleans, Louisiana. She stated two of these newspapers were two issues of "The Militant," one issue of "The Worker," and she believes the other was a Russian language newspaper. She stated she does not recall who delivered these newspapers to her but definitely recalls that they had been forwarded from the post office box that LEE HARVEY OSWALD had rented in New Orleans, Louisiana. Mrs. OSWALD stated upon receiving these newspapers she threw them in the trash since they were addressed to LEE HARVEY OSWALD, and he was dead. She further stated she had no interest in them. She also stated she had no idea of the dates of these particular newspapers. She also stated she does not know if the October 14, 1963, issue of "The Militant" was among the newspapers she threw away.

MICHAEL R. PAINE, 2515 W. 5th Street, Irving, Texas, was interviewed at his place of employment, Bell Helicopter Company Research Laboratory, Arlington, Texas.

He was exhibited the October 14, 1963, issue of "The Militant" and it was pointed out to him that this particular issue of "The Militant" on pages 4, 5, and 6 contains an article entitled "What Is Our Line? The Line Of Consistent Anti-Imperialism," a major policy speech by FIDEL CASTRO. PAINE stated he had no information that IEE HARVEY OSWALD received the October 14, 1963, issue of "The Militant" or any information that OSWALD had read that particular article appearing in the October 14, 1963, issue of "The Militant." PAINE stated he did not discuss the October 14, 1963, issue of "The Militant" with OSWALD nor did OSWALD make any comments to him regarding this particular issue of "The Militant" or regarding any articles appearing in this particular issue of "The Militant."

PAINE stated that his discussions with OSWALD usually involved discussion of communism and Russia, and he only recalls one occasion in October, 1963, when OSWALD mentioned CASTRO. This was following a meeting of the American Civil Liberties Union in Dallas, when LEE HARVEY OSWALD stated that a certain individual at this meeting, whom MICHAEL PAINE did not know, might be a communist since he spoke in favor of FIDEL CASTRO and CASTRO's regime in Cuba.

PAINE advised he had no information regarding any mail forwarded to OSWALD at 2515 W. 5th Street, Irving, Texas, either prior to or subsequent to the assassination of President KENNEDY. PAINE pointed out that in September, 1962, he moved from 2515 W. 5th Street, Irving, Texas, at which time he was estranged from his wife and did not move back to his Irving residence until a few days following the assassination of President KENNEDY. PAINE stated that his wife, RUTH PAINE, always removed the mail from the mailbox and stated he saw only the mail addressed to him. He said he had no information concerning any mail that may have been forwarded to LEE HARVEY OSWALD at 2515 W. 5th Street, Irving, Texas, from his post office box in New Orleans, Louisiana.

She said she does not know the date of this issue of "The Militant" since she did not take it out of its wrapper. She stated that OSWALD had one issue of "The Worker" addressed to him at 2515 West 5th Street, Irving, Texas, and one copy of a Russian newspaper. She said she does not know the date appearing on any of these newspapers since she did not open the jackets. She advised that the one issue of "The Worker" and the copy of a Russian newspaper arrived, addressed to OSWALD at 2515 West 5th Street, living, Texas, sometime during the approximate period November 12, 1963, to November 29, 1963, but she did not know the exact date each arrived. She said she destroyed all three of the above-described items sometime within a week or so after the assassination and she further advised that MARINA OSWALD did not see any of these items.

Mrs. PAINE advised that no mail was forwarded to LEE HARVEY OSWALD at 2515 W. 5th Street after November 22, 1963. She stated she is positive that no mail was forwarded to LEE HARVEY OSWALD from New Orleans, Louisiana, following November 22, 1963.
