Under date of September 17, 1964, the FBI Laboratory furnished the following information concerning an examination requested by the Dallas Office on August 31, 1964:

Specimens received September 3, 1964

D-251 Hard-cover journal bearing handprinted title on first page "DIARY OF IMPRESSIONS & OBSERVATIONS OF ERIC RITZEK BEGAN SEPT. 5, 1963"

Result of examination:

The submitted specimen, D-251, was examined cryptanalytically and the following determinations effected:

Some of the cryptic symbols following the entry dated October 22, 1963, are copied from electronic symbols. Others may be attempts to generate writing resembling shorthand. No valid meaning could be derived from these symbols.

The entry dated October 24, 1963, may be an attempt to fabricate writing resembling a foreign language. The Latin phrases "In hoc signo vinces" and "per aspera ad astra" are set forth consecutively in the entry. The former quotation means "In, or by this sign thou shalt conquer" and is a motto said to have been adopted by the Emperor Constantine after seeing a vision of the cross. The latter means "To the stars by hard ways" and in the reverse order "Ad astra per aspera" is the motto of the State of Kansas.

The above entry also contains isolated words in Latin, Spanish, German, Russian, and Scandinavian and possibly other languages. Other than mentioned above, no valid meaning was derived from this entry.

The entry following the January 3, 1964, entry appears to be an invalid mathematical formula. The entry on the following page has the appearance of a sketch of a solar system. The first word above the sketch appears to be "moon" but the remaining writing is illegible.

The symbol of the skull with crossed cigarette and pistol with connecting rod appearing on the third page from the end of the written material would appear to be a representation of the views expressed immediately preceding and following the symbol concerning death, cigarette smoking and drivers.

In general, the cryptic entries in the submitted specimen evidence the characteristics of being randomly generated with no valid meaning. These cryptic entries are very similar to entries observed from other sources which are frequently derived from demented minds.

V. BACKGROUND -- INTERVIEWS WITH MARINA NIKOLAEVNA OSWALD, NEE PRUSAKOVA, ALSO KNOWN AS MRS. LEE HARVEY OSWALD; DATA RELATING TO HER AND LEE HARVEY OSWALD; AND INFORMATION CONCERNING OFFER TO MARINA OSWALD TO LIVE AT RESIDENCE OF WALTER NEUNSON, CAMDEN, NEW JERSEY

Date September 8, 1964

MARINA OSWALD was interviewed at a cabin at Lake Tawakoni, in which she was residing temporarily with PRISCILLA JOHNSON, with whom she is collaborating on a book. She was interviewed in the English language.

MARINA was questioned as to whether to her knowledge LEE HARVEY OSWALD had prepared any written material, such as a letter to her or any other document, prior to the assassination of President KENNEDY on November 22, 1963. It was pointed out to her OSWALD had left a note for her on the occasion that he attempted to assassinate General WALKER, and he had furthermore left his wedding ring in MARINA's room at the PAINE house on the evening before or the morning of the assassination of President KENNEDY.

MARINA said she had made available everything in the way of documents, books and other articles which could be considered pertinent to the investigation of the assassination or the inquiry into OSWALD's background. She stated that to her knowledge OSWALD had not prepared any letters or other documents prior to the assassination of President KENNEDY.

She was asked if OSWALD had said anything in her presence or performed any act which to her mind would lead her to believe that he intended to perform some act similar to the attempted assassination of WALKER.

She answered that OSWALD's leaving of his wedding ring at the PAINE house and his directions to her to buy needed articles for herself and the children, as well as the fact he visited her on Thursday night instead of his usual week-end visit and told her he would not return to the PAINE house the following day, Friday, were unusual circumstances, but these did not strike her as important incidents in themselves until her reflection upon the things that had happened in the time leading up to the assassination.

She said she had discussed all of these things with the FBI and with representatives of the President's Commission. She said she has sincerely tried to aid in the investigation of the assassination and will continue to do so. She said that to the best of her knowledge she has informed the FBI and the President's Commission of all information which might be of value in this investigation.

MARINA was questioned as to whether she had ever stated OSWALD had had the intention of killing President EISENHOWER. She stated she had never heard OSWALD make such a remark, nor did she have any information which would indicate OSWALD had any such intention. She said she has no idea whatever as to how such a rumor could have started; that is, that she had said that OSWALD had the intention of killing President EISENHOWER.

MARINA was questioned concerning the reported radio broadcast of OSWALD in Moscow. At the time of MARINA's first visit to Moscow with OSWALD, he referred to his address book to find a name of an individual. It was OSWALD's intention to call this person on the telephone. He showed the name to MARINA. This name she has identified from a photograph of one page of OSWALD's address book which contains the name written in the Latin alphabet, "LEO SETYAEV". MARINA said this written name, as well as the line immediately above it and three lines immediately below it, all of which are written in Cyrillic handwriting, were not written by OSWALD or by her. She said she could not identify the person who performed this handwriting.

MARINA said OSWALD tried to contact this person, but had been unsuccessful. MARINA asked OSWALD who this individual LEO SETYAEV was. OSWALD replied he was a man who had helped him make some money shortly after his arrival in Moscow by assisting him in a broadcast for Radio Moscow. MARINA asked OSWALD what he had said, and he told her he had criticized the United States and said Russia was a better place in which to live. MARINA asked him why he had said this, and OSWALD replied it was necessary to make this propaganda because at the time he had wanted to live in Russia.

MARINA said OSWALD had remarked to her of the visit of LEO SETYAEV to him at the Hotel Metropole in Moscow. MARINA connects this visit to OSWALD by SETYAEV at the Hotel Metropole to the broadcast reportedly made by OSWALD over Radio Moscow.

She advised further SETYAEV had taken a photograph of OSWALD during his visit to the latter at the Hotel Metropole. This photograph is one of the photographs of OSWALD presently in possession of investigators of the assassination as MARINA

recalls seeing it. It is the photograph of OSWALD standing in a room, in which he wears a black suit, a white shirt, and a tie. MARINA said OSWALD looks quite serious in the photograph. The photograph is about 5" by 7" in size. MARINA said it was obvious to her OSWALD was quite worried in this photograph because she noticed that a vein was standing out very noticeably on the right side of his face.

MARINA said she does not know anyone by the name of LEO SETYAEV, nor has she, to her knowledge, ever met the individual whom OSWALD said assisted him in the broadcast over Radio Moscow. She said she does not know any member, nor has she ever seen to her knowledge any member, of SETYAEV's family or any person who worked in Radio Moscow.

MARINA was exhibited the following photographs which were obtained from LILLIE MAY RAHM at Ketchikan, Alaska, on August 4, 1964. RAHM is the mother of ANITA MAY SETYAEVA. These photographs are described as follows:

MARINA could identify none of the individuals appearing in these photographs. When the above described photographs were examined by MARINA OSWALD in the presence of interviewing Agents, no unusual reactions were noted.

MARINA OSWALD was interviewed at her residence, 629 Belt Line Road. Present during this interview was DECLAN FORD, who is MARINA's adviser.

MARINA OSWALD was requested to produce for perusal of the interviewing Special Agent all material presently in her possession which may have been the property of LEE HARVEY OSWALD, including any writings of OSWALD and any writings to him. She was further requested to produce any items belonging to her, exclusive of personal items such as wearing apparel, which were in her possession as of November 22, 1963. MARINA was also asked to produce any additional correspondence she may have received from the Union of Soviet Socialist Republics (USSR) subsequent to the assassination.

MARINA said she does not have, to her knowledge, anything that could be considered solely the property of LEE HARVEY OSWALD as all of his property is presently in the hands of officials concerned with the assassination investigation. MARINA made available for examination various documents, books, photographs and other property, which she said was all of her property, exclusive of personal wearing apparel, which she had in her possession as of November 22, 1963. The property made available by MARINA was examined by the interviewing Agent in the presence of MARINA and DECLAN FORD. The following articles, which might be considered of possible pertinence to this investigation, were taken and a receipt was given to MARINA OSWALD:

- (1) Book written in Russian for study of English with note on flyleaf written to MARINA OSWALD by Mrs. RUTH PAINE. Book has blue cover with red lettering.
- (2) Book entitled "English" for study by Russian-speaking persons. Book cover has picture of English alphabet.

By letter dated September 3, 1964, the President's Commission on the Assassination of President KENNEDY requested investigation to determine if RUTH PAINE was ever a customer in Hutch's Super Market, 2333 West Shady Grove, Irving, Texas, and to obtain from Mrs. PAINE certain additional information concerning her knowledge of LEE HARVEY OSWALD. This letter also requested reinterviews of MARINA OSWALD and MARGUERITE OSWALD along the same lines and, in particular, requested that a determination be made whether MARINA OSWALD, MARGUERITE OSWALD and LEE HARVEY OSWALD ever shopped together at Hutch's Super Market on a Wednesday evening sometime during October or November, 1963.

RUTH PAINE, 2515 West Fifth Street, was interviewed at her residence. She said she has resided in Irving for approximately five years and, as best she can recall, she has only been in Hutch's Super Market, 2333 West Shady Grove, Irving, Texas, perhaps once or twice. She said she believes that the only time she ever went into Hutch's Super Market was to buy some milk. She believes that it is possible MARINA OSWALD was with her on one occasion that she went into Hutch's Super Market, but she does not recall whether or not MARINA actually went into the store with her or waited in the car. She said she could not remember the date that she had actually gone into Hutch's Super Market. She said she believes the occasion on which MARINA was with her when she went to Hutch's Super Market was sometime in March or April, 1963, and MARINA was visiting her for the day during the time that the OSWALDs were living on Neely Street in the Oak Cliff Section of Dallas, Texas. She said she cannot recall another specific occasion when she was a customer at Hutch's Super Market, but she has a vague recollection that she may have purchased ice at this store on one occasion.

She said LEE HARVEY OSWALD had never been a customer of Hutch's Super Market, to her knowledge.

She recalls that she passed by Hutch's Super Market on the day she took OSWALD to the Oak Cliff driver examination station because the route she took included West Shady Grove. She is sure that she did not stop at Hutch's Super Market on that occasion.

She said she can recall one occasion on which MARINA fixed a lunch for LEE HARVEY OSWALD which he took with him to work on a Monday morning after he had spent the week end at her house. She said there may have been other occasions but she cannot specifically recall that there were. She believed the one occasion that she can recall in which MARINA fixed a lunch for OSWALD was in late October or perhaps early November, 1963.

She said she had never seen OSWALD drink large quantities of milk or any other liquid. She said she seemed to recall OSWALD liked sweet rolls and would generally eat sweet rolls, if Mrs. PAINE had them, with coffee on the Monday mornings following his week ends at the PAINE house.

Mrs. MARGUERITE OSWALD, 2220 Thomas Place, mother of LEE HARVEY OSWALD, advised that she does not know if she will answer any questions that the President's Commission may ask, as she had tried repeatedly this past weekend to contact members of the Commission when they were in Dallas, and they refused to answer her telephone calls or to return any calls that she made to them. Mrs. OSWALD said this upset her a great deal, and therefore, she is "very mad" at the Commission; however, Mrs. OSWALD stated for SAS EARLE HALEY and ROBLEY D. MADLAND to ask her any question and she would decide if she would answer the question.

Mrs. OSWALD stated that she had not seen her son, LEE HARVEY OSWALD, for about one year prior to the assassination of President JOHN F. KENNEDY, until her son's arrest in Dallas on November 22, 1963. Mrs. OSWALD stated further that she did not know anything about her son's activities or his life during the time that he resided in Dallas or in Irving, Texas during the fall of 1963, because she was not in contact with him during that period of time.

Mrs. OSWALD stated that she does not know if her son took a bag of lunch with him to work during October and November of 1963, but would assume that he did not, because of the fact that she understands he was residing in a rooming house in the Oak Cliff section of Dallas, and does not know if he had kitchen privileges.

Mrs. OSWALD stated further that she was never with her son and his wife, MARINA, at Hutch's Super Market in October or November, 1963, and never shopped with them in Irving at any time. Mrs. OSWALD said further that to her knowledge, her son never had a habit of eating cinnamon rolls with large quantities of milk.

Mrs. OSWALD expressed a keen curiosity concerning the location of Hutch's Super Market in Irving, Texas, and stated that she believed that she would conduct her own investigation and possibly contact Hutch's Super Market, because she felt that she could learn a great deal of information, because she was the "sorrowing mother" and that people "just tended to give more information" to her than they would investigators. Mrs. OSWALD said "I am a sorrowing mother", but still more "I am a very good investigator."

MARINA OSWALD was interviewed at her home, 629 Belt Line Road. Present during this interview was Mr. DECLAN FORD, who is MARINA OSWALD's adviser.

She was interviewed concerning whether or not she had ever been a customer of Hutch's Super Market, 2333 West Shady Grove, Irving, Texas, and concerning other questions requested by the President's Commission on the assassination.

MARINA said to her knowledge she had never been in Hutch's Super Market at Irving, Texas, nor had her late husband, LEE HARVEY OSWALD. She said she does not believe LEE HARVEY OSWALD ever had a check for \$189.00 in his possession during the time they lived in the United States. She has no information indicating OSWALD ever tried to cash a check for \$189.00 at Hutch's Super Market, 2333 West Shady Grove, Irving, Texas. She stated when she lived at Mrs. PAINE's house, she generally traded at the A and P Grocery Store in Irving, and she went generally with Mrs. PAINE. She said she could recall one occasion on which OSWALD had attempted to cash a check which was refused. She believed this occurred in New Orleans, Louisiana. She was with him on that occasion but was in another part of the store when he tried to cash the check. She believed this was one of the \$33.00 unemployment checks which OSWALD received. She cannot be sure of the date. She is sure that OSWALD did not try to cash this check at Hutch's Super Market in Irving, Texas. She stated further she had never shopped at Hutch's Super Market on any Wednesday evening during October or November, 1963, with LEE HARVEY OSWALD and his mother, MARGUERITE OSWALD, as she had never been in Hutch's Super Market, to her knowledge. Furthermore, she does not recall shopping together with MARGUERITE OSWALD and LEE HARVEY OSWALD. She said she does not recall whether or not OSWALD cashed a \$33.00 check at the A and P Store in Irving, Texas, or any other place, on October 31 or November 1, 1963.

Concerning whether or not LEE HARVEY OSWALD took lunches to work on the Monday mornings following the week ends which he spent at the PAINE house, MARINA OSWALD advised as follows:

She stated she believed she had fixed lunch for OSWALD on about three occasions. On these occasions, she fixed the lunch at night, put it in a paper bag, and then put the lunch in the ice box. She would usually fix a sandwich, perhaps of cheese, sometimes of chicken, and also put fruit in the bag. She did not get up in the morning when OSWALD left for work. She cannot recall the exact occasions on which she fixed these lunches.

Concerning the question as to whether OSWALD was in the habit of eating cinnamon rolls with large quantities of milk, MARINA said that OSWALD liked sweet rolls but did not ever drink much milk because it was expensive and whatever milk the family had was mostly left for the children. If he drank milk, one glass was the usual quantity taken. He did like milk, however, but never drank it in large quantities, to MARINA's knowledge. She said when she was residing at Mrs. PAINE's house, she did not fix OSWALD's breakfast on the Monday mornings he was at the house and was not aware of what he had eaten, if, in fact, he had eaten breakfast on these occasions. She said she believed, however, he would eat sweet rolls or toast with coffee. She said during evening meals when OSWALD was at the PAINE house, she, MARINA, would fix iced tea for him.

On September 14, 1964, SA RICHARD J. BURNETT clocked the mileage from the house of RUTH PAINE, 2515 West Fifth Street, Irving, Texas, to the Hutch's Food Mart, which is commonly referred to as Hutch's Super Market, 2333 West Shady Grove Road, Irving, Texas, as .8 miles.

There are only two logical ways to walk the route between Mrs. PAINE's residence and the grocery store, and they are as follows:

1. From Mrs. PAINE's residence, 2515 West Fifth Street, east to Westbrook Drive; south to Tenth Street; southeast to 11th Street; east to South Storey Road; and then south to the northeast corner of West Shady Grove Road and South Storey Road, on which corner the grocery store is located. It takes approximately 13 minutes to walk this route at a normal man's pace.

2. From Mrs. PAINE's address, 2515 West Fifth Street, east to South Storey Road, and then south on South Storey Road to the northeast corner of West Shady Grove Road and South Storey Road, takes approximately 14 minutes walking at a normal man's pace.

The following information supplements that contained in a letter to the President's Commission, dated September 15, 1964, from Federal Bureau of Investigation Headquarters, Washington, D. C., relating to translations of foreign language material in Exhibits D-244 through D-248 and to WALTER NEUNSON, referred to in Exhibit D-248.

RUTH PAINE was interviewed at her residence, 2515 West Fifth Street, Irving, Texas. She was questioned concerning her contact with WALTER NEUNSON, who reportedly had offered MARINA OSWALD a place to stay at his home. She said she recalled WALTER NEUNSON had called her on the telephone from New Jersey to extend to MARINA through her an invitation that MARINA could come to live at his home with his family. She stated she considered NEUNSON's offer to be very generous and that she thought it might have been good for MARINA to live in a large Eastern community where there would be more Russian-speaking persons. She said she had written a letter to MARINA not too long after the assassination to tell MARINA of the offer of NEUNSON, as well as financial offers from other persons. She said she cannot recall now whether she returned NEUNSON's call or if he called her a second time. She said she recalled NEUNSON said MARINA had met his son, EDWARD. She did not discuss this point further with NEUNSON and cannot add anything in this regard. She did not receive an answer from MARINA with regard to her letter telling of NEUNSON's offer. She said she had had no prior contact with NEUNSON and had not been in contact with him since the two occasions noted above.

Mrs. PAINE advised the notations on the back of one of the envelopes containing a letter written by her to MARINA OSWALD, which notations are "Maria Martin AD 9-56-42 Marina Kataya Ford", are not her notations. She said she recognized the name "Kataya Ford" as the name of MARINA's friend, Mrs. DECLAN FORD, whom she, Mrs. PAINE, also knows. She does not know anything about the name "Maria Martin" or the telephone number "AD 9-56-42". She presumes the name "Marina" refers to MARINA OSWALD.

MARINA OSWALD was interviewed at a cabin in which she was staying with PRISCILLA JOHNSON, her collaborator on a book. During this interview, Mr. DECLAN FORD, adviser to MARINA, was present. PRISCILLA JOHNSON was not present.

MARINA was questioned concerning Exhibit D-248, which is comprised of two letters in the Russian language directed to MARINA by RUTH PAINE; D-245, a letter in the Russian language directed to the OSWALDs from PAVEL GOLOVACHEV; D-247, a handwritten letter in the Russian language to the OSWALDs from "OLYA" and "KOLYA"; and D-246 and D-247, which are letters to MARINA from GALINA KHONTULEVA.

MARINA said she recalls receiving the letter from RUTH PAINE, which furnished information that a Mr. WALTER NEUNSON had offered a place to live to her. She stated she did not know this Mr. NEUNSON and had never written him nor talked to him on the telephone, nor had she received any letters from NEUNSON. She said she had not answered RUTH PAINE's letter concerning NEUNSON. She advised she recalls that RUTH PAINE said NEUNSON told her that MARINA had met NEUNSON's son, EDWARD. MARINA said she could not recall this "EDWARD".

Concerning a person named "EDWARD" whom she had known in Russia, MARINA stated she recalled one young man named "EDWARD" whom she met in Leningrad, Russia, on Russian Revolution Day, November 7 or 8, 1960. She said on this occasion, she was with a young man acquaintance, OLEG TARUSIN, and they were in attendance at a dance at one of the buildings of Leningrad University. She was introduced to this young man, whose name was "EDWARD", and she danced with him. The next day she recalls she visited the apartment

of this "EDWARD" with her friend, OLEG TARUSIN. There was no one else in the apartment on that occasion except the three of them to the best of MARINA's knowledge. She said she cannot recall this "EDWARD's" last name or anything else about him except his appearance. She said "EDWARD" was dressed well in clothes which appeared to be other than Russian in origin. She said he was handsome and had a thin appearance. His eyes were dark and he had dark blond hair. She did not see him again after these two occasions.

MARINA stated she could think of no other person named "EDWARD", who might possibly be identical with the son of WALTER NEUNSON named "EDWARD".

MARINA said the writing on the reverse side of one of the envelopes, which contained one of the above-mentioned RUTH PAINE letters, which writing is "Maria Martin. AD 9-56-42 Marina Kataya Ford", were notes made by either her or JAMES HERBERT MARTIN. She said she would have to examine the handwriting to determine who prepared it. She said the name "Maria Martin" referred to her, MARINA, as this was the name under which she had a joint account with JAMES HERBERT MARTIN of moneys which had been donated to her. She said the telephone number AD 9-5642 is the telephone number of her friend and adviser, DECLAN FORD. It will be noted that this telephone number presently is that of DECLAN FORD. She said the name "Marina" pertains to her and the name "Kataya Ford" refers to her friend, Mrs. DECLAN FORD.

MARINA said she has not received any correspondence from PAVEL GOLOVACHEV subsequent to the assassination. The only correspondence she has received from Russia since the assassination have been the two letters from GALINA KHONTULEVA.

She said the person mentioned in Exhibit D-247 - VALERIK VINOKUROV - was a friend of hers in Russia. She said VINOKUROV is a young man about her age who lives in Minsk with his parents. His father is Vice President of the Academy of Science of Belorussia, in Minsk. She does not know his father's name. VINOKUROV was one of the group of friends with whom MARINA associated in Minsk just prior to the time she was married. She stated VINOKUROV was attending the Polytechnical Institute in Minsk at the time she knew him.

She stated that "LYALYA", who is mentioned in the letter labeled Exhibit D-247, is identical with LARISSA PETROVANA PETRUSEVICH, who is another of her friends in Minsk. MARINA considered PETRUSEVICH to be one of her best girl friends.

MARINA advised that she has copies of Exhibits D-246 and D-244, which are the letters from KHONTULEVA noted above.

A review of such telephone calls fails to reflect that any one of them was to telephone number WO 4-0357, Camden, New Jersey, which, according to Exhibit D-248, is the telephone number of WALTER NEUNSON.

Mrs. RUTH PAINE was interviewed at her home, 2515 West Fifth Street on September 22, 1964. She made available a letter to her from Mr. WALTER NEUNSON, 909 North 24th Street, Camden 5, New Jersey. Mrs. PAINE said that in the previous interview had with her concerning NEUNSON, she had not been sure she had received a letter from NEUNSON, and if so if she had retained it. She said she had searched through her personal files and had found the letter and desired to make it available for examination and consideration in connection with this investigation. She said she desired this letter be returned to her when it had served its purpose. She explained the letter had been written to her following the previously mentioned telephone call made to her by NEUNSON in which he invited MARINA OSWALD to reside with him in his home.

The letter is written on two sides of one sheet of paper and is without an envelope. It is quoted verbatim as follows:

"Hello Dear Mrs. Ruth Paine

"After talking to you on phone I talk to my wife, told her that Mrs. Marina was not living in your home. So I will write you and hope you will help in some way. I am sending letter for Mr. Marina Nickoloivna Oswald. I wrote to her in Russian so she will under stand the situation. I wrote her, asking her to give me her answer on my letter what she want to do; My wife and rest of the family wanted her to come. I talk to some of the Russian families they are here about 5 year they also said it

It will be better here, people will cool off and she will raise the children, I will help her as father to her. Will you please forward the letter to her in person. I will be waiting from you, please write what you have news about Marina. I will be very thankful to you and your husband. If I hear from her I will let you know. DECLAN FORD, adviser to MARINA OSWALD, furnished the following information:

He said that in anticipation of the release of the President's Commission report, MARINA OSWALD had been interviewed by representatives of the three major radio-television networks, ABC, NBC and CBS. These interviews were filmed. Mr. FORD said the interviews with CBS and ABC had been given free by MARINA, but upon being approached by NBC, MARINA had requested \$10,000 for an interview, and had finally settled with NBC for \$5,000, which was paid her and the interview was made and taped. Mr. FORD said these interviews are to be released immediately following the issuance of the Commission's report.

Mr. FORD also advised that PRISCILLA JOHNSON, the person with whom MARINA is collaborating on a book, intends to proceed with MARINA OSWALD to a relative's house in Santa Fe, New Mexico, upon the issuance of the Commission's report in order that MARINA will not be bothered by newsmen and, thereby, distract her from her attention to the preparation of the book.

Mr. FORD advised he would keep the FBI advised as to the whereabouts of MARINA.

Mrs. RUTH PAINE, 2515 West Fifth Street, Irving, Texas, was interviewed at her place of residence.

Mrs. PAINE stated that she recalls that in the one letter that she had received from WALTER NEUNSON, 909 North 24th Street, Camden, New Jersey, which was dated November 28, 1963, NEUNSON had commented in his letter that he was sending another letter written in Russian to MARINA OSWALD. Mrs. PAINE stated that this latter letter to MARINA OSWALD was enclosed in Mrs. PAINE's letter from NEUNSON.

Mrs. PAINE stated that she sent the NEUNSON letter for MARINA OSWALD, as well as the envelope which enclosed her letter and MARINA's letter from NEUNSON, to MARINA through the Irving Police Department, who was acting as the intermediary between herself and MARINA OSWALD for a short period of time subsequent to the assassination of President KENNEDY.

Mrs. PAINE stated that she does not have this letter from NEUNSON to MARINA OSWALD and does not know its present whereabouts, unless MARINA has it herself. She noted that MARINA OSWALD had never discussed this particular letter with her.

Mrs. PAINE added that she does not know the nature of the contents of the letter from NEUNSON to MARINA OSWALD.

Mr. DECLAN P. FORD, friend and adviser of MARINA OSWALD, 14057 Brookcrest, Dallas, Texas, telephonically advised that MARINA OSWALD as of this date is staying in seclusion with her writer, Miss PRISCILLA JOHNSON, at the home of a relative of Miss JOHNSON's in Santa Fe, New Mexico.

Mr. FORD identified this relative as DAVID DAVENPORT whose telephone number is "505-9820817". The "505" is the Area Code number for Santa Fe, New Mexico.

Mr. FORD stated that he suggests that when contacting MARINA OSWALD at this Santa Fe telephone number, that the Agent ask to speak to Miss JOHNSON, and not to ask for MARINA OSWALD. He continued that the Agent should then identify himself to Miss JOHNSON and explain to her the purpose of the call.

Mr. FORD continued that to the best of his knowledge, the present whereabouts of MARINA OSWALD is unknown to the news media who have been trying to locate her and interview her regarding the published report of the President's Commission.

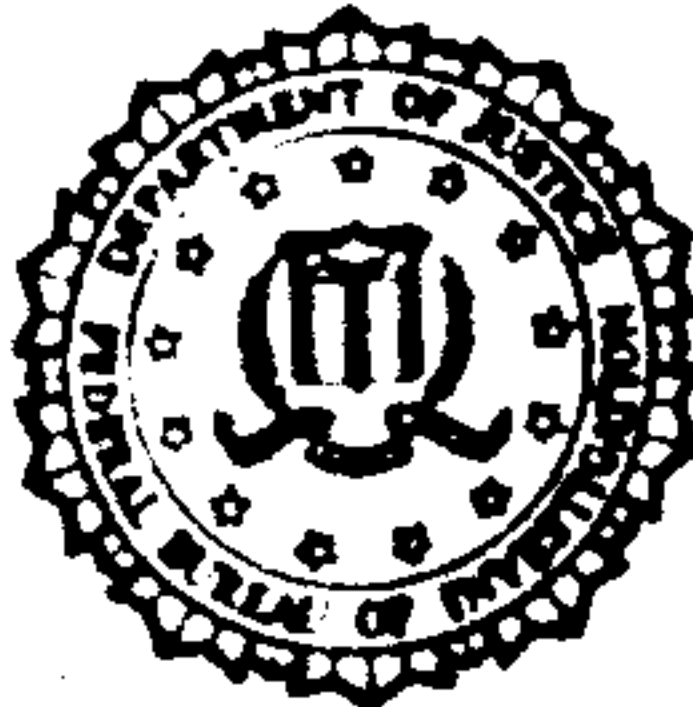

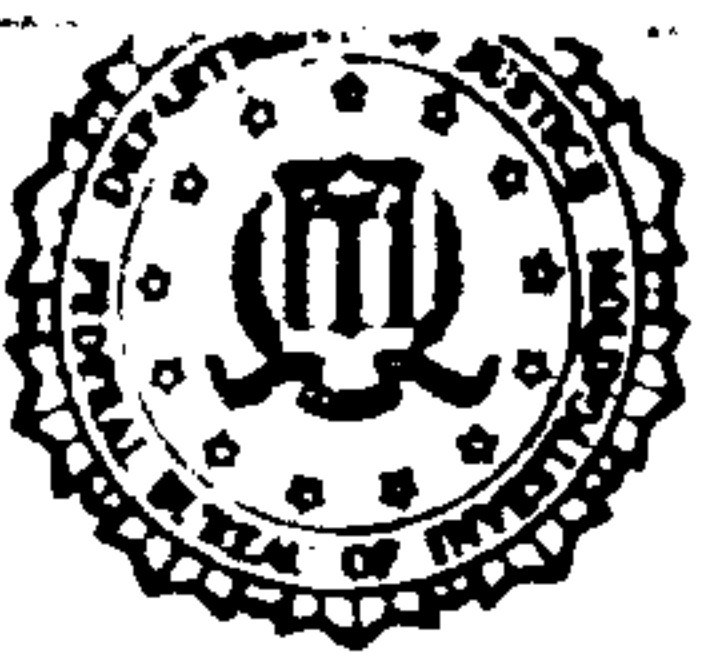
