SI Claim of Lee R. Gould, S. S. No. 433-24-2037

Set out below is the history from our claim records pertaining to this individual.

On April 12, 1963, Gould filed a claim in our Dallas Office listing Jagger-Chiles-Stoval, 212 Broadway, Dallas, Texas, as his last employer. He showed that he was separated on April 5, 1963, because "I was laid off by John Graves, head of the photography and art department, due to lack of work." He showed his occupation to be photographer and his age to be 21. He listed his address as 214 W. Hoaly, Dallas 6, Texas.

On April 16, he was mailed a determination disapproving his initial claim because of insufficient wage credits. The only wage credits which were shown were from Lowry-R-Pack Div., which is Leslie Welding, Inc., 200 East North Tarrant Street, Fort Worth, Texas. On April 29, 1963, he filed a disagreement from New Orleans, Louisiana, showing that he should also have wage credits from Jagger-Chiles-Stoval. These wages were found (they had been reported by the company under an incorrect social security number), and a new determination approving his claim was issued on May 8, 1963. This determination approved his claim for maximum benefits of \$369 payable at the rate of \$33 per week. Thereafter he filed claims as indicated below:

There is no indication that we had any correspondence with Gould other than through routine claim actions.

We have checked our microfilm records back to 1937 and find no prior claim actions by this individual.

We are requesting photographs of the cancelled warrants from the Treasury Department.
