On 11/27/63, Detective L. D. ~~STRINGFELLOW~~, Special Service Bureau, Dallas PD, advised that he had determined that JACK RUBY had guaranteed service for NICK and BUDDY TURMAN, 4531 Columbia, Apt. 101, Dallas, Texas, for telephone TA. 4-6229, to The Southwestern Bell Telephone Company in Dallas. Detective ~~STRINGFELLOW~~ said this was no longer a working number, that NICK and BUDDY TURMAN had submitted a letter to the telephone company guaranteeing the payment of any telephone bill of the TURMANS. It was ~~STRINGFELLOW~~'s understanding that calls had been made from telephone number TA. 4-6229 to Bastrop, Baton Rouge, New Orleans, Tyler, Los Angeles, and perhaps other towns and cities on this telephone. He did not know whether the TURMANS have had another phone installed.

On 11/29/63, Captain W. P. GANAWAY, WA, Special Service Bureau, Dallas PD, advised he had ascertained the following information concerning JACK RUBY:

RUBY places ads in the Dallas Morning News twice a week for his Carousel Club, and is well known at the Dallas Morning News. On 11/22/63, at 11:45 AM, he placed such an ad to be run in Saturday's paper. The deadline for such ads is noon, and it was because of the nearness to the deadline that employees in this office remember RUBY being present at this precise time. While there RUBY talked to DON CAMPBELL and GEORGIA MAYOR. They have advised he stayed much longer than was his usual custom and he was in this office at the time President KENNEDY was shot. During the time he sat at MAYOR's desk, from which he could look north on Houston Street and have a good view of the Texas School Book Depository. While at the Dallas Morning News RUBY made a telephone call but Captain GANAWAY had no information regarding this call.

Employees in this office stated RUBY made a point to be seen and heard by other people in the office during his presence there. These employees stated RUBY had no reason for staying such a long period of time.

The St. Louis Division had furnished Dallas FD-302 setting forth results of review of RUBY's military record at the MPRC, St. Louis, Missouri. The information so provided, however, did not contain details of RUBY's medical history while in the service. In view of this, writer telephonically contacted Security Patrol Clerk MIKE BORGARD, St. Louis Office, at 7:30 PM, 11/28/63, and instructed that MPRC records as they relate to RUBY be rechecked and his complete and detailed FD-302 forwarded setting forth medical history on RUBY.

The above is considered of significance in view of rumor to effect RUBY supposedly has a metal plate in head and that such may be used as basis for his defense in forthcoming trial.

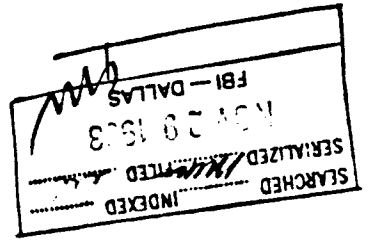
