The informant had no information indicating that members of the Arkansas Association of Klans of the KKK were going to Dallas on 12/23/63 to picket in behalf of JACK RUBY at the time he has his hearing to be released on bond. Informant stated he would make necessary inquiries to determine if anyone was going and would immediately advise of any positive information.
