Mr. WILBUR SCHWEMLEIN, Registrar, Veterans Administration Hospital (a psychiatric hospital), advised as follows:

Huntington, W. Virginia, was admitted to this hospital December 11, 1963. On December 11, 1963, the same day of admission to this hospital, Mr. JAMES CROUCH, Chief, Benefits Control Section, Veterans Administration Hospital, Huntington, W. Virginia, had telephonically furnished the following information to the Veterans Hospital, Chillicothe, Ohio:

had come to the Hygiene Clinic at Huntington, W. Virginia, voluntarily where he was examined by Dr. YOUNG (not further identified) who expressed the opinion that emergency hospitalization of would be desirable. His condition was diagnosed as "depressive reaction and alcohol addiction chronic". During this visit to the Hygiene Clinic at Huntington. reportedly stated that following the assassination of President KENNEDY he took an airplane to Dallas, Texas, carrying with him two pistols. He intended_to kill LEE OSWALD, however, the plane on which was traveling was two hours late getting to Dallas and on arrival, he learned that OSWALD had already been killed. to Huntington, W. Virginia, and gave his guns to the FBI.

Mr. CROUCH of the Veterans Administration Hospital, Huntington, W. Virginia, in furnishing this information to the Veterans Hospital in Chillicothe, Ohio, was unable to confirm story.



Inspector JAMES R. MALLEY telephonically advised that we should go ahead with the interview and that the same should be conducted in a very businesslike manner. He suggested that we stick to the questions that the Bureau has previously set forth. He said that definitely the Agents should control the interview and if there is any attempt on the part of BELLI or whatever attorney representing him present to interfere or tell RUBY not to answer the questions, then we should tactfully terminate the interview and tell this man that we do not care to proceed with it under those circumstances. Certainly, there should be no recording made of this interview. In other words, we are to dominate and set the conditions under which the interview is conducted.

In the event Mr. BELLI or RUBY, or whatever attorney represents him, states that he wants his client to take a polygraph examination, we should advise that we have no desire to give him a polygraph examination and certainly, no truth serum. If they want to give him a polygraph examination, they can do so on their own or if they want to ask the police to give him one, that is their business.

I pointed out to him that I have been questioned by the newspapers and that I would like to furnish the following answers to the newspapers after the interview has been conducted:

- 1. We did not and do not desire to give RUBY a polygraph examination.
- 2. In answer to the question as to whether we are investigating the murder of OSWALD, I would like to state were not investigating the murder of OSWALD by RUBY, but that we are conducting a Civil Rights investigation at the request of the Department and that the local murder case is strictly a local murder case.




