



She said she was CAIN'S wife and advised that CAIN had been missing for two weeks and she had no idea as to his whereabouts. She said he left his employment at the French Market in Kansas City, Missouri, at about the time he disappeared but gave no one any indication he intended to leave the Kansas City area.

On 12-31-63, CAIN subsequently located and interviewed at Raytown, Mo. Enclosed to Dallas are 25 copies of appropriate FD-302 reflecting CAIN'S interview on 12-31-63.
