Reference is made to Lead Sheet 665, which reflects the name SHIRLEY BRUCE, with a notation FL 4-5129.

The following investigation at Dallas failed to identify SHIRLEY BRUCE:

A check with the telephone company reflects there is no exchange FL 4- in the Dallas area or in fact in the State of Texas.

City Directories were checked for the years 1961, 1962 and 1963 without identifying SHIRLEY BRUCE.

Credit records of the Retail Merchants Credit Association failed to positively identify SHIRLEY BRUCE.

A review of Main Case File 44-1639 reflects that FREDERICA is probably identical with JOE FREDERICI aka Joe Frederica. JOE FREDERICA resides at the Tanglewood Apartments, 3909 Innwood, Apartment 110.

Mr. REYNOLDS, Manager of Tanglewood Apartments, on 1/3/63, advised that JOE FREDERICA currently resides at the apartments and he, REYNOLDS, last saw FREDERICA on 1/2/64.

FOR INFORMATION OF HOUSTON, KANSAS CITY OFFICE HAS ADVISED THAT RUBY, IN LATE JANUARY OR EARLY FEBRUARY, NINETEEN SIXTY-THREE, WAS IN WICHITA KANSAS. HE REPORTEDLY STAYED AT CASSA SIESTA MOTEL AND WAS IN CONTACT WITH GAIL RAVEN, A STRIPPER, WHO WAS THEN EMPLOYED AT T-BONE CLUB, WICHITA. GAIL RAVEN REPORTEDLY INTRODUCED RUBY TO JIM JONKER AND VIRGIL PEEL, MANAGER AND EMPLOYEE OF T-BONE CLUB. LIEUTENANT FLOYD HANNON, NATIONAL ACADEMY, WICHITA POLICE DEPARTMENT, REPORTEDLY CHECKED RECORDS AT CASSA SIESTA MOTEL AND DETERMINED RUBY MADE ONE TELEPHONE CALL FROM THERE TO T-BONE CLUB IN JANUARY, NINETEEN SIXTYTHREE.
