Inquiry at the Rogers Engineering Company, above indicated MRS. O. B. THOMLINSON was no longer with the company but during 1960, an employee named GLADYS MOORE might possibly be the individual who had made inquiry of the Better Business Bureau concerning the Sovereign Club.

An indices search has indicated GLADYS MOORE has been interviewed, per serials 1378, 2879 and 1513. MISS MOORE was contacted 1/21/64, telephone number LA 6-6919 and she advised she had made inquiry concerning the Sovereign Club and had been a member years ago. She had been interviewed by the FBI previously in this matter.
