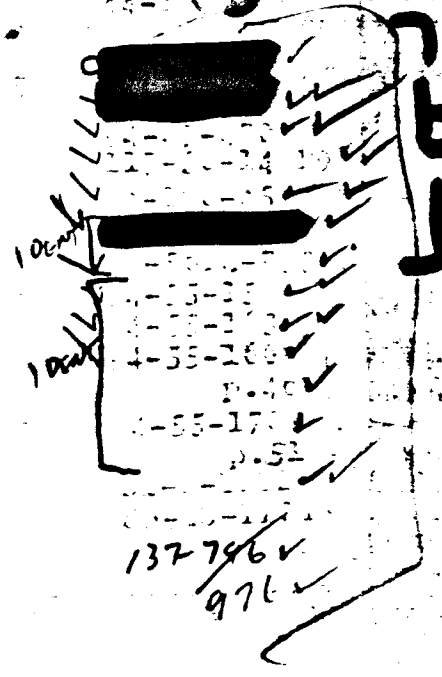

Re Detroit airtel, 3/13/64 with 302's enclosed.

I called the Detroit Office and first talked to NEAL WRIGHT, who was not particularly familiar with this. He then let me talk to IRVING ANDERSON, the Supervisor handling it. I referred to their 302's and pointed out they were not responsive to the Commission's request; that they should handle (1) the date of the call (2) the exact time of the call, if possible (3) the length of the call (4) the telephone number called, and (5) the person or identity called.

At that time, Agent CASSIUS RATHBUN came in and stated that he now found that the telephone company had given him some wrong dates; that some of these were in 1962 when they should have been in 1963, and he was going to have to redo the 302's and this 302 should not be utilized. I inquired as to how long he thought it would take to redo the 302's, and he said it would be quite a project to do what was requested. I pointed out to him that the deadline was already passed and this should be handled as expeditiously as possible.

I talked to ASAC WILLIAM B. WELTY, Chicago Office and pointed out to him that the information requested had been in detail and comply strictly with what the Commission has requested. I also advised him that they should teletype to other offices where the telephone number was in another Division and tell them to teletype the results to Dallas, furnishing the name of the Agent conducting the investigation, the name of the telephone company official making it available, the date of the investigation, the name of the person to whom the telephone was listed as of that date, and any pertinent information in their files.

SA MANNING C. CLEMENTS talked to Relief Supv. NICHOLAS MC GAHAN, Los Angeles, and pointed out that they had omitted from their information re telephone calls the time of day, night at which telephone calls were made. They were asked to submit revised 302's at the earliest moment.

The notebook in question was sent to the Labor

never mailed. The Lab retained these items per Lab repo
12/2/63, D-436849AX.

The letter referred to by the Commission, Page
495, of report, was from GAIL or GALE EATON, Harrison,
Michigan, to CRAFARD at Carousel Club.

At the time this letter was exhibited to ANDRE
ARMSTRONG, we were attempting to locate CRAFARD, inasmuch
as an individual had seen RUBY and a young man together
thought the second person was OSWALD. We sent the letter
written by CRAFARD and the notebook in question to the Lab
for handwriting examination, which proved handwriting in
the notebook was that of CRAFARD and thus eliminated OSW
as being the person with RUBY.

The letter from GAIL to CRAFARD was of no interest
to us except it provided a lead for locating CRAFARD. It
turned out to be the stepdaughter of an aunt of CRAFARD
whom CRAFARD had been trying to court. The letter was
found among exhibits.

SA PEGGS, New Orleans Office, advised telephonically he recalls the incident of the letter from GAIL, that he did not retain the letter as it was of no value except to provide an investigative lead.

ANDREW ARMSTRONG advised telephonically he recalled furnishing SA PEGGS a letter, but could not say whether it was the letter in question. He said the Big D Copa, nee Carousel, has been closed and he does not know whether the letter would still be there if he did not give it to SA PEGGS.

The above information was furnished to Inspector MALLEY by SAC SHANKLIN, 11:55 AM, 3/18/64. It was pointed out to him that the letter referred to by the Commission is of no consequence to us, that CRAFTARD was carrying on correspondence with the girl; that difficulty would be experienced in getting RALPH PAUL, Arlington, who operated the club after RUBY went to jail, and ANDREW ARMSTRONG, now unemployed, together at the club and conducting a search. Inspector MALLEY was advised no further action would be taken in the absence of any additional instructions. He speculated that the letter at the Lab may be the one the Commission is actually interested in.
