names I do not.

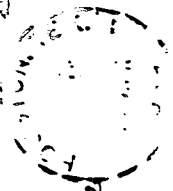



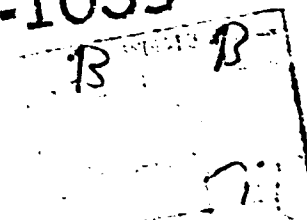
