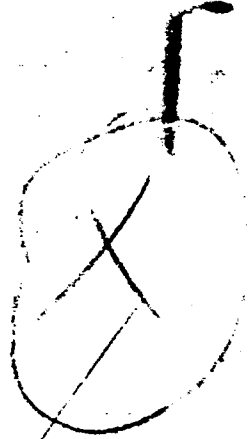

FIVE FOUR THREE SEVEN SEVEN THREE, HAD JUMPED BOND ON A LOCAL NARCOTICS CHARGE IN LOS ANGELES AND TRAVELED TO DALLAS. JAMES BREEN WAS REPORTEDLY DRIVING A CAB IN DALLAS AND THE WOMAN HAD ENGAGED IN PROSTITUTION ACTIVITIES. SHE RELATED BREEN HAD APPARENTLY MADE CONNECTIONS WITH A NARCOTICS RING THROUGH A FORMER ASSOCIATE FROM FCI, SEAGOVILLE, TEXAS, WHERE HE HAD SERVED TIME. SHE CONTINUED QUOTE IN SOME FASHION JAMES GOT OK TO OPERATE THROUGH JACK RUBY OF DALLAS UNQUOTE. IT APPEARED BREEN HAD APPARENTLY ABANDONED THE WOMAN AT THE TIME OF HER CALL. CURRY DISAPPEARED FROM DALLAS AREA IN MID-FIFTYSIX, KNOWN TO HAVE OPERATED AS PROSTITUTE IN OTHER AREAS SUBSEQUENTLY, PRESENT WHEREABOUTS UNKNOWN TO DALLAS OFFICE. BREENS WHEREABOUTS LIKEWISE UNKNOWN TO DALLAS. CHECK OF FEDERAL BUREAU OF NARCOTICS RECORDS, DALLAS DISCLOSES NO REFERENCES TO RUBY, CURRY OR BREEN UNDER KNOWN ALIASES.

COMMISSION DESIRES INTERVIEW WITH CURRY AND BREEN FOR FURTHER DETAILS OF ABOVE ALLEGATIONS AND INFORMATION CONCERNING ANY SUBSEQUENT CONTACTS WITH RUBY. IF LOCATED, INTERVIEWING OFFICERS SHOULD INTERVIEW FULLY RE ALL KNOWLEDGE OF OR ASSOCIATION WITH RUBY, ANY INFO RUBY HAS ENGAGED IN NARCOTICS

AND HAS USED THE NAMES CAROL O-CONNOR, EILEEN REDDON AND WAS ARRESTED FEBRUARY ELEVEN LAST BY THE CHICAGO, ILLINOIS PD UNDER THE NAME JOAN WEBSTER CHARGED WITH KEEPER OF A HOUSE OF PROSTITUTION; DISPOSITION NOT SHOWN.

[REDACTED], DESCRIBED MALE CAUCASIAN, BORN JANUARY FOUR TWENTYEIGHT, SIX FOOT ONE, TWO TWENTYFIVE POUNDS, BROWN HAIR, BLUE EYES.

RECEIVING OFFICES IMMEDIATELY INSTITUTE INVESTIGATION THROUGH FILE REVIEWS, CHECKS OF LAW ENFORCEMENT AGENCIES AND INSTITUTIONS INDICATED IN EFFORT TO LOCATE AND INTERVIEW CURRY AND BREEN.

BUREAU INSTRUCTS RESULTS OF INVESTIGATION TO BE SUBMITTED AS SOON AS COMPLETED BY LHM REFERRING TO THE SPECIFIC COMMISSION REQUEST COVERED THEREIN WHICH, IN THIS CASE, WOULD BE LETTER OF THE PRESIDENTS COMMISSION TO DIRECTOR, FBI DATED JUNE ONE LAST REQUESTING INTERVIEWS WITH CURRY AND BREEN AS

INDICATED ABOVE. MATERIAL MUST BE CAREFULLY REVIEWED PRIOR TO SUBMISSION FOR SUBSTANCE AND ACCURACY OF GRAMMAR AND PUNCTUATION SO IT MAY BE DISSEMINATED IMMEDIATELY UPON RECEIPT AT THE BUREAU WITHOUT DELAY. ABBREVIATIONS AND TERMINOLOGY PECULIAR TO THE BUREAU, SUCH AS NA, AKA AND WORD QUOTE REFLECTS UNQUOTE MUST BE CAREFULLY AVOIDED. LHM MUST NOT CONTAIN PROPERTY STATEMENT. A STEPMOTHER WILLIAM S. BREEN, SIX ONE ONE SEVEN PENNSWOOD, LAKEWOOD, CALIFORNIA HAS ADVISED JAMES ECKFORD BREEN LAST KNOWN BY HIM TO BE IN ANAHEIM, CALIFORNIA LAST FALL. ADVISED HE HAS NOT SEEN JAMES IN SEVEN YEARS AND THAT JAMES HAS NOTHING TO DO WITH RELATIVES WHO INCLUDE A STEPMOTHER ESTELLA ROSE BREEN, TWO FIVE TWO FIVE POPPY DRIVE, EURLINGAME, CALIFORNIA, MOTHER LORENZA JOHNSON, FATHER FNU CALVERT, COFFEYVILLE, KANSAS. CALVERT IS HEAD OF CREDIT UNION IN

COFFEYVILLE. SISTER ROSETA WILSON, HUMBOLDT, KANSAS, HER MARRIED NAME UNKNOWN.

JAMES PURCHASED FIFTYNINE CADILLAC CONVERTIBLE WHILE IN ANAHEIM, CALIFORNIA LAST FALL, THIS CAR SINCE REPORTEDLY RECOVERED SINCE PAYMENTS DELINQUENT. CALIFORNIA HIGHWAY PATROL REPORTS MOST RECENT ADDRESS OF BREEN AS TWO EIGHT ONE NINE TRIANGLE ROAD, SALEM, OREGON.

INVESTIGATION AT ANAHEIM, CALIFORNIA DISCLOSED JAMES ECKFORD BREEN PURCHASED A NINETEEN FIFTYNINE CADILLAC CONVERTIBLE, CALIFORNIA LICENSE MAU EIGHT ONE THREE, IN APRIL SIXTYTHREE AT AL E. BARNES USED CAR LOT IN FULLERTON, CALIFORNIA AND DROPPED THE CAR IN PHOENIX, ARIZONA AT GARAGE ABOUT NOVEMBER SIXTYTHREE. BREEN REPORTED FORMERLY EMPLOYED BY MATSON LINES, FOUR EIGHTY MAIN STREET, SAN FRANCISCO, CALIFORNIA AND FORMERLY A MEMBER OF THE MARINE COOKS AND STEWARDS UNION, FOUR ZERO EIGHT AVALON BOULEVARD, WILMINGTON, CALIFORNIA. HE LISTED AS A FRIEND DALE CARLSON, NINE ONE ONE THREE WEST AVENUE, EAST EIGHTH STREET, LANCASTER, CALIFORNIA.

RECORDS AT ANAHEIM POLICE DEPARTMENT SHOW BREEN'S MOTHER AS LORENZA CUSHMAN, TYRO, KANSAS.

MICHAEL LARRY CUSHMAN, ROUTE ONE, WANN, OKLAHOMA, ADVISED SA'S JOHN E. CHENOWETH AND CLAIR B. EMPEY JUNE ELEVEN SIXTYFOUR HIS MOTHER, MRS. DON (LORENZA) CUSHMAN, IS PRESENTLY AT KANSAS UNIVERSITY, LAWRENCE, KANSAS, AS A COUNSELOR FOR GIRL'S STATE AND SHE RESIDES PEARSON HALL DORMITORY. SHE WILL NOT RETURN TO WANN UNTIL JUNE SIXTEEN NEXT.

MICHAEL CUSHMAN ADVISED HE DOES NOT KNOW JAMES BREEN BY THAT NAME OR ANY ALIASES AND DOES NOT KNOW HIM AS A RELATIVE.

MRS. LOU CALVERT, MOTHER OF LORENZA CUSHMAN, WHO RESIDES COFFEYVILLE, KANSAS, ALSO DENIED ANY KNOWLEDGE OF JAMES BREEN AND STATED SHE HAS BEEN CONTACTED RECENTLY REGARDING THIS AND HAS NO INFORMATION.

KANSAS CITY AT LAWRENCE, KANSAS, WILL INTERVIEW MRS. DON (LORENZA) CUSHMAN FOR BACKGROUND INFORMATION AND LOCATION OF JAMES BREEN.

Inspector JAMES R. MALLEY advised at 8:50 AM today that regarding SA CLEMENTS report of 11/30/63, page 694, some information is set forth showing in paragraph 2 that there were no long distance telephone calls from RI 7-2362, which is listed in the name of the Carcusul Club on Commerce Street, and then on the same page, we show a telephone call placed from WH 1-5601, listed to RUBY at 223 South Ewing, that shows telephone call on Nov. 22, 1963 at 11:50 AM to Chicago, Ill.

Subsequently, in CLEMENTS' report of 4/30/64, we came up with 4 or 5 pages of telephone calls, and Mr. MALLEY stated he feels sure that what has happened is that on 11/29/63 when SA LISH checked the telephone calls, he was probably told there were no calls, but what actually happened is that the Telephone Company didn't have the tape available for the pay phone, and when we checked later at a specific request, they may have had the record available.

Mr. MALLEY stated we are probably going to have to correct the wording in the letterhead memorandum furnished to the Commission as the language in the first report makes it appear there were no records.

The telephone call which Inspector MALLEY referred to is the call to Chicago, Ill. at 9:02 PM on 11/22/63 (page 14 of SA CLEMENTS' report dated 3/28/64. Page 694 of the first report shows two calls - one at 11:02 and one at 12:00 noon, both to the same number. Mr. MALLEY stated he was trying to get in touch with the Commission and would call us later when he finds out just what they want.
