Dear Mr. Wade:

Efforts had been made previously to determine whether additional Ruby property had been retained by Dallas Police Department and we had been informed your office had all of the property, that none had been retained by them. 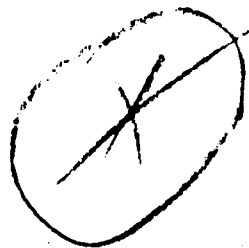
