





During the rapid sequence of events and disclosures yesterday, one short item was broadcast, which seems not to have been again referred to but, at the time, seemed potentially fruitful if followed through. I made no note mental or otherwise at the time as to the station to which I was tuned on my radio, nor to the time of the day, but I am sure it was in the early afternoon.

It seemed that a microphone-carrying newsman had noticed Rubenstein nod or speak to someone in the crowd soon after he was arrested; and the newsman sought them out and asked whether they were friends of Rubenstein. One of morem spoke with a heavy accent, while the other attempted to reply but was obliged to explain that he spoke very little English. The spokesman of the two admitted being acquainted with 'Ruby' and said that he had 'dropped up' to see him a few times. He also remarked that his foreign friend had remarked, "Why, that's the fellah we went to see!" The short interview concluded indistinctly with a reference that sounded like, "He is putting in/telephone call to Warsaw."





She maintained that Mr. SORRELS should be removed from his position as he was incompetent and did not have the ability to protect the President. She stated he was definitely anti-government, against the KENHEDY administration, and she felt his position was against the security of not only the President but the United States.

During the time this individual furnished the information set out above, effort was made to determine her name and address however she declined.




