

My dear Mr. Kubanstein,

Now that I have begun this letter, I do not know exactly what to say. You do not know me, but due to the very unfortunate circumstances of the past forty-eight hours, I think all Americans are being drawn closer together in the web of our citizenship. I don't even know for sure the reason for this letter other than the terrible time in my life this past September and October and I know how very grateful I was for every letter of encouragement I received. I am, as you may or may not have read in your newspapers that sent my six year old son, Steven to a previously all Negro school. I received over a thousand letters from not only all across the nation, but the entire world. This was so very unexpected, but I enjoyed every one of them and was grateful that people would take time from a busy day to write to me. There are so many things I would like to say, but find I am at a complete loss for words. I cannot say that I am glad you did, if you did kill that Lee Oswald. I'm sure that all Americans will agree that death so fast was much too good for him. I, too, wanted to rush to the Dallas jail and take things into my own hands, but realizing the authorities were so much more capable than I



could ever hope to be, I knew they would mete out the punishment he so richly deserved. Mr. Kennedy was my president and I loved him as dearly as anyone outside of his own family, in fact I felt as though a member of my own family was gone. I still cannot realize that we do not have our beloved president. It all seems so impossible that this sort of thing could happen in this country. We keep telling ourselves that we are civilized, that we are above things as this, only to find in a moment of madness that we really in a world gone mad. This is the feeling I experienced during the time of the horrible and threatening telephone calls, the fire set to my home, the four out tires. I kept telling myself that this is not real, I'm sure I will wake up shortly and find this is all a very dreadful nightmare. My situation has improved a great deal, but I have never awakened to find my neighbors are really the civilized human beings I had thought them to be. I have found people, even the most supposedly "nice" people to be viciously cruel animals and can show this part of their character at a moment's notice when crossed, or when they think there is a "change" in the making. I know it sounds to you as though I am only raving on and very probably that is exactly what I am doing. I wish there were some words to say to you to make you feel better at this time, but I find there are none. I have neither wisdom or comfort to offer, only my friendship. You may or may not choose to accept this, do as you wish and see fit. If you are allowed to write, I would like very much to hear from you, but if you do not, I will understand. Whatever happens in the future I will continue to keep up with the news and pray for you.




Sure, you know and I know that you violated the law, and without laws we could not survive as a stable and permanent society.






