ceived, and I shall always

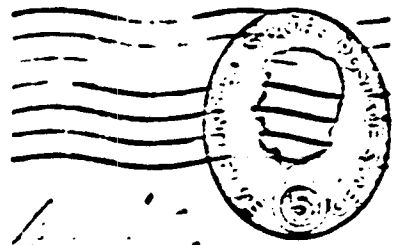
