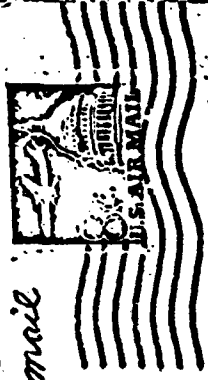
Dear Jack,

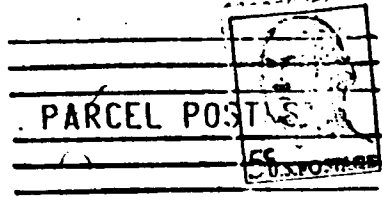

Dear Friend: you know Jack, you would not be where
you are and President Kennedy would not be dead if
the United Secret Service and the Federal Bureau of Investi-
gation had done their duty -

Having in their possession the life history of
Osmond his Russian training, et cetera. That he lived
in Dallas, would have alerted run a hick town police

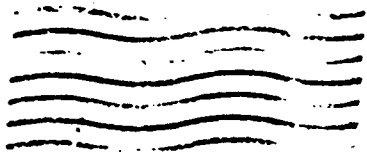
Dear Jack,
