I hope somebody lets you see this, you foul creep, and just be thankful that I'm not your judge.

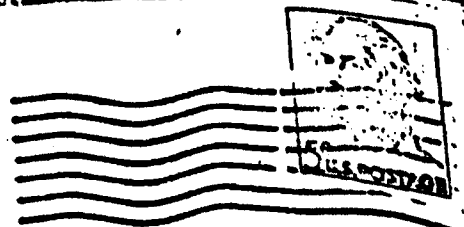
