- IMPORTANT:** Each post office box is rented with the understanding that—
1. Rent is to be paid in advance either quarterly or for a full fiscal year (July 1-June 30). Failure to pay by the first day of the period due will cause the box to be closed.
  2. The box must NOT be used for business or improper purposes, the receipt of a broadcast or letter requires the payment of postage; the contents of any business in violation of law or delivery of mail addressed to an individual or business name. The use of the box is restricted to one individual, family, firm, or corporation, and it may serve only for the delivery of mail addressed to the holder, members of his immediate family, or, in the case of a firm, post masters or clerks as may be entitled to receive mail therein. If any of these rules is broken the box may be closed without refund of any part of the rent.
  3. The Post Office will furnish one or two regular bags without charge, except if they are not returned when bag is completed a charge of 25 cents each will be made. For each other additional bag furnished a charge of 50 cents will be made. The refund will be made on the additional bags.
  4. Subscriber understands and agrees that all orders or replacement bags shall be obtained from the Postmaster, and under no circumstances will the subscriber or his agent obtain bags for the assigned box from any other source or supplier.

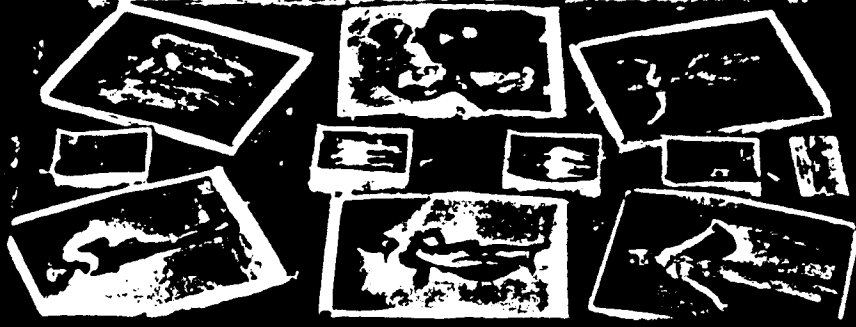

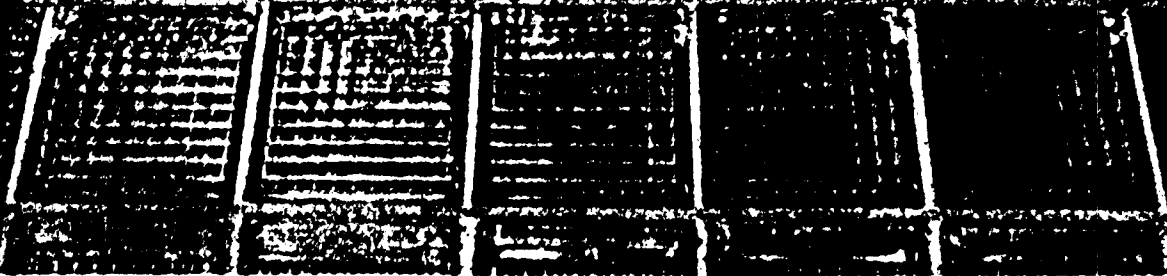
