FRANK KIERNAN, SAUSA, CHICAGO, ON ELEVEN TWENTY FOUR  
LAST, FURNISHED THE FOLLOWING INFORMATION RECEIVED FROM JACK  
WILNER, CRIME REPORTER, QUOTE CHICAGO DAILY NEWS UNQUOTE.  
WILNER STATES HIS QUOTE SYNDICATE SOURCES UNQUOTE REFLECT  
RUBY REPORTEDLY INVOLVED IN NINETEEN FORTY SEVEN WITH NICK  
ST. JOHN, PAUL LABRIOLA, MARCUS LIPSKY AND PAUL RONALD JONES  
IN EFFORT TO TAKE OVER GAMBLING IN DALLAS AREA. ALSO INVOLVED  
WERE STEVE GUTHRIE, SHERIFF OF THE COUNTY AND ONE GEORGE  
BUTLER. WILNER ADVISED INFORMATION ON THIS SITUATION IN  
KEFAUVER HEARINGS NINETEEN FIFTY AND THAT SEVERAL INDIVIDUALS  
WERE CONVICTED IN DALLAS IN ABOVE CASE.
