JIM BLAYLOCK, CHIEF DEPUTY, WOOD COUNTY SO, TEXAS, ADVISED THAT AN UNKNOWN WHITE FEMALE, THIRTY TO THIRTYFIVE YEARS OF AGE, LIGHT RED HAIR, DRIVING SIXTYTWO OR SIXTYTHREE BRONZE CADILLAC SPORTS COUPE, BEARING SIXTYTHREE LOUISIANA LICENSE NINE FOUR ONE NINE EIGHT FIVE, STOPPED FOR GASOLINE AT SMITH HUMBLE SERVICE STATION, HAWKINS, TEXAS, APPROXIMATELY ONE THIRTY P.M. FRANK QUOTE BUTCH UNQUOTE LOVERDE ADVISED SAS WILLIAM A. HEINCKE AND JOSEPH G. SHEA ON NOVEMBER TWENTYFIVE, NINETEEN SIXTYTHREE, THAT HE DOES NOT KNOW THE SUBJECT. LOVERDE SAID THAT HAD THE SUBJECT BEEN CONNECTED IN ANY WAY WITH THE ORGANIZED CRIMINAL ELEMENT OF CHICAGO, HE WOULD HAVE SOME KNOWLEDGE OF RUBY. LOVERDE ADVISED THAT MANY PEOPLE IN CHICAGO HAVE CONFUSED THE SUBJECT WITH HARRY RUBENSTEIN, AN INDIVIDUAL WHO FORMERLY OPERATED THE OLYMPIC HOTEL AND KILLED A MAN IN NINETEEN FORTYSIX. HE STATED THAT HARRY RUBENSTEIN HAD GOTTEN MIXED UP WITH WRONG PEOPLE AND HAD BEEN RUN OUR OF CHICAGO. HE BELIEVED THAT HARRY RUBENSTEIN HAD GONE SOMEWHERE IN TEXAS. LOVERED DECLINED TO ELABORATE ON THE ABOVE REMARKS AND DID NOT FURNISH THE DATE OR OTHER PARTICULARS CONCERNING HARRY RUBENSTEIN-S TROUBLES.

MANNY SADER, MANAGER OF THE SIX ZERO SIX CLUB, A STRIP SHOW IN CHICAGO, ADVISED SAS ROBERT A. COOK AND WILLIAM R. BRODERICK ON NOVEMBER TWENTYFIVE, NINETEEN SIXTYTHREE, THAT HE HAD NEVER HEARD OF THE SUBJECT UNTIL HE READ OF HIM IN THE NEWSPAPERS IN CONNECTION WITH INSTANT CASE. SUBJECT: JACK RUBENSTEIN

On Sunday, November 24, 1963, while I was working at J. E. Birchell's Sinclair Service Station, Arlington, Virginia, a Mr. C. H. Payne came in to have a headlight replaced. While we were installing his headlight, an announcement came over the radio that Lee Harvey Oswald had been shot in the Dallas Police Department by a Jack Ruby. After the news broadcaster gave the description of Jack Ruby and stated that he was an operator of a dance hall and strip tease show, Mr. Payne related that years ago, either in Tucson or Phoenix, he had worked for a man from Chicago who fit the description of Jack Ruby. Mr. Payne also stated that the man he worked for was named Jack Rubenstein but he did not know if there was any connection between Rubenstein and the above captioned individual. After Mr. Payne had left the station an announcement came over the radio that the real name of Jack Ruby was Jack Rubenstein. Mr. Payne's address is 3507 Hilltop Place, Falls Church, Virginia.

KELLMAN SAID HE NEVER KNEW RUBENSTEIN-S SISTER EVA GRANT OR OTHER RELATIVES NOR HAD HE HEARD ANYTHING AT ALL FROM RUBENSTEIN OR OTHER SOURCES. KELLMAN WAS NOT AWARE THAT RUBENSTEIN HAD LEFT CHICAGO UNTIL HE RECOGNIZED A FULL VIEW PHOTOGRAPH OF RUBENSTEIN WHEN HE WAS IDENTIFIED AS OSWALD-S ASSAILANT. HE NEVER HEARD ANYTHING TO INDICATE RUBENSTEIN HAD POSSIBLY BEEN CONNECTED WITH HOODLUM ELEMENTS. KELLMAN KNEW OF NO GROUPS, ORGANIZATIONS, OR ASSOCIATES OF RUBENSTEINS AND SAID HE NEVER HEARD OF OSWALD UNTIL THE PRESIDENT-S ASSASSINATION.

KELLMAN ADVISED RUBENSTEIN HAD APPEARED TO HIM TO BE A QUIET, WELL MANNERED, ALMOST EFFEMINATE TYPE OF MAN WHO LISPED. THE IDEA THAT HE COULD BECOME A STRONG ARMED BOUNCER AND AN AFFILIATE OF GANGSTERS WAS TOTALLY AT ODDS WITH THE IMPRESSION KELLMAN SAID HE FORMED OF RUBENSTEIN TWENTY YEARS AGO.

KELLMAN OFFERED ANY ADDITIONAL ASSISTANCE HE MIGHT PROVIDE THIS INVESTIGATION. AM COPY TO CHICAGO, FD THREE ZERO TWO-S FOLLOW FOR DALLAS.
