ALEK J. HIDELL AND O. H. LEE, BOTH AKAS OF LEE HARVEY OSWALD SEMI DACK LEON RUBY, AKA JACK RUBENSTEIN SEMI BROTHERS OF RUBY, EARL RUBY, SAMUEL RUBY, HYMAN RUBENSTEIN SEMI SISTERS OF RUBY, MRS. ANN VOLPERT, MRS. MARIAN CARROLL, MRS. HAROLD ILENE KAMINSKY, EVE GRANT, AND BOTH PARENTS OF RUBY, JOSEPH AND FANNIE RUEENSTEIN. FILES ALSO NEGATIVE RE HELEN AFANCE ROAN. VARIATIONS OF SURNAMES WERE ALSO CHECKED.

HOWEVER, G-TWO OFFICIALS ADVISED INFORMATION RE ONE EARLE RUBY, NOT FURTHER IDENTIFIED, IS LOCATED AT 11.5 THE RECORD SECTION, ACSI, DEPARTMENT OF THE ARMY, THE PENTAGON, WASHINGTON, D. C., UNDER THE FOLLOWING CROSS REFERENCE COLON

CIVIL RIGHTS.

HERSHEY COLVIN, BARTENDER, VERTIGO KEY CLUB, LAWRENCE AND BROADWAY, INTERVIEWED BY SAS JOHN R. BASSETT AND EUGENE I. SATHER ON NOVEMBER TWENTY FIFTH, NINETEEN SIXTY THREE PAREN VERTIGO OWNED BY JOE BOCELINO, [SMALL TIME CHICAGO HOODLUM] END PAREN. COLVIN ADVISED HE WAS LONG TIME ASSOCIATE OF JACK RUBENSTEIN AND SERVED IN THE U.S. AIR FORCE WITH RUBENSTEIN WHILE BOTH STATIONED AT KESSLER, MISSISSIPPI. COLVIN STATED, UPON RETURN FROM AIR FORCE HE RAN SHOW TIME LOUNGE AT MADISON AND HAMLIN DURING WHICH TIME LOUNGE WAS FREQUENTED BY RUBENSTEIN-S SISTER, EVA GRANT AND RUBENSTEIN. COLVIN DESCRIBED RUBENSTEIN AS A QUOTE HUSTLER UNQUOTE WHO SOLD NUMEROUS CHEAP TYPES OF MERCHANDISE IN AN ATTEMPT TO MAKE A PROFIT. COLVIN STATED RUBENSTEIN IS DEFINITELY NOT CONNECTED WITH CHICAGO OUTFIT AND WAS A PERSON OF GOOD MORAL STANDARDS, ALTHOUGH HE DID DISPLAY A QUICK TEMPER ON OCCASIONS. FROM HIS KNOWLEDGE HE, RUBENSTEIN, COLVIN STATED IN HIS OPINION, WAS LOYAL TO THIS COUNTRY WITHOUT QUALIFICATION.

HE VOLUNTEERED THAT RUBENSTEIN, WHO HAD A SENSITIVE NATURE, MOST PROBABLY SIMPLY QUOTE FLIPPED HIS LID UNQUOTE, SUBSEQUENT TO THE ASSASSINATION OF THE PRESIDENT AND IN A FIT OF PASSION DID WHAT HE THOUGHT WAS RIGHT IN TAKING THE LIFE OF LEE HARVEY OSWALD.

COLVIN CONCLUDED BY STATING THAT RUBENSTEIN, DURING THE TIME HE HAD KNOWN HIM WAS POSITIVELY NOT A RADICAL OR EXTREMIST BUT A LOYAL CITIZEN OF THE UNITED STATES.

JOE BOCELINO, PROPRIETOR OF VERTIGO, INTERVIEWED BY SAS BASSETT AND SATHER ON NOVEMBER TWENTY FIFTH, NINETEEN SIXTY THREE AND CLAIMED JACK RUBY NOT KNOWN TO HIM.

SHE STATED POSITIVELY HARRY RUBENSTEIN NO REALTION TO JACK RUBY. SHE HAD NEVER HEARD THE NAME JACK RUBY BEFORE. ADVISED NAMES JACK RUBY AND JACK RUBENSTEIN NEVER MENTIONED BY ANYONE TO THEM WHEN THEY WERE IN THE BUSINESS OF OPERATING NIGHT CLUBS. SHE RECALLS SHE ONCE BOUGHT SOME TICKETS TO PLAY OKLAHOMA THROUGH A TICKET SCALPER NAMED QUOTE SPARKY UNQUOTE APPROXIMATELY RIGHT AFTER WW II BUT NEVER SAW THE MAN.

SHE DENIED HARRY WAS A CLOSE FRIEND OF THE HOODLUM ELEMENT IN CHICAGO ALTHOUGH STATED ANYONE IN THIS BUSINESS WOULD HAVE TO ASSOCIATE WITH SOME. SHE WOULD FURNISH NO FURTHER DETAILS IN THIS REGARD.

RECORDS OF PASSAIC, NEW JERSEY, POLICE DEPARTMENT REFLECT JACK RUBENSTEIN OF SEVEN FOUR NINE MAIN AVENUE, PASSAIC, NEW JERSEY, WAS ARRESTED IN APRIL, NINETEEN TWENTY SIX BY THAT DEPARTMENT. HIS AGE WAS TWENTY TWO IN NINETEEN TWENTY SIX AND HIS PLACE OF BIRTH WAS GIVEN AS NEW YORK. AT THAT TIME HIS RECORD REFLECTED FATHER AS LIVING AND MOTHER DECEASED. NO FINGERPRINTS AVAILABLE.

ROBERT CLARK, SISTER-IN-LAW OF JUSTICE TOM CLARK. ROBERT CLARK IS DECEASED. COLLINS HAD INDICATED TO S D P D THAT HE WAS FROM DALLAS, TEXAS AND MENTIONED NAMES OF HIS GOOD FRIENDS JOHN F. KENNEDY AND LYNDON B. JOHNSON. *(... 4)*

COLLINS ADVISED SA WILLIAM S. FIELDS TELEPHONICALLY HE DESIRED TO MAKE A STATEMENT THE NIGHT OF NOVEMBER TWENTY FOUR LAST CONCERNING JACK RUBY. HE STATED HE HAS BEEN A CLOSE PERSONAL

FRIEND OF RUBY-S FOR MANY YEARS, DESCRIBED HIM AS QUOTE A HERO WORSHIPPER IN LOVE WITH A HERO JOHN F. KENNEDY, GOOD GUY, ALWAYS A GENTLEMAN, SINCERE, INTELLECTUAL, AND THE SHOOTING WAS HIS OWN IDEA UNQUOTE.

COLLINS STATED IN HIS OPINION RUBY SHOT OSWALD ON IMPULSE BECAUSE OF HIS PERSONAL ANIMOSITY OVER ASSASSINATION OF PRESIDENT KENNEDY. HE STATED IT WAS OBVIOUS RUBY QUOTE WAITED UNTIL ALL EVIDENCE AGAINST OSWALD WAS IN BEFORE MAKING HIS MOVE UNQUOTE. COLLINS STATED HE WAS BOTH SURPRISED AND STARTLED OVER RUBY-S ACTIONS IN THIS MATTER.

COLLINS STATES THAT HE RESIDES AT TWO SEVEN ONE THREE VIA CASA LOMA, SAN CLEMENTE, CALIFORNIA.

AT THE BEGINNING OF THE INTERVIEW OF COLLINS ON NOVEMBER TWENTY FOUR LAST HE SAID HE WANTED TO MAKE A PUBLIC STATEMENT IMMEDIATELY CONCERNING THE SHOOTING OF OSWALD. HE WAS ADVISED ANY STATEMENT HE MADE TO THE BUREAU WAS NOT A PUBLIC STATEMENT. HE SAID HE CONSIDERED THE ABOVE INFORMATION TO BE PERTINENT AND HE WANTED IT KNOWN THAT HE MADE SUCH A STATEMENT CONCERNING RUBY. DURING THE ABOVE TELEPHONIC INTERVIEW COLLINS LEFT THE IMPRESSION THAT HE HAD

BEEN DRINKING AND BACKGROUND NOISE DURING CONVERSATION WOULD INDICATE HE WAS ATTENDING SOME SORT OF PARTY.

COLLINS REINTERVIEWED BY SA FIELDS NOVEMBER TWENTY FIVE AT ONE SIX TWO FOUR TORREY PINES ROAD, LA JOLLA, STATED HE HAS KNOWN RUBY SINCE NINETEEN FORTY EIGHT, HOWEVER HE HAS NOT SEEN HIM OR TALKED WITH HIM IN FIVE YEARS. COLLINS ADVISED HE MOVED TO CALIFORNIA THREE YEARS AGO AND HAS SELDOM VISITED DALLAS SINCE THAT TIME. COLLINS THOUGHT THAT RUBY WAS HIS TRUE NAME AND KNEW NOTHING CONCERNING HIS BACKGROUND PRIOR TO MOVING TO DALLAS. COLLINS NEVER WENT OUT WITH RUBY SOCIALLY AND NEVER HAD ANY BUSINESS DEALINGS WITH HIM.

COLLINS STATED THAT IN APPROXIMATELY NINETEEN FIFTY RUBY ADOPTED A SMALL BOY ABOUT SIX YEARS OLD AND ON ONE OCCASSION HE BROUGHT THE ADOPTED BOY TO COLLINS HOME AND INTRODUCED HIM TO THE BOY. HE BELIEVED THE ADOPTED BOY WAS OF SPANISH EXTRACTION. HE DOES NOT KNOW WHAT BECAME OF THE BOY AND RUBY NEVER MENTIONED HIM AGAIN. COLLINS KNEW THAT RUBY HAD A SISTER IN DALLAS AND TALKED TO HER ON ONE OCCASSION ON THE PHONE. DURING THE TIME THAT COLLINS WAS IN DALLAS HE WOULD SEE RUBY QUOTE WEEKLY OR MONTHLY UNQUOTE.

COLLINS STATED THAT RUBY WAS HELD IN HIGH REGARD BY THOSE WHO KNEW HIM. HE STATED THAT RUBY WAS DETERMINED TO DO WELL BUSINESS WISE. HE DESCRIBED HIM AS AN HONEST CITIZEN WITH NO SUBVERSIVE CONNECTIONS WHATSOEVER. HE WAS POSITIVE RUBY HAD NO CONNECTION WITH THE FAIR PLAY FOR CUBA COMMITTEE AND NEVER HEARD HIM UTTER ANY RADICAL OR EXTREMIST VIEWS ON ANY MATTER. COLLINS HAD NEVER HEARD OF OSWALD PRIOR TO THE ASSASSINATION.

COLLINS SAID HE KNEW NOTHING CONCERNING RUBY-S ASSOCIATION WITH ANYONE ON THE DALLAS POLICE DEPARTMENT OR ANY OTHER LAW ENFORCEMENT AGENCY. HE SAID RUBY HAS A HIGH RESPECT FOR LAW ENFORCEMENT AND OFTEN MENTIONED THIS FEELING IN CONVERSATION. COLLINS SAID HE NEVER OBSERVED RUBY WITH A GUN AND DID NOT KNOW THAT HE OWNED A GUN. HE SAID THAT RUBY WAS NOT A VIOLENT TYPE MAN AND HE WAS SURPRISED AND SHOCKED OVER THE KILLING.

COLLINS STATED THAT HE WAS NOT PERSONALLY ACQUAINTED WITH PRESIDENT JOHNSON OR THE LATE PRESIDENT KENNEDY, HOWEVER HIS FAMILY WAS WELL ACQUAINTED WITH PRESIDENT JOHNSON.

PESQUIERA CALLED ATTENTION TO THE FACT MEXICAN TOURIST VISAS COULD BE OBTAINED AT ANY MEXICAN COUNSELOR-S OFFICE IN THE U. S. HE FURTHER ADVISED TOURIST VISAS COULD BE OBTAINED AT ANY AIRLINES OFFICE THAT WENT INTO MEXICO CITY. HE STATED THE PROPER PLACE TO CHECK FOR A TOURIST VISA THAT HAD ALREADY BEEN USED WOULD BE MEXICO CITY WHERE ALL TOURIST VISAS ARE FINALLY DEPOSITED. HE REITERATED THAT THE FILES OF HIS OFFICE WOULD NOT BE AVAILABLE UNTIL NOVEMBER TWENTY SIX NEXT.

THE FOLLOWING INVESTIGATION WAS CONDUCTED BY SA-S ROBERT S. BAKER AND WILLIAM S. OVITT.

IN VIEW OF THE FACT GENEVA FOSTER, FIVE NINE FIVE FIVE CHANDLER DR., SAN DIEGO, CALIFORNIA APPEARED ON A SAN DIEGO TELEVISION STATION NOVEMBER TWENTY FOUR NINETEEN SIXTY THREE, INDICATING SHE WAS AN EMPLOYEE OF RUBY IN DALLAS SHE WAS LOCATED NOVEMBER TWENTY FIVE NINETEEN SIXTY THREE, REPORTEDLY UNDER A DOCTORS CARE, HOWEVER SHE AGREED TO TALK WITH AGENTS.
