MANDREY HAD DIFFICULTY REMEMBERING THE NAMES OF THE INTERVIEWING AGENTS AND ADMITTED ON THE EVENING OF THE CONVERSATION IN QUESTION BOTH HE AND HIS WIFE WERE DRINKING HEAVELY.

MRS. HORST WAS INTERVIEWED AND DENIED MAKING THE ALLEGED STATEMENTS. SHE SAID SHE HAD NEVER HEARD THE NAMES OF RUBENSTEIN, RUBY OR OSWALD UNTIL SHE HEARD THEM ON THE NEWS CAST. SHE WAS SHOWN NEWSPAPER PHOTOS OF BOTH RUBY AND OSWALD AND ADVISED THAT SHE HAS NEVER SEEN THESE MEN.

MRS. HORST WAS REINTERVIEWED IN THE PRESENCE OF MANDERY AND HIS WIFE. MANDERY REPEATED THE ALLEGATIONS AND MRS. HORST CATEGORICALLY DENIED THEM.

MRS. HORST ADVISED THAT HER HUSBAND OWNS FIFTY PERCENT OF THE MERLE V. WATSON RADIO AND TELEVISION PRODUCTION OF PEORIA, ILLINOIS AND HER HUSBAND HAD TO FIRE MANDERY FOR LOW PRODUCTION. SHE SAID THAT MANDERY THREATENED TO QUOTE BLOW UNQUOTE THE WATSON ADVERTISING OPERATION. MEANING HE WOULD INJURE ITS REPUTATION.

[REDACTED] STATED MANDERY AND HIS WIFE DRINK TO EXCESS AND IS VERY UNRELIABLE. *alcohol*

*MINN.* [REDACTED] WHO KNEW MANDERY AS BELL HOP AT THE RUSSELL HOTEL IN MINNEAPOLIS IN ABOUT NINETEEN FORTYNINE STATED HE WAS NOT TO BE TRUSTED, WOULD DO ANY THING FOR A BUCK AND WHILE A BELLHOP ENGAGED IN BOOTLEGING AND PIMPING.

At 9:20 a. m., this date, an individual identifying himself only as Mr. Miller, 1125 14th Street, Northwest, Washington, D. C., called and advised he was a close friend of Ruby. He also identified Clint Murchison and Tommy Webb as friends of Ruby. Miller declined to furnish additional information.

Subsequent to the receipt of this call, Agents of the Washington Field Office (WFO) contacted the landlady at the afore-mentioned address, as well as individuals in the area, in an attempt to identify Miller without success. WFO was instructed to locate Tommy Webb and interview him regarding information furnished by Miller.

At 9:10 p. m., instant date, night supervisor Leonard Webster, WFO, advised the Bureau that Webb had been contacted and advised that he did not know Miller nor Ruby, and was positive that Murchison did not know either Miller or Ruby. It was Webb's opinion that this was obviously a "crank" complaint.

ACTION:

In view of the fact there appears to be no foundation in fact for Miller's statements, no further action is being taken regarding this matter.
