HERBERT CHARLES DAVID KELLY, UNEMPLOYED RESTAURANT MANAGER, NEW ORLEANS, ADVISED SA/S L. M. SHEARER AND FURMAN G. BOGGAN NOVEMBER TWENTYSIX, SIXTYTHREE, THAT HE WAS EMPLOYED BY JACK LEON RUBY IN DALLAS FOR APPROXIMATELY ONE YEAR DURING NINETEEN FIFTYNINE AND NINETEEN SIXTY, AS MANAGER OF KITCHEN AND FOOD OPERATIONS AT THE SOVERIGN CLUB, A HIGH CLASS MEMBERSHIP SUPPER CLUB WHICH WAS THEN OPERATED AT THE SITE OF THE PRESENT CAROUSEL CLUB.

KELLY CLAIMED HAD MET RUBY THROUGH DALLAS INDIVIDUALS IN FOOD SERVICE FIELD, KELLY HAVING BEEN FORMERLY EMPLOYED AS FOOD DIRECTOR OF EATING ESTABLISHMENTS IN TITCHES DEPARTMENT STORE, DALLAS. KELLY QUESTIONED EXTENSIVELY CONCERNING RUBY/S BACKGROUND, ASSOCIATES, AND CONNECTIONS WITH DALLAS LAW ENFORCEMENT OFFICERS. KELLY CLAIMS RUBY SAID HE CAME FROM CHICAGO AREA ABOUT FIFTEEN YEARS AGO AND BELIEVES RUBY MAY HAVE BEEN ASSOCIATED WITH SOME UN-KNOWN UNION IN CHICAGO AREA AND MAY HAVE LEFT CHICAGO BECAUSE OF DIFFICULTY WITH UNION. KELLY CLAIMED RUBY ONCE HIT JOE PETERSON IN ARGUMENT OVER PETERSON/S DESIRE TO SEE CLUB FINANCIAL RECORDS. LEO PAREN LNU END PAREN BARTENDER AT SOVERIGN CLUB BELIEVED BY KELLY LONG TIME ASSOCIATE OF RUBY. KELLY STATES PAUL PAREN LNU END PAREN A BANKER, APPROXI-MATELY SIXTY YEARS, SHORT, MEDIUM BUILD, POSSIBLY WITH REPUBLIC NA-TIONAL BANK, OCCASIONALLY LOANED MONEY TO RUBY IN NINETEEN FIFTYNINE AND PAUL/S NAME APPEARED AS COUNTER SIGNATURE ON CLUB/S PAYROLL CHECKS DRAWN ON REPUBLIC NATIONAL BANK. KELLY STATES RUBY ONCE HIT KEITH WILLIAMS, WILLIAMS OIL COMPANY PROMOTER, FOR GIVING RUBY SIXTY DOLLAR WORTHLESS CHECK. $4 E \times AS$

KELLY CLAIMED HE KNEW NONE OF THEM BY NAME ALTHOUGH RUBY/S OFFICER FRIENDS COMPRISED OF DETECTIVES, INIFORMED POLICE OF ALL RANKS AS WELL AS SHERIFF/S DEPUTIES. KELLY CLAIMED WHILE HE WAS ASSOCIATED WITH RUBY. LATTER HAD WHAT HE CALLED QUOTE CELEBRETY NIGHT UNQUOTE EACH SUNDAY EVENING ON WHICH OCCASIONS RUBY WOULD ENTERTAIN AS MANY AS EIGHT DIFFERENT LAW ENFORCEMENT OFFICERS GIVING THEM STEAK DINNERS AND DRINKS. KELLY CLAIMS HE QUESTIONED RUBY/S PURPOSE FOR THIS DUE TO COST OF SUCH ENTERTAINMENT AND RUBY REPLIED HE LIKED POLICE OFFICERS AND THESE MEN HAD LITTLE MONEY TO SPEND FOR PERSONAL ENTERTAINMENT. KELLY DESCRIBED RUBY AS QUOTE POLICE BUFF UNQUOTE. A PERSON WHO HAD A NATURAL LIKING FOR MEN IN LAW ENFORCEMENT FIELD. KELLY INDICATED THERE WERE INSTANCES END PAGE SEVEN

NO 44-2964 - PAGE 8 WHEN IT APPEARED THAT RUBY WAS FURNISHING CRIMINAL INFORMATION TO POLICE OFFICERS ON INFORMANT BASIS.

KELLY SAID DURING NINETEEN FIFTYNINE RUBY WAS OWNER OR OPERATOR OF VEGAS CLUB WHICH HE DESCRIBED AS QUOTE HONKY TONK UNQUOTE, PATRONIZED BY QUOTE LEVI AND BLACK LEATHER JACKET CROWD UNQUOTE. KELLY SAID RUBY EMPLOYED AN EXPOLICEMAN, NAME UNKNOWN, AS BOUNCER AT VEGAS CLUB. KELLY SAID VEGAS CLUB NOT TYPE OF BAR WHICH WOULD BE FREQUENTED BY PEOPLE OF GOOD CHARACTER, HOWEVER DENIED ANY KNOWLEDGE OF PROSTITUTION, B DRINKING NARCOTICS ACTIVITY OR GAMBLING IN THIS PLACE AND DENIED KNOWLEDGE IT MIGHT HAVE BEEN TROUBLE SPOT FOR POLICE.

KELLY SAID RUBY LIVED WITH LATTER/S SISTER WHEN KELLY ASSOCIATED WITH HIM. HE DESCRIBED RUBY AS EXTREMELY INTERESTED IN MAKING AS MUCH MONEY AS HE COULD AND RELUCTANT TO TURN LOOSE OF MONEY. ON OCCASIONS RUBY MENTIONED TO KELLY THAT THIS INDIVIDUAL WAS RATHER WEALTHY AND ON ONE OCCASION WHEN FINANCES OF CLUB WERE LOW KELLY SUGGESTED THAT RUBY BORROW MONEY FROM THIS OLDER BROTHER AND RUBY REPLIED HE COULD NOT AS HE ALREADY OWED THIS BROTHER TOO MUCH. KELLY SAID RUBY HAD NO ACTIVE INTEREST IN POLITICS AND DID NOT KEEP ABREAST OF CURRENT EVENTS THROUGH READING NEWSPAPERS AND PERIODICALS. KELLY SAID HE NEVER HEARD RUBY MENTION LEE HARVEY OSWALD AND HAD NEVER SEEN OSWALD ASSOCIATING WITH RUBY. KELLY STATED BECAUSE OF RUBY/S TEMPERAMENT HE DIDN NOT BELIEVE RUBY WOULD HAVE EVER KNOWN OSWALD AND WOULD NOT HAVE ASSOCIATED WITH OSWALD IF THEY HAD MET.







Mrs. RUTH E. BONDS, aka Mrs. Joseph Ponds, Dale Belmont, 11736 College View Drive, was interviewed at her residence. She was advised that she did not have to make a statement, that anything she said could be used against her in a court of law and she had the right to consult an attorney if she wished. She volunteered the following information: $LilvEP_{intermodel}$ is the following information:

She said that she and her husband, JOSEPH BONDS, owned and operated the Skyview Club, also known as the Sky Club, located on Palmer Street just outside of Lallas, Texas, during the period 1948 to 1953-54 and that during part of this time she and her husband had known JACK^CRUBY as the owner of another night club.

Mrs. BONNS said she knew RUBY only as another club owner and that she had never worked for him as a stripper or in any other capacity. She said as a matter of fact she had never worked as a stripper but she had worked in the entertainment field and had used the name DALE BELMONT. She said that she was not an associate of RUBY and her contact with him was limited to occasional visits she and her husband made to his night club and similar visits he had made to their night club. On these visits RUBY would come to their table and talk to them usually about the night club business in general. She said she knew of no personal friends or associates of RUBY but named "hAPPY" DOLSON, owner of Happy's Showland Club, and ABE WEINSTEIN, owner of the Colony Club in Dallas, as other club owners who could have known RUBY at least in business contacts.

Mrs. BONDS denied that she knew LEE OSWALD and \mathfrak{S} stated she had never heard his name mentioned prior to the ∞ assassination of President KENNEDY on November 23, 1963.

Mrs. BONDS said she recalled that RUEY originally came from Chicago, Illinois, and that from conversations she had had with him she regarded him as very poorly educated and a very quiet man. She said RUBY reportedly was a good fighter and acted as his own club 'bouncer'. She had no information regarding any trouble in which RUBY might have been engaged and she would consider his mental condition normal.
