AL VERIGHT CORPUS CHRISTI, TEXAS, EX-FELON, CONTACTED CORPUS CHRISTI RESIDENT AGENCY THIS DATE AND SAID HE KNOWS FORMER BOOKKEEPER CARROUSELL CLUB WHICH WAS OPERATED BY JACK RUBY ALLEGED MURDERER OF LEE HARVEY OSWALD,. HE SAID THAT THIS BOOKKEEPER IS KNOWN AS MIKE RYAN, AKA RAY PIKE AND HIS INFORMATION IS THAT RUBY IS FRIENDLY WITH JAMES HOFFA AND QUOTE THE SYNDICATE UNQUOTE. HE ALSO SAID THAT RYAN TOLD HIM THAT RUBY IS PAYOFF MAN FOR DALLAS POLICE DEPARTMENT AND WHENEVER LIQUOR AND GAMBLING RAIDS WERE TO BE MADE ON DALLAS UNDERWORLD RUBY WOULD ALWAYS BE CONTACTED FIRST BY SOME UNKNOWN PERSON FROM DALLAS POLICE DEPARTMENT. HE SAID HE MET RUBY IN COMPANY WITH RYAN ABOUT MARCH SIXTY-THREE AND HAS NOT SEEN SINCE. ALL INFO RE RUBY HEARSAY AS TO WITNESS BRIGHT BUT BELIEVES RYAN SHOULD BE LOCATED AND INTERVIEWED.

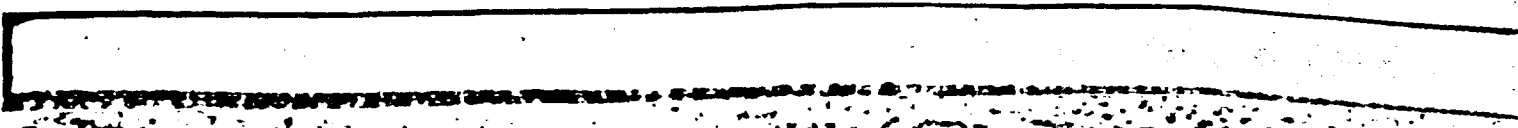

Houston Office advised 11-25-63, concerning information received from one Al Bright, an ex-felon of Corpus Christi, Texas, who said he had heard information to the effect that Ruby is a payoff man for the Dallas Police Department and whenever liquor and gambling raids were to be made on the Dallas underworld Ruby would always be contacted first by some unknown person from the Dallas Police Department.

Bright who contacted the Corpus Christi Resident Agency on 11-25-63, advised he knows the former bookkeeper of the Carousel Club in Dallas which was operated by Jack Ruby, the purported murderer of Oswald. Bright said this bookkeeper is known as Mike Ryan, aka Ray Pike and Ryan is the individual who informed Bright concerning the above information regarding Ruby. Bright stated in about March, 1963, he met Ruby in the company of Ryan and has not seen Ruby since.

ACTION

Dallas has been instructed to immediately locate and interview Mike Ryan and vigorously pursue this allegation of Ruby's association with the Dallas Police Department.

1. Interview Eva Grant, subject's sister, at Dallas, if not already handled, and clarify whether she was operating a night club in 1947 at the time Ruby first went to Dallas. It is not clear from information already available as to whether Ruby went to Dallas to help her operate a club already functioning or whether after his arrival in Dallas, he and his sister pooled their resources and opened a club.

2. Concerning ownership of the Vegas Club, establish the year Ruby opened this establishment and review available records to verify any partners he may have had. Also, it is noted that in interview, Ruby advised that his partners in the Vegas Club were Joe Bonds and Irving Alkanan. If not already handled, set out expedite leads to interview these two persons concerning their business venture with Ruby in the Vegas Club.

3. Verify that Ruby actually purchased the sandwiches at a Dallas delicatessen on 11-22-63 and determine whether or not he actually gave them to KLIF Radio Station personnel.

LLOYD SINEATH, Manager, Charleston Heights Motel, 4241 Rivers Avenue, North Charleston, S. C., advised 11/27/63 that one WALTER last name illegible, registered at Charleston Heights Motel, 9/3/62 in room #17. He was driving a 1956 model Chevrolet automobile. He believes car was green and white. The car bore Virginia license #759078.

The white male paid for one night's lodging and remained at the motel for two days, leaving without paying balance of bill. When he departed he left several articles of personal property and a few clothes in the room.

Sometime later he received a letter from this individual from someplace out of state requesting that he send the clothing and personal articles to him. He destroyed the letter and does not recall the exact locality from which the letter was mailed. He disposed of the clothing and personal articles and did not send them as requested.

When the man registered alone at the motel he appeared to be very nervous and emotionally upset. The man carried on a rambling conversation and did not make sense during his talk with him.

JOHN MARCUS, ATTORNEY, EVANSTON, ILLINOIS, VISITED HAVANA, CUBA, FOR FOUR DAYS LABOR DAY WEEKEND NINETEEN FIFTYNINE WITH TWO COMPANIONS, JAY BOSHOV AND SHERWIN BRAUN. DURING THIS TRIP THE THREE WERE APPROACHED BY A MAN IN THE TROPICANA NIGHTCLUB, HAVANA, WHO GAVE HIS NAME AS JACK RUBY. RUBY STATED HE HEARD THAT THE THREE MEN WERE FROM THE STATES AND INDICATED HE WAS FAMILIAR WITH CHICAGO, HAD ACQUAINTANCES IN CHICAGO, AND MARCUS BELIEVES RUBY MAY POSSIBLY HAVE BEEN ORIGINALLY FROM CHICAGO. RUBY STATED HE OWNED A NIGHTCLUB IN TEXAS, WHICH MARCUS BELIEVES WAS IN DALLAS, TEXAS, AND POSSIBLY CALLED THE CAROUSEL. RUBY INDICATED HE HAD QUOTE EVERYTHING UNQUOTE AT THE NIGHT CLUB INCLUDING GAMBLING. RUBY TOLD MARCUS IF HE EVER PASSED THROUGH DALLAS TO STOP IN AT RUBY/S NIGHTCLUB.

MARCUS STATED RUBY WAS ALONE AND APPEARED TO BE ON VACATION BUT MAY HAVE BEEN FRIENDLY WITH THE EMPLOYEES IN THE GAMBLING SECTION OF THE TROPICANA NIGHTCLUB. THE MEETING LASTED ONLY ABOUT TEN MINUTES AND NO OTHER QUESTIONS OR OTHER INFORMATION WAS OBTAINED. MARCUS STATED NO RADICAL OR POLITICAL TYPE STATEMENTS WERE MADE BY RUBY NOR WERE THERE ANY INDICATIONS HE BELONGED TO ANY PARTICULAR ORGANIZATIONS.

~~ARTURO VOLPE NAVA~~, also known as Yoyo, Nuevo Laredo, Mexico, advised November 29, 1963, that he operates some gambling in Nuevo Laredo, Mexico, and recalls that around the time of the assassination of President KENNEDY and that assassin LEE HARVEY OSWALD was killed by JACK RUBY, someone stated that a lot of bandits and gamblers come to Nuevo Laredo, Mexico from Fort Worth and Dallas, Texas, and wondered if maybe JACK RUBY had possibly been gambling in Nuevo Laredo, Mexico, and NAVA stated that he had never heard the name of JACK RUBY or RUBENSTEIN before this person shot OSWALD and that RUBY has never gambled in Nuevo Laredo, Mexico, to his knowledge.

Records of Mexican Immigration Service, Nuevo Laredo, checked from July 15 to November 22, 1963, failed to disclose any record of JACK RUBY or RUBENSTEIN having entered Mexico at Nuevo Laredo.

RUBENSTEIN SAID JACK INDICATED HE WAS VERY DISGUSTED AND SICK BECAUSE OF THE EVENTS THAT TOOK PLACE IN DALLAS THAT DAY, WHICH PROBABLY CAUSED HIM TO MAKE THAT STATEMENT. RUBENSTEIN SAID THAT JACK MADE NO REMARK ON THE PHONE THAT HE INTENDED TO TAKE ANY ACTION AGAINST LEE OSWALD NOR DID HE INDICATE HE WAS IN ANY WAY ACQUAINTED WITH OSWALD.

Jack Purdie, Chief of Police, Tulsa, Oklahoma, advised a Special Agent of the Federal Bureau of Investigation that he received a telephone call at 12:05 p.m., November 25, 1963, from George Martin, News Director, KVOO-TV (Channel 2), Tulsa, Oklahoma.

Martin advised Chief Purdie that Carl Boye, KVOO-TV newsman had received a telephone call from an unidentified male who spoke in a muffled voice and said, "There will be two assassinations in Washington, D. C. today." This male voice also said that the Chief of Police in Dallas, Texas, will be assassinated today, November 25, 1963.

Secret Service Headquarters, Washington, D. C. and the Chief of Police, Dallas, Texas, have been advised of the above information.

This document contains neither recommendations nor conclusions of any kind. It is the property of the FBI, and is loaned to your agency; it and its contents are not to be distributed outside your agency.

SUBJECT: ASSASSINATION OF PRESIDENT KENNEDY

Deputy Attorney General Katzenbach called with reference to the report which is to be submitted by the FBI in relation to the circumstances surrounding the assassination of President Kennedy.

He noted that a tremendous responsibility had been placed on the FBI in this instance by President Johnson because this report, which is to be publicized, is for the purpose of assuring the American public and the world as to what the facts are in Kennedy's assassination and setting to rest the many, many rumors that have been circulating and speculation both in the United States and abroad.

Katzenbach noted in this regard that we are being called upon to, in many instances, prove the negative. For example, he observed that there has been considerable speculation in the press in the United States and in Europe that the assassination was part of a communist or Castro conspiracy. There have also been allegations that Oswald and Ruby were known to each other and were part of a conspiracy. It has been further alleged that Oswald was killed to silence him.

Katzenbach noted that it is, of course, more difficult to prove that something did not occur than to prove what actually happened. As a consequence, it is his belief there might have to be some so-called editorial interpretation. He noted that the report will be subjected to the closest scrutiny by the world-wide press and foreign governmental representatives, as well as by the American people. He knew that we were keeping this in mind in preparation of the report.

As Katzenbach understood it, the report is to be reviewed by the Justice Department and transmitted to the White House. In this regard, he feels it is his responsibility to do this personally for the Department. To this end, he said if it would be helpful he would be glad to review and discuss preliminary drafts, since time is of the essence.

Memorandum to Mr. Belmont

ACTION BEING TAKEN:

From the facts disclosed in our investigation, there is no question but that we can submit in our report convincing evidence beyond any doubt showing Oswald was the man who killed President Kennedy. The problem is to show motive and this, of course, is a condition of Oswald's mind and can be, at best, a speculative conclusion predicated upon circumstantial evidence. Oswald has admitted he was an avowed Marxist. The facts are not clear cut as to his relationship with organized communism, either the Communist Party or the pro-Castro organizations. The Domestic Intelligence Division has been reviewing this very matter so that our report may reflect the factual information we have in this regard. While neither the White House nor the Department should be able to contend that our report does not meet the required purpose, we must be factual and recognize that a matter of this magnitude cannot be fully investigated in a week's time.

Relative to the Director's question as to how long we estimate the investigation in this matter will take, we plan to have the report on this matter, and on the Jack Ruby matter, this Friday, 11/29/63.

The investigation in both cases will, however, continue, because we are receiving literally hundreds of allegations regarding the activities of Oswald and Ruby, and these, of course, are being run out as received. I think this will continue, and in the absence of being able to prove Oswald's motive and complete activities, we must check out and continue to investigate to resolve as far as possible any allegations or possibility that he was associated with others in this assassination. Likewise, we have to continue to prove the possibility that Jack Ruby was associated with someone else in connection with his killing of Oswald.

All leads are being handled telephonically or by teletype, as they arise. We are continuing to work on the report today and tomorrow, and will have it to the Director on Friday.
