I noted in one of the newspaper stories that allegedly Jack Ruby, the individual who shot Oswald, in commenting on his motive for the killing, said he would be willing to undergo a polygraph examination by the FBI. I doubt the truth of this; nevertheless, one of the key issues in this matter is the actual motive of Ruby for the killing; whether he had help in getting into the police department; whether he is tied in with anyone else, and whether he knew Oswald. Therefore, while I do not think Ruby's attorney would allow any such polygraph interrogation, we should raise the issue.

RECOMMENDATION: To this end, I propose

(1) that we discuss it with the Department from a legal aspect;

(2) that we talk with District Attorney Wade about this, on the basis that, according to a newspaper article, Ruby allegedly was willing to undergo a polygraph examination, and see whether Wade has any objections;

(3) if Wade has no objections, suggest that Wade contact Ruby's defense attorney to see whether he would agree;

(4) if the attorney agrees, and Wade is willing, our agents give Ruby a polygraph examination.





GEOFFREY STATED HE EXHIBITED HIS PRESS CARD TO A UNIFORMED OFFICER, NAME AND BADGE NUMBER UNKNOWN, WHO WAS ON DUTY AT ENTRANCE. HE KNOWS OF NO UNAUTHORIZED PERSON OR PERSONS PERMITTED TO ENTER THE BASEMENT WITHOUT SHOWING APPROPRIATE IDENTIFICATION.

GEOFFREY STATED HE IS OF OPINION AMPLE ARRANGEMENTS FOR SECURITY HAD BEEN MADE INASMUCH AS THE NEWS MEDIA HAD TO ENTER THE BASEMENT FROM THE PARKING LOT, IDENTIFY THEMSELVES, AND REMAIN IN A SPECIFIED AREA ONCE IN THE BASEMENT.

EDWARDS STATED HE HAS NO INFORMATION THAT ANYONE, INCLUDING POLICE OFFICERS OR OTHER OFFICIALS CONSPIRED WITH RUBY OR WILLINGLY PERMITTED THE KILLING OF OSWALD. HE ADVISED HE DID NOT TALK TO RUBY AND THE ONLY TIME HE SAW RUBY WAS AT THE SHOOTING.

EDWARDS ADVISED HE HAS NO INFORMATION REGARDING ANY RELATIONSHIP OR PRIOR ACQUAINTANCESHIP BETWEEN JACK L. RUBY AND OSWALD.

• EDWARDS STATED HE INTERVIEWED TOM HOWARD, ATTORNEY FOR RUBY, AND HOWARD STATED RUBY HAD ENTERED THE BASEMENT OF DALLAS CITY HALL THROUGH THE MAIN STREET ENTRANCE.

EDWARDS STATED HE LEFT DALLAS ELEVEN TWENTYSIX LAST AND RETURNED TO LOS ANGELES, CALIFORNIA. REPORT FOLLOWS. END AND ACK

ON DECEMBER TWO, INSTANT, SA G. MYRYWIN ALDERSON AND SA FURMAN G. BOGGAN INTERVIEWED PETE FISHER, NEW ORLEANS. PHOTOGRAPHEER FRO UNITED PRESS INTERNATIONAL PAREN UPI END PAREN. WHO WAS IN DALLAS COVERING THE VISIT OF PRESIDENT KENNEDY TO DALLAS. FISHER VOLUNTARILY FURNISHED THE FOLLOWING INFORMATION.

FOLLOWING DEATH OF PRESIDENT KENNEDY, FISHER SAW JACK L. RUBY ON ONE OCCASION, THIS WAS AT POLICE HEADQUARTERS IN SHOW-UP ROOM IN BASEMENT OF BUILDING, LATE EVENING OF NOVEMBER TWENTYTWO OR EARLY MORNING HOURS OF NOV. TWENTY THREE, NINETEEN SIXTYTHREE. WHEN OSWALD WAS BROUGHT DOWN TO SHOW-UP ROOM BY DALLAS POLICE. REC 374 ABOUT FIVE MINUTES BEFORE OSWALD BROUGHT INTO SHOW-UP ROOM FISHER NOTED RUBY STANDING IN SHOW UP ROOM NEAR ENTRANCE ON RIGHT SIDE OF SHOW UP STACE AS ONE LOOKS AT STAGE. WHEN OSWALD BROUGHT INTO ROOM FISHER STARTED TAKING PHOTOGRAPHS OF OSWALD END PAGE ONE 1953^{20'}

AND DID NOT AGAIN SEE RUBY. DALLAS POLICE WALKED OSWALD WITHIN THREE FEET OF RUBY AS THEY ENTERED SHOW UP ROOM.

ON NOVEMBER TWENTYFOUR, SIXTYTHREE, FISHER WAS AT COURT-HOUSE IN DALLAS WHERE HE PLANNED TO PHOTOGRAPH OSWALD AS LATTER WAS BEING TRANSFERRED TO COUNTY JAIL AT DALLAS. WHEN HE HEARD THAT OSWALD HAD BEEN SHOT IN BASEMENT OF POLICE HEADQUARTERS, DALLAS, TEXAS, HE IMMEDIATELY WENT TO PARKLAND HOSPITAL TO PHOTO-GRAPH OSWALD. ON NOVEMBER TWENTYFOUR, FISHER DID NOT GO TO POLICE HEADQUARTERS AT ALL.

WITH REGARD TO SECURITY AT POLICE HEADQUARTERS, DALLAS, TEXAS, ON NIGHT OF NOVEMBER TWENTYTWO, FISHER SAID UNIFORMED POLICE WERE CHECKING NEWSMEN/S CREDENTIALS BEFORE ALLOWING THEM TO PROCEED TO THIRD FLOOR OF BUILDING AND AS NEWSMEN EMERGED FROM ELEVATOR ON THIRD FLOOR THEIR CREDENTIALS WERE CHECKED AGAIN.

FISHER MET RUBY ABOUT TWO YEARS AGO WHEN FISHER HAD PHOTOGRAPHIC ASSIGNMENT AT CAROUSEL CLUB. AT THAT TIME FISHER WAS WORKING FOR UPI IN DALLAS AND ATTACHED TO DALLAS TIMES HERALD NEWSPAPER. AFTER FIRST MEETING WITH RUBY, FISHER SAW HIM FROM TIME TO TIME ON STREETS OF DALLAS AND IN DALLAS POLICE END PAGE TWO HEADQUARTERS WHERE OCCASIONALLY RUBY WOULD BRING COFFEE TO DALLAS OFFICERS WORKING OVERTIME ON PROLONGED INVESTIGATIONS.

FISHER HAS NO KNOWLEDGE THAT RUBY AND OSWALD EVER ACQUAINTED WITH EACH OTHER AND HAS NO KNOWLEDGE DALLAS OFFICERS OR OFFICIALS CONSPIRED WITH RUBY IN KILLING OF OSWALD OR PERMITTED KILLING.

• FISHER STATED HE HAD HEARD RUMORS THAT OSWALD AND RUBY KNEW EACH OTHER, CITING AS AN EXAMPLE THE QUOTE MEMORY EXPERT UNQUOTE WHO WAS INTERVIEWED BY THE PRESS AND WHO CLAIMED HE RECALLED HAVING SEEN OSWALD IN THE CAROUSEL CLUB. FISHER SAID HE DISCOUNTS ALL THESE RUMORS AND BELIEVES NONE OF THEM.
