PREVIOUS INTERVIEWS EARL R. RUBY, SOUTHFIELD, MICH., AND REVIEW OF DALLAS REPORT INSTANT MATTER REVEALS NO INDICATION JACK RUBY EVER IN MICH. NO INFO AVAILABLE DETROIT THAT OSWALD EVER IN MICH. OR KNOWN AT MICHIGAN STATE UNIVERSITY .

IT IS FELT DALLAS MOST PROBABLY IN POSSESSION OF WHEREABOUTS OF RUBY AND OSWALD DURING ABOVE PERIODS. UAC DALLAS, NO FURTHER INVESTIGATION OF INSTANT ALLEGATION BEING CONDUCTED. INVESTIGATION TO VERIFY HBR ALLEGATIONS WOULD REQUIRE EXTENSIVE INTERVIEWS OF MICHIGAN STATE UNIVERSITY OFFICIALS AND PERSONNEL IN ADDITION TO VOLUMINOUS RECORD REVIEWS.

SLOAN STATED HE QUIT EMPLOY OF RUBY AND RETURNED TO CHICAGO AS MARRIAGE PLANS DID NOT MATERIALIZE.

HE EXPRESSED OPINION THAT JACK <sup>R</sup>JUBY STARTED IN BUSINESS WITH MONEY FURNISHED BY HIS BROTHER EARL. HE STATED THAT RUBY NEVER KNOWN TO ENGAGE IN GAMBLING ACTIVITIES IN CHICAGO OR DALLAS. OFFICER RUSHING INTO 200K DEPOSITORY BUILDING WHILE MOST OF POLICE AND SECRET SERVICE WERE RUSHING UP AN INCLINE TOWARDS RAILROAD TRESTLE. ██████████ STATED, AFTER VIEWING THIS FILM, IT RAISED QUESTION WHY MAJORITY OF THE PEOPLE WERE RUNNING TOWARDS THE RAILROAD TRESTLE. ANOTHER SALESMAN FOR THE LINCOLN MERCURY AGENCY. LAWRENCE STATED THAT HE HAD ADVISED THE FBI OF BOGARD-S KNOWLEDGE REGARDING OSWALD. BOGARD ADVISED NBC THAT LAWRENCE HAD BEEN "PICKED UP" BY FBI THE EVENING OF ELEVEN TWENTY TWO SIXTY THREE AS A SUBVERSIVE, AND THAT LAWRENCE THEN ADVISED FBI REGARDING BOGARD. LAWRENCE DENIED BEING A SUBVERSIVE AND ADVISED NBC THAT HE HAD POSSESSED A SECURITY CLEARANCE HAVING WORKED FOR PROJECT MERCURY IN FLORIDA. NBC CHECKED WITH PROJECT MERCURY AND NO INDIVIDUAL BY THAT NAME EVER EMPLOYED THERE. LAWRENCE ALSO ADVISED NBC HE HAD WORKED ON PRESIDENT KENNEDY-S PRIMARY CAMPAIGN IN LAWRENCE-S HOME TOWN, CHARLESTON, WEST VIRGINIA, AND HAD HAD A "PLUM JOB". LAWRENCE LEFT DALLAS GIVING FORWARDING ADDRESS IN CHARLESTON, WEST VIRGINIA. NBC CONTACTED THIS ADDRESS AND MAN IDENTIFYING HIMSELF AS FATHER-IN-LAW OF LAWRENCE ADVISED LAWRENCE HAD NOT BEEN THERE FOR SEVERAL MONTHS AND WAS NOT EXPECTED. CONCERNING MRS. MRS. PAINE STATED THE FIRST TIME SHE HEARD FROM OSWALD AFTER HE LEFT NEW ORLEANS FOR MEXICO WAS ON TEN FOUR SIXTY THREE WHEN OSWALD APPEARED AT PAINE HOUSEHOLD. ACCORDING TO MRS. OSWALD INQUIRED CONCERNING THE POSSIBILITY OF OBTAINING A JOB AND STATION MANAGER SUGGESTED OSWALD TRY RADIO STATION AT PLEASANTON, TEXAS. INQUIRY AT THIS STATION BY NBC REFLECTED OSWALD DID NOT CONTACT THEM BUT GAS STATION ATTENDANT, FIRST NAME UNKNOWN PACHECO, PLEASANTON, TEXAS, STATES MAN RESEMBLING OSWALD STOPPED FOR GAS AND HAD WOMAN AND CHILD IN CAR. The Dallas Office previously recommended that Ruby be contacted to ascertain his willingness to answer many questions concerning his movements, possible associations with Oswald, his motive for killing Oswald, how he gained entrance to the basement of the police building and so forth. On 12-11-63, approval was given to Dallas to interview Ruby if County District Attorney Wade and defense attorney Tom Howard interposed no objection. Dallas was also advised that if Ruby insists the interview take place in the presence of Howard, the interview should still be conducted taking all due precautions to phrasing questions in such a manner that neither Howard or Ruby would become aware of information which should be withheld from them.

Press releases now indicate that Melvin M. Belli, a flamboyant attorney from California, will participate in the defense of Ruby and has arrived in Dallas in this regard. Although it appears Belli will gain all of the publicity out of this case he can, it is still believed that we should proceed with the interview of Ruby as we would not be in a favorable position if, merely because Ruby's attorney may be of questionable character, we neglected to receive all of the information Ruby is willing to furnish.

ACTION:

If approved, we will proceed with the interview of Ruby subject to concurrence of the County District Attorney and defense counsel.
