The following investigation was conducted by SA KDNOND C. HARDIN at Dallas, Texas:

On December 18, 1963, MATTIE NELSON, <u>2635 Forrest</u> Avenue, Dallas, was telephonically contacted in order to make an appointment for interview. Mrs. MELSON was advised that her name and the number "TR 8824" appeared in an address book, the property of JACK RUBY. Mrs. NELSON advised that she is sure that this name and number referred to her and that the number was possibly a license number although she does not recall the number at this time. Mrs. NELSON stated that she was previously interviewed concerning this case on December 12, 1963, by SAS ALLEN H. SNITH and TOM P. CHAPOTON.

The name TON MUSKARD appeared in an address book secured from RUBY's property following his arrest by the Dallas Police Department on November 24, 1963. A search of the Dallas Office indices, telephone and city directories from 1958 to present, failed to reflect the name MUSKARD.

On December 19, 1963, BIRDIE SUE BELCHER, Retail Merchants Credit Association of Dallas and Identification officers PAT CROSSLAND, Dallas Police Department, and J. H. KITCHING, Dallas County Sheriff's Office, advised that they were unable to locate any information in their files identifiable with TON MUSKARD.

The name and telephone number JACK GREEN, BL 5-3389, appeared among the property of JACK RUBY obtained from his person following his arrest by the Dallas Police Department on November 24, 1963.

On December 17, 1963, a call was placed to Dallas telephone number BL 5-3389 in an effort to locate JACK GREEN. Mrs DONALD CLARK, JR., 2306 Finley, telephonically advised that she and her husband have had telephone number BL 5-3389 since about 1960 or 1961 and before that time the prefix did not exist in a telephone number at Dallas. She added that JACK GREEN is not known to her.

C. B. NICHOLS, <u>3382</u> Community Drive, was advised that he did not have to make a statement, that any statement he did make could be used against him in a court of law and that he had the right to an attorney prior to making any statement. He then furnished the following information:

In reference to the Carousel Club Pass Card 150, NICHOLS stated that some four to six weeks ago RUBY came to the Sheraton-Dallas Hotel, took the names of all the bellboys on duty that evening and gave them all passes to the Carousel Club. In return, the bellboys were to recommend the Carousel Club to the hotel guests. NICHOLS stated he knew RUBY approximately one year but had never been in his clubs. He stated he knew of no association between RUBY and OSWALD. He knew of nothing of his travels. He also knew of no conspiracy or of any knowledge of any connection between RUBY and the Dallas Police Department.

Mrs. J. DAVIDANICHOLS, <u>5007 Cedar Springs</u>. <u>Dallas</u>. <u>/EIAS</u> whose name was found in a book which was the property of JACK RUBY, was immediately advised of the identity of the interviewing Agent, that she was not required to make a statement, that any statement she made might be used against her in a court of law, and that she had the right to counsel before making any statement. She then furnished the following information:

She had met JACK RUBY some three years ago when she was operating the Nichols International Corporation at the Fidelity Union Life Building, a theatrical booking agency. (RUBY contacted her at that time and requested NICHOLS to obtain dancers for his club. NICHOLS did not furnish any dancers for RUBY's clubs, and stated that that was the only contact she had with RUBY other than the two or three times when she went to the Carousel Club socially. She has not seen JACK RUBY for over one year. She does not know LKE HARVEY OSWALD and she never saw JACK RUBY with LEE HARVEY OSWALD. She knew of no connection between RUBY and the Dallas Police Department, and she knew nothing of RUBY's travels. She did not know any organizations to which RUBY belonged; she knew of no conspiracy between RUBY and any other individual(s) to kill OSWALD.

Mr. ROBERT R. AO'DONNELL, <u>10532 Cronwell</u>. <u>Dallas, Texas</u>, owner of the General Films Distributing Company, 412 South Harwood, Dallas, whose business card appeared as "BOPAO'DONNELL, General Films Distributing Company, 412 South Harwood" in RUBY's personal effects, was interviewed at his place of business at which time he advised that it would be very logical for JACK RUBY to have both his name and his business card in his personal effects. He explained this by saying that he has known JACK RUBY for sometime and has associated with him to a limited degree.

Approximately twelve years ago, he was introduced to JACK RUBY by an individual whose name he recalled as being MOE ROSENBLOOM who is now deceased. During the period he has known RUBY, he never hew him to be anything other than "a real nice guy". Mr. O'DONNELL stated that he has talked with RUBY on various occasions during the past years and that as a general rule the conversation centered around the field of entertainment. He could not recall any particular conversation and did not feel that he, O'DONNELL, ever discussed politics with RUBY. He knew of nothing whatsoever that would connect RUBY with any subversive type group and did not believe anyone conspired with RUBY to shoot LEE HARVEY OSWALD.

O'DONNELL advised that he is not acquainted with LEE HARVEY OSWALD and had heard his name for the first time in connection with the assassination of President KENNEDY.

Mr. O'DONNELL advised that he could only recall one individual that had worked for RUBY and who knew RUBY quite well. He identified this man as being a prize fighter by the name of BUDDY TURMAN, who he believes is now somewhere in Europe. He mentioned that TURMAN is possibly back fighting again and if so would be touring the Europe circuit, explaining that TURMAN would be fighting throughout the various countries in Europe.

O'DONNELL stated that he last saw JACK RUBY during the evening of September 13, 1963, and had engaged in a brief conversation with RUBY at that time. Although

he could not be sure, O'DONNELL was of the opinion that he had seen RUBY that evening at the Carousel Club.

Mr. O'DONNELL stated that he was in New Orleans when the President was assassinated and could not offer any information whatsoever in regard to either the assassination or the shooting of LKE HARVEY OSWALD other than what he had heard from the local news media and television.

In regard to RUBY's background, Mr. O'DONNELL was unable to furnish any other names of friends, associates or relatives that RUBY may have had during his time in Dallas.

Mr. PHIL MARTIN OLIAN, <u>4511</u> Westway, Dallas, Telephone Number LA 8-9024, whose name appeared as "PHIL OLIAN, RI 1-4511," among JACK RUBY's possessions, was contacted at which time he furnished the following information:

He advised that sometime in 1960, exact date he could not recall, he became a member of the Sovereign Club, which he described as being a local night club. He stated that the Sovereign Club was at that time owned and operated by JACK RUBY. In regard to his membership, Mr. OLIAN stated that to the best of his recollection, Mr. RUBY had approached several individuals in efforts to obtain additional members for the Sovereign Club when it was originated in about 1960.

Mr. OLIAN was unable to furnish any information pertaining to RUBY's background inasmuch as he could only recall talking to RUBY on a very casual basis and would as a general rule only greet him whenever he visited the Sovereign Club. He could offer no information as to RUBY's friends, associates, or relatives, but was under the impression that RUBY had several friends in the Dallas area. Mr. OLIAN stated that he had no idea why RUBY had shot LEE HARVEY OSWALD and that the only information he possessed concerning either the assassination of President KENNEDY or the shooting of LEE HARVEY OSWALD was that which he had obtained from the local newspapers and television. He knew of no connection between OSWALD and RUBY whatsoever.

He was not a frequent patron of the Sovereign Club during his membership and could only recall four or five times that he had gone there for entertainment. He stated that he has been in both the Carousel and the Club Vegas on one or two occasions, but could never recall seeing RUBY on any of these occasions. The last time he saw JACK RUBY was approximately seven or eight months ago and believed that it was on the street somewhere in Dallas.

Mr. OLIAN stated that it is very logical that his name and telephone number had appeared in RUBY's personal effects inasmuch as he was a member of the Sovereign Club at one time.

LESTER METTA PARRISH, doorman at the Statler-Hilton Hotel, Dallas, Texas, was contacted since JACK RUBY's records indicate that PARRISH had Carousel Club pass no. 109. Mr. PARRISH furnished the following information:

He resides at <u>1202 Dearborn, Dallas, Texas.</u> His telephone number is AD 5-6965.

PARRISH has known JACK RUBY on a very casual basis for approximately six to eight years. RUBY has been in the Statler-Hilton Hotel where Mr. PARRISH is doorman, many times over the years and has on numerous occasions asked PARRISH, or indicated to PARRISH, that he would like PARRISH to give out RUBY's cards to guests of the hotel. PARRISH has told him on each occasion that he has a standard answer when guests indicate they are interested in seeing a "girlie show." This answer is "There are three places down the street." He further tells them that all these shows are in close proximity to the hotel and insofar as he knows they are all the same.

PARRISH has indicated on more than one occasion to RUBY that he had no interest in his show and although he was civil to RUBY, he never so much as had a cup of coffee with him. RUBY told him he was going to give him a permanent membership card to his club and PARRISH replied to RUBY that he did not know why RUBY would do this because his answer to the guests of the hotel would still be the same.

PARRISH stated that he has been to the Carousel Club on two occasions and on each occasion he stayed not more than approximately 20 minutes. He informed that the last time he was there was approximately five months ago, when he had one beer and left. PARRISH informed that he is not acquainted with LEE HARVEY OSWALD and knows of no connection between JACK RUBY and OSWALD.

JOHNNIE ROSS PATRONO, commonly known in Dallas as JOHNNY ROSS, residence <u>4411 Munger Street</u>, <u>Dallas</u>, <u>Texas</u>, who operates the Sportsman Club, 2716 McKinney, Dallas, advised he has known JACK RUBY for about seven or eight years. He said he first met RUBY at the Vegas Club on Oak Lawn Avenue, which RUBY was operating at the time. He continued to see RUBY at this club and later at the Carousel Club. He stated that conversations with RUBY usually had to do with the night club business or were of a general nature. PATRONO stated he never discussed politics with RUBY, nor did he ever hear RUBY state any political likes or dislikes, or any fondness for or animosity to any politician.

PATRONO stated that RUBY's best friend, in his opinion, was <u>RALPH</u> <u>PAUL</u> PATRONO stated he had observed PAUL with RUBY at both the Vegas and Carousel Clubs on numerous occasions.

PATRONO described RUBY as the type of person who would do anything to help anybody. He cited as an example, about five years ago RUBY had loaned PATRONO \$500 which PATRONO needed very badly at the time. PATRONO stated he paid this back over a period of three years at \$10 and \$20 at a time. PATRONO stated RUBY had a very bad temper, was high strung, and appeared to be quite nervous. PATRONO stated that whenever RUBY became angry be would resort to physical violence.

PATRONO advised he had never heard JACK RUBY mention the name of LEE HARVEY OSWALD and PATRONO also stated he had never seen OSWALD with RUBY at any time. He stated he knew of no association whatever between RUBY and OSWALD. PATRONO stated he does not know OSWALD.

PATRONO stated the last contact he had with RUBY was about five weeks ago, or about the middle of November, 1963, at the Carousel Club, and again his conversation with RUBY had to do with the night club business. PATRONO advised he had no information whatsoever that RUBY had ever been involved in any manner in any gambling activities.

He stated he never has actually worked for JACK RUBY and has had little contact with him. He said to the best of his knowledge, RUBY operates a "clean," legitimate business and he has never been engaged in any illegal activities.

- CHARLES T./PETTIGREW, <u>2729 North Henderson</u>, <u>Apartment B. Dallas. Texas.</u> furnished the following information:

PETTIGREW is employed by the City of Dallas in the City Planning Department. In about April, 1960, he joined the Sovereign Club, paying an initial fee of \$10 to \$15. The Sovereign Club was a private club and was located at the present location of the Carousel Club. He was a member of the club for approximately one year, at which time the Sovereign Club closed. Shortly thereafter, the Carousel Club, a public club, was opened.

PETTIGREW was casually acquainted with RUBY since he saw RUBY when he, PETTIGREW, attended the Sovereign Club during the period of his membership.

When the Sovereign Club closed, PETTIGREW did not frequent the Carousel Club and, thus, did not see RUBY again until approximately June, 1963, when RUBY appeared at the City Planning Department Building. RUBY remembered PETTIGREW from the Sovereign Club days and offered PETTIGREW a pass card for the Carousel Club. In September, 1963, PETTIGREW had out-of-town friends visiting him and he took them to the Carousel Club. That was the last time PETTIGREW saw RUBY.

PETTIGREW advised he did not know LEE HARVEY OSWALD and has no information or knowledge pertaining to any acquaintance between OSWALD and RUBY.

He advised he, naturally, has heard of JACK RUBY through all the press information in recent weeks, however, never was personally acquainted with him. He stated he never officially joined any of RUBY's clubs, although may have gone to one of them, date and time unrecalled.

• PHILLIPS stated he never knew LEE HARVEY OSWALD and knows of no connection between RUBY and OSWALD. He has no knowledge as to how RUBY may have entered the Dallas Police Station or why RUBY shot OSWALD and, further, has no information regarding RUBY's acquaintances among the Dallas Police. He does not recall ever seeing JACK RUBY and can furnish no information as to his activities at the time of the assassination or immediately thereafter.

Mr. <u>AADRON A.</u> (ALY PIERCE, <u>1532 Del Rancho</u>. <u>Irving, Texas, telephone BL. 4-6640, pilot for Central</u> <u>Airlines, Dallas, advised he resided three or four doors</u> from JACK RUBY at the Continental House Apartments, 4828 Alcott, Dallas, for approximately five or six months during 1961.

Mr. PIERCE advised that he met RUBY around the phol of the Continental House and learned he was the operator of the Sovereign Club in downtown Dallas. RUBY gave him a pass to enter the club and he and his wife subsequently visited the club four or five times.

He last daw JACK RUBY in the early part of 1962 in his club, which he believes was The Sovereign. He did not talk to him at that time, although did get in free with his pass.

As far as he knew, RUBY operated these clubs in Dallas, however, did not discuss them with him other than in a general manner. He does not know RUBY's associates or close acquaintances and did not socialize with him other than mentioned above.

PIERCE stated he did not know LEE HARVEY OSWALD and, to his knowledge, OSWALD never visited RUBY at the Continental House Apartments, nor had he ever seen them together at that time. He knows of no connection between RUBY and OSWALD and knows of no reason why RUBY shot OSWALD. He stated he has no information as to why or how RUBY may have entered the police station. As reiterated above, he last saw RUBY in early 1962 and knows of no information as to his recent activities.

He added that, at the time RUBY lived at the Continental House Apartments, RUBY did not appear to be overly friendly with anybody who resided there and he can offer the name of no individuals who may have been close associates of RUBY at this location.

He is employed by the First Southwest Company with offices in the Mercantile Bank Building, telephone number RI 2-6461, Dallas, Texas. The first time he met JACK RUBY was about three years ago when he went to RUBY's Sovereign Club. Some individual, whose name he cannot recall, came to his office and furnished him a pass card to the club. He only visited the club on a few occasions and chatted with RUBY briefly one or two times. The last time he saw RUBY was on the street in downtown Dallas about one and one-half years ago. He knows nothing concerning RUBY's background, personal life or political convictions. He stated he does not know the identity of any of RUBY's friends or associates. He cannot recall the identity of any other members of the Sovereign Club at that time.

He had never heard of LEE HARVEY OSWALD prior to the President's assassination, has no idea why RUBY shot OSWALD, and knows of no connection between these two men.

His office telephone number in Houston was CA 7-5221 and he seemed to recall that the number RI 3-2783 was some how connected with his activities there. He felt therefore that the name RACK on the note pad was obviously a mistake in spelling and should have been RASH.

Mr: REDMON has been the manager of the Texas Consumer Finance Company, 1310 Commerce Street, Dallas, since April 22, 1963. Since April, 1963, REDMON has had periodic contact with JACK RUBY as RUBY's Carousel Club is located on the second floor in the same building as the Texas Consumer Finance Company.

REDMON recalled that approximately four or five months ago RUBY desired to install a blinking light Carousel Club sign that would have extended across the top of the Texas Consumer Finance Company building frontage. Executives of the Texas Consumer Finance Company objected to RUBY's plan and REDMON so advised RUBY. RUBY did not attempt to carry out his plan.

The last time REDMON had any dealings with RUBY was a week to ten days prior to the assassination of President KENNEDY. At that time, RUBY and REDMON split the expenses of having refuse and debris picked up from the area immediately behind the building that they both occupy. REDMON recalled RUBY as being a person who was friendly and cooperative in any of their business dealings.

REDMON had no knowledge of any of RUBY's associates or personal affairs. He did not know LEE HARVEY OSWALD and had no knowledge of any acquaintance between RUBY and OSWALD.

REEVES furnished the following information:

On Saturday evening, November 23, 1963, at approximately 7:30 p.m., a stripper from JACK RUBY's Carousel Club, which is located adjacent to Nichols Garage, appeared at the garage and asked to use the telephone. Shortly thereafter, REEVES received a telephone call from JACK RUBY who was at home at his apartment. RUBY told REEVES that one of his strippers from the club had just called him and was in need of some money. RUBY requested REEVES to give the girl \$5 and to get a receipt from her. RUBY advised REEVES that he, RUBY, would be at the garage later that evening to repay REEVES the \$5 loan. REEVES complied with RUBY's request and gave the girl \$5 and in turn received a receipt from her.

Approximately 30-45 minutes later that evening, JACK RUBY appeared in Nichols Garage and repaid REEVES the \$5.

REEVES has been employed as night manager of Nichols Garage for approximately one year. He became acquainted with RUBY at the start of his employment as RUBY for many years has parked his personal car at Nichols Garage. REEVES described RUBY as a good-hearted man who always seemed friendly and cheerful. RUBY, after closing his Carousel Club after midnight, periodically would bring REEVES a cup of coffee when RUBY came to the garage to get his car. On some nights when RUBY came to pick up his car he would have one of his strippers from the Carousel Club with him. Many times, RUBY would come to pick up his car and would be alone.

REEVES did not know LEE HARVEY OSWALD. Upon viewing a photograph of OSWALD, REEVES was positive that he had never seen OSWALD in the company of JACK RUBY.

MICKEY ANN RHODES, 3502 Michigan, Dallas, Texas, who is presently unemployed, advised as follows:

In approximately 1959 when Miss RHODES was employed at the Baker Hotel, Dallas, as an information clerk, a man, JACK RUBY, whose identity was not known to her until two years later, started a conversation with her at the Baker Hotel. She said he wanted to get acquainted and offered her a job at his nightclub. She stated she was only 17 years old at the time and could not work in a nightclub. He did not indicate the type of work she was to do.

Approximately two years ago she visited RUBY's Carousel Club in Dallas with friends and RUBY introduced himself to her group. She said until that time she did not know the man who approached her in 1959 with an offer for a position at his club was JACK RUBY.

She did not see RUBY again until April 1963 when RUBY ran into a car driven by her. She stated that Dallas police officer L. W. SPRADLIN (phonetic) investigated the TEXAS accident and while she, RUBY and Officer SPRADLIN were talking about the accident, officer SPRADLIN made the following comment to RUBY: "Well, JACK, we've been friends for a long time but the way I see it, you're in the wrong." She added that officer SPRADLIN gave RUBY a ticket.

She related that soon after the accident RUBY called her and offered her \$50 if she would not show up in court. She said RUBY told her he was afraid of losing his driver's license if the case went to court. Miss RHODES informed RUBY that she had a summons and had to appear in court. She stated that in approximately October, 1963, she and RUBY appeared in a Judge's chambers and their case was settled there.

Miss RHODES believed that RUBY had no car insurance and her insurance company brought no charges against RUBY. She said she carried \$50 deductible and her insurance company paid for the repairs to her car above \$50. She added that in the settlement RUBY gave her a cashier's check in October, 1963, in the amount of \$50 and in addition, he gave her \$20 or \$25 in cash. She recalls that the cashier's check

given to her by RUBY in October, 1963, was purchased by RUBY in April, 1963 but she was unable to recall the bank from which RUBY purchased the cashier's check.

She related that other than possibly Officer L. W. SPRADLIN mentioned above, she knew of no one acquainted with RUBY and she has had no other contacts or association with him. She knew nothing about his social or personal life. She did not know LEE HARVEY OSWALD and had no idea why RUBY shot OSWALD. She knew of no association between RUBY and OSWALD. 1

Mr. JOSEPH E. RICHMAN, 6709 Prestonshire Lane. General Supervisor for Wards Drug Company, advised he met JACK RUBY approximately three or four months ago in a Wards Drug Store on Oak Lawn Avenue. RUBY was in the store buying whiskey for his club and he had occasion to speak to him. He was not socially acquainted with RUBY and did not visit his clubs, however, heard about him, in view of their similar religious beliefs. He understood that RUBY had many acquaintances in the Dallas Police Department and invited many policemen to his clubs from time to time. He felt that RUBY was a religious man and heard he went into the synagogue to pray for the President immediately after the assassination.

He has no information as to how RUBY may have entered the Dallas Police Station or why he shot OSWALD. He has no information of RUBY's activities the day of the assessination or immediately thereafter.

He is employed as a salesman for the BEN E. KEITH Beer Company in Dallas. During the course of his work he met JACK RUBY at the Vegas Club about eight or ten years ago. The last time he saw RUBY was sometime during the Summer of 1963 in Dallas.

RILEY recalled vaguely that about three years ago, RUBY furnished him with a membership card to the Sovereign Club.

RILEY knew very little concerning RUBY's background other than he mentioned being from Chicago. He knew nothing concerning RUBY's personal life, but always found him to be a friendly individual. He had no idea of what RUBY's political convictions were or why he took upon himself to shoot LEE HARVEY OSWALD.

RILEY had never heard of OSWALD prior to the President's assassination and knows of no connection between OSWALD and RUBY.

J. BYRONASAUNDERS, Room 346, Texas Bank and Trust Company, <u>Attorney-at-Law, Tyler, Texas</u>, was interviewed concerning his knowledge of JACK RUBY inasmuch as Mr. SAUNDERS' name was believed found among the effects or property of JACK RUBY.

Mr. SAUNDERS stated he was representing a client in Dallas during 1960 and while at Dallas joined the Sovereign Club which was operating in the 1300 block of Commerce Street. He stated he joined the club and had correspondence with the club concerning his bill; however, he was at the club only one time. He said he can recall meeting JACK RUBY one time and RUBY was believed to be the manager of the Sovereign Club.

Mr. SAUNDERS stated the one conversation he had with RUBY at the club he would term as being "chit-chat". Mr. SAUNDERS had two pieces of correspondence bearing the letterhead name of the Sovereign Club. One letter concerned charges for food and drink and was signed Miss DALE, Office Secretary. The other letter concerned placing reservations for an anticipated party and was signed Miss LANE, Office Secretary.

Mr. SAUNDERS concluded the interview by stating he met JACK RUBY one time to his recollection and had no information about him or of any association RUBY may have had with LEE HARVEY OSWALD.

HARRY P SELDERS, <u>2337 Highwood</u>, <u>Dalles</u>, <u>Texas</u>, whose name was found in a book which was the property of JACK RUBY on December 19, 1963, advised as follow:

He is employed as a <u>taxicab driver</u>. He never met JACK RUBY and does not knew RUBY by sight. He did not know LEE HARVEY OSWALD and has no information regarding any relationship between RUBY and OSWALD. He has no information concerning the shooting of OSWALD.

He has a close friend named RICHARD HAND, former office manager of Rich Concrete Company, Dallas. About three years ago, HAND submitted four or five names of persons connected with the Rich Concrete Company as company members of the Sovereign Club. He believes HAND submitted his (SELDERS) name and that his probably how his name happened to be in RUBY's property. However, he never visited the Sovereign Club or any other night club operated by RUBY. RUTH SHAY, <u>3333 Inwood Road, Apartment D. Dallas.</u> Texas, furnished the following information:

Mrs. SHAY is employed by Texas Instruments, Inc., Dallas. She first met JACK RUBY approximately seven or eight years ago at the Vegas Club. She periodically went to the Vegas Club and on these occasions RUBY was very friendly and nice to her and any companions that attended the Vegas Club in her company.

In approximately mid-October, 1963, Mrs. SHAY attended a Texas Products Show held at the Mart Building, Dallas. There she met RUBY and during the conversation RUBY inquired as to why she in recent years had never been to his Carousel Club. Jokingly he said to her that perhaps his club was not good enough for her. He then gave her a card for the Carousel Club and at the same time he also gave her a twistboard that he was attempting to distribute and sell.

Mrs. SHAY described RUBY as a good-hearted man who would oftentimes go out of his way to assist a friend in need. Mrs. SHAY advised that she had no other pertinent information regarding RUBY and any of his associates. She did not know LEE HARVEY OSWALD and had no knowledge of any acquaintance between OSWALD and RUBY.

SIMMONS, employee, Advertising Service Department, Dallas Morning News, advised that he has seen JACK RUBY on four or five occasions at the newspaper during the past year and a half in connection with RUBY desiring to change an ad he planned on running. The last time he saw RUBY was a month or so ago, at which time RUBY indicated he was giving SINDONS a Carousel pass card. RUBY indicated he was starting this system of pass cards for his Carousel Club rather than writing out pass slips to the club as he had done previously. SIMMONS never used this pass and has never been in the Carousel Club. His contacts with RUBY were limited to the newspaper building and he has not seen RUBY since the last time RUBY was in regarding an ad.

SIMMONS was not acquainted with LEE HARVEY OSWALD, knew of no association between OSWALD and RUBY and knew of no individuals involved with either of these two men in the shootings.

Mrs. SMITH advised she resides at 6217 St. Albans Drive telephone TA 7-2090. She stated she met JACK RUBY in 1958 at a restaurant where she was eating with a group of people and where RUBY was also with another group. She does not recall the identities of the other people with RUBY. She stated as a result of this meeting RUBY took her out to dinner two or three times during the following two or three sonths and when she realized he was too old a man for a girl her age (19 years), she decided to see no more of him. She added that since that time she has not seen or talked to RUBY.

Miss SMITH stated RUBY appeared to be a nice friendly person and other than this she learned practically nothing concerning his background, character or personality.

Mrs. SMITH advised she did not know LEE HARVEY OSWALD and knew nothing of the shooting of OSWALD on the part of RUBY. She stated she has received no information concerning any possible relationship between OSWALD and RUBY.

VENOICE ANN/SMITH, 1327 Plymouth Road, WH. 1-0997, <u>Dallas, Texas</u>, was interviewed, in that her name was found when RUBY was searched.

She related that sometime during June or July, 1963, she was walking through the lobby of the Medical Arts Building, which connects with the Republic National Bank, where she works, when she was stopped by a man waiting for an elevator. She continued that she had worked as a teller in the Republic National-Bank and assumed this man was one of her customers. He acted as though he knew her but, after a few words, she asked him who he was. He stated he was JACK RUBY and continued to talk to her as if he knew her and asked her where she was located now. She told him she was in the Personalized Check Section at the bank. She also told him she was in a hurry and departed without further conversation. She did not furnish her name to RUBY and stated he must have obtained her name from the name plate on her desk in the bank. She continued that she received two or three telephone calls from RUBY at the bank, asking her to have dinner or drinks after work but, on each occasion, she refused his invitation. She stated the name JACK RUBY had meant nothing to her at this time and she finally realized he was associated with the Carousel Club. On the last call, she mentioned this to him, and he acknowledged that he operated the Carousel Club, and stated he was sorry she had found this out, in that he did not often have an occasion to date nice girls.

SMITH concluded that she has no additional knowledge concerning RUBY, has no idea who his friends and associates are, has no information regarding his business dealings, and has no knowledge of any connections he has with the police. She stated she did not know LEE HARVEY OSWALD and had no information as to whether OSWALD and RUBY were associated. She did not know RUBY's whereabouts on November 22 - 24, 1963.

They talked a few minutes and she was introduced to RUBY and was told that he also had an apartment in this same building. RUBY was only there for a short time and departed.

She had stated that SPRADLIER had said, "Well Jack, we have been friends for a long time, but the way I see it, you are in the wrong.

Patrolman SPRADLIN advised he remembered the incident, that he has not seen RUBY for seven or eight months. He became acquainted with him while he was in the Patrol Division and was working a district where one of RUBY's club was located. He advised he never knew RUBY well, but that while working the late shift, he frequently dropped by an eating place called "Phils" which was located on Preston Road on the East side of the street just South of Northwest Highway. He stated this place has changed hands or is no longer there. He stated he frequently dropped in late at night for coffee and that often JACK RUBY was in there and would buy coffee or a breakfast for him, depending whether he was eating, or drinking coffee.

SPRADLIN stated that on the day that OSWALD was shot, it was his way off and he was church at the time OSWALD was shot. He stated he does not recall seeing RUBY" since he had worked the accident mentioned above. He knows nothing of any association that RUBY had with OSWALD and does not know any of RUBY's associates. He has known RUBY casually for seven or eight years.

Mrs. TAYLOR stated that her mother, Mrs. PRIEST, met JACK RUBY six or seven years ago in Dallas, when she operated a dance studio. Some of her instructors put on dance exhibitions in RUBY's clubs. Mrs. PRIEST moved from Dallas approximately two years ago and, to her knowledge, has not seen RUBY since that occasion.

She met her mother at the home of their relatives in Louisiana "Frieral weeks ago, at which time they discussed the assassination of President KENNEDY and subsequent shooting of OSWALD by JACK RUBY. At this time, her mother did not profess to have ever heard of OSWALD before and did not give her any indication that she knew why RUBY shot OSWALD. Mrs. PRIEST has not been in Dallas for many months and was not in Dallas at the time of the assassination, nor has she been in Dallas since.

Mrs. TAYLOR continued that her mother did not furnish her with any additional information concerning RUBY's activities and she knows that when her mother was in Dallas she did not associate with RUBY, other than in a professional manner, as related above.

TRIESCH advised that he was at a men's fashion convention in Dallas sometime during April, 1963. While leaving his hotel one night with another man, he observed two well-dressed men and a woman arguing in front of the Carousel Night Club located across the street from the hotel. He and his companion crossed the street and told the three people who were arguing that they had better quiet down before causing a scene and getting arrested. At this point, the three individuals walked away and JACK RUBY stepped out of the Carousel Night Club and said to TRIESCH, "My name is JACK RUBY. I just saw what you did and would like to invite you in for a drink." TRIESCH introduced himself and his friend and they went in with RUBY and had a beer. While drinking the beer, RUBY stated that one of the waitresses needed a ride home and he had told her that he would give her this ride. He also stated that because he was a bachelor he would appreciate it if TRIESCH and his companion would go with him. They did and after taking the waitress home and driving back towards the center of town, TRIESCH commented that he wanted to get some bacon and eggs and then go to bed. RUBY replied that he would be more than happy to make some coffee in his apartment and then call a cab for TRIESCH and his partner. They went to RUBY's apartment, where RUBY showed the men his bar bells and other equipment used to develop the body, and drank a cup of coffee and then took a cab back to the hotel.

TRIESCH stated that during the conversation HUBY had said that if he ever had guests in Dallas that he could bring them to the Carousel Night Club and they would be personal guests of RUBY's. That night TRIESCH was in the lobbey of the hotel and he was talking with a number of individuals, one of whom was Major DOBKINS who is the Mayor of Del Rio. Texas. TRIESCH had said

that he knew the man who owned the Carousel Night Club and any time he wanted to bring visitors over there he could do so. The other men began to kid him and jokingly told him what a big man he was. He said that "if you think that I am kidding let's take a walk across the street and I'll prove to you that I know RUBY." They did this and upon walking into the Carousel Night Club RUBY approached TRIESCH and said, "How's it going GIL. I see you have brought some friends along." TRIESCH advised that at this point they all laughed and sat down and had a beer. RUBY did not join them nor did TRIESCH have any further conversation with RUBY that night.

Be stated that he has never heard or seen RUBY wince those two nights in April when he was at Dallas on business. He described him as being a very nice and friendly gentleman and was quite surprised when he heard that RUBY was responsible for the murder of LEE HARVEY OSWALD.

ROSSAVALORE, Ace Hollywood Artists Agency, 100 M Florence, El Paso, Texas, advised that he had known of JACK RUBY of Dallas, Texas, for several years, as RUBY had frequently contacted him, VALORE, for stripper acts to use in the Dallas clubs.

VALORE advised he had never seen RUBY and that RUBY had never been known to come to El Paso. He said their contacts had all been by telephone. RUBY still owes VALORE about \$350 on a contract handled some time ago. VALORE got the impression that RUBY was always looking for notoriety in one way or another and wanted to impress people.

VALORE reiterated that he was sure RUBY had never been to El Paso, Texas, as he would definitely know about this, most likely through a direct contact from RUBY or certainly from his sources of information in the entertainment field.

JOHNNY/VOUDOURIS, <u>Star Route A. Box 760</u>, <u>Austin</u>, <u>Texas</u> operator of Austin Maintenance Company, a janitorial maintenance service, 1924 South First Street, Austin, <u>Texas</u>, furnished the following information: MRS, <u>JCHNNY</u>/VouDDURIS

Late in October, 1963, he and his wife, FAYE Went VOIDFURTS to Dallas, Texas, to attend the Texas State Fair on the last weekend the fair was in operation. While in their motel in Dallas on Saturday evening, they noticed an advertisment in a tourist guide which referred to the Carousel Club in Dallas. He asserted that they did not have any prior plans to attend the Carousel Club and that they had never been there before. When they arrived at the Carousel Club they observed that the featured exotic dancer and stripper was a girl called "JADA", whom they had seen in an act in New Orleans, about two years previously.

VOUDOURIS stated that after "JADA" had performed, a man whom he later learned was the owner of the club, JACK RUBY, came to their table to apologize for the incident of "JADA" cutting her act short because she was upset with the orchestra. VOUDOURIS stated that he and his wife were not aware that the dancer had cut her act short and would not have known that she was upset if RUBY had not so advised them.

He added that RUBY offered to make some adjustment for the action of "JADA" by offering the VOUDOURIS' a complimentary drink. After conversing with RUBY for a short time, JOHNNY and FAYE went to the Vegas Club at Dallas, which JOHNNY understood was also operated by RUBY, who gave them a pass to the Vegas Club. RUBY's sister took the pass from them when they entered the Vegas Club where RUBY also arrived at about 1:30 am, Sunday. They stayed there until about 2:00 am, when the Vegas Club closed and RUBY and his sister, a waitress from the Carousel Club and the manager of the Carousel Club, all went to a bowling alley, believed to have been the Cotton Bowl. While eating, they engaged in casual conversation, mostly concerning dieting. After eating, JOHNNY and FAYE drove RUBY to his apartment residence where it was understood that the manager of the Carousel also resided in an apartment across the hall from RUBY.

During their conversation, RUBY did not mention anything which VOUDOURIS recalled as referring to LEE HARVEY OSWALD nor did RUBY discuss political affairs or any controversial topic. VOUDOURIS recalled that the only comment RUBY made which seemed unusual was at one point in their conversation, RUBY asked JOHNNY if he had any kind of a political job in Austin; whereupon JOHNNY advised RUBY that he did not have any political connections and that the only remotely connected sort of position he had was that his firm provided the janitorial maintenance of the local television station, KTBC-TV, channel 7, in Austin, which is owned by Mrs. LYNDON B. JOHNSON, the wife of the then vice president of the United States. RUBY did not pursue the subject any further and did not query VOUDOURIS concerning his acquaintance with Mrs. JOHNSON.

RUBY told VOUDOURIS that if he ever wanted to come to Dallas to work, RUBY knew a lot of people and may be able to help him.

VOUDOURIS stated that his last contact with JACK RUBY was on Sunday morning, the last weekend of the State Fair. in Dallas, which was later in the morning after he and his wife had eaten with RUBY at the Cotton Bowl. RUBY telephonically contacted VOUDOURIS at the motel to determine if they were returning to Austin that day. RUBY offered VOUDOURIS a free pass for the performance of "Little Egypt", an exotic dancer, at the Club Caravan, which is located in Austin, Texas, at the Villa Capri Motel and Restaurant, VOUDOURIS added that "Little Egypt" was apparently a professional acquaintance of RUBY's and that "Little Egypt" and her manager were acknowledged by the master of ceremonies as guests of the Carousel the night that JOHNNY and FAYE attended the Carousel club in Dallas.

RUBY gave VOUDOURIS a business card with a notation written in longhand to "admit party except Saturday" and a telephone number "WH 1-5601." VOUDOURIS stated that he also gave RUBY his name and number for RUBY's reference if he ever came to Austin.

VOUDOURIS asserted that he had never seen or met RUBY before the above described incident which VOUDOURIS described as a strictly chance meeting which was also their only contact. He added that he was shocked to learn through public news services that RUBY was the accused killer of LEE HARVEY OSWALD and that RUBY gave him no impression of being inclined to commit such a violent act. He further described RUBY as a "promoter" who talked to as many people as possible in the course of business to create a favorable impression and to build up his clientele. LA 44-895 JEH: Joc

JACK WALSH

On December 13, 1963, Mr. JACK P. WALSH, 2034 Merced Avenue, advised that until November 16, 1963, when he resigned, he was a vice president of the Texas Aluminum Company, 600 North Third Street, Covina, California. His parent company is located in Dallas, Texas.

He stated that he went to Dallas on November 3, 1963, to attend a board meeting the following day and stopped at the Carousel Club for about an hour. While at the Carousel Club, the owner, JACK RUBY, stopped at his table and chatted with him for about ten minutes. They talked mostly about Chicago and also about Dallas not having a private club for businessmen when they came to town. RUBY stated he contemplated opening such a club and asked WALSH for his business card as he would send him an application for the club if he got it underway.

Mr. WALSH advised this was the one and only time he had ever seen or talked with RUBY and knew absolutely nothing more regarding him and the above.

WILLIAM WAYNE WHALEY, <u>619 Fine Street</u>, <u>Levisville</u>, <u>Texas</u>, Route 2, <u>driver for City Transportation Company</u>, Cab #36, who previously stated upon interview that he drove OSWALD in his cab as a fare on November 22, 1963, advised as follows:

Mr. WHALEY stated when OSWALD was a fare in this cab immediately following the assassination of President KENNEDY on November 22, 1963, OSWALD made practically no conversation and said nothing to indicate possible relationship or association with JACK RUBY.

Mr. WHALEY advised he has known JACK RUBY by sight and reputation for two or three years and on each occasion that he has had to speak to RUBY, it was when WHALEY was with a group of other cab drivers. On these occasions, RUBY would mention his clubs and invite the cab drivers to come to his clubs and request them to remind customers of his clubs. WHALEY stated he has never associated with RUBY socially and has never visited his clubs. He stated the above,... is the extent of his acquaintance with RUBY, and he does not know him well enough to feel qualified to make any kind of ..., statement concerning RUBY's character, personality or political opinions.

Mr. WHALEY stated he is sure he has never heard RUBY... mention the name OSWALD or say anything to indicate he knew OSWALD. WHALEY added he has no information concerning the shooting of OSWALD by RUBY or how RUBY was able to enter the basement of the Dallas Police Department prior to the shooting. He further stated he last saw RUBY several months prior to the assassination of President KENNEDY.

She explained that about two or three months ago, IEXA she and her date, HAROLDANC LAUGHLIN, and NC LAUGHLIN's friend, ROSCOE "ROCKY" ROBINSON were at the Carousel Club one night. JACK RUBY came up to them and appeared to be acquainted with ROBINSON. RUBY indicated he was always interested in securing hostenses and cashiers and indicated he wanted her name and phone number if she would be interested in such employment. She gave him her name and phone number and a week or so later, he called her at her place of employment regarding a job. She stated she was satisfied in her present employment and told RUBY she would not be interested at that time or in the future in any employment with him.

She advised that this was her only contact with RUBY. She advised she was not acquainted with LEE HARVEY OSWALD, knew of no association between OSWALD and RUBY and knew of no other individuals as possibly being involved with OSWALD or RUBY and the shootings.

The following listed names and notations were secured from RUBY's personal property, and the following investigation was conducted by SA LANSING P. LOGAN in efforts to locate and identify the same for purposes of interview concerning RUBY:

### VIVIAN STATLER Barber Shop

Mrs. VIVIAN RAY/KTLLEBREW, 419 North Marsalis, Apartment 4. Dallas. Texas, was contacted by SA LOGAN on December 19, 1963, at which time she advised that she is employed as a manicurist at the Statler Barber Shop in Dallas. She stated that she is not personally acquainted with JACK RUBY and could never recall having any type of conversation with him. However, she could recall that Mr. CHARLES, who is a barber at the Statler Barber Shop, had mentioned RUBY's name as being an individual who at one time used to get his hair cut at the Statler Barber Shop. Mrs. KILLEBREW stated that she knew absolutely nothing concerning JACK RUBY's background, friends, or associates and knew of no connection between RUBY and anyone in the Dallas area. She did not know LEE HARVEY OSWALD prior to the assassination and could offer no information pertaining to any connection between RUBY and OSWALD, if there ever was any connection. She could not explain why her name "VIVIAN" and the notation "Statler Barber Shop" had appeared in RUBY's effects other than the fact that maybe one of the barbers had possibly given her name to RUBY.

#### **VF** 7119 - HOUTON

The above notation appeared in RUBY's personal effects, and the following investigation was conducted in efforts to ascertain the identity or the meaning of this particular notation:

A check of the records pertaining to 1963 Motor Vehicle License Plates, Texas, revealed that 1963 License VF 7119 was issued to a 1959 Ford registered to W. J. He advised that he had cut RUBY's hair several years ago, but could not recall having had any contact whatsoever with RUBY since around 1960. Mr. CHARLES mentioned the fact that JACK RUBY was always very particular about the way his hair was cut and was, as a general rule, complaining about the way his hair was cut. He was unable to furnish any background information, friends or associates of RUBY, and stated that he never had engaged in any lengthy conversations with RUBY at anytime. Mr. CHARLES did not know of any connection between LEE HARVEY OSWALD and RUBY, and stated that OSWALD was unknown to him prior to the assassination of President KENNEDY.
