She stated that within ten minutes after viewing the shooting of LER HATVEY OSWALD by JACK RUBY on television on November 24, 1963, she impulsively decided to send a telegram to JACK RUBY in Dallas, Texas. Her husband was also watching television and when she told him what she was going to do, he said "You wouldn't have the nerve to do it." She stated that she called Western Union and recalled that the contents of the telegram were generally:

"Congratulations. God bless you and good luck. /s/ Mr. and Mrs. Sal St. Angelo."

She stated that she sent the telegram to JACK RUBY, c/o the City Hall, Dallas, Texas.

Mrs. ST. ANGELO stated that she was emotionally upset over the assassination of President KENNEDY and that after RUBY shot OSWALD, she had an uncontrollable compulsion to congratulate him for his act. She said that she realizes now that this was wrong on her part and regrets that she did send the telegram.

She stated that she is employed as a Machine Attendant on the evening shift at General Electric, Electronics Park, Building 5, Syracuse, New York, and that her husband is Manager of the ABC Vending Company, a soft drink firm, in Syracuse.

Mrs. ST. ANGKLO stated that both she and her husband were not acquainted with RUBY or OSWALD and know of no connection between them.

The following investigation was conducted by SA KENNETH W. DELANOY on December 19, 1963:

Mrs. JRAN SCATTERGOOD, also known as Mrs. R. Robert Scattergood, Taunton Road and Tomlinson Will Road, Marlton, New Jersey, Edvised as follows:

She has always been a staunch defender of former President KENNEDY; and, upon his assassination, she became so overwrought and outraged at the act of LEE HARVEY OSVALD that she was actually pleased when she learned that JACK RUBY had killed OSWALD. She was so gratified that RUBY had been done away with a man such as OSWALD that she sent a telegram to JACK RUBY, care of the Dallas Police Department, in which she stated that she could not find it in her heart to condemn him since she felt as strongly as he did regarding the assassination of the president. She felt she may have done the same thing if in RUBY's place.

Mrs. SCATTERGOOD advised she was born in 1816.and admittedly is a very emotional person. She stated she does not know either JACK RUBY or LEE HARVEY OSWALD and the first time she had ever heard of either of them was via her television and radio following the assassination of the president.

She stated that she has absolutely no information of any connection between JACK RUBY and LKE HARVEY OSWALD and as she indicated previously, both names were totally unknown to her prior to the incident on November 22, 1963.

On December 19, 1963, Mr ARTHUR G XSTASKO, 210—Ridgewood Drive.) Syracuse, New York, telephone number 437-4143/was interviewed by SA ROBERT A. BEERS and furnished the following information:

He stated that on the afternoon of November 24, 1963, in an emotional act after viewing the shooting of LEE HARVEY OSWALD by JACK RUBY on television, he called Western Union and sent a telegram to JACK RUBY at the Dallas Station, Dallas, Texas. He stated that the telegram, as best as he could recall, said:

"You have done what many of us would have done."

He stated that he now realizes that it was not a prudent act on his part, that he regrets sending the telegram, and would not have done so if he had known that the FBI was going to investigate the matter. He stated that he did not discuss his action with his wife and is quite concerned about what her attitude might be if she found out. Mr. STASKO stated that he is the organist at Blessed Sacrament Church, 313 James Street, Syracuse, New York. He stated that he was quite angered and upset over the assassination of President KENNEDY and said that he acted in a very spontaneous fashion and sincerely regrets that he had sent the telegram.

Mr. STASKO said he was not acquainted with RUBY or OSWALD and knew of no connection between them.

STUART H. ATSON, 14100 Sarasota, Detroit, Michigan, stated that at the time of the assassination of President KENNEDY, he was extremely upset and emotionally disturbed by the assassination. Se stated that when RUBY shot OSWALD, he was emotionally motivated to send a telegram of a congratulatory nature to RUBY. WATSON stated that his sending the telegram was an emotional, spur of the minute gesture which he has subsequently regretted.

WATSON stated that he does not know RUBY or OSVALD and has no knowledge whatsoever of the acquaintances of RUBY or OSVALD.

The following investigation was conducted by SA ERNEST T. BIRD:

AT COHOES, NEW YORK

On December 19, 1963, JOHN C. MALLORAN, 18
Lighthall Avenue telephone CEdar 7-5300, advised that on
November 24, 1963, he sent a telegram signed JACK C. HALLORAN,
Cohoes, New York, to JACK RUBY at the Dellas Police Department,
Dallas, Texas. He recalled his message was to the effect:

"Thank you my friend and fellow American."

HALLORAN advised he was emotionally upset over the assassination of President KENNEDY. On impulse he reasoned that OSWALD was a Communist and had murdered a police officer in addition to the President. Upon seeing him brought to justice so swiftly by RUBY, HALLORAN decided to send the telegram.

HALLORAN stated he is not acquainted with either RUBY or OSWALD and knows of no connection between them.

HALLORAN advised he is employed as an electrician by the State of New York, Office of General Services.

On December 20, 1963, EDWARD J RANE advised he resides at 19 Vleet Street, phone CEdar 7-9352, and is employed as a route salesman for the Cook Coffee Company, Cohoes, New York, and as a Marshal of the City Court in Cohoes, New York. He volunteered that additionally he is an official of the local Democratic party in the city of Cohoes.

He stated that following the shooting of LEE HARVEY OSWALD on November 24, 1963, he sent a telegram to JACK RUBY at the Dallas Police Department, Dallas, Texas, signed "Ed Kane, City Marshal, Cohoes, New York." KANE recalled that the message in effect said:

"Congratulations - thank you."

KENNEDY, whom he had met in 1960, left him emotionally upset and outraged. He said that in view of his grief he was drinking heavily on November 24, 1963, and while in this state upon viewing on the television the murder of OSWALD by RUBY he acted on impulse when he sent the congratulatory telegram. He said he has since regretted his action, and the implication that he approved of anyone taking the law into their own hands. KANE said he was not acquainted with RUBY or OSWALD and mew of no connection between them.

A review of the 1963 Buffalo telephone directory and December 19, 1963, revealed that one MARY COLOSI resides at Wan Wyck, Lackawanna, New York, telephone number TA 6-2512.

An attempt was made on December 19, 1963, to contact MARY COLOSI at the above address with negative results. A neighbor, whose identity was not ascertained, volunteered information that Mrs. COLOSI was presently a patient in Lafayette General Hospital in Buffalo.

General Hospital, 113 Lafavette Avenue, Buffalo Advised SAs
PAUL A. JOENSEN and LEE MASON EIDSON on December 19, 1963,
that Mrs. MARY COLOSI, of the above Lackawanna address, is
presently his patient and that she was admitted to the hospital
following an automobile accident in which she suffered a
cerebral concussion. He advised her present condition would not
prevent an interview following questions as to whether an interview could be conducted.

Mrs. MARY COLOSI advised she resides at 44 Van Wyck Street, Lackawanna, and she was born March 31, 1921, at Buffalo, New York.

Mrs. COLOSI stated that on November 24, 1963, following a news broadcast which identified JACK RUBY as the slayer of LEE HARVEY OSWALD, she did send a telegram addressed to JACK RUBY, in care of the Dallas, Texas, Police Department, which bore a one word message, "Congratulations." Mrs. COLOSI stated this action on her part was spontaneous following an emotional reaction described by her as elation. Mrs. COLOSI explained that she was grieved at the death of the President as she had deep respect for Mr. KENNEDY, so as an instantaneous reaction to the news of the slaying of the assassin she felt compelled to send the telegram.

Mrs. COLOSI maintained she has had no personal association with either JACK RUBY or LEE HARVEY OSWALD and had no specific information concerning them or any association between the two of them.

On December 19, 1963, Miss CAROL JANE BRUNDO, 51 Gerald Place, Buffalo, was interviewed by SAs PAUL A. JOENSEN and BEE MASON ELDSON. W. 1

Miss BRUNDO advised she was born January 25, 1942, at uffalo. She admitted directing a telegram to JACK RUBY in the state of the state

care of the Dallas Police which contained the message, Congress-lations Mr. Ruby, you have redeemed the State of Texas. She explained this action as the result of her family's spontaneous decision upon hearing the news broadcast which identified RUBY as the slayer of LEE HARVEY OSWALD. She denied any prior association with RUBY or OSWALD and also denied having any information regarding RUBY's activities or association with OSWALD or any other persons.

Miss BRUNDO requested it be made clear that had she waited until the news broadcast which advised of the death of OSWALD, she would not have sent the telegram. Miss BRUNDO stated that in her opinion OSWALD deserved to be shot but not killed.

The following investigation was conducted by SA MARK H. TUOHEY, JR. at Rochester, New York:

On December 20, 1963, JEROME AT BARBER, 48 Weider

Street, Rochester 20, New York, furnished the following information:

He is also known as JERRY BARBER and is 29 years of age. He is a member of Local 33, International Association of Iron Workers, Rochester. He is currently employed on a job at the GIF Plant in Batavia, New York. His home telephone number is BR 1-7725.

He and his fiancee, KILEEN J. KILDEA, 132 Wellington Avenue. Rochester departed together from Rochester late Saturday evening, November 23, 1963, and arrived in Washington, D.C. November 24, 1963. The purpose of the trip was to attend the wake and funeral of the late President, JOHN F. KENNEDY.

B. APDROX 1939

On November 24, 1963, upon learning of the shooting of the late President's alleged assassin, LEE HARVEY OSWAID, by JACK RUBY both BARBER and KILDEA decided to send a telegram of "congratulations" to RUBY, in Dallas, Texas. BARBER does not know RUBY and/or OSWAID personally and knows of no relationship between OSWAID and RUBY. The action in sending the telegram was a spontaneous thing undertaken because of BARBER's and KILDEA's high regard for the late President. There was only one telegram sent and both signed the telegram as JERRY BARBER and EILEEN KILDEA, Rochester, New York.

BARBER advised he and KTIDEA departed Washington the early morning of November 25, 1963 for Rochester, arriving the Rochester the same day. He has no further information.

On December 20, 1963, Niss EILEEN J. KIIDEA, 132 Wellington Avenue, Rochester, New York, advised as follows:

She is employed as a secretary for Optical Gauging Products, Inc., Rochester. She is 25 years of age. Her home telephone number is ID 6-4654.

She and JEROME BARBER, to whom she is affianced, left Rochester together on November 23, 1963, to attend the wake and funeral of the late President, JOHN F. KENNEDY. They arrived in Washington, D.C. November 24, 1963.

On November 24, 1963, she and JEROME BARBER sent a congratulatory telegram to JACK RUBY, Dallas, Texas, and signed both their names with an address for each as "Rochester, New York." She has no personal knowledge of RUBY and/or LEE OSWAID and has no information regarding any relationship between RUBY and OSWAID except that which she knows from the newspapers and other such media.

Miss KILDEA and BARBER left Washington, D.C. on November 25, 1963 and returned to Rochester.

Her action in sending the telegram was a "spontaneous reaction" to the death of the late President, for whom she had a high regard. She has no further information.

A source who has access to Western Union files advised on December 20, 1963 that a telegram was sent from Stamford, Connecticut at 3:18 p.m., November 24, 1963, to JACK RUBENSTEIN, c/o Dallas Police Department, Dallas, Texas, and signed FRANK and ANDY. These records reveal the senders of this telegram refused to furnish their address when so requested. This telegram indicated it was accepted by EDITH WRIGHT, an employee of Western Union, Stamford, Connecticut.

On December 20, 1963, Miss EDITH WRIGHT was contacted by SA ROBERT E. SHORTELLE at the Stamford House, West Park Place, Stamford, Connecticut and advised that she did recall receiving such a telegram but could only recall that the two individuals were white males in their early 20's and stated she has never seen these individuals before a since. She stated she could furnish no further information that would lead to the identity of the individuals who signed the telegram FRANK and ANDY. She did advise that she requested these individuals to furnish their address at the time of sending the telegram but they both refused to do so.

FRANK DRAGOTTA telephonically contacted Field Supervisor WILLIAM H. PORZER on December 20, 1963, stating that he was calling from his parents' home, 372 Union Street, Jersey City, New Jersey. He stated that he understood that an FBI agent was attempting to locate him. He advised that when President KENNEDY was assassinated he "was ashamed that I was an American". He added that after hearing that JACK RUBY killed OSWALD he "became an American again".

Mr. DRAGOTTA further advised that he was in Asbury Park, New Jersey, at the time visiting relatives and that he felt so much gratitude towards RU3Y he sent him a telegram of congratulations and a \$100 money order.

Mr. DRAGOTIA stated that except for a brief period of time he spent in the United States Navy, he has resided in New Jersey. He said that he knows of no connection between RUBY and LEE HARVEY OSWALD and, in fact, knows neither of these persons.

ROBERT J. CARNOCK, partner Amble Inn. 721 Avenue A Bayonne, New Jersey, advised SA RAYMOND F. HOYLE on December 20, 1963, that on the evening of the afternoon that JACK RUBY shot LEE HARVEY OSVALD, a group of individuals who had been drinking in his tavern decided to send a telegram to RUBY to congratulate him for shooting OSVALD. He added that it was a spur-of-the-moment decision and that although the telegram was sent by one DONALD A. WALTMAN, 28 Silver Street, Bayonne, New Jersey, he permitted WALTMAN to sign the telegram with the name of the tavern, that is Amble Inn. He added that he knows neither RUBY nor OSVALD and that to the best of his knowledge neither does WALTMAN.

DONALD A. WALTMAN, 28 Silver Street. Bayonne, New Jersey, advised SA HOYLE on December 20, 1963, that he had been drinking the day OSVALD was shot and at the time he felt it was a good idea to send a telegram of congratulations to JACK RUBY. He said that he did this and that the telegram was signed Amble Inn. He added, however, that he does not know RUBY or OSVALD and that to the best of his knowledge no one he is acquainted with knows either of these individuals.

KIDWELL, JR. that on November 24, 1963, after witnessing the killing of LEE HARVEY OSWALD by JACK LEON RUBY on television, she directed a telegram to RUBY in care of the Dallas, Texas Police Department congratulating him on his actions. Mrs. ROSARIO stated that she is not acquainted with RUBY or OSWALD and had no prior knowledge of these individuals until the time of the assassination of President JOHN F. KENNEDY and the subsequent murder of OSWALD. She stated she cannot recall exactly what she sent in this telegram, but she believed that it included the phrase "I would be honored to call you friend". She explained that she was quite upset over the assassination of President KENNEDY, and even now believes that OSWALD deserved to die for committing this crime. She was unable to recall further information concerning this incident.

ALBERT EDMOND LONG, also known as ED LONG, 293

Maria Street. Santa Clara. California. advised this date he has had absolutely no acquaintanceship with RUBY or OSWALD and sent the telegram to RUBY believing that a long trial with the attendant publicity is just what OSWALD would have wanted. He advised that it was a spur of the moment act but he still feels that considerable time and expense have been saved.

Mrs. CALLICOTTE stated that she did not know either JACK RUBY or OSWALD personally and has no information to offer concerning them.
