Miss FROWN stated that she formerly resided at 1221 Carza in Dallas, Texas and way employed at the Carcusel Lounge in Dallas for suproximately one and a half months. Miss BROWN advised that in mid Barch, 1953, she saw an ad in a local newspaper which indicated theo dancers were wanted at the Carousel Lounge in Dallas. She said she applied for this position and was interviewed by JACK RUBY for the job. She said that prior to this date she did not know JACK RUBY and that he exployed her on a trial basis in March of 1963. She said that at the time the applied for this work she had no money and that she borrowed \$55 from RUBY giving him a check in this amount drawn on her bank in Dallas:

Niss BRUDN advised that she asked RUBY to hold this check and that she rade an arrangement with him whereby he deducted payments from her selary until the \$55 was repaid. She said that she obtained \$100 a weak for this employment and that she terminated her amployment with RUBY in May, 1963.

HEE BROW advised that during the month and a half that she was exployed at the Carcusel Loange she saw JACK RUBY on a defly basis. She stated that RIBY is highly emotional, very inpulsive and has a quick temper. Hiss DROWN advised that suring the time she know JACK RUBY she never saw LEE PARVEY CINCO at the Carcusel Lounge of elsewhere and never heard KUBY minicion USWALD's name at any time. Miss BROWN attend that WEBY spent practically all of his time at the Carcusel Lounge and that he has very few friends. She advised that whe had no information which would indicate that RUEY and OSAPLD were acquainted and that she had no knowledge of RUBY being connected in any way with the assassination of Fresident KENNEDY.

HENRY "RED" CALHOUN (former employee of RUBY). 4906 Linnet Lane, furnished the following information:

CALHOUN is a musician by trade. During 1950 -1954, CALHOUN had a combo which worked for JACK RUBY during this four-year period. In about 1954, CALHOUN had an argument with RUBY, at which time RUBY struck him in the mouth, which required medical treatment and sixteen stitches. After this fight with RUBY, CALHOUN quit working for RUBY and has had nothing to do with him since that time.

CALHOUN could furnish no reason for RUBY shooting LEE HARVEY OSWALD, with the exception of the fact that he has a violent temper. When RUBY loses his temper, he has no control over himself.

CALHOUN knows of no connection between LEE HARVEY OSWALD and JACK RUBY and knows of no police officers with whom RUBY was particularly close.

ROBERT DAIGNEAULT, 14431 Avalon, Farmers Branch, was reinterviewed to determine if he knew of the existence of a deal between the Sovereign Club and the District Attorney's Office which permitted the Club to serve mixed drinks at tables.

Mr. DAIGNEAULT worked as a waiter at the Sovereign Club on a part-time basis during 1960 and knows of no deal between the Sovereign Club and the District Attorney's Office. He pointed out that the Sovereign Club was chartered as a private club and as such was legally permitted to serve mixed drinks at the tables at the club. DAIGNEAULT knew of no guest list of city officials being maintained at the Sovereign Club and feels sure he would have known if such a list existed. WILLIS D. DICKERSON, also known as "DUB"-DICKERSON, 2442 Hawthorne Street, Dallas, whose name was furnished by JACK J. ROWE as having possibly worked for RUBY in the past 10 and at one time had a fight with RUBY, furnished the following information:

DICKERSON advised that he is presently unemployed but is a musician by trade and plays the guitar. He first met RUBY in about 1950 or 1951 when he played his guitar in a small combo for RUBY for a period of about three months. Since DICKERSON during that period had been changing from one combo to another, he does not recall the particular combo or the members of the combo in which he played for RUBY.

DICKERSON related that several months after he quit working at RUBY's club, he dropped into the club at about 12:30 or 1:00 AM sometime in about 1951 in order to be with RUBY's musicians during the after-hour period. There were still some customers in the place and DICKERSON pulled up a chair to a table of four people whom he recognized and sat down. He partially blocked the aisle and RUBY walked by and kicked DICKERSON's chair and stated, "DUB, you know you can't block the aisle like that".

DICKERSON said he replied to RUBY that "RUBY could go to hell" and if that was the way RUBY felt about it DICKERSON said he would not return to his club any more. DICKERSON walked outside and RUBY followed him, making some derogatory remark which DICKERSON does not recall. DICKERSON repeated to RUBY that he could "go to hell" and that DICKERSON did not plan to return any more. RUBY became extremely angry and struck DICKERSON in the face with his fist, knocking him down. When DICKERSON got to his feet, RUBY pushed him against a wall and while holding him to the wall, with one hand in DICKERSON's face. RUBY began striking DICKERSON in the groin with his knee.

DICKERSON stated that during this activity one of RUBY's fingers entered DICKERSON's mouth and DICKERSON, partly gritting from the blow and partly in self-defense, bit down hard on RUBY's finger and partially severed it at the first joint. He learned

He added that he never knew LEE HARVEY OSWALD and never had any reason to suspect that RUBY ever knew OSWALD or associated with him. He further stated that he has no information concerning the assassination of President KENNEDY or the shooting of OSWALD by RUBY.

Mr. WILLIAM BOONE GOODE, Vice President, Diversa, Inc., 13th Floor, Exchange Bank Building, Exchange Park, residence 6754 Ridgeview Circle, advised that he had been the managing partner of an accounting firm known as W. B. Goode & Company, Room 1220, Mercantile Securities Building, Dallas, Texas, from 1956 until the firm merged with Alexander Grant & Company in Dallas in August of 1959. The W. B. Goode & Company was preceded by the W. O. Liggem Company and inherited JACK RUBY as a client from that company.

Mr. GOODE stated RUBY's account had always been a very small one and, to the best of his recollection, had consisted merely of assembling facts and figures furnished by RUBY to allow the execution of RUBY's income tax returns since the information upon which such returns were based was furnished exclusively by RUBY, with the firm having no way of knowing the truth or falsity of any item. Such returns were not certified by the firm.

Information furnished by RUBY for the firm's assistance in preparing the tax returns was invariably returned to him after the returns were prepared.

Mr. GOODE had not personally handled the RUBY account and was unable to recall at this time the identities of employees of the firm who had handled the RUBY account. He had seen Mr. RUBY on only one occasion during a visit made by RUBY to the firm. The principal thing he recalled concerning the RUBY account was that the firm had difficulty in collecting the fees charged for its services. To the best of his recollection, the firm prepared income tax returns for RUBY for the years 1956 to 1958, inclusive.

That portion of the firm's records which were not trans ferred to Alexander Grant & Company on the merger is in the possession of Mr. GOODE but in dead storage at this time. He stated that they would in no event contain any information in addition to the dates and amounts charged RUBY for the firm's services and the dates of payment.

Mr. GOODE has no knowledge or information at this time regarding the ownership of either the Vegas or the Carousel Club.

Mrs. LEONA KIRILENKO, 3908 Camino del Valle, SW, was reinterviewed and she re-affirmed information previously furnished by her on December 2, 1963, with regard to the homosexual allegations of JACK RUBY.

She stated that in about 1957 she had an engagement of two weeks at-a strip tease joint in Houston, Texas, which was directly across the street from a homosexual hangout named the Carousel. She described the Carousel in Houston as a completely "faggott" joint catering to extremely obvious and wild homosexuals. She explained the term faggott by describing them as extremely obvious and wild homosexuals. She went directly to the Carousel Club in Dallas, Texas, operated by JACK RUBY and upon her arrival, she was impressed with the fact that it was being run by JACK RUBY, whom she described as a "queen." She said a "queen" or "auntie" is a homosexual past thirty years of age.

She said that it was obvious to her from the first that RUBY hated women and he frequently came to the dressing room where the performers were dressing and becated the female performers in what she described as filthy four letter words.

She stated that RUBY had a "girl friend" who was a male individual whom she described as white male, 22 years, dark brown curly hair and "very pretty." She could not recall the name of this male individual, but stated his homosexual name was CARMEN. CARMEN associated closely with RUBY and she added that CARMEN painted his eye brows and darkened his eye lashes. She said that RUBY would become particularly mean towards the female performers when he had a "tiff" or argument with CARMEN.

KIRILENKO advised that she knew of no actual homosexual actions which may have taken place between RUBY and CARMEN and she never observed them in any other place than the Carousel Club or on the street. She stated that RUBY particularly made affectionate gestures towards CARMEN when he lighted CARMEN's

cigarette, picked up a drink tab or gave him a drink. She said it was common talk among the performers at the club that RUBY was homosexual and was having an "affair" with CARMEN. She said she could not furnish exact dates and times concerning this activity stating that she had only a two week performance at the Carousel in Dallas, probably sometime in 1957, where she was a strip teaser. She has not observed RUBY since that time until he appeared on television recently.

The only other performer that she could recall who was there at the time and with whom she discussed RUEY's homosexual actions is a performer named BRONYA (phonetic). She could not recall BRONYA's last name, but she thought it was similar to WARBURN, WARBRUN or WERBEN. She said that BRONYA did a half and half act at the Carousel Club when she wore men's attire in the form of a tuxedo on one side of her body, while the other side of her body was attired by a formal dress. She recalled that BRONYA had a boyfriend named."BULLY" who was a former hoodlum, who may have been from the Kansas City, Missouri area; however, she was not sure of the location. She knew of no way in which BRONYA could be identified or located at the present time.

Regarding CARMEN, she stated that CARMEN was a "faggott" who exhibited extremely effeminate characteristics when not in RUBY's presence; however, CARMEN curbed these tendencies when in RUBY's presence. She also advised that RUBY used cologne heavily.

During the interview, KIRILENKO referred to RUBY several times as RUBY K. When questioned concerning this term, she said that she and other personnel at the Carousel Club referred to RUBY, when not in his presence, as RUBYKINS or RUBY BABY. She said the term of endearment RUBY K probably evolved from the term RUBYKINS; however, she cannot recall now specifically. She said that RUBY threw champagne parties at the club after closing hours, which CARMEN would attend; however, Mrs. KIRILENKO was never invited and could furnish no specific information regarding these parties. Several times during the interview, Mrs. KIRILENKO affirmed the fact that she was furnishing above information concerning JACK RUBY at the Carousel Club, noting that she definitely recognized him when she observed him on television. She could recall the names of no associates or employees other than BRONYA and CARMEN set forth above.

Mrs. LEONA KIRILENKO, 3908 Camino del Valle SW. was reinterviewed concerning the homosexual allegations she previously made concerning JACK RUBY on December 2, 1963, and December 23, 1963. It was pointed out to her that RUBY did not operate the Carousel Club in Dallas until approximately sometime in January, 1960, and apparently did not venture into the operation of a strip tease club until approximately that date. Photographs of RUBY were displayed to her, and after carefully viewing them she said she is in error concerning the homosexual allegations previously made by her against RUBY. She said she is of the opinion now that she does not know JACK RUBY and was confusing him with someone who is very similar in appearance. Mrs. KIRILENKO was questioned concerning the identity of this individual whom she is confusing with RUBY, and she stated she cannot now recall. She said she has performed as a strip teaser in so many different. clubs for short two-week contracts over a period of years that her recollections concerning specific individuals are now vague.

MANTIA. He stated that her last known address following her marriage was 1649a McLaran, St. Louis, Missouri.

She indicated she did not know to where they had moved. Mrs. BLOECHER stated that LEWIS had a sister living somewhere in the St. Louis area by the name of Mrs. FERD L. On January 6, 1964, a Telephone Directory check revealed that a Mrs. FERD L. GRAF resided at 7657 Sunset Drive Hazelwood, Missouri. On the same date Mrs. GRAF was interviewed and acknowledged that she is the sister of DONALD LEWIS. She stated that her brother, DONALD, now lives at 2831 Leurel View Lane, Bridgeton, Missouri, and that he surreatly works for Air Therm Manufacturing Company on South Spring Street, St. Louis. LEWIS eald that he often drove RUBY around the Dallas area on RUBY's social visits, but that he never really got to know RUBY very well. He said he was not paid for his services other than meals and "a bar tab".

In describing RUBY, LEWIS said he always felt that "JACK had a little Chicago in him" in that he was rather gruff and liked his own way. IEWIS also said RUBY had a bit of a temper but he felt he was basically a "softhearted guy". LEWIS cited an example of an occasion when RUBY at his own expense gave football tickets for an important game in Dallas to a man he hardly knew. He said that RUBY wanted very badly to make a success of the Sovereign Club. LEWIS recalled that RUBY kept a .38 snub-nosed revolver in his, RUBY's, desk at the Sovereign Club. LEWIS felt that RUBY kept the gun strictly for protection purposes and thought that periodically RUBY took the gun with nim when making a night deposit of large sums of money at the bank. He said that so far as he knew RUBY never carried the gun on his person other than the aforementioned occasion.

LEWIS said that he recalled President KENNEDY traveling through Dallas in the fall of 1960 and that he, LEWIS, was very thrilled about it, as he had the opportunity to shake the President Elect's hand. He could not recall if he mentioned this to RUBY or of any reaction RUBY had to it. He said to the best of his knowledge he never heard RUBY mention KENNEDY at all.

LEWIS recalled at one time that there were two men in the Sovereign Club, a JOE PETERSON and a BRECK WALL, who were producers of plays and entertainment in the Dallas area and who had staged some entertainment for RUBY during his operation of the club. LEWIS said that he recalled RUBY having been in a fight with JOE PETERSON at one time over something to do with PETERSON and WALL wanting to back out of a contract. LEWIS said that he had recently noted that PETERSON and WALL were producing some entertainment at the Adolphus Hotel in Dallas, Texas.

MANTIA stated that he is currently living at 1649a McLaran, St. Louis, Missouri and is married to the former PHYLLIS GREEN. MANTIA stated that he and a friend of his by the name of DONALD LEWIS, traveled to Dallas, Texas, in the late summer of 1960 with the idea in mind of opening a cocktail lounge there. MANTIA said they both had taken all their savings with them on the trip. MANTIA said that the last address he knew of for LEWIS was 5171a Eichelberger in St. Louis, Missouri.

MANTIA stated that prior to leaving St. Louis, neither he nor LEWIS had ever heard of JACK RUBY. He stated that in addition to the idea of opening a cocktail lounge in Dallas, his other purpose for the trip to Dallas was to see his girlfriend, PHYLLIS GREEN, who was then an airline stewardess for American Airlines in Dallas.

MANTIA said that while in Dallas, he and LEWIS had met JACK RUBY's sister who was at that time managing the Club Vegas and had talked to her indicating that he and LEWIS were looking for work in the Dallas area. MANTIA said that RUBY's sister suggested to them that they contact JACK RUBY with regard to selling memberships in the Sovereign Club, a night club which was owned at that time by har brother JACK RUBY. He stated that they met RUBY and RUBY agreed to pay them on a commission basis for any memberships sold in the club. MANTIA said that his efforts to sell these memberships were unsuccessful and that while he lived in Dallas for the most part he lived off his savings. He said he did some work for RUBY in the club, such as greeting visitors and other . "odds and ends." 
LOY initially met JACK RUBY when LOY, as a member of a Dixieland Combo, played at the Vegas Club on week ends for approximately a year in 1953 - 1954. During that period, LOY had no personal business dealings with RUBY, as he was only a member of the band; however, he, on occasion during that period, did talk to RUBY. In approximately 1954, the Dixieland Combo that played at the Vegas Club received a better offer and thus terminated their employment at the Vegas Club.

In approximately 1961, LOY, as a member of a musical combo known as the Cellblock Seven, accepted an offer from RUBY to play at the Sovereign Club for approximately four week ends. To the best of his recollection, the group stayed on for an extra week end, making it a total of five week ends that they played at the Sovereign Club. At that time, they left the Sovereign Club and accepted an engagement at a different night club.

LOY recalled that he last saw JACK RUBY in late October or early November, 1963, approximately three weeks prior to the assassination of President KENNEDY. At that time, RUBY appeared at the Levee Night Club, where LOY was playing as a member of a musical combo.

LOY described RUBY as a person who impressed him as being crude, uneducated, and definitely outspoken. LOY further described RUBY as a person who, when he had the Sovereign Club, had hoped to make the "big time" as a night club operator as he had planned to make the Sovereign Club into a club where he would cater to the carriage trade. It was LOY's opinion that this was

INGE P. MAXWELL, 1226 Owenwood Drive, Irving, Texas, whose name, as Mr. MAXWELL--another accountant, was furnished by WILLIAM H. WISE as a possible acquaintance and associate of RUBY, furnished the following information:

Mr. MAXWELL advised that he is an accountant, with office in the 511 North Akard Building, Dallas, and by virtue of his employment met RUBY some ten or twelve years ago when RUBY brought a small account to his firm. This was the only work which his firm has done for RUBY, and he has seen RUBY on only a few occasions since that time, but never socially. He added that he has never been a member of any of RUBY's clubs but has seen RUBY a few times at one or another of RUBY's clubs.

MAXWELL advised that he does not recall that RUBY attempted during the early part of 1963 to obtain office employment for one of his girls but added that this was possible but he is sure that none of RUBY's girls has ever been employed by the firm.

MAXWELL advised that he has never closely associated with RUBY and has never discussed politics with him. He added that he does not recall seeing RUBY for over a year and stated that he knows of no relationship or acquaintance between RUBY and OSWALD. He also stated that he had never known OSWALD, has no information concerning the assassination of President KENNEDY or the shooting of OSWALD on the part of RUBY.

GEORGE B. MOSSE, JR., 5243 Mercedes Street, whose name appeared in a list obtained from JACK RUBY following his arrest on November 24, 1953, indicating former employment by RUBY, advised as follows:

Mr. MOSSE advised that he is presently self-employed as leader of a combo at Dallas. He stated that he has been so employed for over ten years and by wirtue of this employment he met JACK RUBY about ten years ago at Dallas and has maintained a continuous acquaintance and association with RUBY since that time. He stated that his associations with RUBY are mainly through business contacts and mutual visits to clubs operated by RUBY and at which MOSSE has played with his combo. He stated that he has had limited contacts with RUBY socially, usually with other people at public places.

MOSSE advised that he was employed by RUBY in about 1958 to play at the Sovereign Club, operated by RUBY, and was so employed nightly, with his combo, for one or two weeks only. RUBY had to discontinue the services of this combo due to the fact that he felt he could not afford to pay the combo the money demanded for its services. MOSSE stated that this combo discontinued playing together and all the members have left Dallas and their whereabouts are unknown to him, with the exception of two members who have remained at Dallas, namely, WILLIAM F. SIMMONS, piano player, who resides at Irving, Texas; also RICHARD SHADBURNE, JR., trumpet player, who resides at Dallas, exact address unknown, and who is employed by the State Farm Insurance at Dallas.

MOSSE advised that he has always known RUBY as an extrovert and an individual who is usually friendly and wrapped up in his work. He stated that RUBY has always been friendly with many members of the Police Department and the press and has appeared to always try to run his clubs properly and within the law. He stated that he has never discussed politics with RUBY and does not know whether RUBY personally knew the late Officer TIPPIT.

From approximately March 1961 to July 1961 he was a member of the Kismet Review in which he played the oud, a stringed instrument. This review was managed and led by MURAD SOMAY. He assumes SOMAY is still leader of the Kismet Review and travelling through the United States but does not know how he can be located.

In approximately the early part of April 1961 the Kismet Review was booked into the Carousel Club, Dallas, Texas for approximately 10 days. This club was owned and operated by JACK RUBY. On the first night of their engagement he and RUBY had a conversation relative to Chicago after NAZARETH told RUBY that he had played clubs in Chicago. At the close of the first night RUBY invited him to meet him the following day and he would show him around Dallas. He na ny mana said that for the next eight or nine days he spent considerable time socially with RUBY and would also see him every night at the Carousei Club. RUBY introduced him to numerous persons whose names he cannot recall and took him to various clubs and y restaurants. He recalls going to the Brass Cow Restaurant and the La Tunisia Restaurant where RUBY seemed to be well ecquainted with the owners.

He recalls that two close friends of RUEY that came regularly to the club were a Mr. and Mrs AUSTIN, 2742 Wilton Avenue, Dallas, Texas, telephone number FE 77042. He believes that at one time the AUSTINS were discussing going into partnership with RUEY. Mrs. AUSTIN's mother ALICIA ALUSAS, 1238 Tarpley Road, Dallas was also friendly with RUEY.

In about July 1961 he returned to the Dallas area on a visit and lived with the AUSTIN family for a few days. During that time he saw RUBY on two or three occasions when they visited the Carousel Club.

RUBY contacted him by phone in Florida in 1961 and invited him to organize a club and come to play at the Carousel for a week or two. About a year ago RUBY again telephonically contacted him at Haverhill, Massachusetts and wanted him to ogranize a club to play the club for a couple of weeks. On both occasions he told RUBY that it would not be a profitable venture for him and declined the invitation.

He considered RUBY to be a fine gentleman who appeared to be well liked by his employees and associates. He knew nothing of RUEY's activities other than that set out above and they never had occasion to discuss politics. He had never seen or heard of LEE HARVEY OSWALD until the time: of the President's assassination and knows of no association between OSWALD and RUBY. On December 26, 1963, MARJORIE ALICE PUTNAM, 2031 Ivar, Hollywood, California, advised she is known as "SIRI, the Dutch Doll." She said she has no telephone but can usually be located through the Cora Lee Agency in Los Angeles or at Room 9, at the Blake Hotel on Beechwood Street, Los Angeles.

PUTNAM stated she has been in show business for about 20 years and has worked as a "stripper" for the past several years. She said she did not know JACK RUBY or LEE OSWALD and had never worked at any of JACK RUBY's clubs in Dallas, Texas. She said there is another "stripper" known as "SIRA, MISS SWITZERLAND" or " The Swiss Miss." She said however, she

did not know the location of that "stripper." The following investigation was conducted by SA NY CALLAND GEORGE A. PAINE, JR., on December 26, 1963.

JIM KELLY, AGVA, Los Angeles, advised he could not locate any record of "SIRA, aka" or "MISS SWITZERLAND, aka" in his records. He suggested AGVA, New York City, might be able to furnish information regarding that "stripper."

He is a tax accountant and met JACK RUBY in early 1961, at which time RUBY came to him and explained he had been in difficulty with Internal Revenue Service and would like him to take care of his accounting in connection with the Vegas Club. He prepared the quarterly social security, withholding and cabaret returns for that year and also prepared his Federal Income Tax return for 1961. He saw RUBY approximately 12 times during that one year period and was obligated to discontinue working RUBY's papers as he became ill and was forced to forego some of his business commitments. To his knowledge, RUBY 🚓 was the only person associated with the operation of the Vegas Club, although he had heard it was possible one of RUBY's provi brothers, name unknown, may have put up some money at the inception of this club. He believes RUBY's sister, EVA, ran the club for RUBY. the second second second second

At that time, he understood the Carousel Club, under RUBY, was just getting started and he had no knowledge of how the accounting regarding this club was handled. It was his opinion RUBY likely held off obtaining an accountant to handle the paper work on the Carousel Club, as this appeared to be what he had done regarding the Vegas Club and was the reason he was behind in his book work and experiencing difficulty with Internal Revenue.

During this one year association with RUBY, he did not discuss with him politics, philosophy, and the like, and he had no knowledge of traveling on the part of RUBY. His interests with RUBY were strictly business and it seemed to him RUBY was solely interested in making money. He described RUBY as the typical night club operator who always believed "the next deal will set me up for life."

He did not know LEE HARVEY OSWALD and, therefore, knew of no association between JACK RUBY and OSWALD.

Miss BARBARA/SHEETS, 1028 East Colfax Avenue, advised that she is presently employed by the Mountain States Telephone and Telegraph Company at Denver. Miss SHEEPS waid that she was formerly employed by the Curtis Mathis Sales Company at Dallas, Texas, and resided at 1423 Hortense, Dallas. She advised that in April, 1963, she was employed on a "fill in" basis by JACK RUBY at the Carousel Lounge in Dallas, Texas for two or three nights. Miss SHEETS advised that she worked one night as a waitress and two nights collected cover charges at the Carousel and this constituted her complete employment at this lounge.

Miss SHEETS advised that because of this, her acquaintanceship with JACK RUBY was extremely limited and she had little information concerning his activities or acquaintances. Miss SHEETS advised that during the time she was employed by RUBY she never saw LEE HARVEY OSWALD at the Carousel Lounge and never saw OSWALD in RUBY's presence anywhere. She said she had no information concerning any groups or organizations to which RUBY might belong nor did she have any knowledge which would indicate that he was connected in any way with the assassination of former President KENNEDY.



WEAVER stated that he has known JACK RUBY since the late 1940's when RUBY was operating the Silver Spur might club. WEAVER often frequented the Bilver Spur and states over the period of years got to know RUBY casually and had a speaking acquaintance with him. He advised that at no time did he socialize with RUBY and he reiterated that his acquaintanceship was based on his, WEAVER, attendance at the Silver Spur and the Vegas Clubs. Sometime in 1961, WEAVER accidentally bumped into RUBY at a waffle shop late : at night in the vicinity of the Carousel Club. In conversing with RUBY that night, WEAVER identified bimself to RUBY as a Public Accountant and RUBY, upon learning of WEAVER's occupation, asked WEAVER to handle the quarterly reports and returns of the Vegas Club and the Carousel Club. WEAVER accepted the business offer from RUBY and 🗓 did work on the books for both clubs. He stated that he did complete a Schedule C tax return for the Vegas Club for the year of 1960 or 1961. WEAVER was unable to state definitely for which year he did make but the return. WEAVER did start a corporation return for the Carousel Club but never was able to complete the return. He advised that he had problems with the Carousel Club. return as RUBY kept some of his papers and bills at his apartment, some at the Vegas Club, some at the Carousel Club and some in his car. WEAVER recalled that he probably worked on the Carcusel Club corporation return until late 1961 or early 1962 when he decided to give up the task as he could not get all the needed reports and bills together..

It is WEAVER's recollection that the Carousel Club is part of a corporation known as the S&R Corporation of which RUBY is an officer. WEAVER advised that he last saw RUBY in early 1962 or possibly late 1961, when he, WEAVER, was working on RUBY's books.

WEAVER advised that he could recall no information regarding any form of bills or IOU's in the possession of the second RUBY that would in any way reflect any acquaintance or
