She lived in Apartment 105, at 508 South Marsalis, Dallas, from about March, 1962 to January, 1963. During that period, JACK RUBY lived in Apartment 205, located directly above the apartment of Miss FREELAND.

Miss FREELAND advised she knew RUBY on a casual basis and, during the period RUBY lived in Apartment 205, GEORGE SENATOR moved in with RUBY and became his roommate. She advised that, if RUBY had partied at his apartment, she was not aware of it, as he was a quiet tenant. She stated she last saw RUBY in about January, 1963, when she moved from 508 South Marsalis.

Miss FREELAND stated she did not know LEE HARVEY OSWALD, nor did she have any information pertaining to an acquaintanceship between OSWALD and RUBY.

**R. L. DAVIS**, in charge of Occupational License and Special Tax Department, City of Dallas, furnished the following information concerning money paid by **JACK RUBY** to the City of Dallas relative to the services of special officers at the Vegas Club:

Mr. DAVIS explained that regular police officers in Dallas are not permitted to work at any club during their off-hours or at any other time for the club management. He stated that clubs which have dancehall licenses use the special officers who are certified as special officers by the Special Service Bureau of the Dallas Police Department. These special officers are civilians who, when so employed, wear the regulation police uniform and carry a pistol inasmuch as they have been given the power of arrest. This explains why the money paid to these officers is turned over by the clubs to the City of Dallas, which in turn issues the money to the special officers. Mr. DAVIS stated that clubs qualified to use such officers usually send in money one year in advance, i.e. \$7.00 per night for estimated work to be performed, and this money is directed to Mr. DAVIS's office who in turn puts it in a excrow fund in the Municipal Building, which fund is known as the Special Service Fund. Each day the Special Service Bureau of the Police Department turns in to Mr. DAVIS a list of the Special Service policemen performing such duties with the data relative to the amount of work performed and amount of money owed each one. Every two weeks Mr. DAVIS turns over the necessary funds to the Auditors Office which in turn issues the necessary funds to the special officers who come by every two weeks to pick up these checks. Mr. DAVIS further explained that occasionally such clubs will make out their checks relative to the services of such officers payable to the Police Department and in such instances the Police Department will merely forward the checks to the Tax Department to be placed in the above described Special Service Fund.

Mr. DAVIS advised that he keeps records of payments made by various clubs to Special Service officers on pink 3 x 5 cards and often these cards are destroyed after a certain period of time or when room is needed due to the

W. R. BROOKS, whose name was furnished as Mr. BROOKS, barber shop owner, by SARAH BORMASTER as a possible acquaintance and associate of JACK RUBY, advised SA EDMOND C. HARDIN as follows on January 14, 1964:

Mr. BROOKS advised that he is owner of the Brooks Barber Shop located in the basement of the Statler-Hilton Hotel, 1914 Commerce Street, Dallas. He stated that for several years he has been acquainted with GEORGE SENATOR, a customer in his barber shop. He recalls sending SENATOR to the warehouse of Mrs. BORMASTER and her husband on one occasion to take advantage of a sale of men's shirts. He advised that he did not at that time or later know JACK RUBY and if RUBY later went to this same warehouse to buy shirts, he must have been recommended to the establishment by SENATOR.

BROOKS stated that he has never been acquainted with RUBY and is not sure whether RUBY has ever been a customer in his barber shop. He added that he has no information concerning the assassination of President KENNEDY or the shooting of LEE HARVEY OSWALD.

The name PEGGY FRANKLIN, 3904 Hall Street, telephone LA 6-7211, was found in a book in the possession of JACK RUBY.

The following investigation was conducted by SA'S JAMES J. WARD and ROBERT E. BASHAM, at Dallas, Texas:

The 1963 telephone book reflected a PEGGY FRANKLIN residing at 7801 Pond, telephone EX 8-6938; however, there was no listing for PEGGY FRANKLIN in the city directory for 1963.

On December 17, 1963, Mrs. LESTER RICH, 7801 Pond, mother of PEGGY A. FRANKLIN, advised her daughter worked for Texas Industries and never lived on Hall Street, in Dallas. She advised her daughter receives telephone calls for a PEGGY FRANKLIN, whose picture appeared recently in a Dallas newspaper. She exhibited a newspaper clipping which indicated that PEGGY FRANKLIN worked at Continental Rent-A-Car Company, Dallas, and was a Dallas "Big D" Beauty. The clipping indicated that FRANKLIN had been in the Dallas area the past four years.

Attempts were made to locate PEGGY FRANKLIN at the Continental Rent-A-Car Company, in Dallas, 4411 North Central Expressway, and at her desk at the Cabana Motel, with negative results, on December 17 & 18, 1963.

On December 19, 1963, PEGGY H. FRANKLIN, 5647 Gaston, Apartment 215, telephone TA 1-3586, advised she never lived on Hall Street and did not know JACK RUBY. She advised that, when she saw RUBY on television, he looked

familiar to her, but she may have seen him in front of his club, or at the garage on Commerce Street around the corner from the Continental Rent-A-Car Office, on Akard Street, where she used to work. She said she did not know of any other PEGGY FRANKLIN in the Dallas area.

On December 19, 1963, OLIVER H. PENDER, Assistant Manager of apartments located at 3904 Hall Street, advised he never heard of PEGGY FRANKLIN and he has only been at the apartment house for two years, as has the present manager. He said Doctor WILLIAM S. HARRIS is the owner of the apartment building and has been since the building was built approximately five years ago. He said HARRIS has offices at 4020 Junius.

On December 20, 1963, Doctor WILLIAM S. HARRIS was contacted at his place of employment, Presbyterian Hospital, 4020 Junius, and he advised he could not recall the tenant PEGGY FRANKLIN. He said his manager when the building was erected was Mrs. LUCILLE RHODES, whose husband was H. J. RHODES, a paint contractor at Garland, Texas, telephone BR 6-5369.

On December 20, 1963, Mrs. LUCILLE RHODES was telephonically contacted and advised she could not recall PEGGY FRANKLIN.

On December 20, 1963, JIM KITCHING, Identification Officer, Dallas County Sheriff's Office, and J. G. VICKERY, Identification Officer, Dallas Police Department, advised their records contain no information identifiable with PEGGY FRANKLIN.

On December 20, 1963, SA ROBERT J. WILKISON caused a search of the records of the Retail Merchants Credit Association, which reflected that one PEGGY ANN FRANKLIN, who resided

She said if she thought of any information concerning PEGGY FRANKLIN she would contact the FBI.

Mrs. MARGARET HOPKINS, Club Manager, Casa Del Sol, 554 South Summit Street, furnished the following information:

Casa Del Sol is a private club operated at the Westchester House Apartments and also operates a private club in connection with Cross Key, a cafe located at the Westchester Apartments. Casa Del Sol receives numerous calls from persons in Dallas, either on business or sometimes in making reservations at the club.

Mrs. HOPKINS stated that she has been the manager of this club since it was organized about two years ago. She stated that she was not acquainted with JACK RUBY and does not recall any particular phone call from JACK RUBY to Edison 6-2823, which is the phone number of Casa Del Sol in the Westchester House Apartments. She related that she and other employees around the club had discussed the assassination and JACK RUBY, and that none of the employees around Casa Del Sol ever said they were personally acquainted with RUBY.

Mrs. HOPKINS stated that she is not acquainted with RUBY and has never met or been acquainted with LEE HARVEY OSWALD.

The Chicago Division of the FBI received a copy of a mimeographed letter from the Independent Voters Organization, 6649 South Lowe, Chicago, Illinois, directed to a business organization in Deerfield, Illinois. This letter reflected that the Independent Voters Organization issues a publication within a specified Chicago area and solicits ads from various firms which might benefit from the publication. A typewritten insertion to the mimeographed form reflected that all proceeds from this particular ad campaign would be utilized for the JACK RUBY defense. This letter was signed by ~~ARNOLD KRAUSE~~.

On December 31, 1963, S. W. JONES, 6649 South Lowe, Chicago, Illinois, was contacted, at which time he stated that ARNOLD KRAUSE came to work for him on a non-salaried basis, approximately two months ago in an effort to promote business directly as indicated in the promotional letter. He was to work strictly on a commission basis and the only reason he took KRAUSE in was because he had met KRAUSE at an Art Show at Navy Pier, in about 1958. Mr. JONES stated that the only reason he used KRAUSE in this promotion was because that KRAUSE was a white man and he felt it would do the promotion some good. KRAUSE was Director of Advertising until December 21, 1962, when he left Chicago to participate in some march on civil rights. JONES is not sure of the location of this march. He and KRAUSE had a disagreement because KRAUSE could not take orders and would not follow up on the promotional letters he had sent out. Upon learning that KRAUSE was placing a note on the letter that "all proceeds from this ad drive will go to the Defense Fund for JACK RUBY," JONES got extremely upset and told KRAUSE that this promotion had nothing to do with JACK RUBY and the proceeds would not go to the RUBY Defense Fund. JONES said that KRAUSE was using this as a come on and was completely without basis or merit.

He knew very little about KRAUSE other than that he was somewhat of an artist and does not know of KRAUSE's previous employment. KRAUSE is a white male, approximately 29 years old of medium height and build, whom JONES believes came from Germany to the United States as a child. KRAUSE was driving a 1960 black, two door Cadillac with an unrecalled Illinois license number.

JONES reiterated that this promotion, utilizing the Independent Voters Organization had nothing whatsoever to do with JACK RUBY and KRAUSE had used the notice in the letter on his own. JONES said that the Independent Voters Organization was organized by himself in order to promote advertising of various remodeling companies having homes which he felt would reach a select area in Chicago, and would be of advantage to these remodeling companies.

Dr. REID stated that he never heard of JACK RUBY prior to the assassination of President KENNEDY. He recalled that several years ago he became a member of the La Cabana Club, Dallas, Texas, but has not actively participated in that membership for well over a year. REID further advised that he does not know LEE HARVEY OSWALD.

On January 7, 1964, FRED ELLIS, Credit Manager, Upjohn Drug Company, 4114 Central Expressway, Dallas, LEE KELTNER, Southwestern Drug Company, Dallas, and ROBERT MORRISON, McKesson and Robbins, Inc., Dallas, made a search of their records and advised they could locate no record of Serv-U-Pharmacy.

On January 8, 1964, SA PEGGS physically observed the address of 1601 West 6th Street and determined it to be a residential area in Oak Cliff, a suburb of Dallas, Texas.

Mr. JOHN F. WILSON, Attorney, Room 710 at 109 North Akard, advised that he was not acquainted with JACK RUBY, had never represented RUBY in any legal matter and had never represented an individual named FRANK FERRARO in any legal proceeding against RUBY. He caused the records of his firm to be checked which failed to disclose that the firm had ever represented any individual named FRANK FERRARO.

Mr. WILSON stated he had never heard of LEE HARVEY OSWALD prior to the assassination and that he was aware of no connection or association between OSWALD and RUBY. He had no information as to the nature or extent, if any, of RUBY's contacts and associates among members of the Dallas Police Department and was not aware of any reasons why RUBY shot OSWALD.

Mrs. O. A. HESS, Apartment A, 2129 Tucker, Dallas, advised on January 2, 1964, she is the manager of a series of apartment buildings located in that block, and which includes Apartment B at 2119 Tucker. According to her records, the W. YEAGER who formerly occupied Apartment B at 2119 Tucker, moved without leaving a forwarding address on December 15, 1962. According to her records and her recollection, he was known as "BERT" YEAGER, which leads her to believe his given name was probably WILBERT rather than WILLIAM.

WILLIAM EARL YEAGER, #530 Malden, Dallas, employed as a pharmacist by the Complete Pharmacy, 219 North St. Paul, Dallas,

advised on January 4, 1964, that he had formerly resided at 4635 Bryan Street and at Apartment 102 at 1107 South Ewing Street, both Dallas, Texas. He had never been in any of JACK RUBY's clubs and had never heard of either JACK RUBY or LEE HARVEY OSWALD prior to the assassination of the President and the shooting of OSWALD.

Mr. W. C. YEAGER, 8741 Rexford, Dallas, advised on January 3, 1964, he had never been inside one of JACK RUBY's clubs and had never heard of either RUBY or OSWALD prior to the assassination and the shooting of OSWALD.

Reverend W. J. YEAGER, 1601 Hill Street, Grand Prairie, Texas, advised on January 3, 1964, that while his address is listed in the telephone book as 1601 Hill Street, it is listed by the post office as 1606 Hill Street. He had never been inside one of JACK RUBY's clubs and had never heard of either RUBY or OSWALD prior to the assassination and the shooting of OSWALD.

Mr. W. N. YEAGER, 1226 Ottawa Circle, Richardson, Texas, advised on January 2, 1964, he had formerly resided at 626 Dumont Street, Richardson, Texas. He had never heard of either LEE HARVEY OSWALD or JACK RUBY prior to the assassination and the shooting of OSWALD and had never frequented any of RUBY's clubs.

WILLIAM R. YEAGER, 208 Island, Richardson, Texas, advised on January 2, 1964, he had formerly resided at 107 South Bowser in Richardson, Texas. He is employed as administrative assistant to the City Manager of Richardson, Texas, and has been prominent as a coach of Little League ball teams in the area for the past several years. He stated he had been in JACK RUBY's Vegas Club on one occasion approximately three years ago, at which time he believed he might have met JACK RUBY. He stated he had no subsequent contact with RUBY and would not know him if he saw him at this time. He never heard of LEE HARVEY OSWALD prior to the assassination of the President, and he was aware of no connection between OSWALD and RUBY. He had no knowledge or information as to the nature and extent, if any, of RUBY's association with members of the Dallas, Texas, Police Department. He had no idea why RUBY shot OSWALD.

Mr. WESLEY W. YEAGER, 945 Greeville, Road, Richardson, Texas, advised on January 2, 1964, he had never heard of LEE HARVEY OSWALD or JACK RUBY prior to the assassination of the President and the shooting of OSWALD. He had never been in any of RUBY's clubs.

ANDREW ARMSTRONG, Acting Manager and Bartender;

WALLY WESTON, Master of Ceremonies;

DIANE HUNTER, Dancer and former employee Vegas Club;

BILLIE HADLEY, Waitress.

ANDREW ARMSTRONG, named above, stated that RUBY habitually wrote names of many individuals in his address books who were prospective employees, many of whom were never actually employed by RUBY.

never been in any of JACK RUBY's clubs and had never heard of either RUBY or LEE HARVEY OSWALD prior to the assassination of the President and the shooting of OSWALD.

Mr. FRANK SCHEFFLER, 3616 Centenary, Dallas, advised on January 2, 1964, he had never attended any of JACK RUBY's clubs and had never heard of either RUBY or LEE HARVEY OSWALD prior to the assassination and the shooting of OSWALD.

Mr. DOCK BOYLE, 733 Hillburn, Pleasant Grove, Texas, advised on January 2, 1964, he had never been in any of JACK RUBY's establishments and had never heard of either RUBY or LEE HARVEY OSWALD prior to the Presidential assassination and the shooting of OSWALD.

MILDRED HUNTLEY, Turtle Creek Square Apartments, 3883 Turtle Creek Boulevard, on January 4, 1964, advised she is an interior designer for the Sanger-Harris Department Store in Dallas, Texas, and that she formerly resided at 3525 Turtle Creek Boulevard. She continues to have the same telephone number, LA 8-7475, as she had at her previous address. She stated she had never been inside any of JACK RUBY's establishments and had never heard of either RUBY or LEE HARVEY OSWALD prior to the Presidential assassination and the shooting of OSWALD.

She also advised that at her current address, as well as her previous address, she has frequently received telephone calls from persons trying to call the Vegas Club. She referred to the current Dallas Metropolitan telephone book and discovered the telephone number for the Vegas Club is LA 8-4775. She believed that such persons calling her while attempting to contact the Vegas Club had probably transposed the first two numbers of the 4-digit sequence. She indicated an intention of getting her telephone number changed to avoid future inconvenience from this cause.

Mrs. JOAN THOMAS, Vacation Sales Agent, United Air Lines, Room 2003, Adolphus Towers Building, 1412 Main Street, Dallas, advised on December 31, 1963, that United Air Lines does not fly in or out of Dallas, Texas, but merely maintains an office here for the convenience of persons who desire to use connecting air lines to cities serviced by her company. She stated that consequently the volume of business conducted by her

office is quite small and that it would be possible to check records of reservations to determine whether or not JACK RUBY had obtained a reservation on a United Air Lines by telephone or otherwise in Dallas, Texas.

She personally checked her records from April 1, 1963, to December 1, 1963, which failed to disclose any reservation made by or for JACK RUBY during that period. She stated that it was possible that RUBY might have called her office seeking information, in which event no record of the inquiry would be maintained. She had never been inside any of RUBY's establishments and had never heard of either RUBY or LEE HARVEY OSWALD prior to the Presidential assassination and the shooting of OSWALD.

Mrs. ETHEL WILLIAMS, 219 West Hobson, Dallas, advised on January 2, 1964, she is the holder of telephone number Whitehall 8-7475. She has never been in any of JACK RUBY's clubs and never heard of either RUBY or OSWALD prior to the Presidential assassination and shooting of OSWALD.

Corrigan Properties, Inc., 211 North Ervay, Dallas, Texas, which company owns the property at 3508 Oak Lawn Avenue, where the Vegas Club is located. On one or two occasions prior to 1963, she performed her striptease dance at the T-Bone Club, a supper club at 47th and South Broadway, Wichita, Kansas. It is her understanding the owner of this place (name unrecalled by her) is in some penitentiary. The manager is JIM YONKERS and a man named VIRGIL PEEL is around the club and she believes he is a part owner.

In early January, 1963, she was doing her striptease dance at the Carousel Club at Dallas, Texas, operated by JACK RUBY. Her agent, JACK COLE, doing business as Jack Cole Theatrical Agency, 525 Interurban Building, Dallas, office telephone RI-8-46664, home telephone (unlisted) BL-3-7136, arranged for her to appear at the T-Bone Club at Wichita. She referred to her contract for this appearance and furnished the dates as January 20, 1963, through February 9, 1963.

She was preceded at the T-Bone Club by PRECIOUS DIAMONDS, a stripper from Dallas whose agent is also JACK COLE and who regularly dances at the Theater Lounge in Dallas. Her boy friend is JOHNNY (Last Name Unknown), who plays the trumpet at the Theater Lounge.

GAIL RAVEN flew to Wichita from Dallas by herself on January 20, 1963. She stayed at the Casa Siesta (as GAIL RAVEN), 4449 South Broadway, about two blocks from the T-Bone Club. On Saturday afternoon, February 9, 1963, RUBY telephoned her from Dallas and told her he would fly to Wichita and bring her back to Dallas after she finished her engagement that night. She was packed and ready to leave Wichita after her Saturday night performance. At about 3:30 a.m. on February 10, 1963, JACK COLE telephoned her from Dallas and told her there had been some mix up about the next girl who was to commence stripping at the T-Bone Club who was scheduled to open on February 11, 1963. He instructed her to stay until he got someone to take her place and until further notice from him. She continued to strip at the T-Bone Club through Wednesday, February 13, 1963.

On that date, COLE called her and instructed her to return to Dallas. She left Wichita by plane at 6:30 a.m., February 14, 1963, by herself and returned to Dallas. She opened at the Colony Club that night, which place is next to the Carousel Club. She did not contact RUEY to tell him not to come to Wichita because she was staying a few extra days and she presumed he learned of her change of plans from JACK COLE.

RUBY was not in Wichita when she was there. She definitely did not introduce him to JIM YONKERS or VIRGIL PEEL. It was her impression from their conversation that they did not know RUEY as they inquired about him as club owners frequently do about one another.

She understood that RUEY had come to Wichita before she arrived to work at the T-Bone Club, that he had made a trip there to return PRECIOUS DIAMONDS to Dallas. If RUBY did go to Wichita, he stayed at the Casa Siesta Hotel where all the persons appearing at the T-Bone Club customarily stay. If he made the trip to Wichita, she presumed he went by himself and returned to Dallas with PRECIOUS DIAMONDS on or about January 20, 1963. She knew of no other time RUEY went to Wichita.

GAIL RAVEN returned to Wichita for another stripping engagement on July 29, 1963, but RUBY did not come to Wichita during her stay there at that time.

She reiterated she was not certain RUBY went to Wichita to return PRECIOUS DIAMONDS to Dallas but thought he might have made this trip.

The following investigation was conducted by SA ALVIN J. ZIMMERMAN at New Orleans, Louisiana:

On January 9, 1964, Mrs. ELOISE KELLUM, Probation Officer, 8000 Foucher Street, advised that she had received information that one TONY OTILLAR who is employed as a ticket agent by Delta Airlines, had made the statement that he was well acquainted with JACK RUBY inasmuch as RUBY had made numerous flights via Delta Airlines from New Orleans.

On January 10, 1964, TONY OTILLAR was contacted at his home at 228 North Atlanta Street, Metairie, Louisiana. OTILLAR advised that approximately seven years ago, JACK RUBY flew from New Orleans, Louisiana, to Havana, Cuba. At the time, RUBY was at the New Orleans Airport to catch this flight, OTILLAR struck up a conversation with him and then became acquainted with him. He advised that prior to leaving on the flight, RUBY made a long distance call to Dallas, Texas and talked with someone who was employed at his night club. He told whoever he was talking to that he was going to Havana and that the entire trip was being paid for by someone else and was not costing him anything. He advised the person he was speaking to on the telephone not to disclose his whereabouts unless it were to the police or some other official agency.

OTILLAR advised that approximately six months ago JACK RUBY came to the New Orleans Airport and flew via Delta Airlines to Houston, Texas. RUBY talked with OTILLAR for a short time and told him that he was transporting a dog which he had purchased and was taking it to the well known strip dancer CANDY BARR. OTILLAR advised that RUBY was with a Jewish or Italian man and RUBY introduced him as a bar operator in the French Quarter; however, OTILLAR was unable to recall the man's name.

An item appeared in the Dallas, Texas, Morning News edition of December 24, 1963, entitled "EARL WARREN Poster - Upset RUBY Took Photographs at 4:00 AM, Says Roommate." According to testimony by GEORGE SENATOR, RUBY's roommate, after photographing a billboard sign reading "Impeach EARL WARREN," SENATOR and RUBY went to the Post Office, Dallas, Texas, and protested to a clerk there about the "newspaper ad" (full page ad in Dallas Morning News of November 22, 1963, of American Fact-Finding Committee, BERNARD WEISSMAN, Chairman, Post Office Box 1792, Dallas, Texas).

In an effort to identify the post office clerk referred to in testimony by SENATOR, Postal Inspector HARRY HOLMES was contacted and he advised he would instruct various supervisors in the post office to make inquiries in an effort to identify the clerk in question.

On January 3, 1964, ALLAN MADDOX, Clerk, Postal Inspectors Office, advised it had been determined that 17 clerks were on duty between the hours of 5:00 AM and 7:00 AM on the morning in question and that if RUBY and SENATOR had appeared at the post office shortly before 5:00 AM, or shortly after 7:00 AM, there would be an additional 50 or 60 clerks who could possibly have been contacted by RUBY.

On January 7, 1964, MADDOX advised it had been determined that a great many individuals had made complaints or comments concerning instant ad and the clerks who had been queried concerning this matter had been unable to specifically recall RUBY as a complainant.

RUBY declined the invitation explaining that he had to go elsewhere. CAMPBELL stated that he talked with RUBY and PAUL for only a minute or so and left.

Mr. CAMPISI, who has been previously interviewed, stated that he recalls seeing RUBY and RALPH PAUL at his restaurant during the evening of November 21, 1963. He stated that he recalls this as a very busy evening and consequently cannot be sure of the details surrounding RUBY's visit. He stated that as best as he recalls, RUBY and PAUL arrived at the restaurant between 9:45 and 10:00 PM and had dinner there, staying some 45 minutes. He stated that he does not recall the identity of any individual to whom RUBY and PAUL spoke while there and does not recall any particular conversation he himself may have had with them.

Mr. BETH KANTOR, Scripps-Howard Staff Writer, "Washington Daily News" Building, 1013 13th Street, N. W., Washington, D. C., advised he definitely saw and talked with JACK RUBY on November 22, 1963, at the Parkland Hospital, Dallas, Texas. He stated he previously furnished this information to the FBI in Dallas and a couple of days later upon being interviewed by Captain JONES of the Dallas Police Department executed a detailed signed statement showing this information.

KANTOR stated he fully realizes the importance of what he has said, i.e., that he saw and talked with RUBY at the Parkland Hospital, November 22, 1963. He knows a man's life is at stake, and for that reason wants to be as specific as possible.

He stated he wrote an article showing he saw RUBY about 1:28 p.m., at the Parkland Hospital. Upon reflection, he stated, realizing the importance of the matter, it might have been about 2:00 p.m., rather than 1:28 p.m. He is positive, however, that it was November 22, 1963.

KANTOR stated it had to be at the Parkland Hospital. He explained from the airport in Dallas he joined the Presidential Motorcade. He was in a White House Press Bus with other reporters. He heard shots and the bus proceeded to the Trade Mart in Dallas. Somebody at the Trade Mart called the Dallas Police and asked what had happened. He was told the President had been shot and had been taken to the Parkland Hospital. Somebody or other took him and about six other reporters to the hospital in his station wagon. They arrived at the hospital about 12:50 p.m. He saw U. S. Senator YARBOROUGH of Texas outside the hospital. He spoke to him briefly. After identifying himself, a police officer took him in the hospital. This was about 12:55 p.m. Across from the emergency surgery room he phoned Washington and was on the phone about 20 minutes. After calling Washington, he spoke to Texas U. S. Congressmen ALBERT THOMAS and HENRY GONZALEZ who were in the emergency ward area. MALCOLM KILDUFF, PIERRE SALINGER's assistant, told everyone on the scene that he had an announcement to make and that everyone should follow him. KILDUFF walked off and MERRIMAN SMITH, of United Press International, and AL GROMLEY of the "Oklahoma City Oklahoman," walked on each side of KILDUFF, talking to him, apparently trying to find out what had happened. Three or four others, identities not recalled, and himself, followed KILDUFF, SMITH and CROMLEY.

They went outside the hospital and back in through another entrance. As he went in this entrance, three or four steps in, he felt a tug at the bottom of his coat. He turned around. It was JACK RUBY. RUBY said "Hello, SETH," and stuck out his hand. KANTOR shook hands with RUBY. RUBY then said something to the effect, "Isn't this a terrible thing? Do you think I ought to close my places for three days?" KANTOR replied to the effect, "Yes, I think you should." KANTOR specifically recalled that RUBY said "three days." KANTOR stated that was all there was to the conversation. He stated that quite frankly he gave RUBY the brush-off. He did this because he was most interested in what KILDUFF was to announce and did not want to take the time to talk to RUBY. He could not recall what RUBY was wearing other than he believes he was hatless.

KILDUFF followed by the reporters proceeded to a make-shift press room in the hospital and announced that President KENNEDY was dead. This announcement was made at 1:30 p.m., November 22, 1963. KANTOR stated he had talked with RUBY just prior thereto so he figures he talked to him about 1:28 p.m. After making the announcement, KILDUFF stated he would have another announcement in about ten minutes. KILDUFF left the room.

After hearing the announcement, KANTOR got on the first available phone in the Parkland Hospital and called the Scripps-Howard Office in Washington, D. C. He was on the phone about 15 minutes. He then went back to the make-shift press room. KILDUFF was not there.

BILL STINSON, an administrative aid to Texas Governor JOHN B. CONNALLY, was in the make-shift press room. Another aid, JULIAN O. READ, was with him. STINSON for the benefit of the reporters present reconstructed on a blackboard where President KENNEDY, Governor CONNALLY and their wives were seated in the motorcade. While STINSON and READ were talking, JIGGS FAUVER, head of transportation at the White House, interrupted and told all present that a press pool car was needed to go to Love Field. This was about 2:00 p.m.

About 2:00 p.m., KANTOR stated, he left the make-shift press room along with other reporters. When he got outside the hospital he decided not to go to Love Field, thinking perhaps more news would be available in the make-shift press room. Immediately

outside the hospital he saw Senator YARBOROUGH, Texas Congressman OLIN/TEAGUE and HENRY GONZALEZ and Dallas Mayor EARL/CABELL. They were waiting for transportation to go to Love Field. KANTOR stated he tried to get some information from them and then re-entered the hospital.

As KANTOR entered the hospital, RUBY was standing inside the entrance. It was either here that he saw and talked with RUBY as reported herein or at the time he was following KILDUFF as above. KANTOR stated he is not certain whether it was about 1:28 p.m. or about 2:00 p.m. He is positive, however, that he saw and talked with RUBY at the Parkland Hospital, November 22, 1963. It was about 1:28 p.m. or about 2:00 p.m.

He described the immediately foregoing entrance as on the south side of the hospital. It might have been the main entrance but it was rather small.

KANTOR stated he was in Dallas from September, 1960, to May, 1962, at which time he worked for the "Dallas Times Herald" newspaper. Shortly after starting work with this paper he met JACK RUBY. RUBY was a nightclub operator and quite naturally wanted publicity for his clubs. He frequently approached KANTOR with stories publicizing his interests. KANTOR specifically recalled he wrote one story furnished by RUBY. It was about a stripper who used snakes in her act. KANTOR stated there is no question that he knows JACK RUBY when he sees him.

KANTOR reiterated it was November 22 and at the Parkland Hospital that he saw and spoke with RUBY. It was not prior or subsequent thereto. KANTOR stated he was at the hospital November 22, and did not return to the hospital until about ten days thereafter. RUBY was in custody when he returned to the hospital. It had to be November 22 that RUBY was there.

KANTOR stated he was unable to furnish the identity of anyone who might have seen him talking with RUBY. About 1:28 p.m., there was a big rush following KILDUFF, as previously stated, and he is certain MERRIMAN SMITH and AL CROMLEY were so engrossed talking

with KILDUFF, also they were in front of him, that they could not have seen him with RUBY. He is likewise certain the other reporters, identities not recalled, paid no particular attention to him, having their minds on what KILDUFF was to announce.

About 2:00 p.m., when he re-entered the hospital, after talking with the officials previously referred to, KANTOR stated, he observed hospital personnel, identities not known, in the entrance. He believes they were personnel because of their white garb. If it was there he saw RUBY rather than about 1:28 p.m., the personnel would not remember it because they were not paying any particular attention to him.

KANTOR stated after re-entering the hospital about 2:00 p.m., he went to the make-shift press room in the hospital. KILDUFF was not there. KANTOR stated he subsequently left the press room and got on a press bus en route to Love Field. He checked his notes and advised they show a notation by him at 2:30 p.m., written while on the bus, that he observed mobs of curiosity seekers driving around the Parkland Hospital.

KANTOR stated he next and last saw RUBY in the Dallas Jail. This was Sunday, November 24, 1963, at which time RUBY was being led by the Dallas Police from an upper floor of the jail. KANTOR stated he looked directly at RUBY and RUBY appeared to be looking directly at him. RUBY, however, showed no signs of recognition. RUBY's complexion was pasty, his face was grim and his lips were drawn tightly together.

KANTOR gave a note to ART HAMMET, a Dallas police officer, who works in the office of Dallas Police Captain GLEN KING, asking that HAMMET give the note to RUBY. The note read, "JACK, Can I please talk to you, SETH." HAMMET told him he would try to see that RUBY got the note, but cautioned KANTOR that he could not make any promises that RUBY would get the note. Subsequently, KANTOR stated, he gave the same type note to TOM HOWARD, RUBY's lawyer, and asked that HOWARD give it to RUBY. HOWARD said he would. KANTOR stated he received no reply to these notes.

KANTOR was pointedly told by interviewing agents that RUBY has emphatically denied he was at Parkland Hospital at any time November 22, 1963, or subsequent. KANTOR was specifically asked whether he might be mistaken about seeing RUBY there November 22. KANTOR reiterated he is absolutely certain he saw and spoke with RUBY at the Parkland Hospital on November 22.

KANTOR was told that he might be called upon to testify in this case. He was asked what he would say if under oath and on the witness stand in a court of law to the question, "Did you see and talk with RUBY at the Parkland Hospital on November 22, 1963?" KANTOR stated he would answer, "Yes," because he is absolutely certain he did.

KANTOR speculated that perhaps RUBY has said he was not at the Parkland Hospital on November 22, as part of his reported plea of temporary insanity. KANTOR stated he is not acquainted with all facets of such a plea but felt it might help RUBY's cause for RUBY to deny being at the hospital when he knows he was, and that KANTOR would have to testify that he saw him there. Then too, KANTOR stated, RUBY might have been in emotional shock and cannot recall being at the hospital.

KANTOR stated he did not know LEE HARVEY OSWALD, and he does not know whether RUBY knew OSWALD. He stated he does not know whether there was any connection between RUBY and OSWALD.

KANTOR stated he wants to cooperate with the FBI anyway possible, and the FBI should consider him at all times available for interview.

Mr. DOYLE STOKES, 213 South Ewing, who was reported to have seen RUBY on Sunday morning, November 24, 1963, furnished the following information:

Mr. STOKES advised he is employed by the Veterans Administration Hospital where he is in charge of the Morgue. He works five days a week, Monday through Friday, and weekends when emergencies arise. Mr. STOKES last saw JACK RUBY on Saturday afternoon, November 23, 1963, sometime between 1:00 and 1:30 PM, as RUBY drove his automobile out of the driveway which runs along side of the STOKES' residence. He knows definitely it was Saturday afternoon because he was called back to the hospital to work and after he received his call to go back to work, he telephoned Mrs. STOKES to tell her that he had to work. Mr. STOKES did not see JACK RUBY on Sunday morning November 24, 1963.

Mr. STOKES has known JACK RUBY for three or four months having met him in the neighborhood when RUBY was walking his dogs. Mr. STOKES knows nothing concerning RUBY's personal life or political beliefs. He stated he knows of no connection between RUBY and LEE HARVEY OSWALD.

The following investigation, conducted by SA PAUL L. SCOTT at Dallas, Texas, was based on information received that a Mr. MORRIS, who formerly owned the MORRIS stores in Dallas and now owns several buildings in Snider Plaza, had taken a photograph of the President in his automobile as it was turning from Houston to Elm Street, and in the background JACK RUBY could be seen standing on the curb at the corner of Houston and Elm.

On January 9, 1964, Mr. MORRIS WEINKRANTZ, 5508 Forest Lane, Dallas, advised that several days after the assassination of President KENNEDY he purchased an enlarged photograph of President KENNEDY and the Presidential party from a Negro, identity unknown, who was selling these photographs on Forest Avenue in Dallas. The Negro told him that the photograph had been taken of the President in his automobile as it was turning from Houston onto Elm Street and that JACK RUBY was standing in the background when this photograph was taken. Mr. WEINKRANTZ said the man with the hat, standing in the upper right of the photograph behind the man with the camera in his hand, had been pointed out to him as JACK RUBY, and the woman without glasses back of this man was supposedly one of the girls who had worked for JACK RUBY at the Carousel Club.

Mr. WEINKRANTZ made available this photograph for copying.

SA MANNING C. CLEMENTS has observed a photograph, which includes the late President JOHN F. KENNEDY in an automobile during the parade on November 22, 1963. This photograph was furnished by Mr. MORRIS WEINKRANTZ on January 9, 1964, and purportedly was taken at a point where the President's car was turning from Houston Street to Elm Street.

According to Mr. WEINKRANTZ, an individual standing in the upper right of the photograph behind the man with a camera in his hand had been pointed out to him as being JACK RUBY.

SA CLEMENTS, who interviewed RUBY over a period of some three and one-half hours on December 21, 1963, advises the photograph does not in his opinion include anyone closely resembling JACK RUBY.

BARNEY BAKER is a former organizer for the Central States Conference of the International Brotherhood of Teamsters Union and was a reported muscle and bagman for Teamster President JAMES RIDDLE HOFFA.

BARNEY BAKER was interviewed at his residence, 5900 Sheridan Road, Apartment 5E. He advised that he was released from Sandstone Penitentiary June 7, 1963, and is presently employed as field representative for the Chicago Loop Auto Refinishing Company, Incorporated, paint factory, 3216 South Shields Avenue, Chicago.

BAKER advised that on November 11, 1963, his wife CAROLINE called him at his office and told him that he had just received a long distance telephone call from Dallas, Texas, at his home phone of RA 8-4031. His wife stated that it was requested that he return the call and ask for LOU. BAKER advised that he cannot recall the telephone number that he called in Texas, but stated he did return the call the same day from his office telephone which is Chicago number 225-0560. He stated that upon completion of the call to the Dallas number he told the person who answered that he was BARNEY BAKER and that he was returning a call to someone at that number. He stated that the person on the other end of the line said "That's me. My name is (BAKER could not recall the first name) RUBY." This person then told BAKER "You don't know me but we have mutual friends." BAKER said he asked who the mutual friends were but RUBY simply said "We got friends but I don't want to talk over the phone." According to BAKER, RUBY then related that he was in the burlesque and strip show business in Dallas and that competitors were "attempting to knock me out." He advised that he needed a favor and BAKER asked what the favor was. RUBY related that he had several strip shows operating in the Dallas area and said that the American Guild of Variety Artists (AGVA) "are giving me a headache." He told BAKER that competitors through the help of the AGVA were "giving me a fit." BAKER stated that RUBY suggested that "mutual friends" had advised that BAKER was familiar with unions

and handling matters such as this and requested that BAKER contact the AGVA and "straighten them out."

BAKER advised that he had not known JACK RUBY prior to the call but RUBY spoke in a fast and erratic manner making it rather difficult to understand him. BAKER stated that he advised RUBY that he had been released from prison in June, 1963, and that part of the provisions of his five years probation were that he should not engage in any labor management relations activities during the probation period. BAKER recalled that RUBY attempted to persuade him to intercede with the AGVA for him but BAKER concluded the conversation by firmly declining to offer any assistance in the matter.

BAKER advised that as a result of his former capacity as union organizer, he had many friends some of whom were influential politicians and high ranking hoodlums. He stated, however, that he forgot about the conversation with RUBY and did not attempt to determine who the "mutual friends" were who had referred RUBY to him at that time. He stated, however, that after the assassination of President JOHN F. KENNEDY and the subsequent murder of LEE HARVEY OSWALD by JACK RUBY, he made inquiry of numerous persons in an attempt to determine who referred RUBY to him. He stated the results of the inquiry were negative and he still has no idea as to the identity of the individual who suggested that RUBY contact him at Chicago.

Concerning letters and telegrams received by JACK L. RUBY following the shooting of OSWALD, copies of which were furnished the Dallas Office by the Dallas County Sheriff's Office, the following letter, received by RUBY, is quoted in full:

"Well Jack now that Things have sorta quited down I will drop you a fue lines, Jack you probley dont Remember this Picture or that is this Picture of This Person, But I will sorta reFresh your memory a Little, now think Back not to far for it was say about Last May I Came into your night club and this Fellow was with me I interduced this Person to You and while we were sitting their in come this other Fellow and up jumped this Fellow I interduced to you and he went over to where this Person was and brought him Back to where we were sitting he interduced him to us Both Remember Yes the one and only OSWALD he shouted and you jumped up and started to through this Person out in the pictre and said you will never get me, than in a fue days i came back into your night club and their you and This Person OSWALD sit, This Person of which interduced OSWALD to you and me he is Back East now I'am gong back in a Fue days, he said as long as OSWALD is dead now he hoped that you will never talk, I will Tell the old gang helleo For I Know you would want me to So Long For now Jack will Try to get to your Trials.

The letter was postmarked Portland, Oregon, on December 8, 1963, bearing no return address and addressed to JACK RUBINSTEIN, In Care of the Dallas County Jail, Dallas, Texas. The entire letter as well as the envelope was printed.

Mr. SIDNEY EDWARD VOEBEL, commonly known as EDWARD VOEBEL, was interviewed at his place of employment, Quality Flower Shop, Inc., 4916 Canal Street, likewise his residence address.

He was shown a photograph of several patrons in the business establishment of JACK RUBY, Dallas, Texas, it having been alleged that one of the individuals pictured in the foreground is possibly LEE HARVEY OSWALD. He stated that he knows without question that the person to which referred is not OSWALD. He continued that, among other reasons for so stating, OSWALD had darker, wavier hair than the person in the photograph, and that the facial features of the individual pictured are unlike those of OSWALD.

Mr. VOEBEL continued by saying that he first saw the photograph in the latter part of November or early part of December, 1963, when a person whose identity he did not know came to the flower shop. Thrusting the photograph before Mr. VOEBEL, this person inquired if the person seated in the foreground could possibly have been OSWALD. Mr. VOEBEL stated at that point that it could not. He advised that this individual had said something to the effect he was with an organization identified by its initials, much like a representative of the Associated Press (AP) or United Press International (UPI), and this individual left the impression he was with one of the national wire services. Mr. VOEBEL stated this person then left the premises and has not been seen since.
