Mr. TERRY A. FRIEDMAN, 416 North Labarre Road, was interviewed at "The Times-Picayune", where he is employed as a photographer.

He was shown & photograph of several patrons in the business establishment of JACK RUBY at Dallas, Texas. He said he had previously been shown the same photograph by the person who took it, Mr. EDWARD ROCCO, free-lance photographer. Mr. FRIEDMAN continued by saying he originally had told Mr. ROCCO the person seated in the foreground looked like LHE HARVEY. OSWALD. He said the had no actual basis for saying this, as OSWALD was never known to him. He advised the statement was intended only as conversation and was by no means intended as an identification. Mr. FRIEDMAN then stated he has no knowledge whatsoever of the identity of the person in question.

He continued by saying that he was introduced to Mr. ROCCO at "The Times-Picayune" in the latter part of November or early part of December, 1963, by Mr. SAM-SUMMERLIN, Associated Press (AP) Bureau Chief in New Orleans., He said he had never seen Mr. ROCCO before and has not seen him since. He advised Mr. SUMMERLIN did not participate in the conversation, as he left after making the introductions. Mr. FRIEDMAN concluded by saying that he could add nothing additional to the facts concerning the occasion of his conversation with Mr. ROCCO.

With reference to information received from Attorney SEARCY LEE JOHNSON, Dallas, Texas, on December 31, 1963, that one RUSS MOORE, a disk jockey at Station KLIF, Dallas, had mentioned to him sometime ago that one of the station's engineers had indicated he was doing a rewiring job at one of JACK RUBY's clubs and was of the opinion he had observed LEE HARVEY OSWALD at that time, the following investigation was conducted by SA HAROLD R. DOBSON:

Mr. RUSSELL LEE MOORE, also known as RUSS KNIGHT, "The Weird Beard", residence 2715 Barnes Branch Road, Dallas, Texas, employed as a disk jockey by Radio Station KLIF, 2104 Jackson, Dallas, advised on January 3, 1964, he was unable to recall ever receiving information from anyone that one of the station engineers had observed LEE HARVEY OSWALD in one of JACK RUBY's clubs while performing a rewiring job at such club. He was likewise unable to recall ever stating to anyone he had received information to that effect.

He advised that there is only one engineer assigned to the station at its office at the above address, MIKE EDWARDS, and that other engineers are stationed at the station's transmitter site. Mr. MOORE stated he had previously been interviewed by Bureau Agents concerning his contacts and association with JACK RUBY, which had consisted of doing some radio advertising for RUBY approximately one and one-half years ago; observing RUBY bowling at the Cotton Bowling Palace in Dallas, occasionally after work, and a visit from RUBY at the station on the evening of November 23, 1963, following the assassination of the President and the apprehension of LEE HARVEY OSWALD.

Mr. MOORE had never heard of LEE HARVEY OSWALD prior to the assassination of the President and had no knowledge or information concerning any connection between OSWALD and RUBY. He had no knowledge or information as to why RUBY shot OSWALD. He was aware that RUBY was generally acquainted with members of the Dallas, Texas, Police Department, but he had no information as to the identities of specific officers with whom RUBY was associated.

Lane, Dallas, Chief Engineer, Radio Station KLIF, Dallas, advised on January 4, 1964, that following the assassination of the President on November 22, 1963, he was in conversation with one

of the station's radio engineers assigned to the station transmitter, DONALD C. STUART, 1505 North Fitzhugh, Dallas, who advised him that approximately two weeks prior to the Presidential assassination and the shooting of LEE HARVEY OSWALD, JACK RUBY had entered an electronics shop in which he, STUART, was a partner, accompanied by an individual who, from the photographs of OSWALD, might have been LEE HARVEY OSWALD. RUBY at that time had requested STUART to bid on the rewiring of the sound system at the Carousel Club.

At the time of Mr. EDWARDS' conversation with STUART, STUART had not advised the authorities of the above information and asked EDWARDS to whom such information should be furnished. EDWARDS told him he should immediately report the information to both the FBI and the Dallas Police Department. Mr. EDWARDS saw STUART on Tuesday, following the shooting of OSWALD, at which time STUART indicated he had not yet found time to report his information to the authorities, whereupon EDWARDS told him if he did not report same forthwith he himself would call the authorities. Mr. EDWARDS stated that STUART then called both the FBI and the Dallas Police Department, and he personally knew that STUART had been subsequently interviewed fully by Special Agents of the FBI concerning the matter.

Mr. EDWARDS was not acquainted with either JACK RUBY or LEE HARVEY OSWALD and had no information that they were in any way associated with each other.

Investigation has previously established the individual referred to by DONALD C. STUART as having been in company of RUBY was CURTIS LA VERNE CRAFARD, not OSWALD.

AT GALVESTON, TEXAS:

On December 4, 1968, ALVIN HARRINGTON, salesman, Factory Outlet Shoe Store, advised SA CARLOS L. KIRBY, JR., that on November 25, 1963, an unknown white female appeared at the store and purchased a pair of shoes. While at the above store, this unknown female related she has a friend who has an acquaintance in New Orleans, Louisiana, who operates a rooming house, and this acquaintance at one time rented a room to LEE HARVEY OSWALD, but the landlady found some Communist literature in OSWALD's room and requested him to move.

The unknown female also reported that a station wagon picked up OSWALD at the rooming house in New Orleans, Louisiana, and the landlady obtained the license number from the station wagon, which license number reportedly was listed to JACK RUBY.

ALVIN HARRINGTON and other employees at the factory outlet store, Galveston, Texas, advised they have no idea as to the identity of the unknown female (customer) referred to above.

JESSE JAMES GARNER advised that he observed the station wagon with Texas license plate in which Mrs. OSWALD and the baby departed. He said this station wagon was cream colored and was driven by a lady who had two small children. He said that he did not obtain the license number but did observe that it was a Texas license plate. He advised that he has seen photographs of JACK RUBY in the newspapers and on television and that he has never seen him in New Orleans and that he knows of no connection between JACK RUBY and LEE HARVEY OSWALD.

Mr. GARNER stated that shortly before OSWALD was arrested by the New Orleans Police Department, probably the day before, Mrs. GARNER told him that OSWALD had two posters attached to the screen porch of his apartment at 4905 Magazine Street. This occurred sometime between 4:30 and 5:00 p.m. after GARNER got home from work. He said that he went over to the OSWALD apartment and observed the posters which read "Hands Off Cuba." He told OSWALD to remove the posters, and OSWALD asked him, "Who rejected?" GARNER replied that he objected and that if OSWALD did not remove the posters, he would have to move.

GARNER related that OSWALD immediately took the two posters down. Mr. GARNER said that he did not know of any other place of residence which OSWALD had in New Orleans, other than the apartment in which he lived at 4905 Magazine Street.

Mrs. JESSE JAMES GARNER advised that she did not know of any rooming house in which LEE HARVEY OSWALD resided, and his only place of residence known to her is the apartment which he resided at 4905 Magazine Street. This station wagon was driven by a lady and had a Texas license plate on it. She did not recall the license number. Mrs. GARNER stated that she had seen photographs of JACK RUBY on television and in the newspapers and that she never observed RUBY in New Orleans and that she knows of no connection or association between OSWALD and RUBY.

Miss MARILYN MURRET, 757 French Street, cousin of LEE HARVEY OSWALD, advised as follows:

OSWALD arrived at the home of her mother, 757 French 3 Street, where MARILYN lives, in the spring of 1963. OSWALD was the advised that he had come from Texas where his wife and child integral were staying at the home of a woman who speaks Russian. OSWALD stayed at the MURRET home for about a week until he had obtained 🚧 a job and rented an apartment on Magazine Street. She does not know the address of this apartment. It is the only place she knows of that OSWALD rented. She saw on television the landlady of this apartment who stated she asked her husband to request OSWALD to remove a poster or leaflet, which apparently was in praise of CASTRO or Cuba. This was apparently pasted or hung somewhere on the front of the apartment OSWALD had rented. As best she could recall this television interview, the landlady said her husband told OSWALD that if he did not remove the poster or leaflet that he would have to move. OSWALD removed it. Miss MURRET was not aware of any room OSWALD had rented or of any communist literature found in the room. She stated that if there is such a rumor it was probably confused with the above incident.

She does not know of any contacts between OSWALD and JACK RUBY. She had never heard RUBY's name mentioned prior to the murder of OSWALD by RUBY. The only station wagon she is aware of that has any connection with OSWALD is the station wagon which was driven by the lady from Texas, who brought OSWALD's wife and child to New Orleans. She did not see this station wagon herself, although she was at home when the woman arrived with OSWALD's wife and child. Her mother told her they had arrived in a station wagon. MARILYN was in the house getting ready to go out and this woman came into the house for a few minutes, and she was introduced to her but she did not recall her name. She assumes it was the Mrs. PAYNE who was reported in the newspaper as being the woman at whose house OSWALD's wife and child had stayed.

Mrs. CHARLES F. MURRET, 757 French Street, furnished the following information:

She knows nothing concerning her mephow, LEE HARVEY OSWALD, ever living in any rooming house. She knows mothing about any landlady finding communist literature in his room and requesting him to move. She stated she had seen on television the landlady of the Magazine Street apartment where LEE and his family had lived while in New Orleans in the spring and summer of 1963, and the landlady said she had asked LEE to remove a pro-Castro sign from the front of his apartment which LEE did. Mrs. MURRET saw no communist literature in LEE's possession while he stayed at her house for about a week after he arrived in New Orleans in late April or early May, 1963, prior to moving to the apartment. She knows of no other place where he lived in New Orleans after his arrival in the spring.

She knows of no connection between LEE OSWALD and JACK RUBY. She does not know and had never heard of JACK RUBY prior to RUBY shooting LEE. The only station wagon she saw in connection with LEE OSWALD was the station wagon which a lady was driving who brought LEE's wife, MARINA, and child, to the MURRET home to meet LEE and who then drove LEE and his family to the Magazine Street apartment that LEE had rented. LEE told Mrs. MURRET the woman was the woman with whom his wife had been staying in Texas. Mrs. MURRET may have been told the woman's name but does not recall. She now assumes her name is Mrs. PAYNE, inasmuch as newspaper accounts have stated MARINA had been staying at Mrs. PAYNE's home in Texas.

MURRET knows of no other place where OSWALD stayed in New Orleans after his arrival in 1963. He knows nothing concerning any communist literature found in any room. He knows nothing of any landlady asking OSWALD to move.

He has no knowledge of any contacts between OSWALD and JACK RUBY. The first time he heard JACK RUBY's name was after RUBY shot OSWALD.

The only station wagon he knows of that haw any connection with OSWALD is the station wagon which brought OSWALD's wife and child from Texas about a week after OSWALD had arrived in New Orleans and a day or so after OSWALD had rented the Magazine Street apartment. He is a cousin of LEE HARVEY OSWALD. Sometime in the spring of 1963, OSWALD arrived at the home of his mother at 757. French Street, where MURRET was living at the time. OSWALD stayed at the house about a week and then rented an apartment on Magazine Street. The Magazine Street apartment was the only place he knows of where OSWALD lived after moving from MURRET's parents' house.

MURRET knows nothing concerning the finding of any communist literature in OSWALD's room and a landlady requesting him to move. MURRET say a television interview in which the landlady of the Magazine Street apartment stated that she had requested her husband to ask OSWALD to take down a sign of some sort that was on the screen door or window of the apartment OSWALD was renting. OSWALD did take down the sign.

MURRET knows of no connection between LER OSVALD and JACK RUBY. The first time he had beard JACK RUBY's name was in connection with RUBY's shooting of OSWALD. The only station wagon he knows of that has any connection with OSWALD is the station wagon which brought OSWALD's wife and child from Texas. MURRET was told by a member of his family that OSWALD's wife and child had been staying with this woman in Texas. The last time he saw OSWALD was on Labor Day, 1963, when he took OSWALD, his wife and child from the MURRET home on French Street to OSWALD's apartment on Magazine Street.

This meeting took place at a social gathering and Mrs. PAINE, who spoke Russian, became acquainted with MARINA OSWALD, who only spoke Russian and has no knowledge of the English language. According to Mrs. PAINE, in about April, 1963, Mr. and Mrs. LEE HARVEY OSWALD visited at her home where they had dinner together. It later came to Mrs. PAINE's attention that LEE HARVEY OSWALD had lost his job and had traveled to New Orleans, Louisiana, in early May of 1963, in order to seek employment.

Mrs. PAINE advised that on May 10, 1963, she drove MARINA OSWALD and MARINA's child to New Orleans, Louisiana, to join LEE OSWALD. At the time, LEE OSWALD had an apartment on Magazine Street in New Orleans.

Mrs. PAINE, who was very fond of Mrs. MARINA OSWALD, later became aware that OSWALD had lost his job in New Orleans, Louisiana, and that Mrs. OSWALD was in the late stages of pregnancy with their second child. Accordingly in September of 1963, Mrs. PAINE drove from Irving, Texas, to New Orleans, Louisiana, arriving at the apartment on Magazine Street in the late afternoon of September 20, 1963. She remained at the OSWALD apartment until the morning of September 23, 1963, when she and MARINA and the OSWALD baby departed New Orleans leaving LEE OSWALD there. Prior to leaving New Orleans, Mrs. PAINE went to a service station about a block and a half from the OSWALD residence, located for on the same side of the street, where she purchased a new ___ tire for her car, a 1955 green Chevrolet station wagon which then bore 1963 Texas license NK 4041. According to Mrs. PAINE, on leaving New Orleans they drove to a small 🕾 town in Texas where she and MARINA OSWALD spent the night of September 23, 1963, and on September 24, 1963, they arrived at Irving, Texas.

Mr. LYON noted that there was no National Bank of Commerce located in Washington, D. C., and that records of the Bank of Commerce, Washington, D. C., did not disclose the addressee to be an employee or that there was any banking relationship with addressee.

On December 31, 1963, Mr. ROBERT M. LYON, Vice President, Bank of Commerce, advised SA LOVE that in his opinion the notation "has account in your bank" on the bottom of the envelope was written by RUBY because it was in similar handwriting as that contained in the envelope on the letter is signed by RUBY. He theorized that the above notation was placed on the envelope because the donation to RUBY was in the form of a check drawn on a National Bank of Commerce and RUBY presumably did not have the contributor's address.

He addressed the envelope forwarding this checked to "Mr. TOM HOVARD, Attorney for JACK RUBY, Dallas, Texas."

CHASH advised that he had enclosed a note to RUBY 🖘 🥍 🎠 which to the best of his recollection was as follows:

> "Enclosed please find my check for \$10 -which I hope will be multiplied by thousands more in order to help your defense. Hope you will be acquitted. Put your trust in God and your lawyer because I do.

"R. B. CHASN

CHASN stated that the above check had not been returned on his last bank statement and presumably has not yet been cashed by RUBY. He has not received any reply from RUBY or his defense attorney acknowledging receipt of this check.

CHASE explained that he was not personally acquainted with RUBY or LEE HARVEY OSWALD having never heard of these individuals prior to the events which took place following the President's assassination. CHASH has never visited Dallas, Texas, and has resided in the Washington, D. C., area for the past 15 years.

He explained the following circumstances as being responsible for his sending this contribution to RUBY:

WPO 44-520 passed away. .: He attributed her death in part to her grief over the President's assassination. CHASH and his wife were also grief stricken by these events.

In subsequent conversations many of his relatives and acquaintances in discussing these events appeared to attach more guilt to RUBY than to OSWALD. In addition, he noted in the papers that many people were forwarding donations to the widow of the policeman shot by OSWALD as well as to OSWALD's widow. No one appeared to be in sympathy with RUBY and on the contrary it appeared that many people were overlooking the fact that OSWALD was the person responsible for this terrible crime.

He feels that RUBY was emotionally upset at the time he shot OSWALD and did not commit this act for any personal gain or recognition.

Another factor was a press statement made by the prosecuting attorney in Dallas, Texas, to the effect that he had previously secured death penalty convictions and would also secure the death penalty convictions and would also secure the death penalty for RUBY apparently withwould also secure the unusual circumstances.

KENNEDY, because of "humane actions of the President in the past". The personnel file on Sergeant DEWEY indicates that he has never been court-martialed and has had no other difficulties

He was recently given a psychiatric evaluation and treatment examination and the diagnostic impression was that he has a passive aggresive personality with alcoholism, moderate, chronic.

The following description was obtained from the personnel file regarding Sergeant DEWEY:

FIENSTEIN stated that upon hearing the news about the assassination of the late President KENNEDY, he was enraged and emotionally upset, stating that he felt as though a member of his own
family had been assassinated. Upon receiving the
news that LEE HARVEY OSWALD had been shot and killed
by JACK RUBY, he felt that RUBY had performed
an act that he himself would have done had he an act that he himself would have done had he had the opportunity. He further stated that he himself is a law abiding citizen not prone to be violent, however, he could not condemn RUBY for killing OSWALD, and felt that RUBY had done a service to his country by killing OSWALD. After learning that RUBY. had killed OSWALD, he sent a telegram to RUBY in care of the Dallas Police, as he felt he would like RUBY to know that he had performed an act that met with full approval of all law abiding citizens.

FIENSTEIN said that he had never heard of RUBY prior to above shooting nor would he have any way of knowing if there had been any conspiracy between RUBY and OSWALD concerning the assassination.

In conclusion, FIENSTEIN said that from the newspaper accounts, he was aware that the Pederal Bureau of Investigation was attempting to determine if there was any connection or conspiracy between OSWALD and RUBY, and in the event this is determined, he was definitely opposed to what RUBY had done, and further hoped that RUBY was punished to the fullest extent of the law.

Shortly after JACK RUBY shot LEE OSWALD, she sent a telegram to JACK RUBY, Dallas, Texas, congratulating him. She did this because she was deeply shaken by the assassination of President KENNEDY and because of her enthusiasm over the shooting of OSWALD and her sympathy for JACK RUBY. She said that she sent the telegram on her own initiative, although she felt that her husband would have wanted her to do so-having heard through her sister-in-law, VIOLA KRIKR, whose address she believes to be 1222 West Mitchell Street, Milwaukee, that PRANK HOLT had telephoned from parts unknown expressing his approval of RUBY's action.

Mrs. HOLT said that she was not acquainted with RUBY nor with OSWALD nor did she have any information about either except through public sources. She said she did not know whether they were previously acquainted. She also said that to the best of her knowledge her husband didn't know either RUBY or OSWALD.

Mrs. HOLT said that her husband was absent from home at the time the telegram was sent and is again absent from home-his whereabouts being unknown to Mrs. HOLT. She said that he was home for a very short time about two weeks ago but left again. She attributed his absence to his being part Indian, stating that she felt he inherited a tendency to roam and not to stay in one place. She said that she had been married to FRANK HOLT for ten years and during that time he had frequently left home. Mrs. HOLT said that her husband had difficulty in keeping a job because of an arrest record and she said she thought this was one of the causes of his leaving home periodically.

Mrs. HOLT said that she was born in the Netherlands and entered the United States in 1920. She said that she was a U. S. citizen and was currently working as a cook although she has also worked as a nurse. She said that she was loyal to the United States and as an admirer of President KENNEDY had been terribly shocked by his assassination.

On January 3, 1964, BRUCE MC LEAN, owner, McLean Hair Treatment Parlor, 1323 Dallas Health Club Building, 1805 Elm Street, who has been previously interviewed, advised as follows:

MC LEAN stated that JACK RUBY has been a regular 🕫 🕾 🕾 customer at his place of business for some time but added that he has already furnished information concerning his acquaintance of RUBY to the FBI on a former occasion. MC LEAN stated that severe neither he nor any of his employees, to his knowledge, sent Address RUBY a congratulatory telegram or any other type communication following RUBY's incarceration. He explained that his employees are all female and, consequently; could not be referred to as ... "the boys" but stated, in his opinion, this may have been done were as a joke on someone's part, knowing that RUBY was a regular customer of MCLEAN's establishment and knowing that the employees are all women.

MC LEAN further stated that he knows of no other establishment in Dallas such as McLean's Bar, Grill, Lunch, Cafe, Restaurant, etc.

PAUL RALPH NEW, who stated he was born January 10, 1940 at Quincy, Massachusetts, and who stated he is an entertainer, describing himself as a vocalist, comedian and musician, currently residing at The Cairo Hotel, 1615 Q Street, North West, Washington, D. C., and performing at the Crescent Restaurant, 1338 New York Avenue, North West, Washington, D. C., advised he travels in connection with his work, but can always be contacted through the Associated Booking Corporation, 203 North Wabash Avenue, Chicago, Illinois or through his father, JOSEPH J. MEW, who is the general manager the first with a state of the El Mirador Hotel, Sacramento, California.

NEW stated he met JACK RUBY in Dallas, Texas, in the 🔧 🙈 latter part of Jupé 1963. He explained he and his group, which is known as PAUL NEW and the Crew, performed at the Cabana Motor Hotel, Dallas, Texas, during June 1963. ROBERT CALLAHAN, who is well known in the entertainment field in Dallas, took NEW to the Vegas Club. At the door, a CALLAHAN introduced a woman to NEW and as NEW now recalls, it was RUBY's sister, name not remembered. While at the Vegas Club, NEW saw the above unknown male who had been with RUBY. This male appeared to be an employee of the Vegas Club, probably the bouncer, and as NEW recalls, he asked CALLAHAN his identity. He believes CALLAHAN told him this male was an ex-boxer.

About November 27, 1963, NEW stated he wrote a letter to RUBY in care of the Dallas Jail. He believes he was in Benton Harbor, Michigan, at the time. He told RUBY he was writing a song, a tribute to President KENNEDY, and wanted to know RUBY's sentiments at the time he killed LEE HARVEY OSWALD. NEW felt this information might assist him in writing the song. NEW advised RUBY has not replied to the letter.

NEW stated the foregoing constitutes his contacts and knowledge of RUBY in their entirety. He stated RUBY never offered him work, although when RUBY approached him as above, he got the initial impression that RUBY was a booking agent. NEW stated he never met LEE HARVEY OSWALD and has no knowledge of him. He stated he does not know whether RUBY ever met OSWALD, whether RUBY had any knowledge of OSWALD; and does not know whether there is any connection between RUBY and OSWALD.
