SIDNEY MARKS was recontacted at the Cowan Shoe Store 16 East 34th Street, Manhattan, New York, by SAS TIMOTHY B. LAGRONE and ROBERT J. LAWSON and he furnished the following information:

He had given considerable thought to the possibility that a JACK RUBENSTEIN or a JACK RUBY had been at Camp Unity, Kingston, New York, in 1947, at the time MARKS was at this camp. The only individual he could recall who might be JACK RUBENSTEIN was an obnoxious person who became friendly with MARK's wife, THELMA MARKS. He described this individual as a "con artist type", who came from New York City. At the time, MARKS had just married THELMA, but this did not seen to make any difference to this individual and MARKS found it necessary to "straighten out this individual" and point out that MARKS did not appreciate his attentions to Mrs. MARKS.

MARKS was not able to furnish a description of the above individual, but his recollection was that he did not resemble photographs of RUBY which MARKS had observed.

The following investigation was conducted by SA GLENN E. SILVEY:

At Oklahoma City, Oklahoma

On January 3, 1964, ANNABELLE PHELAN, 709 NE 12th Street, who is the Information and Discharge Clerk, Children's Hospital, Oklahoma City, Oklahoma, advised that on or about December 1, 1963, she and DOROTHY JONES, a nurse at Children's Hospital, were discussing various remarks made by parents and visitors of the patients in the hospital concerning the assassination of President KENNEDY and the subsequent killing of OSWALD. She advised during the conversation Miss JONES stated that JENELI HUBBARD, Chief Norse at the hospital, had informed her that everyone in Dallas knew JACK RUBY was a Communist. This information allegedly came from a nurse attending a nurses' workshop in Fort Worth, Texas, at the time of the assassing This nurse was allegedly married to a musician who formerly place.

PHELAN advised there was no further discussion of this remark and she could not identify the source of this allegation about RUBY's Communistic tendencies.

On January 4, 1964, Mrs. DONALD C. (JENELL) HUBBARD, 1600 Anderson Road, Head Nurse, Children's Hospital, advised she was in attendance at a workshop sponsored by the Texas League of Nursing at Fort Worth, Texas, during the latter part of November, 1963. She stated on the day RUBY shot OSWALD she and several of the other nurses at the workshop were discussing this incident at which time Mrs. ANN MARIF CARLSON, 2622 Madera Street, Dallas, Texas, who is employed as a nurse at the Timberlawn Sanatorium in Dallas, made the remark that her husband had formerly played in the band at JACK RUBY's club and had left this job because everyone knew JACK RUBY was "a real kook and a Communist."

Mrs. HUBBARD could furnish no additional information concerning RUBY or CARLSON and advised there was no additional discussion about the above-mentioned statement. She stated there were several other individuals in the room at the time however she could not identify these persons.

Mr. PAUL H SMILEY, 2323 40th Place, N.W., Washington, D.C., advised that he is presently retired from Government service, having formerly been an inspector-investigator for the Veterans' Administration (VA). He was with the VA from 1921 to 1950, at which time he retired and accepted other Government employment as an inspector for a congressional veterans' committee headed by Texas Congressman OLIN TEAGUE. He held this position from 1956 to late 1960, at which time he retired from Government service.

SMILEY said that based upon his lengthy investigative experience he had decided to write the Director of the FBI and express his observations concerning the murder of LEE HARVEY OSWALD by JACK LEON RUBY. He is firmly convinced that RUBY could not have gained access to the Dallas jail without proper identification, possibly police identification. He recalled a past experience where police identification had been used for an illegal purpose.

Specifically, he related that during the 1920's he had made a trip to New York City on official business for the VA. While in New York he attended a social affair sponsored by an individual, name not recalled, who owned a retread tire shop located on Lexington Avenue in New York City. Present at this affair were a number of VA officials and New York City officials, including a Captain and a Lieutenant from the New York police precinct in that area. The owner of the tire shop had a connection with the VA due to the fact that he trained disabled veterans in his shop at Government expense. During this affair large quantities of liquor were served illegally and a lewd and obscene show took place.

SMILEY stated that following the party he asked the tire company owner how he could get away with such illegal activities in the presence of New York City police officials. This individual replied that with proper connections you could do anything. By way of proof he exhibited a gold or goldplated Washington, D.C., Metropolitan Police Department badge, explaining that with this badge he could gain access to the White House anytime he so desired.

SMILEY stated that he was relating this incident on the possibility that RUBY may have gained access to the Dallas jail by means of a police badge and that this entire affair may have been prearranged by RUBY and the Dallas police.

SMILEY stated that another matter of great concern to him was the indiscriminate use of medical testimony in the courts. He feels that anyone with sufficient financial backing can purchase such medical testimony for their legal defense and considers this a sad commentary on justice.

He advised that while investigator for the VA he had occasion to visit Dallas, Texas, on a number of occasions, however, denied that he had ever known or been personally acquainted with JACK RUBY or LEE HARVEY OSWALD. Both of these individuals first came to his attention through television and press media following the President's assassination. He has no personal knowledge of any association between RUBY and OSWALD and, in fact, has no information concerning this matter other than what he has read in the local press or seen on television.

SMILEY explained that he had read an interesting article in the local press which had raised a number of questions similar to that which he had previously discussed, and this had prompted him to write to the Director because he feels it is highly important that all of the facts be brought out in this case. He feels that investigation should determine whether Dallas police officials were involved in OSWALD's murder, and, if so, that they be prosecuted to the fullest extent of the law.

SMILEY stated that should be obtain any factual information relating to this case, he would immediately bring it to the attention of the FBI.

DAVIS has a client, one GENE SHRIBER, San
Francisco, California, residence address not recalled,
that has personal knowledge concerning JACK RUBY and JACK
RUBY's sister, EVA. According to DAVIS, RUBY was employed
by SHRIBER as a card dealer in San Francisco, California,
sometime in the early 1940's. It is DAVIS's recollection
from conversations with SHRIBER that RUBY was in San
Francisco sometime after the war in 1946, 1947 or 1948,
however, he is not certain of the exact period he was
in San Francisco. In addition, SHRIBER related to
DAVIS that he had known JACK RUBY in Chicago prior to
the time RUBY was in San Francisco at which time RUBY was
employed as a bouncer in some club in Chicago.

DAVIS further identified GENE SHRIBER as an individual with previous underworld connections and as a former partner of BONES REMER (phonetic), Reno, Nevada and Lake Tahoe area gambler with operations in San Francisco.

DAVIS advised he has no personal knowledge of JACK RUBY but believed that SHRIBER could furnish pertinent information concerning JACK RUBY. It was DAVIS's understanding also that RUBY's sister, EVA GRANT also known as EVA RUBENSTEIN, had also been employed by SHRIBER in San Francisco as a card dealer. JACK RUBY had been described to DAVIS as a "boodlum" who was "quick with a gun".

DAVIS continued that he is well acquainted with MELVIN BELLI, RUBY's Attorney and he was concerned that BELLI's handling of the RUBY trial might result in RUBY being acquitted and it is his belief that a RUBY acquittal would have implications which might effect the administration of justice in the entire nation. He did not elaborate on this statement but indicated he contemplated contacting District Attorney HENRY WADE in Dallas to offer his assistance in the prosecution of RUBY. DAVIS stated he (DAVIS) has had extensive experience in cases involving defendants with psychiatric problems and he had a number of briefs which he felt might be of assistance to the prosecuting attorney.

DAVIS stated he would return to San Francisco on the might of January 23, 1964, and that he would endeavor to arrange an interview for a representative of the FBI with his client, GENE SHRIBER.

The individual described as GENE SHRIVER by GEORGE T. DAVIS is GENE L. SCHRIBER, 3050 Mineteenth Avenue, San Francisco, California, a former associate of "BONES" REMMER, deceased, San Francisco and Lake Tahoe, California, gambler. SCHRIBER was resident of Chicago during a portion of the time RUBY was a resident of that city. SCHRIBER operated a card room in San Francisco with REMMER during the period RUBY resided in San Francisco. SCHRIBER is acquainted with the gambling element in many areas of the United States, including Dallas.

SCHRIBER has been contacted frequently during the past several months in connection with an Unlawful Flight to Avoid Prosecution matter in which his son, known as EUGENE SCHREIBER, is the subject,

On January 24, 1964, SCHRIBER reiterated a previous statement to SA WILLIAM N. KIDWELL, JR., to the effect that he does not know JACK RUBY or his sister, EVA, has never seen them in Chicago or San Francisco and has never employed these people. He has never seen photographs of JACK and EVA and has discussed the case with acquaintances in San Francisco. He has never told anyone he knows them or employed them.

SCHRIBER advised that some years ago GEORGE T. DAVIS did some legal work for him. He has not had any dealings with DAVIS since that time.

Mrs. W. B. SIMONS, 2701 Washington Boulevard, 2 Venice, California, advised she is the former wife of JAMES WOODWARD, whose location is unknown to her. She said she has not seen her former husband in about four years. She last heard about one year ago that JAMES was in the San Antonio, Texas, area. This latter information was furnished to Mrs. SIMONS by her sister, WINIFRED STEWART, 1437 Santa Barbara Avenue, San Antonio WINIFRED's former husband is CLAUDE L. STEWART, JR., who is employed at the Southern Pacific Credit Union, San Antonio. She stated that only if JAMES was in the San Antonio area would CLAUDE, or WINIFRED, possibly know of his location as he does not correspond with, or contact, any of his present or former family members.

Mrs. SIMONS stated that she and her former husband, JAMES, were at Islamorada, Florida, for approximately two months during the summer of 1958. She was introduced by JAMES to a JACK (last name unknown) and ISABELLE (last name unknown), best described only as friends of JAMES. She said she did not recall specifically where she was introduced to JACK and ISABELLE, or where they were residing at Islamorada. She said she did not recall any information while at Islamorada from JAMES or anyone else, concerning any guns, connection with Cubans, or that JACK (last name unknown) owned a bar in Dallas, Texas. She could only recall that JACK originally reportedly came from Chicago, Illinois.

Mrs. SIMONS was exhibited photographs of JACK L. RUBY and she could not identify JACK as being identical to JACK (last name unknown) met at Islamorada. She described JACK (last name unknown) as white, male, American, 45 in 1958, 6' 3", 185 to 190 pounds, medium build, black hair, black mustache. She described ISABELLE as a white female, in her early 40's in 1958, 5' 7", 160 pounds, heavy build, dark hair, turning grey.

Mrs. SIMONS said she had no indication or information she has ever met JACK RUBY. Concerning the possibility of her husband contacting her, she added she did not expect this to occur inasmuch as she caused a local warrant to be issued for JAMES in 1961 at Santa Monica, California, charging him with

KENNETH R. ISHMAEL, Manager, Casa Siesta Motel, 4449 South Broadway, advised that he had no recollection of JACK L. RUBY ever being a guest at his motel. He made a search of his records from January 1, 1963, to the present, and advised he could beate no one registered there by the name of RUBY.

A review of records of the Casa Siesta Motel did reflect that GAIL RAVEN was a guest of the motel from January 27, 1963, through February 13, 1963, at which time she occupied Room Number 10. ISHMAEL advised he recalled this person, but could recall nothing to indicate that RUBY or anyone else had visited RAVEN while she occupied this room.

ISHMAEL further advised that no record of local Wichita calls is made by the motel and, therefore, there is no way of knowing if anyone at the motel made a telephone call from the motel to the T-Bone Club, Wichita, Kansas, in January, 1963.

ISHMAEL stated it was almost certain that RAVEN had made local calls from the motel to the T-Bone while she was a guest there, since that was the club where she was employed, and it is the normal practice for her to make telephone calls there when she is working in Wichita and staying at the Casa Siesta Motel.

Telephone number JA 4-9269 is a public telephone located in the T-Bone Club, and is available for the use of all patrons of the club. Since this is a public telephone, there is no way of knowing who uses this telephone.

JONKER advised that he has no recollection of JACK L. RUBY ever using a telephone while RUBY was in his club. He stated it was very possible that RUBY, the stippers, MC's or other entertainers may have used this telephone while in the club. He added, however, that if one of these persons had received a call on this telephone the caller would have to know the telephone number as this number is not the one listed for the T-Bone Supper Club.

JONKER made a BEEFOD of his records and advised that during the period from October 28, 1963 to November Krinsas 11, 1963, comic BILLAUE MAR and stripper PROSTIE/CONNERS were appearing at the club. He stated he had booked CONNERS through the Wayne Kaller Thantrical Agency, St. Louis, Missouri, and it was his recollection that DE MAR went to RUBY'S Carousel Club in Dallas following his appearance at the T-Bone. ALICE REAVES NICHOLS, 8797 Redondo Drive, Dallas, Texas, telephone DA 1-3687, telephonically advised that on Monday evening, January 13, 1964, a Mr. DENSON, who identified himself as a private investigator employed by the defense attorneys for JACK L. RUBY, came to see her and talked to her for about one and one-half hours. This was in relation to her knowledge of JACK L. RUBY and particularly to any knowledge she had of the whereabouts of RUBY on November 22, 1963. She advised that she told Mr. DENSON what she knew and after he had gone that evening and during the next two or three days she recalled the interview she had had with SAS ALBERT SAYERS and PAUL L. SCOTT on November 25, 1963. She said she believed she had not told SAS SAYERS and SCOTT about a telephonic contact she had had with JACK L. RUBY on November 22, 1963.

She furnished the following information with regard to that telephonic contact:

She had been working at her regular job on that date and had gone out to lunch between 1:00 and 2:00 PM. She returned from lunch at about 2:00 PM and was advised that she had received a telephone call from JACK RUBY while she was out. He had left a telephone number for her to call. At about 2:10 PM she telephoned the number and the man answering sounded to her like a Negro. She said for this reason she believes the number was probably at the Carousel Club; however, she does not know this to be a fact. The man who answered the telephone told her that RUBY was on another telephone at the time, and she left her number at the office, ... RIverside 1-1321, and asked the man to have RUBY call her.

At about 2:15 PM she received a telephone call from JACK RUBY. This call lasted for only about one minute and RUBY was apparently calling to tell her what a terrible thing he thought it was that President KENNEDY had been assassinated.

RUBY again called her on November 22, 1963, at about 7:30 PM at her home. This was also a very short conversation, and he mentioned to her that he was going to the Synagogue. He also told her that his clubs were closed. She does not know from where RUBY was calling. This is the last contact of any kind she has had with JACK L. RUBY.

She advised that she had received a subpoena which was issued by the defense to appear in court at Dallas on Monday, January 20, 1964.

She advised that the only other contact she has had other than the interview with SA SAYERS and SA SCOTT and the conversation with Mr. DENSON in connection with the JACK RUBY case has been a telephone call from SA LEO L. ROBERTSON of the FBI at Dallas and a telephone call on December 31, 1963, from a newsman of the Associated Press. She did not know that man's name and declined to discuss anything with him. She said when SA ROBERTSON called he asked her if the names of several people were known to her or familiar to her. She recalls that she did not know any of the people whom he named.

ANDREW ARMSTRONG, JR., Assistant Manager, Big D Copa Club, formerly known as the Carousel Club, 1312-1/2 Commerce Street, Dallas, Texas, furnished the following information with regard to the time period from about 11:53 AM until about 4:00 PM or 4:30 PM, November 22, 1963:

He got on the bus near his home at about 11:53 AM and traveled the regular bus route to the bus stop at Main and Akard Street, Downtown Dallas, at about 12:25 PM. At the time he got off the bus he noticed that the Presidential Motorcade, or a large crowd of people watching the Motorcade, were at Main and Lamar Streets, a few blocks west of where he got off the bus. Upon alighting from the bus, he walked to the Carousel Club, which took him approximately four or five minutes. He estimates he arrived at the Carousel Club at about 12:30 PM.

Upon arrival at the club, he went to a room in the rear of the club and took off his jacket and then went to the men's room. While in the men's room, he heard sirens and it sounded to him as though there were many more than just one or two sirens. He became curious about this and consequently left the men's room and went to another room where he keeps his portable radio. He tuned it to Station KLIF, Dallas, and announcements were being made over the radio that someone had fired at the Presidential Motorcade. He then immediately ran to a room in the club, where CURTIS LAVERNEY CRAFARD, commonly known as LARRY, was sleeping, and awakened him. He told LARRY that someone had just shot at the President. LARRY, being a vary hard sleeper, did not awaken completely at that time and did not get up.

He, ARMSTRONG, then listened to the radio for two or three more minutes and heard several apparently confused announcements on the radio and heard that the car carrying President KENNEDY was on its way to Parkland Hospital. He then returned to the room where CRAFARD was sleeping and awakened him. CRAFARD got up and got dressed. While he was doing this, they both listened to Radio Station KLIF on ARMSTRONG's portable radio.

Approximately five to fifteen minutes after LARRY got up, JACK L. RUBY telephoned him, ARMSTRONG, at the Carousel Club. He

believes that RUBY was calling from the Dallas Morning News Building inasmuch as he heard typewriters in the background and also knew that it was RUBY's habit on Friday morning to go to the newspaper building for the purpose of composing his newspaper ads for his clubs for the week-end. RUBY talked to him for three or four minutes, and he surmised that RUBY was calling to tell him that the President had been shot; however, RUBY apparently heard his radio playing in the background and said, "Oh, you have already heard?" and he told RUBY that he had. RUBY at that time told him, "If anything happens, we are going to close the club." RUBY then told him that he would see him after a short while. ARMSTRONG recalls that RUBY forgot to ask him if he had fed the dogs, which he keeps at the club inasmuch as it was RUBY's regular habit almost every time he called ARMSTRONG to ask him if the dogs have been fed.

He, ARMSTRONG, kept the radio tuned to Station KLIF, Dallas, for the remainder of that afternoon. At approximately 1:30 PM, he heard the official announcement when it was first made that President KENNEDY was dead.

Prior to the announcement of President KENNEDY's death, he had heard several announcements on the radio station to the effect that an officer of the Dallas Police Department had been shot. He does not recall hearing the name of the police officer during these announcements and believes, to the best of his recollection, that the officer had not been identified by name at the time these announcements were made.

About fifteen or twenty minutes after hearing the first official announcement of the death of President KENNEDY, JACK L. RUBY arrived at the Carousel Club. He, ARMSTRONG, believes this was at approximately 1:45 or 1:50 PM. RUBY appeared to be distraught and mumbled something about "What a terrible thing." RUBY's first coherent statement after his arrival at the club was that the club was closed and would be closed for the next three days.

RUBY immediately went to a telephone which has telephone number RI 7-2362 and started making telephone calls. He had completed one or two telephone calls within a matter of less than five minutes when they both overheard an announcement on Radio Station KLIF to the effect that Officer TIPPIT of the Dallas Police

Department had been shot and killed. RUBY mentioned to him, ARMSTRONG, at that time that he knew Officer TIPPIT. ARMSTRONG said he believes that this may have been the first announcement on Station KLIF which identified by name the officer who had been shot. (It has been established through records of the Dallas Police Department that Officer J. D. TIPPIT was shot and killed at approximately 1:18 PM, November 22, 1963.)

JACK L. RUBY remained at the Carousel Club until approximately 4:00 PM. ARMSTRONG said he could not be accurate about that time but this is the best estimate he could give as to when RUBY left the Carousel Club. During the time RUBY was there, he gave ARMSTRONG instructions to contact all of the Carousel Club employees and tell them that the club would be closed Friday night, Saturday night and Sunday night. He, ARMSTRONG, started making these telephone calls at about 2:30 PM. One of the persons he called was "LITTLE LYNN", who resides in Fort Worth, Texas.

RUBY was on the telephone almost all of the time he was in the club and made several long-distance telephone calls, as well as numerous local telephone calls. RUBY was crying nearly all of this time. He, ARMSTRONG, knows, through hearing names mentioned and cities mentioned by RUBY while making these telephone calls, that long-distance calls were made that day to Arlington, Texas, where RUBY talked to RALPH PAUL, and to Detroit, Michigan; Chicago, Illinois, and Los Angeles, California. The only local telephone calls that he, ARMSTRONG, can identify were calls made to EVA L. GRANT and Dr. COLEMAN JACOBSON.

He, ARMSTRONG, has no personal knowledge of any activities, travels or whereabouts of JACK L. RUBY between the time RUBY called him from the Dallas Morning News Building and the time RUBY arrived at the Carousel Club. RUBY did not discuss that time period with him, and he has no way of knowing of RUBY's activities at that time. RUBY has never mentioned to him any intention of going to Parkland Hospital, Dallas, or of having gone there at any time.

ARMSTRONG advised that he recalls that sometime between 2:00 PM and 3:00 PM he answered the telephone at the Carousel Club and a woman asked to speak to Mr. RUBY. He recalls telling this woman that Mr. RUBY was at that time talking on another telephone and the woman asked him to have Mr. RUBY return her call as soon as possible. This woman gave him a telephone number, and he believes he recalls the name ALICE being mentioned by the woman as her name. He knows that this woman was not among his own

acquaintances although he has heard of a woman by the name of ALICE NICHOLS who was a former girl friend of JACK L. RUBY.

ARMSTRONG said with regard to the foregoing information that due to the passage of time since the events set out above and the general state of confusion at the time these events were occurring, he could not be certain to the minute with regard to the times of day set out above. He stated, however, that after reflection, and after going over these stated times of day, he believes they are accurate to within a few minutes, to the best of his recollection.

ARMSTRONG related that he does not recall any woman visiting JACK L. RUBY at the Carousel Club during the afternoon of November 22, 1963, and he does not recall RUBY having gone to his office or having been in his office at the club during that afternoon. He said that RUBY usually does most of his paper work at a table near the front door of the club where the telephone is located. He said there is another telephone in the club which is a pay station and which has telephone number RIverside 1-0289. He said he does not recall JACK L. RUBY using the pay station telephone at any time that day.

RALPH PAUL, operator of the Bull-Pen Drive-In, Arlington, Texas, and previously identified as an associate of JACK RUBY was interviewed at the Big D Copa, previously known as the Carousel Club, 13122 Commerce. Mr. PAUL stated he had assumed management of the club recently in order to attempt to protect his "investment" which he said consisted of loans to RUBY. He said the name had been changed to Big D Copa since Dallas newspapers had declined to accept any further advertisement under the name of Carousel Club. He volunteered one of his biggest problems has been to attempt to find who owns "the corporation". He said he attempted through RUBY's attorneys and otherwise unsuccessfully to get a clear picture of the "corporation". He stated he is now sorry he took over the management and did not merely "let it die". He said business is very poor and that he is too old to run two businesses.

PAUL was asked if he could recall specifically the time of day he first heard from RUBY on Movember 22, 1963, the day of President KENNEDY's assassination. He readily stated RUBY called him about 12:45 PM by telephone, the gist of the conversation being to determine whether PAUL had heard of the shooting of the President. He said this call was received prior to the subsequent announcement of the President's death. He said he did not hear further from RUBY until late afternoon or early evening. He said he did not know from what telephone RUBY called him at 12:45 PM.

The following investigation was conducted by SA PAUL L. SCOTT at Dallas, Texas, to determine whether or not JACK RUBY was observed at Parkland Memorial Hospital, Dallas, on November 22, 1963:

.Te195 Mr. C. J. PRICE, Administrator, Parkland Memorial Hospital, Dallas, advised on January 17, 1964, that he was on duty at Parkland Memorial Hospital on the afternoon of November 22, 1963, when President KENNEDY and Governor CONNALLY were brought to the hospital. Within a few minutes after their arrival, there was considerable confusion at the hospital due to the arrival of newsmen and photographers. It was necessary to dismiss classes for student nurses in order to make space available for the newsmen and this added to the commotion in the hallways as many of the student nurses remained in the building. Mr. PRICE was in the area assigned as temporary press room on several occasions during the afternoon but does not recall observing anyone resembling JACK RUBY in this portion of the hospital. He does not believe he would have noticed him had he been there because of the confusion and because of the large number of newsmen in the area. It is PRICE's recollection that the Dallas Police Department had blocked entry to the hospital of all persons other than hospital personnel and news representatives; however, it is possible that some persons gained access to the main entrance and out-patient entrance to the hospital prior to the time the police blocked entry at approximately 1:00 PM.

PRICE advised that subsequent to the admission of LEE HARVEY OSWALD at the hospital on November 24, 1963, he had obtained a written statement from all hospital personnel who were in any way connected with the treatment of President KENNEDY, Governor CONNALLY and LEE HARVEY OSWALD. He had requested the personnel to include in their statement their impressions as to everything that transpired in connection with these incidents. At the time these statements were obtained JACK RUBY had been well publicized in newspapers and on television and PRICE feels certain that had any hospital personnel observed RUBY at Parkland Memorial Hospital at any time subsequent to the assassination of President KENNEDY they would have called this to his attention in their written statement.

PRICE advised Assistant Administrator STEVE LANDRIGAN handled liaison with the White House press group and local newsmen and was in the area of the temporary press room most of the afternoon of November 22, 1963.

On January 17, 1964, STEVE LANDRIGAN, Assistant Administrator, Parkland Memorial Hospital, Dallas, 7/463 advised he had arranged space for newsmen in classroom 101 on the South side of the hospital on Movember 22, 1963, and that he was in the vicinity of the personnel entrance to the hospital on the East side a good portion of the time from 1:00 PM to 2:00 PM on November 22, 1963. During this time, LANDRIGAN did not observe anyone appearing similar to JACK RUBY near this entrance which was the only entrance used by newsmen; however, due to the commotion in the area and the number of strange people, LANDRIGAN does not believe he would have noticed RUBY had he been in the hospital.

LANDRIGAN furnished the names of the following personnel who were in a position to have observed any people in this portion of the hospital on the afternoon of Movember 22, 1963:

BARBARA, HALLFORD

JUDY X HITCHELL

CAROL/REDDICK

On January 17, 1964, MITCHELL and REDDICK were shown photographs of JACK RUBY and they advised they could not say whether or not he was in the Parkland Memorial Hospital or in the vicinity of the hospital on the afternoon of Movember 22, 1963.

On January 17, 1964, BARBARA HALLFORD, formerly employed at Parkland Nemorial Hospital, 5315 Maple Springs, Dallas, telephonically advised she had observed photographs of JACK RUBY and she was unable to state whether or not he was in the Parkland Nemorial Hospital.

RUBY furnished in detail an account of his activities on November 22, 1963, the day of the assassination of President KENNEDY. He accounted substantially for his time during the entire day. He said nothing about having been to Parkland Memorial Hospital on this date. RUBY declined to furnish an account of his activities on November 23, 1963, and November 24, 1963, stating such declination was on advice of his counsel, Mr. HOWARD. RUBY volunteered on this occasion to make himself available for polygraph examination. When the officers told RUBY they would accept his offer he then "hedged" stating he would have to have permission from his attorney. Mr. HOWARD was located and returned to the Interview Room at the County Jail. HOWARD said he was personally for the polygraph examination but that other attorneys were entering the case and that he would have to consult with them. He said he would make known to the officers the decision on December 2, 1963. He did not, however, contact the officers on that date and when contacted postponed a decision relative to the polygraph. On December 3, 1963, the officers returned to the County Jail and were advised by RUBY that he would decline to submit to polygraph examination on advice of counsel. No further efforts were made by the Police Department in this regard.

Lieutenant REVILL stated no information has come to his attention as a result of police investigation or otherwise that RUBY was at Parkland Hospital at any time on November 22, 1963.

On Movember 24, 1963, Mr. EVANS was residing in Apartment 204, Marsala Apartments, 223 South Ewing Street, Dallas, Texas. On the morning of November 24, 1963, approximately 10:00 AM, EVANS recalls seeing JACK RUBY whom he knew by sight walking from the wash-a-teria area of the apartments toward RUBY's apartment. Mr. EVANS was asked if he were certain if it was 10:00 AM in the morning and he indicated that he could not positively state the exact time but felt that it was in the vicinity of 10:00 AM give or take 5 or 10 minutes.

EVANS did not know RUBY personally and knew him only by sight having seen him around the Marsala Apartments. EVANS knows nothing concerning RUBY's personal life or political beliefs. EVANS was not acquainted with LEE HARVEY OSWALD and knows of no connection between OSWALD and RUBY.

MABEL EXSYLVESTER was contacted at the Kendall Hotel, Kendallville, Indiana, and she made the following information available:

She stated that she had information which concerns a very powerful person in the United States who was involved with RUBY and OSWALD in the assassination of President KENNEDY. She knows of a photograph taken in the 1950's which shows RUBY with this person. This powerful figure and RUBY were definitely close associates and it is obvious to her RUBY killed OSWALD to prevent him from talking.

She does not desire to furnish additional information concerning this photograph or to further identify this person she considers to be involved in the assassination.

She is a "medium", and on the night of January 9, 1964, she was contacted by JOHN F. KENNEDY who told her not to give the information to the FBI for if she did, he would "be washed right down the drain". Four days before the assassination "they" told her "President KENNEDY would be pinned to the road". She asked the voices what they meant, but she did not receive any explanation. On the day of the assassination, prior to her knowing of it, she began crying and did not know why she was crying until she learned of the assassination.

The voices later named the person who engineered the assassination, and this person is a very powerful individual whom she cannot name. After his identity was revealed to her, she came upon the photograph of RUBY and this same person.

She is afraid to furnish the information she has to anyone but Mr. ROBERT KENNEDY or a member of the KENNEDY family. She will attempt to arrange the placing of this information in the proper hands.

On December 19, 1963, Special Agent DEL D. DRAKE, Jr. interviewed JAMES DOUGLAS, WATSON at Paris, Texas and Mr. WATSON advised that he believed on one occasion while living in Dallas, Texas that he had observed LEE HARVEY OSWALD having coffee at a restaurant which would have been either the Clifton Hotel, the El Fenix Cafe or the Beckley Cafe.

On December 31, 1963, SA's ARTHUR E. CARTER and WILL HAYDEN GRIFFIN contacted Mrs. FLOCKEMENTS, manager of the El Fenix Cafe at 120 East Colorado, Dallas, Texas, and she advised that the El Fenix Cafe is open from 11:00 A.M. to 10:00 P.M. daily. She said she was familiar with LEE HARVEY OSWALD's appearance through recent publicity on TV and in the Dallas newspapers, but she had no recollection of ever having seen him in the El Fenix Cafe. She made inquiry of other regular employees and was unable to determine that any of them had ever seen LEE HARVEY OSWALD at any time.

Mrs. CLEMENTS said she recalled JACK RUBY had been in the restaurant on a very few occasions, some four or more years ago, but he had not been in to her knowledge in recent years. She said she knew of no connection between OSWALD and RUBY.

MARY, who operate the Colorado Towers Coffee Shop, formerly known as the Clifton Hotel Cafe, at 214 West Colorado, telephone number WH. 6-0040, Dallas, Texas, each advised that they had never observed LEE HARVEY OSWALD or JACK RUBY in the cafe at any time. They contacted their other employees who advised them that they had never seen either LEE HARVEY OSWALD or JACK RUBY in the cafe. Mr. and Mrs. OWEN said they had no knowledge of LEE HARVEY OSWALD and had never been acquainted with JACK RUBY, and knew of no connection between OSWALD and RUBY.

On January 6, 1964, J. DA KELLY, owner, Beckley Cafe, 113 West Jefferson, Dallas, Texas, advised SA's CARTER and GRIFFIN that he had no knowledge concerning LEE HARVEY

and was unable to recall that OSWAID had ever been a patron of his cafe. He said one customer ose identity he was unable to recall, had said shortes after the assassination of President KENNEDY, that he believed LEE HARVEY OSWAID had been in the cafe on one occasion and that OSWAID moved when this customer attempted to engage him in conversation.

and said that none of them recalled OSWALD or JACK RUBY every having been in the case. He said he had no knowledge of either OSWALD or RUBY and knew of no association between them.

The following reflects additional investigation to identify and locate people who sent telegrams to JACK L. RUBY so they could be interviewed. This investigation has been unsuccessful:

On January 19, 1964, the following information was received from the Denver Office:

The following investigation was conducted by SA RICHARD L. CAMPBELL:

AT DENVER, COLORADO

A search of current telephone and city directories for Denver, Colorado, disclosed no listing for a PAT or PATRICK MC NAMARA. Such a person is also unknown to the Denver Office as a resident of Denver, Colorado.

Officer PAUL HUMPHREY, Identification Bureau, Denver Police Department, advised a search of his records failed to disclose any record of a PAT or PATRICK MC NAMARA.

Mr. BRAD WILSHIRE, Retail Men's Credit Association, Denver, advised on January 19, 1964, that his records contain only one PAT W. MC NAMARA, JR., whose permanent address is 4401 Lorraine, Dallas, Texas, who has an account with the May D & F Department Store, Denver.

On January 20, 1964, the following information was received from the New York Office:

The current issue of the Bronx, New York, Directory lists thirty-seven CHARLES SMITHS. There is no information available to indicate that the SMITH telegram was sent by any of the above-mentioned thirty-seven CHARLES SMITHS. Further investigation to identify the sender of the telegram signed Mr. and Mrs. CHARLES SMITH, Bronx, New York, is not considered feasible.

ANGELO FALLETTA, 236 East 6th Street, Manhattan, New York, Apartment 1E, on January 13, 1964, furnished the following information to SA JAMES J. ROGERS:

He resides at the above address and operates the Helrose Luncheonette located at 2nd Avenue and 6th Street, Manhattan, New York.

When President JOHN F. KENNEDY was assassinated on November 22, 1963, he was emotionally upset that a crime of this type could occur in the United States. When JACK RUBY shot and killed LEE HARVEY OSWALD on November 24, 1963, FALLETTA felt that RUBY was to be congratulated and he, therefore, sent a short telegram to RUBY at Dallas, Texas, sometime on the night of November 24, 1963, extending his congratulations to RUBY. FALLETTA had sent this telegram from the residence of his girlfriend Nrs. SCHOMAN who resides at 142-10 Hoover Avenue, Jamaica, Queens, New York, telephone OL 7-9763.

FALLETTA has never been to Dallas, Texas. He does not know JACK RUBY and he knows of no connection between JACK RUBY and LEE HARVEY OSWALD.

Howard Ambrose Ratto advised that he was born on August 26, 1918 at Ozone Park, and is employed as a mechanic at the Sperry Cyroscope Corporation, MacArthur Airport, Ronkohkoma, both Long Island, New York.

Ratto stated that at the time of the announcement of the assassination of President Kennedy on November 22, 1963, he was serving on a Grand Jury in the Suffolk County Courthouse, in Riverhead, Long Island.

Ratto stated that he had been an ardent admirer of President Kennedy. He stated that he returned to his home in West Islip, New York, where he occupied himself by watching television broadcasts of the events following the assassination and also partaking of intoxicating beverages until the murder of Oswald by Ruby appeared on the screen at mid-day on November 24, 1963.

Ratto stated that his immediate reaction was one of complete approbation of the action taken by Ruby, which prompted him to immediately make a cash contribution of \$2.00 to a defense fund for Ruby, which he felt would be organized in behalf of Ruby. He stated that in order to expedite the receipt of his contribution, he immediately drove to the West Islip, New York Post Office, where he had deposited his contribution in the mail.

Ratto stated that in reflection, he regrets the action taken by Ruby as he feels that the true facts surrounding the assassination will never be known.

Ratto stated that neither Ruby nor Oswald were personally known to him; that he knows of no association between said individuals and that he has no information regarding the Ruby defense fund, other than as set forth above.

Among the letters addressed to JACK L. RUBY at the Dallas County Jail was one signed "FRED", postmarked December 8, 1963, Portland, Oregon. To the letter there was attached a reproduction of a photograph of an unidentified person. The photograph had the following at the top left-hand corner: "LMNORA (D) Remember Him." The writer stated the unidentified person and the writer of the letter had been in "your night club last May", and that the person in the unidentified photograph was introduced to RUBY. The writer represented OSWALD appeared in the club at the same time and made reference to a few days later when the writer returned to the club and saw RUBY and OSWALD together.

The writer also, in referring to the individual in the photograph, said he is "back east now" and had said that since OSWALD is dead he hoped RUBY would never talk. The photograph in question was forwarded to the Portland Office and exhibited to members of the Portland Police Department, who could not identify him as being in the Portland area.

Lieutenant WILLIAM BRYAN, Portland Police Department, subsequently produced the October 26, 1963, issue of the Saturday Evening Post, which included an article beginning on page 28 entitled "They call me TIGER LIL." At the bottom of page 32, in connection with the article, appeared the phetographs of four men. The one at the extreme right bears the underline, "The Late VINCENT BLANEY, accused burglar, whose body was found in Atlantic Ocean."

The article includes information that the body of BLANEY, with a bullet hole in the head, was found in the sea off Atlantic City, August 23, 1960, following BLANEY's disappearance on August 3, 1960.

Examination of the photograph attached to the letter in question, under microscope, disclosed it was a print from the publication named above. Inasmuch as VINCENT BLANEY was found deceased August 23, 1960, he obviously could not have been in Dallas, Texas, in May 1963, and, accordingly, no further action is being taken concerning the allegations in the letter to RUBY.
