Gordon Novel is the former associate of Jim Garrison, who fled the State of Louisiana to avoid appearing before a New Orleans Grand Jury in connection with Garrison's so-called probe into the Kennedy assassination. Garrison has tried in vain to have Novel extradited back to the State of Louisiana. Novel recently made a public offer to return to Louisiana and appear before the grand jury if Garrison would publicly assure that he (Novel) would be given truth serum prior to being questioned by the grand jury.

Miguel Torres, referred to in attached, is one-time heroin addict now in state prison at Angola, Louisiana, who has claimed he was offered freedom, an ounce of heroin, and three months' vacation in Florida, if he would help substantiate Garrison's case.

On 8/7/67, [redacted] furnished the following information, which was obtained from a non-controlled source, whose reliability is not known:

A Cuban, believed to be of Mexican origin, known only as "SPONTEJO", and described as a "G-2 agent", was reportedly involved in the assassination of President JOHN F. KENNEDY.

The source is unable to furnish any additional clarifying information, and, in order to better evaluate the source of the foregoing information, has requested any information identifiable with "SPONTEJO".

Indices of the NYO were carefully searched, concerning captioned, including phoenetic variations thereof, with negative results.

The Bureau is requested to search indices for any pertinent identifiable information which may be furnished to the source.

Re Bureau airtel 8/7/67.

On 8/8/67, the residences located at 757 French St. and 4905 Magazine St., New Orleans, La., were personally observed by two SA's of the New Orleans Office. It was determined that neither one of these residences has been demolished or is presently being demolished. It is to be noted, however, that the building immediately next to 4905 Magazine Street, which is described as a duplex-type building with the addresses of 4903 and 4901 is presently being renovated and some interior and exterior work appeared to be in progress.

A review of New Orleans files determined that LEE HARVEY OSWALD resided at 126 Exchange Place, New Orleans, La., during a period preceding the Spring of 1956 when he and his family moved to Ft. Worth, Texas. This address was also observed and no evidence existed that this residence is being demolished or has been recently demolished.

According to New Orleans files, LEE HARVEY OSWALD and his mother resided in Covington, La.; however, these residences were not checked inasmuch as LEE HARVEY OSWALD was an infant at the time he resided in Covington.

ASSASSINATION OF PRESIDENT
JOHN FITZGERALD KENNEDY
NOVEMBER 22, 1963,

Mr. Jan Rups, a representative for the Dutch newspaper "Der Telegram" in Amsterdam, recently contacted the Bureau and informed a Bureau official that he had recently returned from New Orleans where he had been in contact with New Orleans District Attorney James C. Garrison for approximately four hours. Mr. Rups advised that he found Garrison to be very articulate and persuasive and stated that he came away from the interview believing, against his better judgment, that Garrison might have something. Mr. Rups stated that Garrison showed him extracts from various affidavits he had collected and seemed to be supremely confident that he could "make his case."

Mr. Rups further advised that Garrison had shown him a small green notebook, approximately four inches by five inches, which Garrison described as most significant evidence. Garrison claimed that this was a notebook of Lee Harvey Oswald's that had recently been found in a New Orleans house where Oswald had lived in 1963. Garrison informed Mr. Rups that a Negro member of a wrecking crew which is demolishing this house found the notebook and eventually it came into Garrison's hands. Garrison claimed this alleged notebook of Oswald's contained pertinent data regarding the assassination and he allowed Mr. Rups to glance briefly at several pages. Mr. Rups said he saw only jotted notations that were meaningless to him; however, he said he gained the distinct impression that Garrison considered this "new find" to be of great importance.

A check of our files disclosed that Lee Harvey Oswald arrived in New Orleans, Louisiana, approximately April 25, 1963. He spent several nights at the residence

A xerox copy of Unsub's document is attached to each airtel, and five xerox copies of the Unsub's mailing envelope are attached to Bureau airtels.

By letter of 8/10/67, Colonel JACOB SCHOTT, Chief, Cincinnati PD, furnished the above-mentioned document and mailing envelope to the Cincinnati Office of the FBI for information, indicating it need not be returned to the PD and that it had been handled by numerous and undetermined personnel of the PD. Colonel SCHOTT has been mentioned in the nation's press recently as testifying in Washington, D.C. before the Senate Judiciary Committee on the recent racial disturbances in Cincinnati, Ohio. Also the news media has mentioned Captain SOFACZ of Nashville, Tennessee, and Chief BRICE KINNAWON (believed to be in Cambridge, Maryland) as commenting on racial disturbances in their areas.

Using a numerology system of "13" for names and numbers, Unsub alleges five persons plotted President JOHN F. KENNEDY's assassination for a "Red Fabian Mob." On unnumbered page 1, which begins with the words "Confidential Report," and page 2, these persons are listed as follows:

NORMAN S. LEZIER, Aka., who is described as the Red Fabian National Boss from Santa Cruz, California;

ROBERT K. HOPSON, who is described as a big shot "junk" handler, formerly of Santa Cruz, California;

Reverend KURTZ, who is described as an assistant to HOPSON and known to the Santa Clara County, California, Sheriff's Office;

SAM the Shotgun, who is described as SAM MIANO, the brother-in-law of the late AL CAPONE, a gangster; US

"Oyr Mr. Thirteen," who is described as hired by SAM MIANO to shoot President KENNEDY.

Unsub alleged this "Red Fabian Mob" is international in scope, having originated in Great Britain, the alleged current headquarters, engaging in vice, crime, Communism, racial riots, etc., for profit. Unsub alleges this group originated with FREDERICK H. ENGELS and CARL MARX and now

controls our national leaders.

The entire document has scurrilous remarks about many public personages, including President JOHNSON, the Director, and others; however, it makes no threats of harm against them. It is apparently written by a person needing psychiatric treatment.

The FBI Laboratory is requested to compare the typing on the enclosed document and envelope with similar "crank-type" letters for possible identification of the Unsub, and advise San Francisco and other appropriate offices as to the results of the examination. The original document need not be returned to Cincinnati.

SAN FRANCISCO

AT SAN FRANCISCO, CALIFORNIA

1. Will advise the Bureau if that office has information of similar type letters being written by a person or persons who seem to be obsessed by a system of "13" numerology.

2. Will consider a check of indices on the five names mentioned by Unsub, viz., NORMAN S. LEZIER, ROBERT K. HOPSON, Reverend KURTZ, SAN MIANO, and "Our Mr. Thirteen," to determine if the identity of the Unsub has already been determined in San Francisco files.

Information copies of this airtel are being sent to Dallas, which office was Office of Origin in the Assassination of President KENNEDY and JACK L. RUBY; LEE HARVEY OSWALD - VICTIM files.

Also, information copies are being sent to Memphis and Baltimore as Unsub's letter indicates that he had addressed a similar type communication to Chief BRICE KINNAMON (believed to be in Cambridge, Maryland) and Captain JOHN A. SORACE (believed to be of the Nashville, Tennessee, PD).

ANDREWS LOSES BID TO QUASH INDICTMENT

Dean Adams Andrews Jr. today lost a bid to have his perjury indictment thrown out, and more witnesses will testify tomorrow in his bid to have District Attorney Jim Garrison and his aides removed as his prosecutors.

Andrews, on trial before Criminal District Judge Frank Shea, is accused of lying before the Orleans Parish Grand Jury in connection with Garrison's probe of the slaying of President John F. Kennedy.

Judge Shea today denied a motion by Andrews, who is conducting his own defense, to quash the indictment against him on the grounds that the grand jury which indicted him was improperly selected.

ONE WITNESS was heard on this motion, senior Criminal District Judge Bernard J. Bagert. Judge Bagert was questioned for about 10 minutes by Andrews on the manner in which the jury was selected.

Andrews asked, "Did you have occasion to receive from the secretary of the jury commission of the Parish of Orleans a venire list from which to select a grand jury?"

Judge Bagert answered that he did receive such a list, although he did not remember who brought it to him.

ANDREWS THEN asked him to explain the method he used to select the jury.

Judge Bagert said, "I sent out subpoenas to nearly 60 jurors and I interviewed everyone to whom I sent subpoenas. Then I made my decision."

Andrews asked him if the jury were selected following the Labat decision. (A federal court ruled a year ago that Edgar Labat, a New Orleans Negro who spent more time on death row than any other convict in American history, did not receive a fair trial because daily wage earners were excluded from the jury venire.)

JUDGE BAGERT said his selection was made after the Labat decision. He said the process was changed recently to conform to the court ruling.

"I did not exclude anyone as wage earners," said Judge Bagert. "The problem was to get 12 men who were not reluctant jurors. I interviewed 60 people."

He said he did not want to choose reluctant jurors for a grand jury that would serve during the summer months because he wanted to avoid the problems of the jury not having a quorum.

Judge Bagert said there was one wage earner on the grand jury.

"HE IS A teacher nine months of the year and the other three months he is a bricklayer. I understand he makes more money laying brick than he does teaching."

As soon as Judge Bagert left the stand, Judge Shea denied the quash motion and recessed the hearing until 9 a.m. tomorrow.

At that time, Orleans Parish Coroner Dr. Nicholas J. Chetta, Dr. Esmond Fatter and Perry Raymond Russo have been subpoenaed to testify. All three were key witnesses in the preliminary hearing for Clay L. Shaw charged with criminal conspiracy in the president's slaying.

JUDGE SHEA SAID he expected to end the hearing on the recusal motion tomorrow and begin immediately with selection of a five-man jury to try Andrews.

The judge said he would conduct the trial through the weekend if necessary.

As the hearing on the recusal motion went into its second day, Andrews called three witnesses: two policemen and a godson of the late David William Ferrie.

Ferrie, who died here Feb. 22, was a key figure in Garrison's Kennedy death plot probe. The perjury charge against Andrews grew out of the probe.

THE GODSON is Morris Brownlee, 4728 Jefferson hwy. Andrews quizzed him about an incident in October, 1966, in which he, Brownlee, was arrested.

Andrews asked Brownlee if anyone in the DA's office asked him about Ferrie. Assistant DA James L. Alcock objected to Andrews' line of questioning, and Judge Frank Shea said Andrews would have to show that it was relevant.

Andrews asked for a recess to show the judge the relevance of the questioning, and it was granted.

When court resumed, Andrews said he had no other questions for Brownlee, but held him under subpoena for tomorrow.

Andrews then made a motion to withdraw his formal pleading of not guilty in order to make a motion to quash the indictment against him.

Judge Shea instructed Andrews that it was not necessary to withdraw his not guilty plea to file the motion to quash.

Assistant DA James L. Alcock objected to the move to quash because it "was not filed three days prior to the trial as the law requires."

Judge Shea read the law and said it left him the discretion to permit its being filed and he allowed Andrews to do so.

Before Brownlee took the stand, the two policemen testified. They are Ptn. John P. Tobin and Ptn. Warren Armond. They testified concerning the arrest on Sept. 19, 1966, of a man identified as Manuel Garcia Gonzalez.

ANDREWS HAS SAID in the past that he made up the name of Gonzalez, after conversations with the district attorney pertaining to the alleged assassination plot against President Kennedy.

At one point the DA's office was searching for such a man in the Miami area. He was supposedly a powerfully built man.

Tobin identified one of two arrest cards on a Manuel Gonzalez, which Andrews entered into the record as a defense exhibit.

Tobin testified that he did "apprehend a subject whose name is listed as Manuel C. Gonzalez." He said the arrest was made in Vie's Bar, 1107 Decatur. He said the man was arrested for carrying a concealed weapon.

THE PATROLMAN was then asked by Andrews, acting as his own attorney, to describe Gonzalez.

Tobin said Gonzalez was about five feet, seven inches tall, weighed 150 pounds, had black hair and an olive complexion.

Andrews asked if the arrested man was "printed and mugged."

"Not to my knowledge, no," said Tobin.

Armond, who was a partner of Tobin at the time of the arrest, confirmed Tobin's description of the arrested man and like Tobin, said that Gonzalez spoke broken English.

FOR THIS reason, he said, the desk sergeant had a hard time getting the man's name right.

The hearing to recuse Garrison from the trial got off to a late start when Judge Shea cleared his docket of other business.

Andrews went to the back of the courtroom where he carried on conversations with Joseph Rault, a witness in the trial, and Louis Ivon, chief investigator for the DA's office.

When he was not conversing he sat ramrod straight and stared ahead at the proceedings at the front of the court.

A French Quarter stripper stole the show from Andrews early in the day when her obscenity case showed up on Judge Shea's early docket.

RITA ALEXANDER, known professionally as the Champagne Girl, entered the courtroom and took a seat in the back row reserved for witnesses, to the delight of the witnesses and newsmen.

All eyes, including Andrews', remained glued on Miss Alexander until she left the courtroom.

In an interview with the States-Item before the hearing opened this morning, Andrews was asked about a statement yesterday by his former attorney, Sam Monk Zelden, who said he was withdrawing from the case because he and Andrews couldn't agree on strategy. Asked if this were true, Andrews said:

"Aw, he's fulla bull."

ANDREWS SAID HE was seeking the help of additional

counsel for the trial itself after the recusal motion is disposed of.

"I'm not stupid enough to go it alone for the trial—three heads are better than one, you know."

Andrews said he has talked to three or four lawyers about representing him at the trial but has made no decision as yet.

The chubby former Jefferson Parish assistant DA, in a cheerful mood, said he had been exhausted yesterday after 12 hours of grueling testimony, in which most of the questioning was done by him. He said he "slept like a log" from 10:30 p. m. until 8:30 this morning.

YESTERDAY, ANDREWS (who is free on bond), ate lunch at Parish Prison at the invitation of the warden. He had soup and cucumbers. He said:

"Now, if the bed is as good as the food, we're in business."

Andrews, told that Gordon Novel, a fugitive witness in Garrison's Kennedy probe, had called last night to ask about him, said:

"That Gordon, he's something else. Gordon's all right. You know, I've known him for a long time. Yeah, he's really something else."

Andrews wore his habitual dark glasses throughout today's proceedings, as he did yesterday. He got a jolt this morning when police ticketed his car parked outside the courthouse.

The trial, which is the first in Garrison's probe of the president's murder, deals with Garrison's allegation that Andrews lied when he said he could not identify Clay Shaw as Clay Bertrand.

Andrews told the Warren Commission that shortly after the assassination a man named Clay Bertrand called him and asked him to defend Lee Harvey Oswald, accused assassin. Garrison contends that Shaw, retired New Orleans businessman, used Bertrand as an alias and participated in a conspiracy to murder Kennedy.

SHERIDAN ASKS TO AVOID JURY

Suit Is Filed in Federal District Court

Walter Sheridan, National Broadcasting Company investigator, filed suit Thursday in federal district court seeking to enjoin District Attorney Jim Garrison and Albert Labiche, foreman of the Orleans Parish grand jury, from forcing him to testify before the jury.

Milton E. Brener, attorney for Sheridan, said Thursday night that the district attorney's office had agreed not to attempt to force Sheridan to appear before the grand jury pending results of the suit.

Brener said a hearing on the injunction has been tentatively set before Federal District Judge Alvin B. Rubin for 9:30 a. m. Aug. 21.

Earlier this week the NBC investigator who took a substantial part in the two programs on the National Broadcasting Television Network which were critical of the investigation being conducted by Garrison into the assassination of President John F. Kennedy was ordered to appear before the grand jury after he filed a similar suit in state court.

ORDERED TO APPEAR

Wednesday, Judge Bernard J. Bagert in Criminal District Court ordered Sheridan to appear Tuesday to show cause why he should not be held in contempt of court for failing to appear before the grand jury.

In the federal court complaint Sheridan and local TV newsman Richard Townley also ask that Garrison be enjoined from proceeding further with the prosecution of two criminal charges against them.

Sheridan has been charged with public bribery and Townley with bribery and intimidation of witnesses involved in the Garrison probe.

In the federal suit it is alleged that Garrison is using his office to deprive Sheridan and Townley of their constitutional rights, including freedom of speech and press and guarantees against compulsory self-incrimination.

Attorneys Brener and Edward M. Baldwin conferred with Judge Rubin before the hearing date was set.

It is alleged that Garrison has conspired with others and has sought to use the grand jury to accomplish illegal purposes "and to exploit his position as legal advisor thereto."

Sheridan and Townley charge that the district attorney has acted "through malice and personal animosity" and has sought to harass and intimidate them.

The suit claims that Garrison has made numerous and repeated public and private statements which show an intent to "get" Sheridan to prevent the investigation of both plaintiffs "into his practices and methods and to stifle criticism . . ."

ATTACK ON ORLEANS GRAND JURY FUTILE

Judge Denies Andrews' Quash Motion

The second day of court action in the perjury case of Dean A. Andrews Jr. ended Thursday afternoon with testimony from a judge as Andrews began a futile attack on the jury which indicted him.

With a motion to have the district attorney's office recused from prosecution still pending, Andrews entered another motion, this one to quash his grand jury indictment, and called as a witness senior Criminal District Court Judge Bernard J. Bagert, who picked the jury.

However, after Judge Bagert testified, Judge Frank J. Shea denied Andrews' latest motion and called a recess until 9 a. m., when more witnesses are scheduled to testify on the recusal motion.

Andrews is charged with perjurying himself in grand jury testimony concerning District Attorney Jim Garrison's investigation of the assassination of President John F. Kennedy.

LAUNCHES ATTACK

Launching an attack on the method of selecting the jury, Andrews asked Judge Bagert during questioning if he picked the jury after the Labat decision.

A federal court has ruled that Edgar Labat, a New Orleans Negro who has spent more time on death row than any other convict in the United States, did not receive a fair trial because daily wage earners were excluded from the jury venire.

Judge Bagert said the selection was after the decision and that the process was changed to conform to the court ruling.

"I did not exclude anyone as wage earners. The problem was to get 12 men who were not reluctant jurors. I interviewed 60 people," he said.

Judge Bagert said he wanted to avoid the problem of the jury's not having a quorum, and noted that the jury has one wage earner.

"He is a teacher nine months of the year, and the other three months he is a bricklayer. I understand he makes more money laying bricks than he does teaching," he said.

When the hearing on the recusal motion resumes Friday

Andrews May Present Pleadings to Shea Today

But Defense Has Made No Specific Plans

Attorneys for Dean Andrews Jr. who is awaiting sentencing on a perjury conviction involving conspiracy investigation testimony, may go before Criminal District Court Judge Frank J. Shea with pleadings Tuesday.

Harry A. Burglass, one of the attorneys, said Monday he was not sure when the defense will go before Judge Shea, but he added that it "could be tomorrow." Burglass said he had not made "any specific plans" as to what defense requests will be.

Andrews' conviction on three of five perjury counts was returned at 1:30 a.m. Monday by a five-man jury. It terminated a five-day court session which ran into and consumed the weekend.

His 11½-foot-long indictment grew out of testimony in June before the Orleans Parish grand jury concerning District Attorney Jim Garrison's Kennedy death probe.

Counts upon which he was convicted covered testimony in which Andrews told the jury he could not identify mysterious "Clay Bertrand" as conspiracy defendant Clay L. Shaw.

CONSPIRACY ALLEGED

Shaw is under indictment for allegedly conspiring with the late David W. Ferrie and Lee Harvey Oswald to kill President John F. Kennedy.

Garrison claimed that Shaw used the alias "Bertrand." "Bertrand" is Andrews' identification of a man who he says called him in 1963 and asked him to represent Oswald.

After the conviction, Judge Shea said the next move is up to the defense. They can ask for a new trial or immediate imposition of sentence.

Andrews, meanwhile, must wait in the infirmary of the parish prison, where he was

remanded after the conviction. Andrews was placed in the infirmary because facilities there are better and cleaner than in the tiers.

Andrews' sentence can be as great as 15 years if he is given a five-year maximum on each of the three counts, and if these sentences are specified to run consecutively.

If the sentence runs to the maximum length, Andrews will have to remain in jail while his case is being appealed.

If it is for a lesser term, he can go free on bond, Judge Shea said.

The conviction was returned by the jury after two hours and 40 minutes of deliberation.

In final arguments District Attorney James L. Alcock cited numerous statements in which he said Andrews lied to the grand jury and to the Warren commission in 1963.

"These statements and positions are irreconcilable," Alcock said, referring to some of them which dealt with Clay Bertrand's identity.

At one point Alcock said, "This man tells so many lies you can't tell when he's telling the truth."

Concerning Bertrand's identity, Alcock said that Andrews testified that "he is or he isn't, he doesn't exist, or he's Gene Davis."

Davis is a French Quarter bar owner whom Andrews identified as Clay Bertrand after the grand jury testimony for which he was indicted.

Burglass maintained that Andrews was being railroaded by the district attorney's office because he would not cooperate by telling the grand jury that Clay Shaw is Clay Bertrand.

He contended that the state's whole case is based on statements made by Andrews alone and that, for this reason, has no legal foundation.

"Our liberty is too valuable to let people use their own

mouths to convict themselves," he said.

'LIKES ATTENTION'

Of Andrews, Burglass said: "He likes attention. Most of us do. He got squirreled up into the biggest investigation of a murder this country has ever seen — the State vs. Shaw. They wanted him to change his story. They wanted Andrews to equate Shaw and Bertrand, but he ain't that kind of guy."

"Up comes that massive foot. It was coming down on Dean. You (the jury) are the only thing between that massive foot and Dean."

Meanwhile, a spokesman for the office of Clerk of Court for the Criminal District Court said the office was open throughout Andrews' trial. He said a man was available at all times with a key to the office.

A story in The Times-Picayune Monday said a tape of interrogation of Andrews was not readily available because the clerk's office was closed. The spokesman also said the clerk's office never had the tape and that it was in the district attorney's office.
