There is no indication that the above matter warrants further investigation by the FBI and no investigation being conducted, UACB.

On April 18, 1963, an individual wishing to remain
anonymous, who has not been contacted prior to this to sub-
stantiate his reliability, telephonically contacted a Special
Agent of the Federal Bureau of Investigation at Fort Worth,
Texas, and stated that Raymond John Kiolbasa had purchased a
\$25,000 life insurance policy and had disclosed the following
information:

Kiolbasa believes there is sabotage involving the
manufacture of the F-111 and other aircraft at the San Diego
Plant of General Dynamics. He stated that he believed the acts
are directed toward renegeing contracts to enable interested
parties to receive greater profits. He stated that he believed
two men are following him to perpetrate bodily harm on him, as
he has noticed them when frequenting local areas of entertainment.
It is Mr. Kiolbasa's belief that the Federal Government tried to
establish his responsibility in the failure of the Semitar rocket
program in San Diego by requesting his transfer to that plant,
but as he delayed the transfer he was unable to be placed in a
position to assume any responsibility in the above actions.

To further acts against him, he believes there are
several individuals who are endeavoring to place associations
with the John Fitzgerald Kennedy assassination with him to
further efforts to gain his dismissal from his present employ-
ment.

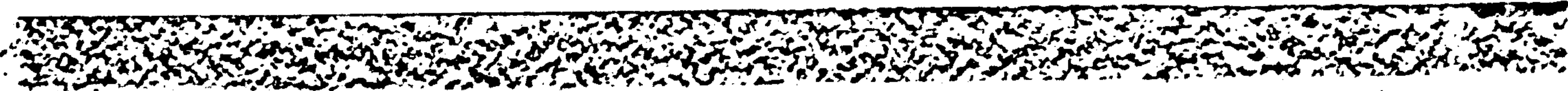

On April 13, 1963, [REDACTED] General Dynamics, Fort Worth, Texas, advised that the [REDACTED] captured [REDACTED] [REDACTED] while reflecting he had voluntarily been in to the [REDACTED] in September 1955, requesting that no further reference be made to this interview. At that time, [REDACTED] complained of an over-activity, [REDACTED] condition and [REDACTED] signs of extreme nervousness. [REDACTED] referred him to the company doctor, Dr. Jackson, who subsequently examined him. [REDACTED] was made that he believed that the [REDACTED] were [REDACTED] him, and trying to [REDACTED] contact with him. [REDACTED] reference was made to the fact that he believed that certain unknown people were trying to blackmail him, as he had been receiving anonymous telephone calls from persons who would never state the purpose for their calling.

In January, 1967, Holbass was considered for transfer to the Penona, California, division of General Dynamics, but never left. [REDACTED] stated that he believes this is the aforementioned connection with the Scimitar rocket program failures. During all interviews and contacts with Holbass he seemed to ramble on in his conversations and never stated anything in definite terms.

[REDACTED] advised that on December 19, 1955, a Secret clearance was obtained for Raymond John Holbass from the San Antonio Air Material Area, which is still in effect at this time.

[REDACTED] stated that he would talk to the supervisor of Holbass and report any abnormal or otherwise questionable information.

On April 13, 1963, a credit investigation at Retail Merchants Credit Association, Fort Worth, Texas, showed that Holbass has a satisfactory credit rating.

On April 13, 1963, a criminal check of Fort Worth Police Department and Tarrant County Sheriff's Office records revealed no arrests or convictions for Holbass.

The files of the Dallas FBI Office contain no information regarding Raymond John Holbass.

Dear Sir:

I am still betting that my sense of the political situation and my knowledge of the methods of some of our political leaders will in time prove me right in my guess as to where the culprit is in the Kennedy assassination.

Back in 1961 I felt that Reuther represented the pro-Castro group and that he was closely allied with the Rusk crowd in State. I never had any doubt that President John Kennedy was opposed to Castro, adamantly so. As long as he was President, even though he was to the Left, he could be budged no farther Left. Reuther said so himself.

Oswald got maximum help from the Rusk crowd in State, including the Zionist crew. Ruby was basically the same type of fellow as the guy who killed King.

Because State was pro-Castro and was willing to help him, we in C.I.A. were also governed by a pro-Castro policy emanating from the very top. The pro-Castro influences were to be found in both the Republican as well as Democrat policy-makers immediately above Allen Dulles.

So far as I can see, Medford Evans makes sense. Garrison may have uncovered low level Right Wing agents. But it was the custom of the pro-Castro elements in State and C.I.A. to order Right Wing career employees to do their dirty work as a cover. That is why I left. I observed too many instances of our people being used as covers because they had no right to disobey orders.

Bobby is now in league with the very people who conspired to liquidate his brother, using our official governmental machinery to carry out the fell purpose. C.I.A. has been heavily penetrated for years, so much so that I would never work for it again.

Now L.B.J. is going to have to pay the piper for playing ball with Keuther. Is it absolutely necessary that each and every one of our Presidents, from Roosevelt, through Truman and Eisenhower, to Kennedy and Johnson, get into bed with Walter and Victor, the two most dangerous politicians in America. You cannot play ball with the Keuthers without getting entrapped. I oppose them and shall oppose them to the very end. I have always hoped that someone with more guts than I could fix their political waggon for them.

The revelations of the New Orleans District Attorney are very damaging to the administration, particularly to L.B.J.. But certainly L.B.J. did not order the killing of Kennedy, although many people are beginning to believe this story. I would stake my reputation that L.B.J. has been framed, even though I think Garrison's presentation of the actual facts are probably correct.

Would L.B.J. not be in a much stronger position for the future if he dumped all party loyalty and uncovered the whole truth of the Kennedy assassination publicly before he leaves the Presidency? If I were in his shoes, I would be ruthless in exposing how the assassination of Kennedy was carried out. Of course there may still exist covers that cannot be broken to reveal the true agents of the assassination. I still hold that the Keuthers had much to gain from getting rid of Jack Kennedy who was a Naval Officer and a combat veteran. I think that there are some things which even a Jack Kennedy would not do for his own personal glorification.

I can testify from my contacts with the public, no one really believes the Warren Report any longer. We know the Communist papers called for the Warren Commission well before it was formed. They even called for Warren to head it. Let's out with the truth if possible in order to give the American People more confidence in their government in this vital hour of crisis.

"The New Orleans Times-Picayune", Sunday, May 19, 1968, Section 3, Page 2, carried an advertisement of a non-profit organization entitled "We The People Speak Of America, Inc." showing that the National Headquarters of this organization is located at Post Office Box 29426, New Orleans, Louisiana 70129. This advertisement sets forth the provision of the First Amendment to the Constitution of the U. S. adopted December 15, 1791. Immediately below, the advertisement contains a petition captioned "PETITION OF JUSTICE OF THE PEOPLE FOR THE PEOPLE BY THE PEOPLE" which sets forth the following information:

"The American citizens whose names appear below DEMAND THAT the files on the assassination of the late President John F. Kennedy, which are closed to the American public, be opened IMMEDIATELY and not seventy-one (71) years from now.

"John F. Kennedy is history; it is our constitutional right to know as much about American History now as Americans will be privileged to know in the year 2,039.

James L. Alcock, Executive Assistant to New Orleans District Attorney James C. Garrison, has written a letter to the Director dated 5/10/68 requesting to see FBI reports on David William Ferrie. Alcock points out that the "classified" FBI reports concerning Ferrie are found in Warren Commission Document number 75.

FBI investigative results concerning Ferrie are set out in the report of Special Agent Warren C. DeBrueys dated 12/2/63 at Dallas, Texas, in the Lee Harvey Oswald investigation. This report was designated Commission Document number 75 by the Warren Commission. Fifty-five pages of this Document contain data regarding David William Ferrie and such data is withheld from public disclosure by the National Archives based on criteria approved by Mr. McGeorge Bundy, former Special Assistant to the President. The data withheld involves allegations, gossip and rumors that David William Ferrie was a homosexual and a sexual degenerate.

David William Ferrie died of natural causes 2/22/67. Garrison maintains that Ferrie was involved in the assassination of President John F. Kennedy and has alleged that Clay Shaw met with Ferrie and Lee Harvey Oswald in Ferrie's apartment in September, 1963, to plot the assassination of President Kennedy.

We conducted extensive investigation of Ferrie during our investigation of the assassination and found no indication he was involved in the assassination. All allegations linking Ferrie to Lee Harvey Oswald or the assassination emanated from Jack S. Martin, a New Orleans private investigator who has a sordid reputation as an alcoholic and has been hospitalized in the past for mental illness. Martin is in current contact with Garrison and his attitude and demeanor strongly suggest he is mentally deranged at this time.

Following David Ferrie's death on 2/22/67, representatives of the news media and others requested to see the Ferrie material which is being withheld from public disclosure by National Archives. By letter dated 2/24/67 we informed the Acting Attorney General that in view of the public interest surrounding David William Ferrie and his involvement in Garrison's allegations, we had no objection to public disclosure of the data concerning Ferrie as set out in Commission Document number 75. We noted that the final decision as to public disclosure of the Ferrie material rests with the Department of Justice. The Department took no action on releasing the material concerning Ferrie to the public.

OBSERVATIONS:

We have not responded to letters from Garrison or his staff in the past and it is felt we should not reply to Alcock's letter but instead refer the letter to the Attorney General. We have no objection to the Department making the Ferrie material available to the public and, thus available to James L. Alcock. It would be in our interest to permit the public to read the Ferrie material and recognize that the allegations involving Ferrie with the assassination and Lee Harvey Oswald emanated from Jack S. Martin. This would give news media a keen insight into the type of investigation Garrison is conducting and could well result in various news reporters writing hard-hitting articles exposing Garrison and his prime source, Jack S. Martin. In view of this, it is felt we should urge the Department at this time to make available to the public the 55 pages of material in Commission Document number 75 relating to David William Ferrie.

ACTION:

Attached for approval is a letter to the Attorney General transmitting a copy of Alcock's letter requesting results of FBI investigation of Ferrie and suggesting that the Attorney General consider releasing the Ferrie data to the public at this time.

U.S. Refuses Subpena for Ex-CIA Chief

The United States attorney's office in Washington, D. C., has refused to serve a New Orleans subpena on former Central Intelligence Agency chief Allen W. Dulles, an aide to District Attorney Jim Garrison said today.

Assistant DA James L. Alcock said efforts to serve a grand jury subpena on Dulles to testify in Garrison's probe of the assassination of President John F. Kennedy have been thwarted.

DULLES REPORTEDLY told newsmen in Washington today that he has not been served, despite Garrison's announcement Feb. 16 that a subpena was being issued for a District of Columbia resident.

Alcock said today this was true. He said the proper procedure under the Uniform Act to Secure Witnesses in criminal proceedings is to send the subpena to the proper authorities in the jurisdiction concerned. They serve it, and the person subpoenaed is re-

quired to go to court, there and show cause why he should not be required to answer the subpena.

A representative of the DA's office checked with the U.S. attorney's office here and was told that the proper person in Washington is U.S. Attorney David G. Bress, Alcock said.

HE SAID BRESS was mailed the legal papers, plus a check for \$239.88 for Dulles' travel expenses.

Alcock said that on March 13, he received a reply from Bress saying, "We decline to represent you in this matter. Accordingly, we are returning the documents and the check, so you can pursue the matter yourself or arrange for other counsel."

This leaves the DA's office with no further legal recourse, Alcock said.

THIS LEFT in doubt the disposition of another subpena issued May 9, in which Garrison asked the U.S. archivist Dr. Robert H. Bahmer to produce the top secret photos and X-rays taken during the autopsy on the body of President Kennedy the day he was assassinated.

The Bahmer subpena also would go to the District of Columbia jurisdiction.

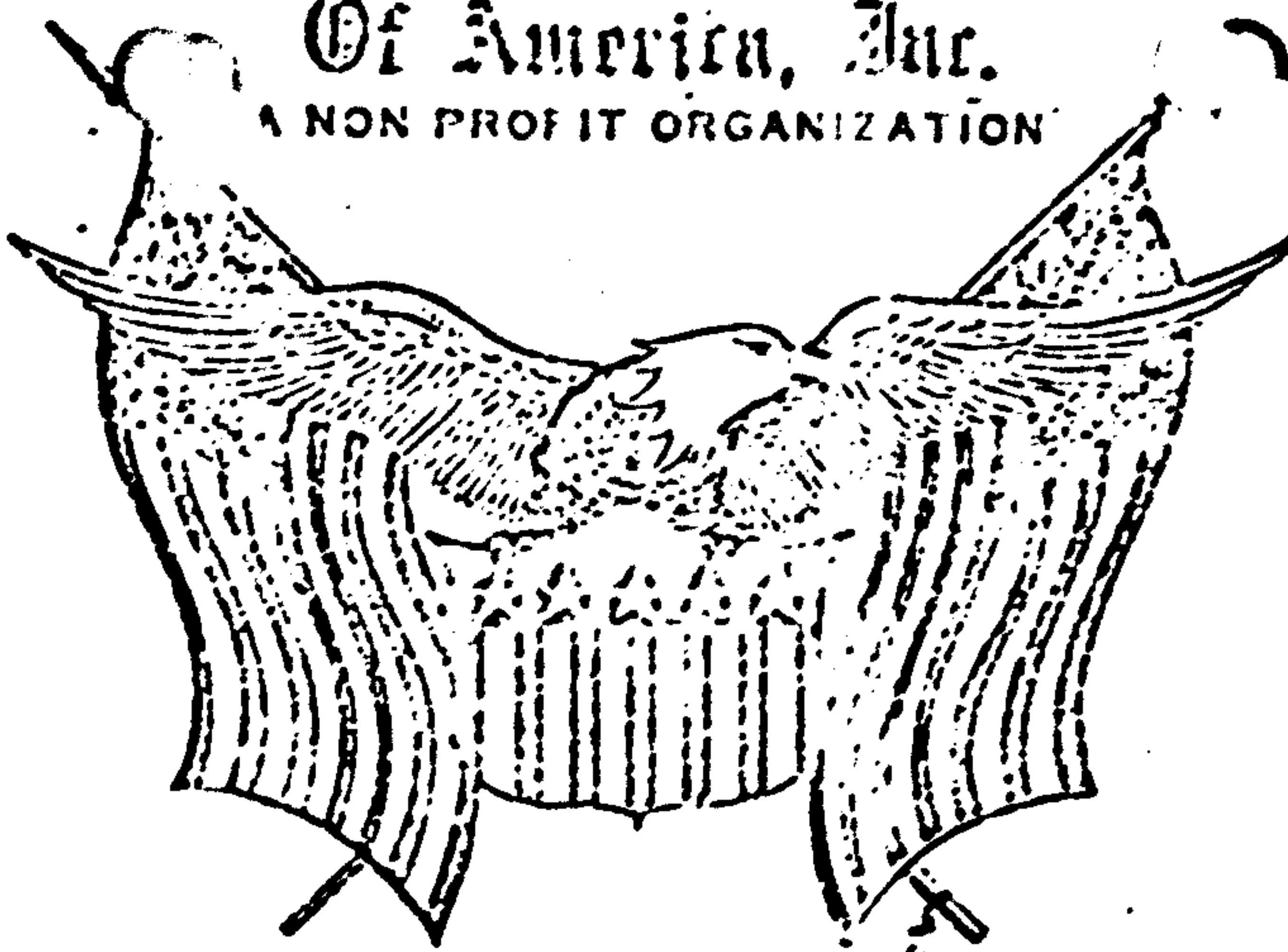

He has since been transferred there twice. In every case, an entire wing or ward of the private hospital involved had to be sealed off to all except a handful of Kennedy confidants and doctors.

It is said that not even the doctors were aware of the location.

—the last half of his life a total
blank.

Secret Grave

The Kennedy Foundation recent-
ly purchased a large tract of land
very close to downtown Chicago—
supposedly to build a mental health
center.

In truth, the center will be a gi-
gant's tomb—with a hospital in-
stalled to provide the medical
care for the remainder of his natural
days.

The workers and patients on the
upper floors will have no inkling
that—only a few yards away—
the destroyed but living JFK exists.

When he finally dies, JFK will
be laid to rest in a secret grave.

You may wonder where I have
found this astounding information.

Unfortunately, I am not at liberty
to say—because to reveal my
sources would seriously jeopardize

persons closest to JFK during his
presidency, and who is one of no
more than a dozen persons who
knows the truth about what has
happened since.

It is possible that I was told a
lie—that someone with a sick sense
of humor was trying to perpetrate
a hoax.

But I don't think so. The person
was simply too highly placed—and
had too much to lose.

5. The reason why the "autop-

Mr. Hoover;

Ever since the assassination of our late President John F Kennedy, the police officer, the death of Lee Harvey Oswald and Jack Ruby. I have been trying to put together a purpose why all those events happened. I believe the most important event was the time when Jack Ruby took the life of Lee Harvey Oswald meaning that the witnesses at the police station at the time were not the only witnesses that saw the event. I saw the event but questioned it after all these years to seek an answer. I believe God exercised his laws on Oswald then Jack Ruby. That would mean Mr. Hoover that the deed that was done by Jack Ruby to Lee Harvey Oswald was not murder but an execution prescribed by God and his Law system. I will express those laws in this manner. Lee Harvey Oswald was on trial while he sat in the jail cell in Dallas.

For the life of John F. Kennedy and for the life of the police officer God applied his laws in this manner.

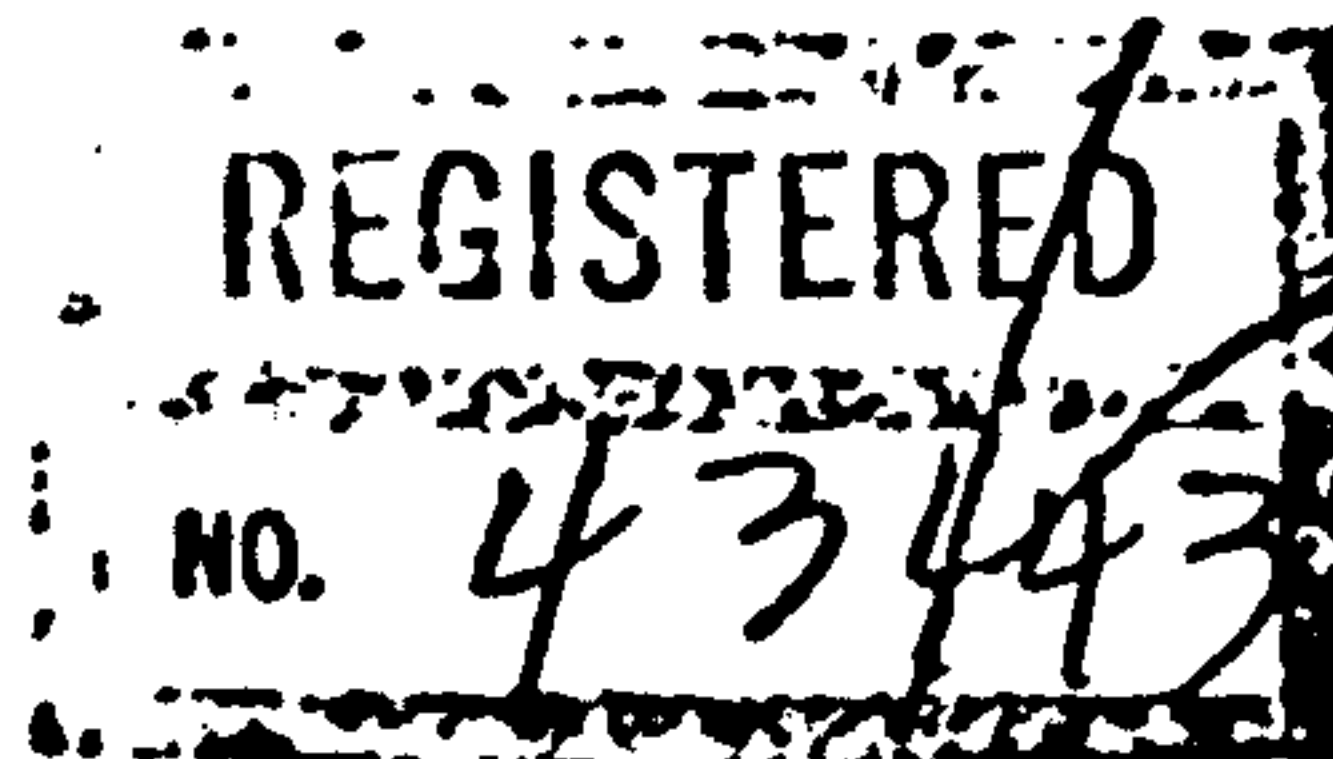

Attached is a letter from captioned individual who is not identifiable in Bufiles. Mr. Gach would like to come to Washington and discuss with Mr. Hoover his belief that Jack Ruby was carrying out the will of God when he murdered Lee Harvey Oswald. It appears Mr. Gach is a religious fanatic and possibly mentally disturbed. He states that as a result of his investigation of the Jack Ruby matter, he was labeled a crackpot by the Dallas Police Department and spent five and one half months in the hospital as the result of asking questions. He states that God has handed him the job of clearing the late Billy Mitchell and the three German judges who were tried at Nuremburg. He would like Mrs. Jacqueline Kennedy to be present when he discusses these matters with the Director.

RECOMMENDATIONS:

1. In view of Gach's apparent mental instability, his communication not be acknowledged.
2. In the event he appears at the Bureau Headquarters, he be interviewed by an Agent of the Crime Records Division.

At 2:30 p. m. on 5-21-68, Mr. Henry J. Taylor, the noted columnist whose relations with the Director and the Bureau are extremely cordial, telephonically requested that he would like me to bring the following information to the Director's attention so that the Director "might share his (Mr. Taylor's) satisfaction with him." Taylor advised that Mark Lane had spoken before the Dutch Treat Club in New York today and Mr. Taylor was present. It will be recalled that Lane is the renegade New York attorney who has widely criticized the findings of the Warren Commission in lectures and books concerning the assassination.

Mr. Taylor advised that in his talk to the Dutch Treat Club, Lane made his usual allegations that there was a conspiracy involved in the assassination, criticized the FBI's investigation into the assassination, and was also very critical of actions of the Immigration and Naturalization Service in allegedly taking Lane's passport away from him on his return from a foreign trip.

Taylor advised that Lane lectured until the closing time for the luncheon meeting, but after the meeting concluded Mr. Taylor went up to him and "straightened him out" very vigorously with regard to his remarks. He advised that he informed Lane that Lane is "relying on the ignorance of people who haven't read the Warren Commission report" in casting aspersions on the conclusion of the Commission and in criticizing the FBI's investigation into the assassination. Mr. Taylor stated that he derived a great deal of satisfaction from being able to do this with Lane based on his excellent information concerning the events surrounding the assassination. He advised that he merely wanted to the Director to know of this, and he was assured that this would be brought to Mr. Hoover's attention.

WATSON advised that SIMS mentioned FRENCH reportedly purchased a gambling stamp from the Federal Government for 1968, but SIMS did not furnish any other information concerning the address or other information in connection with the gambling stamp.

New Orleans indices reflect several references to a JAMES LOUIS FRENCH; JAMES HAROLD FRENCH, aka Jimmy French; however, it is not known if these references, which involve interviews concerning ITSMV, ITSP, and FAG violations, pertain to JIMMY FRENCH wanted by the District Attorney's Office, New Orleans. References concerning JAMES HAROLD FRENCH indicate that he was age 40 in 1965, W/M, and resided in Texas City, Tex., in 1965. JAMES HAROLD FRENCH, aka Jimmy French, was interviewed on 12/12/66 in connection with an ITSP matter; and at that time, FRENCH resided at Rt. 2, Box 75, Winnfield, La. His wife is listed as MARY ALICE FRENCH.

As stated above, it is not known if these New Orleans references, concerning JAMES HAROLD FRENCH, are identical to the JIMMY FRENCH in question.
