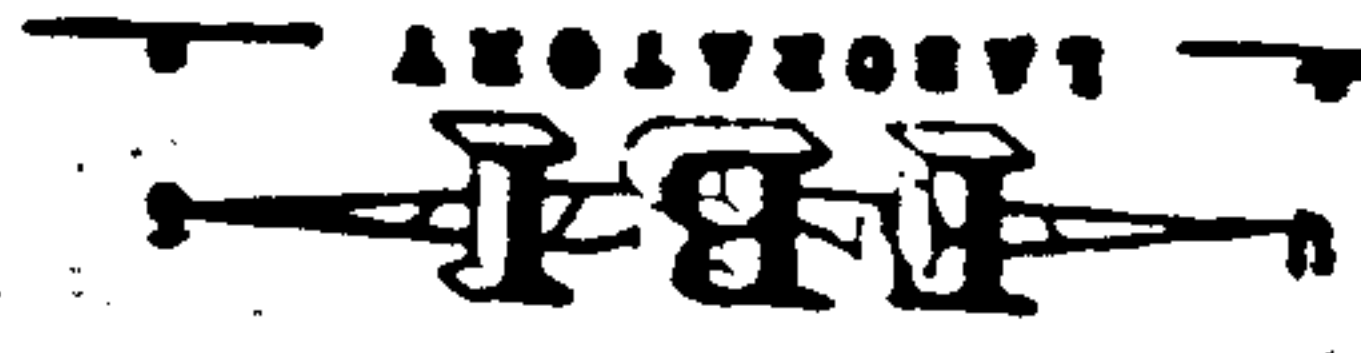

has now advised [redacted] allegedly met Mitter in Jacksonville 11/23/63. Mitter was described as jubilant over the President's death and said, "Everything ran true to form. I guess you thought I was kidding you when I said he would be killed from a window with a high-powered rifle." [redacted] asked whether Mitter was guessing when he originally indicated a plan to kill the President and Mitter allegedly replied, "I don't do any guessing." In a subsequent trip from Jacksonville to Columbia, South Carolina, Mitter reportedly told [redacted] he had been in Fort Worth and Dallas as well as other southern cities. He did not indicate the dates of his visits to these cities.

Memorandum to Mr. Belmont  
RE: ASSASSINATION OF PRESIDENT  
JOHN F. KENNEDY

Milteer also allegedly said he contacted Robert Shelton, Klan leader, Tuscaloosa, Alabama, on the evening before the bombing of the Sixteenth Street Baptist Church in Birmingham. He expressed the opinion Shelton could not be depended upon as Shelton is against violence.

Milteer was further alleged by [redacted] to have said that Martin Luther King and Attorney General Kennedy are now unimportant but the next move would be against the "Big Jew." He alleged that at this time there is a communist conspiracy by Jews to overthrow the United States.

On 11/24/63 at Columbia, South Carolina, Milteer indicated to [redacted] he may have made a long-distance call and said that they did not have to worry about Oswald getting caught because Oswald knew nothing and the right-wing was in the clear. He added that the "patriots" outsmarted the communists by infiltrating their group in order that the communists would execute the plan without involving the right-wingers. Also at Columbia, South Carolina, Milteer reportedly prepared notes prior to the arrival of members of the Constitutional American Parties of the United States. He captioned his notes "Notice to all Christians" and wrote "The Zionist Jews killed Christ Kennedy. You Jews killed the President. We are going to kill you." Milteer allegedly signed his notes as "International Underground."

Atlanta has advised that investigation indicates there is no truth in the information furnished by [redacted] and that Milteer was in Quitman, Georgia, on 11/22/63. In addition, it has been reliably reported in the past that Jack Brown has furnished deliberately false information to persons he suspects of being informants for the purpose of trapping them if the information is repeated. In connection with the investigation of the Birmingham bombings, [redacted] furnished information bordering on the fantastic, which investigation failed to corroborate.

**ACTION:** Secret Service is being advised and the Atlanta Office is checking into whether Milteer may have made any long-distance calls during pertinent period, will check out his activities during the pertinent period, and will interview him. Activities of Brown are also being checked during pertinent period.

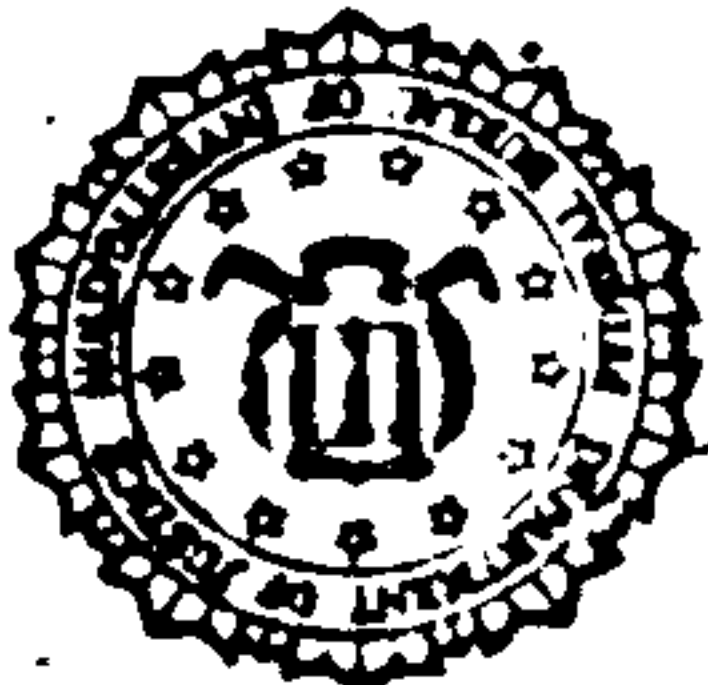

ASSASSINATION OF PRESIDENT KENNEDY  
NOVEMBER 22, 1963, DALLAS, TEXAS

JOSEPH ADAMS MILTER, Gultman, Georgia, was interviewed November 27, 1963. MILTER advised that during April, 1963, he attended a national meeting of the Congress of Freedom, New Orleans, Louisiana. He described this organization as one that believed in Americanism and he attended this meeting as the result of an invitation by a Mr. THOMAS, Chairman of the organization, Omaha, Nebraska. He stated during this meeting neither he nor anyone in his presence discussed the assassination of President KENNEDY.

MILTER stated further that in June, 1963, he went to Dallas, Texas, to attempt to persuade DAN SMOOT, author of the "Dan Smoot Report" to run as Vice-President on the Constitution Party ticket in the election in November, 1964. He stated he had no other business in Dallas.

MILTER further stated that on October 18-20, 1963, he traveled to Indianapolis, Indiana, with BILL GOVERSETT of Miami, Florida, and LEO CLOUD of Atlanta, Georgia. They attended the National Convention of the Constitution Party. He stated he attended this meeting as the result of an invitation by CURTIS B. DALL, former son-in-law of the late President FRANKLIN D. ROOSEVELT.

MILTER described himself as a non-dues-paying member of the White Citizens Council, of Atlanta, Georgia. The Congress of Freedom and the Constitution Party.

MILTER emphatically denies ever making threats to assassinate President KENNEDY or participating in any such assassination. He stated he has never heard anyone make such threats. He also denied making threats against anyone subsequent to the assassination of President KENNEDY. He stated he does not know, nor has he ever been in the presence of LEE HARVEY OSWALD or JACK RUBY to his knowledge. MILTER denied any knowledge of the bombing of the Sixteenth Street Baptist Church in Birmingham, Alabama, on November 15, 1963.

Miss JOHNSON stated that she had been expelled from Moscow in July, 1960 and she attributed this expulsion to the U-2 incident. She said she believed "my visa was just picked up by accident". She went on to state that visa had been granted her on a three month basis. In her opinion, the extension of her visa was contingent on the fact that her writings did not displeas the Russians. She stated that Vice President NIXON at one time intervened in her behalf to obtain an extension of her visa. At another time, U.S. Ambassador LEMWELYN THOMPSON spoke to NIKITA KHRUSHCHEV about an extension of her visa.

At this point she interpolated that during the summer of 1962, she had re-visited the USSR representing "The Reporter" magazine. She stated that during her stay in Russia from 1958 to 1960 she was, on several occasions, taken to lunch by Russians "who tried to buy me with drink". She stated that

the drinks very little and did not accept these offers. During these meetings, she was asked questions regarding activities of working members of the U.S. press corps in Moscow. The question centered on the overall interests of these correspondents, in other words, they wanted the " dirt on different correspondents."

Miss JOHNSON stated she surmised that if she provided the answers to the above questions, the next step would probably have been to have asked her "what did Ambassador THOMPSON say yesterday in the briefing?". She said probably the third step developing from the first two questions would have been a request for information "on the people in the Embassy". She said that she never provided information to her questioners, whom she did not identify by name.

Miss JOHNSON commented that sexual advances had been made to her but she had never let these advances get stated. She added that she was constantly fearful that she might be drugged or be the victim of compromising photographs. However, no incident of the kind occurred.

She made the observation that all U.S. correspondents were believed to have been approached in a similar manner and subjected to similar pressures. She stated she considered herself vulnerable because her visits were of only three months duration and also because her articles became more and more critical.

With regard to her 1962 visit to Russia she advised that 13 notebooks were seized by the Russians together with two finished manuscripts on Russia as well as four sets of files containing Soviet news clippings and background data on numerous stories appearing in the Russian press.

She stated further that on one occasion she made efforts to obtain permission to take a boat trip on the Volga River in order to write a story of the people on the trip. She said her field was "atmospheric", that she liked to write of moods and attitudes of people. She was given a variety of reasons why permission could not be granted her to make this trip. She said she did not realize until later that she had unwittingly asked permission to enter an area which she learned was suffering from acute food shortages and was having political trouble.



No further interview of Miss JOHNSON is contemplated by Boston at this time.

Miss JOHNSON stated that none of her brothers had ever been a "pilot".

Miss JOHNSON was very cooperative during the interview and readily assented to an additional interview if necessary. She was advised that because of her considerable reservoir of information concerning individuals in Russia and methods used by the Russians, that such an interview might be desirable in the future.

She did not receive permission to go there.

The Congressional Record for Wednesday, November 27, 1963, has been reviewed and the following items contained therein have been noted for your attention.

Pages 21738 - 21739. Congressman Goodell, (R) New York, submitted a joint resolution (H. J. Res. 814) to establish a joint committee to conduct an investigation and study of the recent assassination of the President of the United States and of certain other matters pertinent thereto. He made reference to the need for Federal legislation to provide protection for the President and Vice President. Mr. Goodell, in citing Federal jurisdiction, stated "Other less pertinent grants of authority may be cited, but the fact remains that the FBI and other Federal investigating agencies do not have the kind of direct and unambiguous jurisdiction that they should have in matters of this nature."

Page 21739. Congressman Horton, (R) New York, introduced a bill, H. R. 9255, to provide for the greater protection of the President and Vice President of the United States, members of the President's Cabinet, and Members of Congress. A copy of this bill will be secured as soon as it is available.

Pages 21739 - 21740. Congressman Ashbrook, (R) Ohio, submitted a joint resolution, H. J. Res. 812, directing an investigation of the Department of State. He stated "without a doubt, almost everyone in this House recognizes that an investigation of the Department of State is long overdue. The tragic events of the past weekend indicate that the Department of State was the vehicle through which the assassin, Lee Harvey Oswald, returned to the United States. - - - This is but one of scores of examples of the Department of State's policies which show mismanagement, bad judgment and even subversion."

Pages 21740-21741. Congressman Fascell, (D) Florida, pointed out that President Johnson has ordered an investigation, by the Justice and Treasury Departments, surrounding the assassination of President Kennedy and the killing of the suspected assassin. He advised that the results of this investigation should be made available to the proper congressional committees for the purpose of review and evaluation to determine whether there is any need for congressional action. Mr. Fascell stated "Congress shares in the responsibility of doing all that can be done in the future to lessen or eliminate the chain of events which reached such tragic proportions. - - - Some committees will be concerned with the need for additional funds to provide for additional security measures. Some committees will be concerned with the internal operations and efficiencies of each of the departments, and the coordination and cooperation between the Secret Service and the FBI dealing with the security of the President and other high officials of our Government. - - - While all of these interests are proper and reflect the responsibility which the Congress has, in my judgment, it would serve no useful purpose for each of the committees to conduct an independent investigation of its own." Mr. Fascell also pointed out that he would contact both the Department of Justice and the Treasury Department requesting the results of the investigation.

SENATE

Pages 21764-21765. Senator Scott, (R) Pennsylvania, introduced S. 2345, a bill to amend the Federal Firearms Act to further restrict the use of instrumentalities of interstate or foreign commerce for the acquisition of firearms for unlawful purposes. A copy of this bill will be obtained as soon as it is available.

Pages 21765-21766. Senator Dodd, (D) Connecticut, submitted for himself and Senator Fong, (R) Hawaii, an amendment to S. 1975, a bill to amend the Federal Firearms Act. S. 1975 was introduced by Mr. Dodd and several other Senators on August 2, 1963. Mr. Dodd pointed out that S. 1975 was being amended to require that not only must a person provide an affidavit attesting to his age, name, address, and criminal record, if he has one, and his compliance with State gun laws, but, in addition, the affidavit must be authenticated by the highest local law enforcement authority in his community. He urged that the bill be given the urgent attention of every Member of the Senate and quick passage by Congress.

Pages 21779-21780. Senator Douglas, (D) Illinois, spoke concerning

the book "The Strategy of Deception" edited by Jeanne J. Kirkpatrick. Mr. Douglas stated "This book is the most concise yet descriptive volume on Communist tactics that I have read in a long time. In none of the 16 perceptive essays will the lay reader become lost in theory and conjecture. These essays present hard proven facts. They show the devious, inconsistent, and conflicting methods that the Communists have used in their efforts to expand Soviet power. - - - This is a book for the general public. Also, I recommend it to the youth of today who has not had the opportunity to observe Communist tactics at first-hand or is too young to remember the Communist's promises and their betrayal of them."

Pages 21790-21791 and 21805-21820. The Senate passed and cleared for the President H. J. Res. 805, to continue through January 31, 1964, funds for those agencies whose regular appropriation bills have not been approved.

Page 21801. Senator Javits, (R) New York, spoke concerning the

investigation of the assassination of President Kennedy. He pointed out that the Senate Judiciary Committee should conduct this investigation. Mr. Javits stated "Americans are concerned that there will not be an investigation by the Senate, that there will not be an investigation by the House, since the President has already ordered an investigation to be made by the FBI, with its report to be made public. - - - So I address a plea to the leadership that, within the limits of their authority, they do their utmost to bring about a situation in which, if the die is cast that way—and, as I say, I am sure it can be done, and done superbly well—the Senate Committee on the Judiciary will be the investigating body, and that everybody's ideas and everybody's desires to get to the bottom of the whole situation may be pooled in that committee, and that its report be the authoritative report to the people."

Mrs. Green included with her remarks an editorial from the Washington Post of November 27, 1963, entitled "Deadly Weapons." This editorial states "Of the 7,261 murders reported by the Federal Bureau of Investigation last year, more than half of the victims were killed with guns."

Pages A7313. Congressman Rogers, (D) Florida, extended his remarks concerning the need for a congressional committee to oversee the Central Intelligence Agency and other intelligence agencies. He included an article from the Los Angeles Times entitled "Watchdogs Over CIA Demanded—Lawmakers Assert They Have Right To Check on Agency" written by John H. Averill. Mr. Averill stated "Rogers' views were seconded generally by Representative H. Allen Smith (Republican, of California), a former FBI agent who worked on several World War II espionage cases. 'The CIA is no more secret than the FBI,' Smith said, 'and the FBI gives Congress all the information it requests, puts out annual reports on its activities, and lets Congress know how much money it needs and spends.' -- -- This view was challenged by Representative Gerald R. Ford, Jr., Republican, of Michigan, a member of the House Appropriations Subcommittee on Intelligence. 'I see no need for any special committee,' Ford said, 'I know of no instance where we have requested information that it has been denied. The CIA is a lot more complicated than the FBI.'" (H. Allen Smith was employed with the Bureau as an Agent from December 2, 1935, to November 3, 1942. His services were satisfactory.)

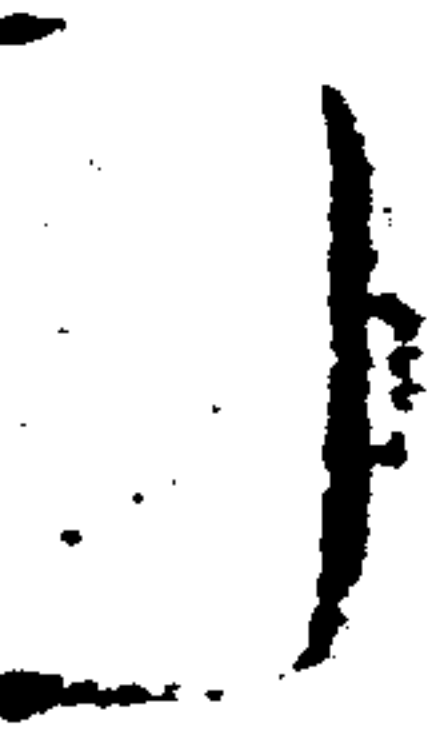

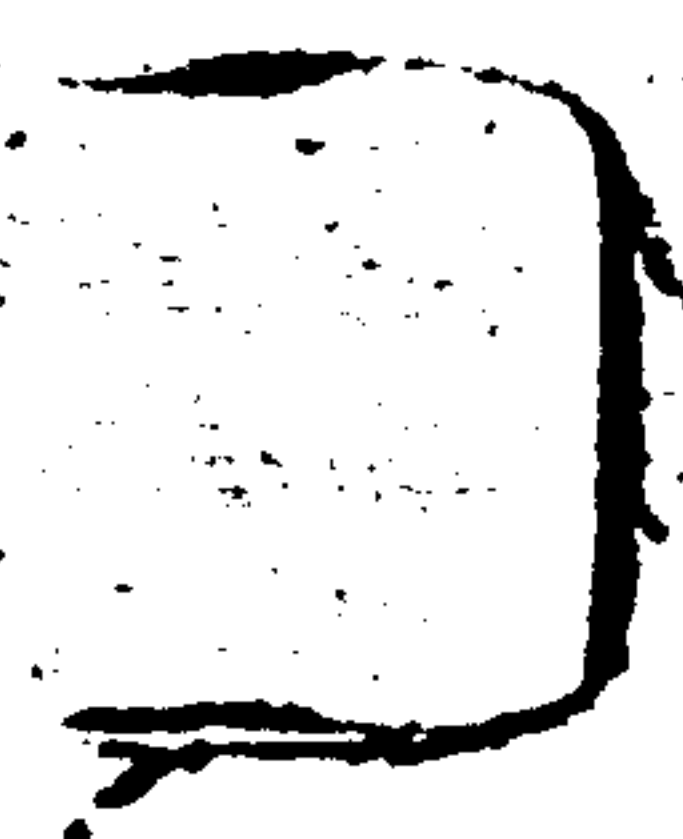

This development will be closely followed.

In order to resolve this allegation, which is known to state and local authorities in Texas, according to Inspector Malley, immediate authority was granted to afford polygraph examination.

A Special Agent of the Dallas Office is in the process of interviewing [Floyd] and other facts will be forwarded as soon as they are available. Inspector Malley indicated, however, that thus far [Floyd] refuses to change his story. He requested authority to afford [Floyd] a polygraph examination, which he has volunteered to take.

At 10:30 a. m., 11/30/63, Inspector J. R. Malley advised that James Eugene Floyd, an inmate at Eastern State Farm #172555, a branch of the Huntsville, Texas, prison system, claimed to be a former associate of Jack Ruby and that he had been paid \$3,000 by Ruby for killing a man. Specific details as to the victim's identity and dates are not yet available. [Floyd] likewise alleged that Ruby had made a proposition to [Floyd] that he [Floyd] kill President Kennedy.
