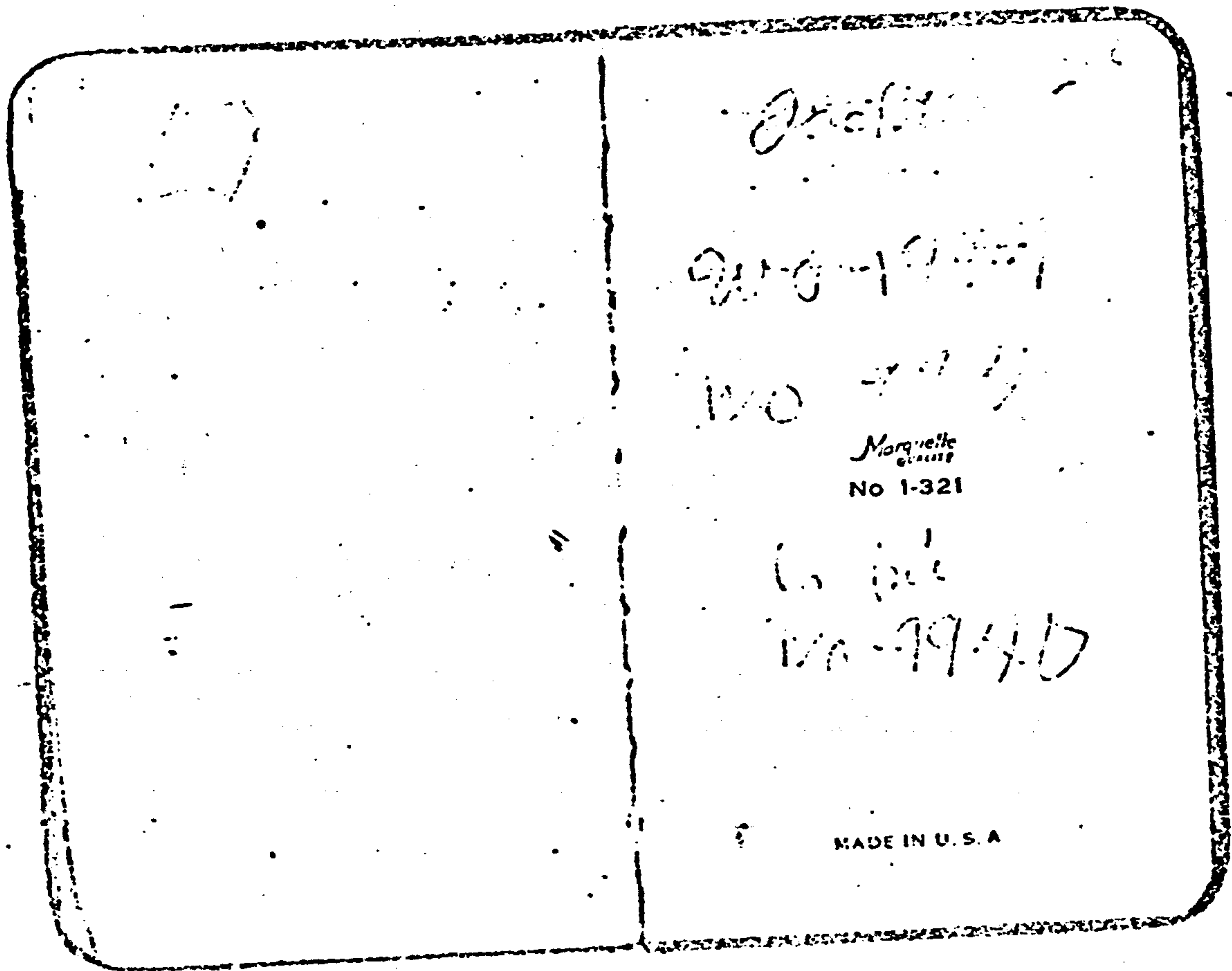

# Jack Ruby Clubs Report Changes

Three Mesquite residents have applied for a beer and wine license to operate Jack Ruby's Vegas Club at 1416 Oak Lawn.

Mrs. Dolores Gene Nolley filed the application for the license at the office of County Judge Lew Sterrett.

She made the application in the name of the Nolley Corp., listing herself as president. Other officers of the corporation according to the application are Bob Young, vice president, and J. A. Knox, secretary.

In the application, Mrs. Nolley said her corporation was buying the night club from Jack Ruby.

Meanwhile a new wine and beer license application was made Tuesday for the Carousel Club, Ruby's other night club.

Ralph Paul applied for a new wine and beer license for the Carousel Club after Judge Sterrett refused to renew the current license which expires March 8.

Mr. Paul applied for the new license under the name of the S&R Corp., and listed himself as president. S. D. Ruby, brother of Jack Ruby, was listed as vice president, and Leo Torti was listed as secretary-treasurer.

The new application asked for a license under the name "The Big D Copa" instead of the Carousel Club. This club is located at 1312 1/2 Commerce.

Judge Sterrett will hold hearings at a later date on both license applications. The Dallas police department and the liquor control board are expected to protest the license for the former Carousel Club.

Memorandum to SAC, Dallas  
Re: ASSASSINATION OF PRESIDENT JOHN F. KENNEDY

NOTE: Betty Douthit, 631 South Inman Road, West Covina, California, furnished LA Division a box of papers reportedly obtained from Jack Ruby's Dallas night club ("Club Vegas") in approximately 1964-1965 by her former husband, Robert Kenneth Young (deceased). Douthit and Young are not identifiable in JFK related Bufiles. Among papers furnished to and reviewed by LA Division were two address books apparently belonging to Ruby. LA determined only items of possible value were address books, copied pages of which were furnished to the Bureau for review. Of all entries, only 54 names were searchable and references were found to Ray Johnson, Bufile 62-109060-3477 and John Rector, Bufile 44-24016-1829. LA was to return items, following review, at owner's request. This is to apprise LA and Dallas of result of Bufiles check and to instruct Dallas to submit results of its check in form suitable for dissemination.

On 4/25/77, BOB RIGGS, 6150 West Mansfield Avenue, Denver, Colorado, telephone 303-986-2788, stated he is the publisher of the Mercedes Benz Star, 5740 South Gallup Street, Littleton, Colorado, telephone 303-794-3038.

RIGGS said on 4/22/77, he was telephonically contacted at his residence by an individual who identified himself as [redacted] New Orleans, Louisiana. RIGGS said [redacted] asked him if he was the publisher of the Mercedes Benz Star and when advised in the affirmative, stated that he "had something to do with the JOHN F. KENNEDY murder." RIGGS stated that [redacted] told him that he wanted his information published in the Mercedes Benz Star, and that he would telephonically furnish it to him at 2:00 PM on 4/23/77. He said that to date, [redacted] has not recontacted him.

RIGGS stated that he had no prior contact with [redacted] and could furnish no information regarding him. He said he had no idea why [redacted] wanted his information published in the Mercedes Benz Star and had no idea how [redacted] had obtained his home telephone number which is unpublished. He said [redacted] contacted several publishers within the Denver Metropolitan area and has found no one else who has been contacted by [redacted].

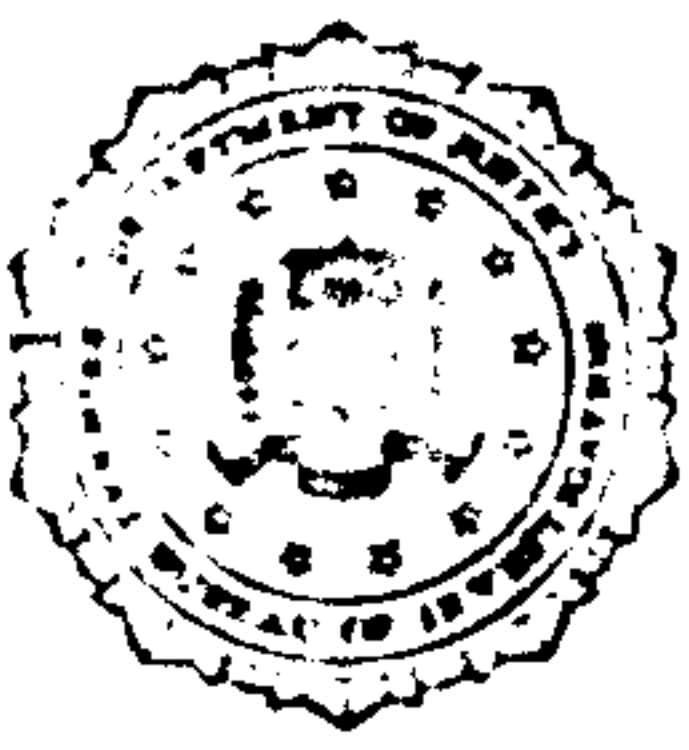

On February 16, 1977, Mrs. Betty Douthit, 631 South Inman Road, West Covina, California, advised that in 1964 and 1965, her former deceased husband, Robert Kenneth Young, was manager of the Club Vegas, 3508 Oak Lawn Avenue, Dallas, Texas. When they took over management of the club, Douthit and her deceased husband cleaned out the storage area located on the first floor of the club. At the time, they found various business records and what appeared to be personal address books belonging to Jack Ruby, the former owner of Club Vegas. Douthit further advised that she recently read an article in a collector's magazine in which a signature of Lee Harvey Oswald was being offered for sale for \$2,000. She further advised that she planned to offer for sale the various signatures on records she had found at the Club Vegas. She stated that prior to offering these records for sale, she wanted the FBI to review them so that she would not later be accused of holding or destroying evidence.

She advised that she and her husband left the Dallas area in June, 1967, when he was transferred to the Santa Fe Springs office of the Mobil Oil Company, where he was employed as a Geophysicist. At that time they brought the records with them to the California area, and they have been in storage ever since. She advised that while the records were in her possession, they were never reviewed by either the Dallas Police Department, the FBI, or any other governmental agency or commission.

Mrs. Douthit furnished a cardboard box of material to be reviewed by Special Agents of the Los Angeles Office. This material was reviewed by Special Agents of the Los Angeles Office and most of the material was found to be old business records. Nothing in any of this material gave any indication of contacts or connections between Lee Harvey Oswald and Jack Ruby. Copies were made of the two address books in order that these copies could be retained by the FBI.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.


