It was most likely for this reason that it later came to the murder of the murderer, whose action was begrudged him.

I had originally predicted, and had also made it a condition in conversations with the President, that I would not make known the truth about the murder to the public until half a year after the deed. I also suggested the founding of a memorial library.

However, Kennedy did not agree that the announcement of the truth about the murder should wait so long; rather, he demanded that his family be told about it in time. Therefore, some 14 days after the deed, I informed Robert Kennedy, who then informed the widow of the President. Jacqueline Kennedy then sent me a telegram which stated that she thanked me very much and was of the opinion that what I had reported was the best solution of the case. Unfortunately I no longer have the telegram.

The above document is signed by Hiller and by the Criminal Commissioners Schaber and Voehringer. Page 12 is a statement signed by the Criminal Commissioner Schaber. It is here stated that Dr. Ostermann could not be reached on June 23, 1964, in Tuebingen. From April 8 until June 5, 1964, Hiller was under treatment in the University Sanitarium in Tuebingen. The doctor in charge was Dr. von Kalckreuth. He stated that Hiller suffered from Schizophrenia and that his visions and series dreams are symptoms of this illness. He said that the statements of Hiller are to be considered of no importance.

The report states further:

As the inquiry shows, we are concerned in the case of Hiller with a mentally ill person. He suffers from Schizophrenia.

His accounts and written reports about his meeting with the Chief of the French Secret Police, and his knowledge about the grounds for the murder of President Kennedy, are symptoms of this illness.

Hiller has released the doctors who treated him in a written statement, from their duty to keep his communications secret.

The examination of Hiller was conducted so thoroughly in order to demonstrate what his mental state actually is.

Attached hereto is a true copy of a letter and envelope, addressed to J. Edgar Hoover, FBI, Washington, D.C., and postmarked at Kenosha, Wisconsin, July 19, 1964. The letter is signed "Americans" and states in part that "President Johnson knows the Gangsters, and why John F. Kenedy was murdered, . . ."

The FBI Laboratory conducted an examination of this anonymous communication, the results of which are as follows:

Q1 Envelope bearing handwritten address "J. Edgar Hoover Federal Bureau of Investigation Washington D.C." and postmarked "KENOSHA, WIS. AM JUL 9 1964"

Q2 Accompanying handwritten letter beginning "President Johnson know's the....." and ending ".....about the President Johnson, American's".

The handwriting on the envelope and letter, Q1 and Q2, was searched through the appropriate sections of the Anonymous Letter File but no identification was effected.

The envelope and letter were examined in the Identification Division and two latent fingerprints were developed on the front of the letter only.

The envelope, Q1, was made of white bond paper, containing no watermark, to measure approximately 6.51 inches across the top, 6.48 inches across the bottom, 3.63 inches along the right edge, and 3.66 inches along the left edge.

The letter, Q2, was prepared on a sheet of ruled white paper, containing no watermark, which measures approximately 5.00 inches across the top, 4.99 inches across the bottom, and 8.01 inches from top to bottom. The front of the letter bears nineteen blue lines and the back bears twenty-three blue lines.

No indented writing of any significance was noted on the envelope and letter. The postage stamp on the letter was torn from a booklet of five-cent postage stamps. Also, the letter was written with a ball-point pen, equipped with blue ink.

A search of the indices of the Milwaukee Office of the FBI on July 24, 1964, failed to reveal any information concerning an organization known as "Americans" or any letters similar in nature to the attached letter.

On July 24, 1964, sources of information of the Milwaukee Office, who are acquainted with subversive activities in the Wisconsin area and have furnished reliable information in the past, advised that they had no information concerning the origin of the attached letter.

On July 27, 1964, [Lorraine Ferraro, Identification Clerk, Bureau of Identification] Milwaukee Police Department, advised that the records of that department contained no information regarding an organization known as "Americans."

On July 27, 1964, Lt. Orville Livingston, Handwriting Expert, Milwaukee Police Department, examined the letter in question and advised that he could not identify it with any other known handwriting contained in the records of the Milwaukee Police Department nor was it similar in nature to any other letter contained in the records of the department.

On July 29, 1964, [Captain Arthur J. Riley, Detective Bureau] Kenosha Police Department, advised that the records of the Kenosha Police Department did not reflect any information concerning an organization known as "Americans" and he could not furnish any information concerning the possible identity of the writer of the letter in question.

On July 29, 1964, [Investigator Arthur Blake] Kenosha County Sheriff's Office, advised that the records of that department did not contain any information concerning the organization "Americans" or any information concerning the possible identity of the writer of the letter in question.

1. The letterhead memorandum does not indicate Milwaukee is the office who prepared it.
2. The letterhead memorandum is not dated.
3. The letterhead memorandum does not incorporate a true copy of the anonymous letter as instructed.
4. The letterhead memorandum does not accurately quote pertinent portions of the anonymous letter (Page 1, Paragraph 1, Lines 5 and 6)
5. The letterhead memorandum contains contradictory information regarding the postmark date. In this connection the information prepared by the Laboratory is accurate.

1. Page 2, Paragraph 1, should be appropriately reworded, to omit reference to "attached letter."

2. Page 2, Paragraph 3, Line 3, Word 6, should be "contain."

3. Page 2, Paragraph 5, beginning of Line 3, should read "Police Department do not contain..."

4. Page 2, Paragraph 6, Line 3, Word 1, should be "do."

[It has been necessary for the Bureau to communicate on two occasions with your office in an effort to obtain a suitable communication for dissemination. You are instructed to immediately prepare an acceptable product for dissemination by the Bureau. No further delinquencies will be tolerated.]

[Milwaukee is instructed to submit separately appropriate explanations from the Agent handling this matter and the supervisor approving same, along with your recommendations for your failure to handle this matter in a suitable fashion.]

Milwaukee is reminded this investigation is extremely important and that matters submitted will in turn be disseminated to the President's Commission, who will in turn make all communications submitted by this Bureau available to the general public after its inquiries are completed. It is, therefore, absolutely essential that extreme care be taken in the preparation of such communications in the future.

NOTE: An anonymous letter was received at the Bureau alleging that President Johnson knew why President Kennedy was murdered. The letter alleges other knowledge on the part of President Johnson. The United States Secret Service was furnished a copy of this letter as well as the negative results of our Laboratory examination. MI has been furnished adequate information on two occasions as to how to handle the results of this matter. [However, they have failed to comply. In view of the fact it has been necessary for the Bureau to engage in unnecessary communications with the Milwaukee Office to obtain suitable communications for dissemination, it is felt that explanations should be obtained.]

Enclosed are ten copies of a letterhead memorandum containing the requested information.

As set forth in Dallas teletype to Bureau, 7/20/64, the Bureau was requested to advise if a copy of the transcript of the radio transmissions could be made available to Texas State Attorney General WAGGONER CARR, via Chief of Police JESSE E. CURRY, Dallas Police Department. By telephone call July 21, 1964, Inspector JAMES R. MALLEY advised that J. LEE RANKIN of the President's Commission had authorized that a copy of the transcript be made available to the Chief of Police at Dallas, Texas, for transmittal to Texas State Attorney General WAGGONER CARR, provided the FBI's review of the tapes revealed no significant variances with the transcription previously made available by the Dallas Police Department.

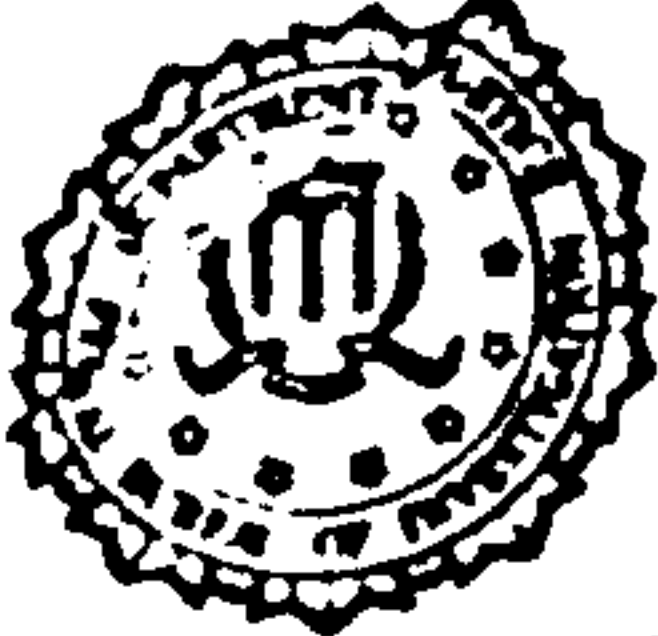

By letter dated July 16, 1964, the President's Commission referred to a memorandum captioned "Dallas, Texas, March 23, 1964." This memorandum contained the transcripts of all radio transmissions from Channel 1 and Channel 2 of the Dallas Police Department radio station covering the period from 10:00 A.M., November 22, 1963, to 6:00 P.M., November 24, 1963, as they relate to the assassination of President KENNEDY, the murder of Dallas Police Officer J. D. TIPPIT, investigations of said assassination and murder, and the security and movement of LEE HARVEY OSWALD to the Dallas County Jail.

The President's Commission letter advised that in view of the importance of these transcripts, it was desired that the Federal Bureau of Investigation obtain the original tapes of the radio broadcasts and a new transcript be prepared from these tapes for the period 10:00 A.M. to 3:00 P.M. on Friday, November 22, 1963, and from 10:00 A.M. to 2:00 P.M. on Sunday, November 24, 1963. The President's Commission letter requested that the name of the reporting police officer be listed alongside each message.

On July 21, 1964, Chief of Police JESSE E. CURRY, Dallas Police Department, Dallas, Texas, made available to a Special Agent of the Federal Bureau of Investigation the original recordings reflecting the radio transmissions of Channel 1 and Channel 2 of Dallas Police Department Radio Station KKB 364 for the above-described period, and these recordings were reviewed by a Special Agent of the Federal Bureau of Investigation on July 21, 22, 23 and 24, 1964, at the Dallas Police Department.

The radio transmissions for the period 10:00 A.M. to 3:00 P.M. on November 22, 1963, and 10:00 A.M. to 2:00 P.M. on November 24, 1963, on Channel 1 of Dallas Police Radio Station KKB 364 were recorded on dictabelts using "Dictaphones" purchased by the Dallas Police Department in 1957. These dictabelts are badly worn from being played and, in many places, the dictabelt skips and some of the messages are garbled.

The radio transmissions for the period 10:00 A.M. to 3:00 P.M. on November 22, 1963, on Channel 2 of Dallas Police Radio Station KKB 364 were recorded on a "Gray Audograph" recorder using 8½" flexible Celluloid discs. This equipment was purchased by the Dallas Police Department in the early 1950's. It was noted that these discs are badly worn from being played. In many places, the discs skip and portions of the messages are garbled.

On July 21, 1964, Lieutenant D.H. GASSETT, Platoon Commander, Dallas Police Department, advised that on November 22, 1963, between the hours of 10:00 A.M. and 3:00 P.M., three radio dispatchers were on duty at the Dallas Police Department at the same time. He stated that two dispatchers handled Channel 1, each working an opposite side of the radio console which separated one dispatcher from the sight of the other. On this radio console, above each dispatcher, are a series of knobs with a unit number assigned to each knob. The purpose of the knobs is to indicate which units are "in service" and which units are "out of service." Upon being contacted by any of the units the dispatcher, in addition to replying to the unit calling, adjusts the knob relating to the unit calling, to either the "in service" or "out of service" position.

The third radio dispatcher's position is located at one end of the radio console. This position is for the Channel 2 dispatcher. Channel 2 is usually used only when a special situation is anticipated, as was the case on November 22, 1963, during the Presidential motorcade. This relieves the volume of

radio traffic on Channel 1 and permits those dispatchers to handle other traffic with greater ease.

Lieutenant GASSETT advised that each dispatcher has a time stamp clock before him and pointed out these clocks are not synchronized. He demonstrated by simultaneously time stamping a blank piece of paper, using two of the clocks. It was noted that one clock stamped the time as 11:16 A.M. and that the other clock stamped the time as 11:17 A.M. He stated this would explain a time element variation between Channel 1 and Channel 2. He further pointed out that the position of the hands on the clock appear different, depending on the angle of sight from which one is looking at the clock. He stated a short person would have a different angle of sight than a tall person. Lieutenant GASSETT stated this quite probably could explain the time element variation of the shooting of Officer J. D. TIPPIT with the Channel 1 entry indicating the approximate time as 1:16 P.M. and the Channel 2 entry indicating the approximate time as 1:18 P.M.

Lieutenant GASSETT also pointed out that the information relating to the shooting of Officer TIPPIT was broadcast to the Dallas Police Department on Channel 1 by a citizen using Officer TIPPIT's police car radio, which is a different radio frequency than Channel 2. He stated that this same information was then rebroadcast on Channel 2, which could also explain the time element variation between 1:16 P.M. and 1:18 P.M.

The following is a transcript of the radio transmissions from Channel 1 and Channel 2 of the Dallas Police Radio Station KKB 364 for the periods 10:00 A.M. to 3:00 P.M. on November 22, 1963, and 10:00 A.M. to 2:00 P.M. on November 24, 1963, it being noted that Channel 2 was not operating during the period 10:00 A.M. to 2:00 P.M. on November 24, 1963, as they relate to the assassination of President KENNEDY, murder of Dallas Police Officer J. D. TIPPIT, investigations of said assassination and murder, and the security and movement of LEE HARVEY OSWALD to the Dallas County Jail:
