Our deal about the crisis is not getting any better, and I think about New Year, I'll fly into Moscow, and go to the Embassy about it.

As time goes on, our complaints, and their inactivity, will bring things to a head, and one side or the other will break.

We sent you a can of a kind of Russian candy, called "KHAMMA", it's made from grain and sugar, so when you'll open the package you'll know it's candy. I eat a lot of it, if you all like it, will send some more.

We'll send all this or about Dec. so you should receive it about Christmas (I hope).




from here.



I told you in my last letter that we have finally been granted exit visas for leaving the Soviet Union will probably be in the states in the spring.

You once said that you asked around about whether or not the U.S. government had any charges against me, you said at that time "no", maybe you should ask around again, it's possible now that the government knows I'm coming they'll have something waiting

Mother wrote me a letter the other day in which she informed me that the Marine Corps had given me a dishonorable discharge in Nov. 1959

ΣΡΣΣ-090601-09

Did you know this?

Of course, this is not too bad, since it relieves me of some duty, but still I should take this into account.

I wrote a letter to John B. Connally, Secretary of the Navy, who lives in Ft. Worth asking about my dishonorable discharge matter you could ask him to look

into the case since I don't know whether the Russians will let that bill through.

You said you were sending us something but it still hasn't gotten anything but worry packages are being slow coming and going.

The Embassy said they will see about a loan of some when we leave so it seems our money problem will not be too acute.

Martin still has a month to go so by the time you get this bill, you'll be pretty close to being on wheels. March 1 is the big day.

Mamma sends her love to all, as.

I do hope to see you all soon.

I really don't know where we'll settle  
I'd sort of like New Orleans.

How's the hunting out at the farms?  
How the weather, and all?

If you find out any information  
about me, please let me know, I'd like  
to be ready on the draw so to speak  
I'll keep writing until we  
get ready to leave so don't quite  
writing




The information might come in handy when I get back. I wouldn't hate to come back completely surprised.






In case you hear about our coming,

time we actually arrive in the U.S.



For the history of the past 2 weeks  
or more than my eyes & heard with  
my ears & felt with my body & with  
future reference for myself &  
future members of the family.

Friday - November 22, 1963

I was out to lunch, on this noon to  
be by day, with Bill Damm, Burnett  
of the lunch & Dick & Bud Adams all  
to the lunch & Bill in order to earlier.  
Commented "Have you heard speaking to all  
that the President had been shot  
this was approx 1:00 P.M. As we walk to the  
car generally we all had doubt if it  
were true or not. Soon as we entered  
the car the radio was turned on &  
it was real enough but at the time  
the reports were still stating they  
serious the President was as Gov. Connally  
was near in the yard of the "old"  
Diner that when a man from the  
single dept said the President Kennedy  
was dead. It seems in true & hard  
to believe it was in real & it's

sure none of these really grasped the full meaning of that statement.  
We return to the "New Denton Plant" with many degrees of comment from everyone in the car. Soon as we stepped from the car someone said we should have our flag at half-mast. This was done promptly.

After about 2 hrs in the office we went out on the yard of the New Plant and returned to the office approx 2:15 PM later.

I returned to my desk & worked on some papers for about 15 min. I left my office & walked by to the front desk & then into Marvin Ellis' office & Miss Providence the receptionist located there also had a portable radio going. I remember that the radio announcer said Lee's name & Miss Providence said 'Donald' with shock & realization on her face - then she heard Tom Lee's name - then it hit me my statement was "That's my hiel brother". I turned & ~~then~~ went to my phone & called Vada & asked her if she had heard she had not. I explained briefly &

told her I would be home shortly.  
I received, before leaving the office, a  
phone call from [unclear] with [unclear] credit  
number in [unclear] "but her  
husband [unclear] has been arrested" [unclear]  
[unclear] "I replied" [unclear] I [unclear]  
[unclear] he advised me that [unclear]  
[unclear] was trying to reach me & gave  
me a number to call. I called &  
we agreed to meet in the [unclear] Hotel  
in Dallas & that a [unclear] telegram  
report would take her there.

I left the office & came home & on  
arrival Vada & I agreed best to call  
her father & have them pick up the kids  
& herself (at first Vada insisted on going  
with me - I am thankful I would not  
let her go).

I called the Fort Worth General office &  
asked for [unclear] [unclear] but he was on a long  
distance call so I called for Bill Davis  
& advised him I needed to go to Dallas  
& he stated [unclear] he had heard [unclear]  
in [unclear] Do not let you need to do & don't  
worry about the office, also the F. B. I. had  
called the office for me.

I called the F. B. I. Fort Worth office

and spoke to a Mr. Jennings & informed him that unless he wanted me to do something else I was going to Dallas & he asked that I go to F.B.I. Office in Dallas soon as possible. I advised him I would give him a call before I arrived.

It was approx 5:15 P.M. as I rang the night bell at the F.B.I. Office. I don't know but I do not recall the agent name who interviewed me for 2 hours or more on the last time I was here? Or who was the last time I made him heard from him? This was an interview with no name applied to me. His first statement was that he had a right not to answer any questions & by reply was I didn't need a lawyer & he could feel free to ask any question. On completion of our talk I asked where was Lee being kept & he said Dallas City Jail or Police Station. I walked into the Police Station and at 7:15 P.M. I had my own air a elevator but it was the wrong floor. I found a Capt. Baker in traffic & asked
