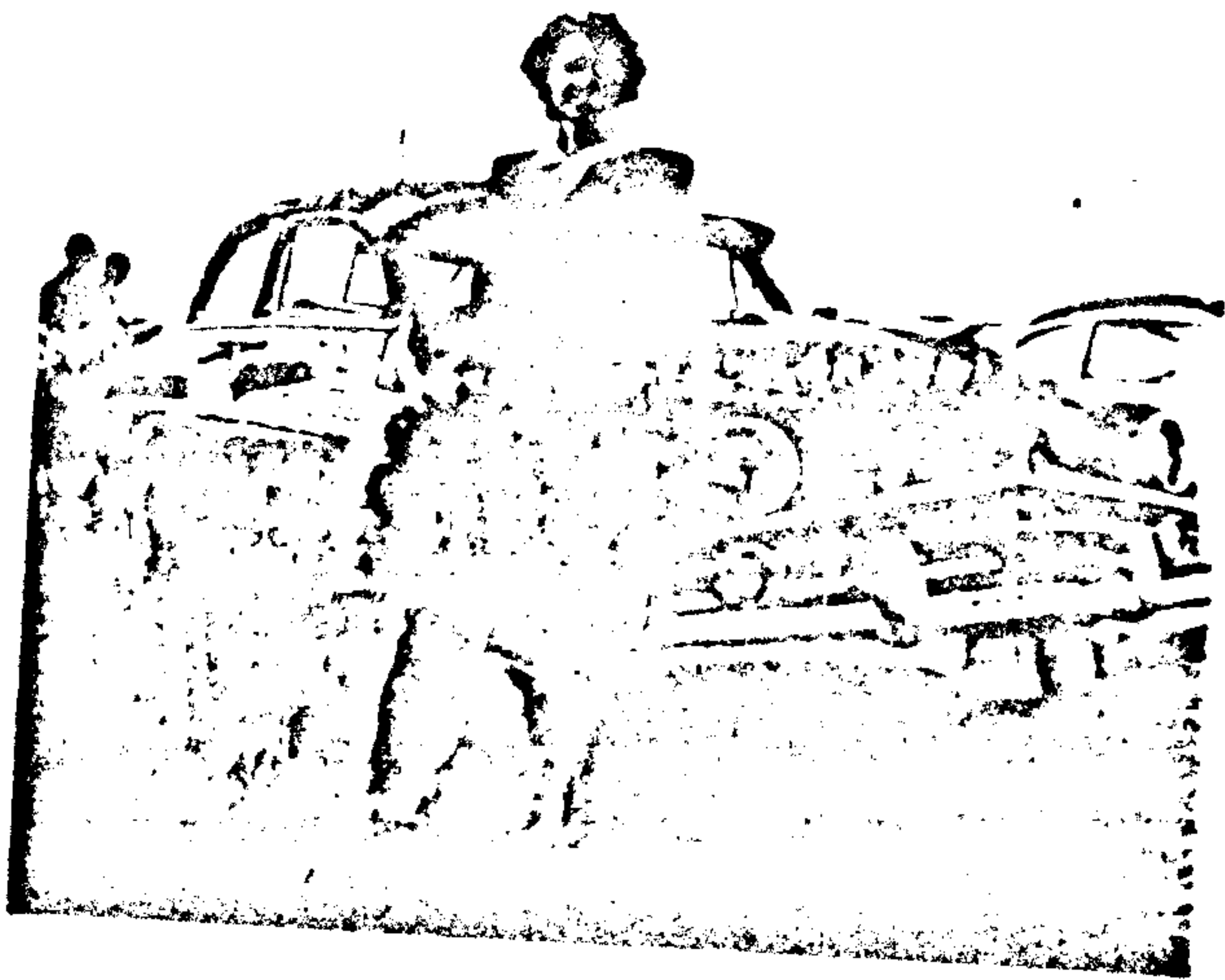

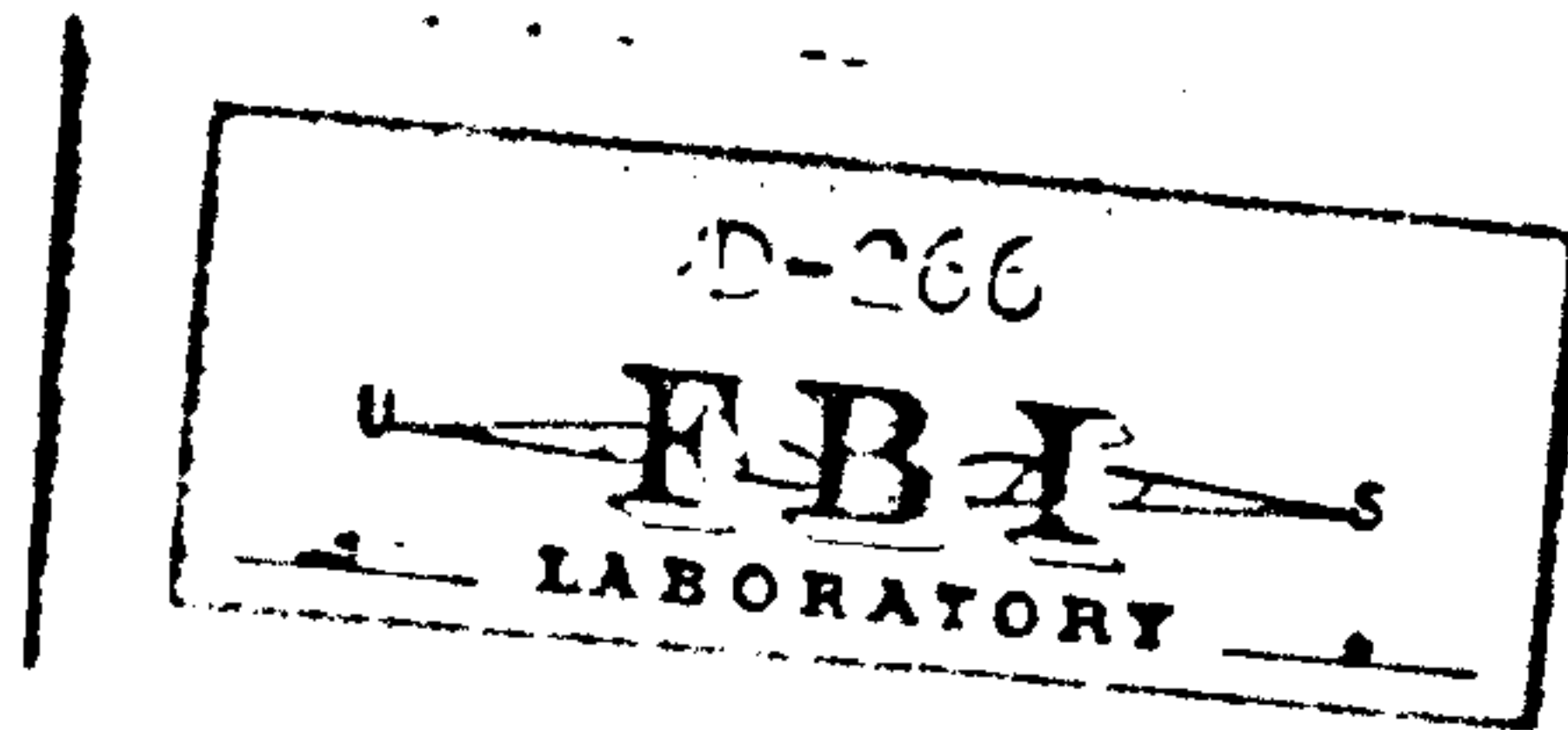

Enclosed are three pages of handwriting specimens of GEORGE BOUKE. The page with English writing is the identification page by BOUKE. The two pages with Russian handwriting contain the same wording as appears in the Russian writing on Inventory Item D-24 (FBI Laboratory Number Q42).

It is requested the FBI Laboratory compare the handwriting and enclosed specimens with that Russian handwriting appearing on Inventory Item D-24 (Q42). It will be noted GEORGE BOUKE, at the time he furnished these specimens on March 11, 1964, stated the Russian handwriting appearing in D-24 (Q42) was his.

GEORGE BOUKE advised this page of writing which comprises D-24 was a lesson in English which he had furnished to MARINA OSWALD. BOUKE wrote the lesson in Russian and MARINA wrote the English translation. BOUKE identified the English writing as that of MARINA OSWALD.

The FBI Laboratory may retain these specimens for as long as is necessary.

For the information of the FBI Laboratory, these specimens have been designated at Dallas as EL-45.
