PURPOSE: To set forth identities of analysts of the Special Case Review Unit (SCRU) and the Special Projects Review Unit (SPRU), Document Classification and Review Section, who will be assigned during the period 2/21-24/78 to work in connection with the processing of expedite requests levied upon the Congressional Inquiry Unit by the House Select Committee on Assassinations (HSCA).

At a meeting with the Assistant Director and DETAILS: Branch Chiefs of the Records Management Division with personnel of the Document Classification and Review Section and the Records Section on 2/21/78, ways and means by which this Bureau could further expedite processing of the expanding requests of the HSCA for information in our files were considered. It was decided in order to meet the immediate requests of the HSCA, 15 analysts would be temporarily loaned to the Congressional Inquiry Unit from the SCRU and ten would be loaned to the Congressional Inquiry Unit from the SPRU.
